Construction heads toward a good year

U.S. construction approached the end of the year in good condition, having built a solid base throughout the year.

"The construction industry, much like the broader economy, carried a surprising amount of momentum through the end of the third quarter," said Marcum Commercial Construction Index analysts on Dec. 6. "Construction spending is outpacing inflation on an annual basis. Material price escalation has moderated. Contractors continue to hire. Even residential construction remains in decent shape despite the paralyzing effects of high interest rates on home buying."

And the word from the Associated General Contractors was also net-positive. "It is apparent that the construction market overall remains healthy," said Ken Simonson, the AGC's chief economist. "But a rotation is occurring among non-residential segments as manufacturing construction expands while commercial construction slumps and highway and street spending stagnates. On the residential side, single-family construction is picking up, while multifamily is descending from record highs."

The AGC said U.S. construction spending, not adjusted for inflation, totaled \$2.027 trillion at a seasonally adjusted annual rate in October. That figure is 0.6 percent above the September rate, and up 8.8 percent compared to the spending level a year ago.

Marcum said there are "several headwinds facing the construction industry. Elevated borrowing costs and tight credit conditions have severely diminished demand for certain types of construction, and worker shortages, long an issue for contractors, are driving up the cost of labor, exacerbating the effects of material price escalation that occurred in 2021 and 2022."

Construction employment Marcum said, remains strong, with the industry adding jobs for the seventh straight month in October. The non-residential sector lead the way, with a 6 percent rise in employment over 12 months through October 2023.

With more than \$1 trillion being spent by the Biden Administration on infrastructure, the AGC noted a September to October decline of 0.4 percent in highway spending. "Many state and local officials are having ongoing challenges in following the administration's complex Buy America rules," the AGC said. "The Biden administration seems to be suffering from a bit of policy schizophrenia; it talks a lot about wanting to build infrastructure while it keeps working to tie those projects up in red tape," said Stephen E. Sandherr, the association's CEO.

Wow... injury/illness rate plunges in construction

Every year, the Bureau of Labor Statistics (BLS) releases its annual report on workplace injury and illness data. This year, the major headline being reported is that from 2021 to 2022, the number of injuries and illnesses in private sector U.S. workplaces spiked 7.5 percent to 2.8 million incidents.

However, what isn't being

discussed enough is that for the third year in a row, injuries and illnesses in the construction industry decreased significantly. After dropping 13 percent in 2021 to 174,000, the number of injuries and illnesses in construction declined another 17 percent in 2022 to 144,480.

These are major strides for an industry that's often perceived as a dangerous place to make a living. And it's not just the total number of injuries and illnesses

that's dropped in construction – it's the injury rate, too.

Construction gets safer as many industries grow more dangerous. The overall injury and illness rate for private U.S. workplaces now sits at 2.7 per 100 workers. In construction, that number is 2.4. That means U.S. workers are more likely to experience a recordable injury or illness in a non-construction workplace.

These results aren't a blip on the radar, either. The recordable

rate for construction has now been below the average rate for all industries for three years in a row. It went from 2.8 in 2019 to 2.5 in 2020 and held steady in 2021 before dropping again, to 2.4, in 2022.

The data shows that many other industries that have long been considered "blue collar" have a much higher reported injury and illness rate than construction.

Clean energy bills signed by governor will transform power production in Michigan

LANSING – "Ambitious." "Bold." "Extreme."

Headline writers in Michigan and across the country used those terms and others to describe the action taken by Gov. Gretchen Whitmer on Nov. 28, who signed landmark legislation that pushes the state on a fast-track path to the use of cleaner energy by 2040.

But the package of bills – with a timeline that makes Michigan one of the few states with such an ambitious schedule to move away from carbon-based fuels – also raises questions about power availability, reliability, and cost. Importantly, the legislation also enshrines some pro-union language into construction of green energy projects, as the package of laws requires the use of prevailing wage and the hiring of workers who have been trained by Department of Labor-approved apprenticeship programs.

"Michigan's clean energy future is bright," said Whitmer at the signing ceremony for the Clean Energy and Climate Action Package. "Today's bills will lower household utility costs by an average of \$145 a year, create 160,000 good-paying jobs, and bring nearly \$8 billion of federal tax dollars home to Michigan for clean energy projects. I am proud that these bills make Michigan the best state in the Midwest for climate action and the strongest state in the nation when it comes to labor standards for clean energy production."

"Together, we are fighting for our air, land, and water, improving public health and protecting our precious natural resources for future generations. We are building the future in Michigan."

The shuttering of decades-old coal-burning power plants by the state's two major utilities – Consumers Energy and DTE Energy – has been ongoing for the past several years. And the broad spectrum of building trades crafts have been steadily losing work opportunities from those plant closures.

But the clean energy work has offered new employment opportunities, with solar power installations and wind generators

Owner poised to resurrect Palisades nuke plant in SW Michigan

ST. JOSEPH – Holtec International, the owner of the Palisades Nuclear Power Plant, announced on Dec. 4 the planned construction of two new reactors at the site. The small modular reactors will each generate 300 megawatts of energy, nearly doubling the output of the plant when it comes back online in the next two years.

The announcement of the plan to place more clean energy on the grid (and nuclear is considered clean energy) comes only weeks after Gov. Gretchen Whitmer signed the Clean Energy and Climate Action Package. According to *World Nuclear News*, the Palisades plant, located about 10 miles north of here, would become the first successfully re-started nuclear power plant in the U.S.

"Buoyed by the State of Michigan's commitment to expand in-state carbon-free generation as well as by the broad-based federal, state, and community support for repowering the Palisades Nuclear Power Plant, we

MPSC OKs Line 5 tunnel, but they aren't the last word on building it

LANSING – The Michigan Public Service Commission (MPSC) on Dec. 1 approved Enbridge's plan to build a tunnel to encase their Line 5 oil and natural gas pipeline under the Straits of Mackinac.

The MPSC's 2-0 decision is the final step in gaining state approval for the five-mile-long tunnel, which would be encased in bedrock under the Straits between St. Ignace and Mackinaw City. An ongoing permitting process from the U.S. Army Corps of Engineers, plus a potential lawsuit against this ruling, means this isn't the final word on building the tunnel.

MPSC Chairman Dan Scripps said the tunnel project is the safest option among multiple alternatives to move petroleum and natural gas through the state and region. Line 5 starts in Wisconsin and terminates in Sarnia, Ontario. The current Line 5 set-up

Hell- Oh Canada! Gordie Howe Bridge approaches mid-river meet-and-greet



THE CONSTRUCTION of the Gordie Howe International Bridge over the Detroit River between Detroit, at right, and Windsor, Ontario, currently offers a rare opportunity to see work on a new, major span between the U.S. and Canada – or actually all of North America. The last time there was such an opportunity was the completion of the second Blue Water Bridge between Port Huron and Sarnia, Ontario, in 1997.

It's beginning to look a lot like a major international bridge crossing.

Both Canadian and American trades workers have been hard at work for the past five years in spots below, at, and well above the level of the Detroit River, building the Gordie Howe International Bridge. And now workers toiling at the leading edge of what's now the most prominent

portion of the project – the road decks from both sides – are within hailing distance of each other over the water.

"Starting from the towers in Windsor and Detroit, the bridge deck is built outward toward the center of the river, one segment at a time using a crane on the deck, eventually meeting in the middle," says the Windsor-Detroit Bridge Authority. "Construction materials and equipment are transported over the back span to

the construction zone, eliminating the need for equipment to operate from the water."

The 1.5-mile crossing will be the longest cable-stayed bridge in North America, and 10th longest in the world, with a main span of .53 mile. Supporting the span now and upon its completion next year will be 216 metal-stranded stay cables, 108 on each side, which are attached to the tops of each tower and then anchored into 35 concrete ground-level boxes on

each side of the river.

The six-lane bridge deck and road deck will have a total of 106 segments. Each floor beam weighs 55,000 lbs. and each edge girder for the road and bridge decks weighs 99,000 lbs. Each concrete precast panel for the road and bridge decks weighs between 35,000 lbs. to 55,000 lbs.

Supporting all that weight are the aforementioned attached cables, which are connected to

Endless labor law barriers

Last month, the United Auto Workers announced an unprecedented organizing effort at 13 non-union auto manufacturing operations in the United States. This attempts to build on the union's success in winning favorable contracts with the Big Three automakers (Ford, GM, and Stellantis), which has already led to wage increases at non-union plants.

Winning in facilities, particularly in the South, where the UAW has failed multiple times in the past would be a triumphant vindication of the aggressiveness of new union president Shawn Fain and his leadership team. It would signal a true resurgence for the labor movement, with 150,000 workers potentially at stake. And organizing is already under way.

But as the UAW is surely aware, there's a big difference between earning a new contract at an established union company and starting from scratch. The latter bumps up against significant barriers inherent in U.S. labor law, where even when the system works, the wheels of justice turn too late to make meaningful change in the workplace.

In fact, there's a perfect example of this left over from one of the last major UAW organizing efforts at a non-union automaker. Richard Ortiz, who was a production associate at Tesla's plant in Fremont, Calif., was fired for protected union activity in October 2017. Every administrative body that has looked at the case, including the most conservative court of appeals in the nation, has ruled in Ortiz's favor. Yet he still doesn't have his job, more than six years later.

The case shows how a persistent, aggressive employer that doesn't want a union can frustrate collective bargaining by flagrantly violating labor law, and trusting that resulting minuscule penalties and especially the glacial slowness of the legal system will let them win in the end. "It's standard operating procedure to delay as long as possible," said Nelson Lichtenstein, labor expert and professor at the University of California, Santa Barbara. "It doesn't matter if they win or lose."

Ortiz, along with his fellow organizers, faced retaliation for handing out union flyers to colleagues and wearing UAW T-shirts to work. He was demoted from his position on the assembly line, "coercively interrogated" on three occasions by managers, and eventually fired along with hundreds of other workers in October 2017.

Ortiz and the UAW alleged that the mass firing, which Tesla claimed was based on performance, was an unfair labor practice intended to replace vocal pro-union workers with temps, and filed a claim with the National Labor Relations Board. Tesla never made the negative reviews that were supposed to be the basis for the firings available.

At that point in 2017, Donald Trump's pro-corporate NLRB had little interest in acting precipitously on the case. It languished for three and a half years. Finally, in March 2021, the board ruled that Ortiz was illegally fired and had to be able to return to work. As part of the ruling, Musk was also supposed to delete a tweet insinuating that workers would lose stock options if they voted in a union.

Of course, the "penalty" for this violation is paltry: The worker gets back pay, less whatever wages he earned in the meantime while not working for the company that engaged in the illegal firing. While the NLRB today is trying to add additional compensation, like housing or transportation costs, that reflect the real loss of a job, in reality it costs a company next to nothing to fire union organizers.

Moreover, the NLRB ruling didn't end Ortiz's ordeal. Tesla appealed, not to the Ninth Circuit Court in California where Ortiz worked, but the Fifth Circuit, which includes Texas. The Fifth Circuit, of course, is notoriously conservative and subsequently anti-union. Tesla has appealed other NLRB rulings to the Fifth Circuit as well, in one case successfully, as the court ruled the company's uniform policy, which bars union insignias, is lawful. But even this very conservative court ruled in Ortiz's favor. In March of this year, a three-judge panel ruled that the nominal reason for firing Ortiz was protected union activity not related to his job performance, and that the firing was motivated by animus.

Tesla petitioned to have the Fifth Circuit rehear the case en banc, with all of its judges present. That was agreed to by the court in July, and an en banc hearing has not yet been scheduled. So as we hit December 2023, Ortiz remains out of his job from which Tesla fired him, by all accounts illegally, in October 2017.

"It's a problem with the framework that we do this work in," said Larry Cohen, former president of the Communications Workers of America. "He's won at every step and he's not back."

The lack of speed to rectify illegal union busting, and the way in which corporations can just drag out cases to gain the benefits of blocking union momentum while avoiding the (meager) consequences, presents a structural hurdle, particularly to organizing new workplaces. Because the NLRB is aware that most of their rulings will be appealed, they spend a lot of time trying to make them bulletproof for appellate courts. That caution eats up more time and is beneficial to management.

"When you have the head of the company who is the founder, the proprietary capitalist," Lichtenstein said, citing Musk, Starbucks CEO Howard Schultz, and former Amazon CEO Jeff Bezos, "they see a union challenge as a personal affront." The law helps them fight those affronts, and this means the biggest organizing effort from a union in decades faces a huge uphill battle.

The high-profile, successful actions by the UAW in the Big Three strikes gave them a lot of goodwill among autoworkers and the public. But the law really is on the side of the companies. That will come into play during organizing, then later if a union election has to be held, and even after that amid the often-interminable bargaining for a first contract. And these barriers are of course critical to the fight to ensure that electric-vehicle jobs are good jobs.

If large parts of the sector are not unionized, that could depress wages and work conditions for everyone. "While Musk and his colleagues are rushing to the EV future, they're trying to drag us back to a robber-baron past," Ortiz wrote in 2021, "where bosses call the shots and workers are treated as costs to be minimized. They fired me because I tried to improve the lives of my coworkers and myself," he told *More Perfect Union*. "We were there to make (Musk) famous. It's all about him. What are we? Disposable."

the second-tallest structures in the state and the region – the massive 722-foot-tall towers on either side of the river.

Since construction began on Oct. 5, 2018, on both sides of the river, about 10,000 people have worked more than 10 million hours of work on the project.

The bridge authority said the construction method for the bridge is called an "unbalanced cantilever system" It said the term cantilever in construction typically refers to a balanced approach with the same level of construction occurring on each side of the tower. However, the Gordie Howe International Bridge's construction is "unbalanced," with the back span of the road deck constructed first, supported by temporary falsework bents, before construction progressed on the main span over the Detroit River.

The bridge authority's latest update on Dec. 5 said "after construction of the bridge deck over the Detroit River started in December 2022, 2023 was a year of significant and stunning progress. Half of the bridge deck is now complete as crews continue to install steel girders and floor beams and place concrete precast panels. Also known as the main span, the bridge deck will be 138 feet above water near the towers with a 5 percent incline reaching 150 feet in the middle of the river."

Corporations: Pay no attention to our sleazy price gouging!

According to an old saying, "You can't squeeze blood from a turnip." True. But that raises this question:

Who would even try squeezing blood from a turnip? Well, metaphorically speaking, if "blood" means profit, and "turnips" are customers, airlines are eager to apply the squeeze. As are banks, credit card outfits, cable TV and Internet hucksters, car rental companies, concert promoters... and can anyone decipher their insurance policies!?

I'm not talking about fair profit, but junk fees, hidden charges, undisclosed add-ons, and other "gotchas" that brand-name giants sneak into the fine print of their price tags. It's pure corporate larceny, adding up to a stunning level of unearned profit for the perpetrators – airlines picked our pockets for nearly \$7 billion last year in baggage fees alone; credit card dealers plucked \$14 billion from us in punitive late fees; and the overall corporate haul from this secretive squeeze on consumers now tops \$64 billion a year!

Shouldn't companies have to tell you – in plain language – what they're actually charging you... and for what? "Yes!" says Joe Biden, who's pressuring the gougers to come clean. "Hoo-ray!" exult consumers who're tired of being played for suckers.

On average, the bridge authority says, up to 35 people are working on the decks every day. They access the decks by walking up 200 flights of stairs or by using the temporary elevator on the north side of each tower.

Substantial work was completed on the road deck before bridge deck work began on the Canadian and U.S. sides.

There's also substantial work going on in southwest Detroit behind the bridge, where the U.S.

Port of Entry is being developed on a 167-acre site that will be one of the largest border facilities in North America. There will be 13 structures that will be located at the U.S. Point of Entry. The bridge will link to I-75.

BUILDING MICHIGAN: Big Red HISTORY IN THE MAKING

ONE OF MICHIGAN'S iconic structures is the Holland Harbor Lighthouse – or “Big Red.” The lamp atop the house-like lighthouse is a beacon visible to mariners 13 miles into Lake Michigan. None of the keepers made it their home, all of them lived ashore while tending to the Holland light. The building’s stark red color against a snowy backdrop or one of Lake Michigan’s often spectacular sunsets makes it a favorite target of photographers.



It’s a claim that’s impossible to quantify, thus tough to argue with. But ultimately, when you peer out at “Big Red” on a warm summer evening or even a frigid winter’s day – it is completely understandable.

We refer to the local Chamber of Commerce-driven claim that the Holland Harbor Lighthouse is “Michigan’s most photographed lighthouse.” Maybe it is, maybe it isn’t. But if you’ve been to Holland State Park on the Lake Michigan shore, chances are good you yourself have taken out your phone and irresistibly snapped a few shots of the Holland Harbor Lighthouse, adding to the local lore.

“Don’t miss Michigan’s most photographed lighthouse, and Holland favorite, ‘Big Red,’” says the Holland Area Convention & Visitors Bureau. “For a great view of Big Red, visit Holland State Park, and walk along the boardwalk to the north pier (wheelchair accessible). You can also view Big Red from Mt. Pisgah, where the dune staircase takes you 157 feet above sea level.”

The current set-up of the Holland lighthouse dates to 1936, when the U.S. Coast Guard merged a 1907 fog signal building with a roof-mounted light tower, creating the house-

like structure that continues to act as a beacon today.

While some of Michigan’s lighthouses have become legendary for some combination of the engineering that went into building them, or for their longevity, or perhaps for a tall, classic cylindrical masonry exterior – the Holland Harbor light essentially owes a fair amount of its picturesque fame to its paint job.

“The Holland Harbor Lighthouse, affectionately known as Big Red, reigns as the most photographed lighthouse in Michigan. But what many folks don’t know is that Big

Red wasn’t always red,” says a 2021 article in Michigan’s *Waterfront Lifestyle Magazine*. “The lighthouse used to be yellow and purple. In 1956, the U.S. Coast Guard sandblasted the tower and painted it bright red, satisfying a requirement that all navigational aids on the right side of a harbor entrance must be red,” says John Gronberg, president of the Holland Harbor Lighthouse Historical Commission and a member of the Michigan Lighthouse Alliance. “Thus began Holland’s love affair with their famous Big Red icon.”

Like most Michigan light-

houses, the current Holland Harbor Lighthouse had its share of inadequate predecessors. The Michigan Historic Site marker explains that when seeking a location for himself and his Dutch emigrant followers in 1847, the Rev. A.C. Van Raalte settled in the area and was intrigued by the potential of using Black Lake (now Lake Macatawa) as a harbor connecting into Lake Michigan. The group saw a harbor as critical to economic develop-

ment. But first a channel needed be dug, and the Dutch settlers did the work themselves, with the first steamboat passing through and making port in 1859.

The first lighthouse built at this location was a small, square wooden structure erected in 1872, after Congress appropriated \$4,000 to the project. In 1880 the Lighthouse Service installed a new light atop a metal pole in a protective cage. The oil lantern was lowered by pulleys for service. In 1886, the federal government established the growing harbor’s first lifesaving station. By 1899 the channel had been relocated and harbor work completed. By 1900 it was a very busy harbor, with the passage of 1,095 schooners, steamers and barges that year moving past the light into Lake Michigan.

“At the turn of the century, a steel tower was built for the light and in 1907 the present structure was erected,” says the Michigan Historic Site marker. “Named the Holland Harbor South Pierhead Lighthouse, it has a gabled roof that reflects the Dutch influence in the area.”

“The steel tower was an obvious improvement from the wooden structure,” says a history provided by the City of Holland. “Not only could it better withstand severe weather, it could be spotted by incoming vessels as far away as 13 miles. When fog lay on the lake, as it so often did, a light signal was useless. It was obvious that a fog signal ... must be incorporated.

“In 1907, a steam-operated fog signal was installed. Two coal fed Marine boilers produced steam to sound the locomotive whistle used as a fog signal. The 1907 building was built as a fog signal building only. It had no light (the light

stood adjacent to it as a separate structure until 1936 when the Coast Guard consolidated the two structures by putting a light tower on top of the fog signal).”

The wooden upper level of the current lighthouse, said the City of Holland, “is Queen Anne Victorian in style. The steeply sloped roof gables and Palladian window motif that are still intact evidence this. The original roofing material was probably cedar shakes.”

“Between the years of 1908 and 1912, three different keepers shared time tending the light, showing how demanding maintaining the signal constantly was on a person,” said *Michigan Lighthouse Series – Holland’s Big Red*. “Not only did the lighthouse keeper maintain the light and signal, they also stood watch. As the steam powered foghorn required 45 minutes to become operational, the watch was generally broken down into six-hour shifts.”

In 1934, the lighthouse and its lamp were wired for electricity, and electric air compressors for the fog horn were installed. The entire operation became automated and no staff were required to operate it. The electrification marked the end of the era of lighthouse keepers there that had spanned 68 years.

The U.S. Coast Guard said when it announced plans to abandon the lighthouse in 1970,


“citizens of Holland signed petitions and wrote letters to save their beloved landmark. This effort prompted the following reply by J. Natwig, Chief of Staff of the Ninth Coast Guard District: “Based upon numerous letters from the citizens of Holland, Michigan, we have recognized the South Pierhead Light Structure to be an aesthetic landmark. Plans for the improvement of the aids to navigation system at Holland have been revised to provide for the continued maintenance of this structure by the U.S. Coast Guard. I trust this information relieves any doubts you may have had for the future of the South Pierhead Light.”

By 2005, the lighthouse was deemed excess by the U.S. Coast Guard, and its control was transferred to the National Parks Service and then to the Holland Harbor Lighthouse Historical Commission. Unlike a number of lighthouses in the state, Holland’s remains closed to the public, and Big Red is best viewed from the nearby state park.

“In 2012, people were complaining that Big Red was looking more like Big Pink,” says *Lighthouse Friends*. A 2009 paint job faded faster than expected. A local company and paint supplier then stepped up to fund a new coat of red on the structure, and it’s repainted every decade.

THE STARS AND STRIPES on the flagpole above the Holland Harbor Lighthouse is seen as a key aesthetic element, and an important aid to sailors. The lighthouse’s operators use a larger flag in the warmer months, and the wind-swept banners are replaced at a rate of eight to 10 each season.

Owner poised to resurrect Palisades nuclear plant

have started the program to build our first two SMR-300 reactor units at the Palisades site," said a statement by Holtec. "The existing Palisades plant refurbished with an array of enhancements is on track to be restarted by the end of 2025 and is designed to provide decades of safe and reliable service. The addition of two Holtec small modular reactors (SMRs) near the existing 800-megawatt (MW) plant will nearly double the Michigan site's total carbon-free generation capacity."

The Palisades plant was shut down by Entergy in May 2022 after 50 years in service. The reactor was de-fueled that June, and its sale to Holtec was completed later that same month with de-commissioning envisioned for completion in 2041. Holtec subsequently announced plans to re-power the unit and in October of this year, and submitted a filing with federal regulators to formally begin the process of seeking re-authorization of power operations at the plant.

The target commissioning date for the first Small Modular Reactor-300 plant is mid-2030, subject to the U.S. Nuclear Regulatory Commission's (NRC's) regulatory reviews and oversight.

"Siting the first two SMR-300 units at Palisades eliminates the delays associated with erecting the plant at an undeveloped property and confers the many benefits of synergy that accrue from the presence of a co-located operating plant – including shared infrastructure and operational expertise, enhancements to grid stability, and resource optimization," said Holtec's CEO, Dr. Kris Singh. "By building at our own site with our own credit and our own at-risk funds, we hope to deliver the dual-unit SMR-300 plant within schedule and budget – an outcome that has eluded our industry for a long time. We thank our federal, state, and community partners for their critical support, which have made the Palisades re-start and our pioneering SMR-300 construction in Michigan feasible."

Earlier this year the State of Michigan budgeted \$150 million in 2024 to aid the plant's transition from decommissioning to operations. "The investment to restart Palisades, which I proudly voted for, is paying even greater dividends," said State Rep. Joey Andrews (D-St. Joseph). "Not only will the initial restart mean the preservation of hundreds of high-paying jobs, constructing and employing two new reactors will put more of our friends and neighbors to work and help us reach our 2040 new clean energy goals. Today is a great day for Southwest Michigan."

Clean energy bills signed by governor will transform power production in Michigan

a boon to several trades. Solar, wind, hydro and nuclear are among the green energies now being given the green light by the state, but there is still a place for natural gas-fired plants, with one caveat. The new package of laws mandates the use of "carbon capture" technology at gas-fired plants. The capture technology is still expensive and evolving, but installing and maintaining the technology at the state's power plants is sure to be a major, future employer for building trades workers.

"Michigan's clean energy future will be built by hardworking union men and women," said Mike Barnwell, president of the Michigan Regional Council of Carpenters and Millwrights. "Gov. Whitmer and leaders in the Michigan Legislature are setting an example for the rest of the country on how to face climate change head on while creating tens of thousands of good-paying clean energy jobs that pay fair wages and offer great benefits. Our state put the world on wheels, assembled the arsenal of democracy, and built the American middle class. All that progress has been made possible by unions and now, with the strongest clean energy labor standards in the country, we will build the future of clean energy right here in Michigan. Let's get it done."

Only Connecticut, New York, Minnesota and Oregon share Michigan's accelerated carbon-free power production plan by 2040 timeline. And the national media paid close attention: the CBS News called the legislation an "overarching package of bills." PBS and Fox News called the reforms "sweeping changes." The Associated Press called them "ambitious clean energy mandates."

And putting Michigan into that fast-tracked realm has its share of detractors, including the entire slate of Republican lawmakers in the state House and Senate who voted against the legislation.

"If wind and solar are so inexpensive, why are they subsidized by the government? I mean, come on, nobody believes that," said state Rep. Andrew Beeler (R-Port Huron), to a local radio station. "Nobody believes that wind and solar powering our grid is going to be less expensive. If it were, why wouldn't we be doing it already?"

The Michigan Chamber of Commerce also has its doubts. "Gov. Whitmer signed seven bills into law that will drastically change the way the state develops and regulates its energy portfolio," said a statement from the Chamber. "At her bill signing event, rhetoric... focused on benefits to businesses and savings to ratepayers, yet energy experts disagree. In actuality, three of the bills (Senate Bills 271, 273 and 502) would hamstring the ability for electric providers to maintain the grid affordably and reliably."

"Through its leadership of the Great Lakes Growth Coalition, the Michigan Chamber voiced strong concerns that the bills will lead to the premature retiring of existing power generation systems, that will then need to be paid for by industrial and commercial customers. Additionally, GLG partners fear these costs will then be passed on to hard-working Michigan families."

On the other hand, some green groups bemoaned the inclusion of natural gas plants in the state's energy portfolio, even though the energy source creates about one-third of the state's energy supply.

The 2023 "Clean Energy Jobs Report" by the E2 group said that clean energy businesses in Michigan added more than 5,400 workers in 2022 and now employ 123,983 Michiganders. Michigan now leads in the number of clean energy workers, the group said.

Polling shows support for the clean energy standard: a survey by Evergreen Action and Data for Progress found that 65 percent of voters supported legislation to transition the state to 100 percent clean energy.

"The bills signed by the governor today set robust clean-energy standards, and position Michigan to become a leader in responsibly fostering the critical shift away from fossil fuels, to a sustainable, clean-energy future," said State Sen. Sam Singh (D-East Lansing), lead sponsor of SBs 273 and 519 in the bill package.

Wow... injury/illness rate plunges in construction

This same trend appears in the days away from work (DAFW) rate, a metric that combines recordable incidents with the resulting number of missed work hours. In 2022, construction's DAFW rate was 1.0, which was lower than the average (1.2) and lower than manufacturing, retail, transportation/warehousing and health care/social work.

However, these numbers need to be assessed alongside two major caveats. First, this new BLS data only reflects recordable injuries and illnesses, and it's well-known that many incidents go unreported. Under-reporting remains a big problem for several reasons, including a workers' compensation system that's often slow and difficult to navigate, a lack of paid sick time in many industries and workers feeling pressured or intimidated about speaking up. For example, it's estimated the 23 percent of the construction workforce is made up of undocumented workers; it's easy to see how an unscrupulous employer could take advantage of that to discourage injury reporting.

Next, these numbers don't include deaths on the job, only nonfatal incidents. While we're still waiting for this year's release of Census of Fatal Occupational Injuries (CFOI) data, construction has historically had one of the higher fatality rates among all industries. In 2021, construction had the highest number of deaths and the third-highest rate among all industries.

Using safety to recruit and retain workers. In today's tight labor market, many companies are competing for the same group of available workers. Whether it's a warehouse job, a manufacturing job or a construction job, workers have more choices than ever before. And they should be armed with accurate information about the safety and health risks of those industries so they can make the best decision for themselves and their families.

For decades, construction has been regarded as a dangerous job. And it can be extremely dangerous when work isn't performed with the proper safety and health programs, protocols and procedures in place. It appears the industry as a whole is making significant, year-over-year strides when it comes to injuries and illnesses.

Laborers International Union of North America District Councils, local unions and other LIUNA affiliates can help change this decades-old perception by spreading the message that the industry is changing for the better and can improve even further. We should share that message with young people entering the workforce for the first time and with more experienced workers who may be considering a career change as construction work booms. Along the way, the Laborers Health and Safety Fund of North America will continue working with LIUNA signatory contractors to make jobsites safer and reduce the number of serious injuries and fatalities in the industry.

When workers, families and communities start to view construction work as just as safe – or safer – than many other jobs, we can attract and retain even more workers to this industry. And once they're here, it's easy to tout the strong union wages, excellent benefits and powerful voice that being a LIUNA member brings to workers and their families.

MPSC OKs Line 5 tunnel, but they aren't the last word on building it

dates to the 1950s, and utilizes twin steel pipelines lying atop the Straits lakebed – making them vulnerable to a strike by a ship's anchor. "We need to get those pipelines off the bottomlands and out of the Great Lakes," Scripps said.

However, work can't proceed on the project without federal permits from the U.S. Army Corps of Engineers, which isn't expected to make a decision until early 2026. Canadian energy giant Enbridge, which is seeking to build the tunnel, called the Army Corps' process "inexplicably lethargic."

"Ultimately, the MPSC agreed with its staff's conclusions that Line 5 transports critically needed energy for Michigan and the region and placing the Line 5 pipeline in the Great Lakes Tunnel better protects the Great Lakes," Enbridge said in a statement.

Pointing to the potential ecological devastation of a pipeline leak, the Whitmer Administration and Attorney General Dana Nessel have not been supportive of the tunnel project, estimated to cost \$500 million. The project would also become a major employer for the building trades in an area of Michigan that rarely sees such major construction.

"The tunnel project was approved by the Legislature five years ago with bipartisan support to protect our Great Lakes – while also creating thousands of good-paying, mainly union jobs," said Upper Peninsula Republican state Sen. Ed McBroom (R-38th District). "In addition to creating jobs and protecting our water, the tunnel will ensure families in the Upper Peninsula and Northern Michigan continue to have access to affordable propane to heat their homes, and the even larger bulk of other products that support tens of thousands of jobs across the state and region are secured."

The project has been discussed for the good part of a decade, and construction was originally scheduled to begin in 2021, with the tunnel expected to be operational by 2024. Lawsuits and permitting agencies have slowed the process.





Attention All Members, this paper is to serve as official notice to the membership. This is how we get information out to all our members, as repetitive as it might be there is new information in each article, please read it carefully and call the hall or attend a union meeting if you have any questions.

With the holiday season coming up, there are a lot of distractions, don't let these distractions cause you to take your eye off the ball, work safe and look out for the members around you so we can all enjoy our time with our families during this holiday season.

If you move or your address changes, call the hall and make sure you fill out the right forms on the NEIBP website.

If you are going to be off with an injury (work related or non-work related), surgery or illness for a prolonged length of time, call the fund office and inform the hall. When you go back to work, call the fund office, and let them know you are back to work, and inform the hall.

2024 Wage rates, Zone pay, death assessment, and dues sheets were sent out last week, you should receive nine sheets of paper, if you have any questions call the hall.

The picnic assessment will be \$53.00 per member and will be assessed with fourth quarter dues.

All active members shall be assessed twenty-five dollars (\$25.00) on Dec. 1, 2023. This funding will allow the fund to increase the IUEC Death Benefit amount, continue to invest in a responsible manner and allow for timely payment to beneficiaries. Local Unions shall be responsible for collecting the IUEC Death Benefit assessment and transmitting it to the IUEC on or before January 15, 2024. This will be assessed with fourth quarter dues.

Just want to remind all members that the rule of thumb was to have a savings of six months in case of a strike/lockout. Nowadays you never know what is going to happen, you could get hurt on the job, family emergency, unforeseen circumstances or get laid off. It is important to be able to have financial stability while you are off.

If you think there are contract violations or safety violations on the job you are on, call the hall, we will come out to the jobs and get the violations corrected.

If you would like to sign up for Safety alerts, text (855) 957-1801 and sign up to receive Safety alerts via text and email. As you are aware, individuals with a Mechanic Exam Pass Date on or after Jul 9, 2022, through December 31, 2022, must take a Mechanic Required (MR) Continuing Education course in 2023 to receive their scheduled pay raises January 1, 2024. **I highly recommend if you fall in this category and haven't done so, take the course and keep up on it.**

We have grandfathered mechanics that have completed this course more so than mechanics that are required to complete this course. **You have 1 month to complete this course, or you will not receive your pay raise on January 1, 2024, and you will not get back pay if you complete this after January 1, 2024.**

The Conversation That Adults of All Ages Need To Have – But Most Often Don't

Certainly, every scenario can't be known or addressed ahead of time, but discussing things in advance and having documents in place offers a roadmap that'll make for fewer bumps in the road.

Let the Law Help

Huge amounts of stress can come into play when illness reaches a critical stage. Having documents in place that designate a person to make decisions and offer guidance on what should or shouldn't be done, can relieve some of that stress.

Engaging the services of a legal professional is advisable for creating some of these documents, but state agencies and reputable organizations often offer forms and other advice online to get documents done at little or no expense.

Here are some documents experts say can help ease confusion and stress when illness incapacitates someone from making their own decisions.

• **Durable Power of Attorney for Healthcare ("Patient Advocate").** This designation ONLY relates to medical care decisions and designates a person to act as your medical advocate and make medical care decisions if you are unable to do so.

If possible, choose someone who is geographically close by and has time and energy to devote to what can become a consuming task.

In Michigan, Advance Directives forms are available at: <https://mihin.org/advance-care-planning-resources/>. AARP has an online resource to obtain similar forms in

every state.

• **Living Will.** This spells out a person's wishes for care, including whether to be put on life support; treatments you do or don't want; spiritual care; and any specific comfort routines that are particular to you. You can also include your wishes regarding funeral and memorial services.

You'll want to discuss the contents of this document with the person you designate as your Patient Advocate. A Living Will is not legally binding in some states, but rather a guide that helps medical professionals and a Patient Advocate understand what type of care is desired.

• **Durable Power of Attorney.** Unlike the Durable Power of Attorney for Healthcare, this type of designation allows you to name someone to handle your legal and financial affairs should you become unable to do so. You can limit this to apply only to certain types of transactions and also specify whether you want a doctor to certify you are incapacitated in order for the Power of Attorney to be activated.

Certainly, every scenario can't be known or addressed ahead of time, but discussing things in advance and having these documents in place offers a roadmap that'll make for fewer bumps in the road.



Who's in Charge?

Difficult emotions may surface when thinking about things such as whether you would choose or reject feeding tubes, or have a "Do Not Resuscitate" order on file, but soldier on. The more you talk about it and prepare advance directives, the more you'll feel in charge about what might lie ahead.

Bringing up this topic with an elderly parent can be especially difficult because they may feel like they're losing control over their lives. Try framing the discussion to emphasize they're in charge, and you need them to speak up so you can follow their wishes.

Ask open-ended questions that invite them to take the lead, such as "Where do you want to live if you need more help?" or "What's your priority in medical care – easing pain or aggressively fighting the disease?" Set a respectful tone that shows you want them to make the decisions.







Message from the Business Manager. You have my sincere wishes Brothers and Sisters for a very Merry Christmas and a Happy New Year from my family to yours! It is my hope the New Year brings you and your family all unbound prosperity.

Some of you may have received notices in the mail asking for receipt documentation for purchases made using your WEX fund account. There are a number of member claims that require a receipt to substantiate the expense. 170 members have at least 1 receipt that needs to be submitted. If proper documentation isn't received by the end of the year, the claims will be considered taxable income and a 1099 will be issued. In order to keep in line with IRS regulations, our new third-party administrator is following all rules and enforcing required receipts for purchases made.

If you are asked for a receipt you no longer have, please contact the provider to get a copy. An Explanation of Benefits (EOB) will also suffice. Receipts can be mailed, faxed, uploaded via the Wex Special Fund website or uploaded using the app (MI IBEW Special Fund). Please contact the hall if assistance is needed with this process.

Work Report. Ongoing projects in our jurisdiction that may require additional manpower include:

-Nelson Electric (Currently) GM Powertrain - Many more projects to come at Powertrain.

-J. Ranck Electric – continuing work at SK Siltron semi-conductor chip manufacturing facility.

-Master Electric has begun Elec-

trical installations on the new Isabella County Jail. Calls for this project have been on the recorder. -Countyline has secured Airport Work. Countyline has a Michigan Sugar De-Sugarization Project and also a project at the Mt. Pleasant Water Treatment facility. Look for job calls from Countyline.

-Clements Electric Independence Bridge work continues along with Bay Carbon Project, and also work out to the Bay City State Park.

-Conti Electric has many projects inside I -Park (DOW). Conti Electric has also secured a couple small projects inside Michigan Sugar along with a nice Fire Alarm Project on site at M.S. -Many, many solar projects are on their way. I can see up to 400 Mw for 2024

-Escon has secured a nice project at Mersen USA in Bay City's south end. Much more work is to come out at Mersen with projects bidding as you read this article.

-The State has approved its final permit for the Great Lakes Tunnell. The last permit needed for this project to occur is in the hands of the Army Corp of Engineers. It is unknown at this time how long this process will take.

Rest assured both organizers and myself are working very diligently to secure whatever work is being bid in our jurisdiction for our membership. Detroit, Ann Arbor and Lansing are currently having many calls getting into Book II if you are looking for work. Please contact the hall if you would like to sign any books.

As always, 692 Organizers continue to visit jobsites within our jurisdiction to speak with unrepresented electricians, building relationships and discussing the opportunities that exist by joining our Brotherhood. We should never lose sight of the organizing mission that guided the birth and growth of the IBEW. Our founders built a strong union by organizing all qualified workers, which allows us to achieve higher union density and ultimately increases our bargaining power during negotiations.

Regular school visits and renewed partnerships with area ISD programs will continue through the fall and winter in an effort to recruit apprenticeship applicants and increase overall interest in the skilled trades. Area public school administrators have reached out directly for assistance in creating curriculum and pathways to pre-apprenticeship for their students. It seems after many years of neglecting the skilled trades in lieu of college our education system has embraced the benefits of promoting a career in the skilled trades.


