#### Slow start to 2024 construction

Total construction starts brought a mildly positive start to 2024, growing 1 percent in January to a seasonally adjusted annual rate of \$1.16 trillion, according to a report issued Feb. 20 by the Dodge Construction Network.

Nonbuilding (usually infrastructure) starts rose 9 percent for the month, while nonresidential construction starts dropped 2 percent and residential starts were flat.

For the 12 months ending January 2024, total construction starts were down 1 percent from the 12 months ending January 2023. Nonresidential building starts were down 5 percent while residential starts were 8 percent lower, with nonbuilding starts up 17 percent on a 12 month rolling sum basis.

"Construction starts are struggling to make headway in the new year," said Richard Branch, chief economist for Dodge Construction Network. "Construction starts will continue to struggle early on in 2024 as higher interest rates and tight credit standards are slowing down projects moving through the planning cycle to start. The Federal Reserve is expected to cut rates later this year. That will move some of these projects in the planning queue through to start and provide for a more stable rising trend in construction activity in the second half of the year."

Dodge said the largest nonresidential building projects to break ground in January were the \$5.5 billion Texas Instruments fabrication plant in Lehi, Utah, the \$2.6 billion Terminal B construction at George Bush

# **Bill would put needed** fangs into state's prevailing wage law

LANSING - The state's newly resurrected prevailing wage act became effective Feb. 13, after state Democrat lawmakers voted to return it to the state's books last year along with a raft of other pro-labor legislation.

Now, there's additional legislation in the works to provide another obstacle for shady, lowpaying contractors who seek to bid on state taxpayer-funded projects. State Sen. John Cherry (D-Flint) has introduced Senate Bill 571, which would require contractors and subcontractors to register with Michigan's labor department before bidding on state construction and demolition projects, as well as solar or wind energy projects.

"It modifies the new prevailing wage statute to require registration of contractors and subcontractors who are going to be working on state prevailing wage projects, and requires the submission of the certified payroll that they're required to maintain to (the state's Department of Labor and Economic Opportunity (LEO)," Cherry told the Senate Labor Committee, as quoted by the news service MIRS.

Last year's House Bill 4007, which was adopted by Dems with razor-thin margins in both the House and Senate, gave new life to the prevailing wage law after Republican lawmakers snuffed it out in 2018. Cherry is chairman of the Senate Labor Committee, and the panel gave its first hearing to SB 571 on Feb. 15 after it was introduced last October.

A Senate Fiscal Agency analysis of the bill said it would "require LEO to implement a state project registration system for contractors and subcontractors bidding and working on state construction projects.

"The bill would allow LEO to charge a fee for a registration application and require the fee and any fines for a violation of prevailing wage and fringe benefit requirements to be deposited into the bill's proposed Prevailing Wage Fund. It also would require LEO to create and maintain a certified payroll database for contractors and subcontractors to submit certified payroll records that contained specific information."

#### Gains made for Black women, Latinas

A new report from the National Partnership for Women and Families shows that some of the biggest labor movement gains in 2023 came from Black and Latino women.

The NPWF reported last month that among full-time Latina workers, those who are union members made nearly \$14,000 more per year than their nonunion counterparts in 2023. Black women who are in a union make about 20 percent more than nonunion women. Additionally, women in unions are far more likely to have stronger employer-sponsored benefits like quality health care and parental leave.

Black women and Latins leading new organizing drives and negotiating contracts prompted "some of our most compelling arguments," said International Federation of Professional and Technical Engineers Local 21 Vice President Shelsy Bass Zhang.

In construction, for all women, the union pay advantage is even more pronounced: the latest (2022) Bureau of Labor Statistics numbers show that union tradeswomen make 23 percent more than their nonunion counterparts.

# **Safety first: OSHA** ups the costs for negligent employers

Federal OSHA is notoriously underfunded and understaffed for an agency tasked with protecting the health and safety of millions of workers across millions of workplaces. This is so well-established that AFL-CIO's Death on the Job report keeps track of how long it would take OSHA to inspect every U.S. workplace once. The current math is... 190 vears

Despite those limitations, OSHA ramped up the number of inspections it conducted in 2023. According to information shared with the LHSFNA, OSHA conducted 34,250 inspections in 2023, a seven percent increase

Bureau of Labor Statistics said in its annual report on the subject, released Feb. 21. "This is the largest number of major work stoppages since there were 39 in 2000.'

And the numbers of strikes was up significantly, too, but some perspective is necessary here. The lowest annual total of major work stoppages was five in 2009. Strikes and walkouts this century don't come close to when the labor movement was at its zenith in the 1950s. The greatest number of work stoppages recorded was 470 in 1952.

Moreover, the heightened number of work stoppages the nation has witnessed in the past few years has been tempered by the relatively low number of workers involved. Last year, however, there was somewhat of a breakout.

### Workers at two Southern plants vote to seek historic link with UAW

A majority of workers at Mercedes-Benz's largest plant in the U.S., in Vance, Ala., have signed union cards in support of joining the UAW.

In a Feb. 27 video announcement, Mercedes worker Jeremy Kimbrell, surrounded by coworkers, said they "are ready to win a better life with the UAW."

The announcement marks the second southern plant to reach the 50 percent milestone, after Volkswagen workers in Chattanooga reached majority support for the union in early February. A union can seek an election run by the National Labor Relations Board once a majority of workers support it, but the UAW will likely seek to strengthen its position with workers before doing so.

# Aquadome topped out at Gun Lake

## A silent revolution

I don't think you're expecting what I'm about to say, because I have never seen anything like this in 50 years in politics.

For decades I've been sounding an alarm about how our economy has become increasingly rigged for the rich. I've watched it get worse under both Republicans and Democrats, but what President Biden has done in his first term gives me hope I haven't felt in years. It's a complete sea change.

Here are three key areas where Biden is fundamentally reshaping our economy to make it better for working people.

#1, Trade and industrial policy. Biden is breaking with decades of reliance on free-trade deals and free-market philosophies. He's instead focusing on domestic policies designed to revive American manufacturing and fortify our own supply chains.

Take three of his signature pieces of legislation so far - the Inflation Reduction Act, the CHIPS Act, and his infrastructure package. This flood of government investment has brought about a new wave in American manufacturing. Unlike Trump, who just levied tariffs on Chinese imports and used it as a campaign slogan, Biden is actually investing in America's manufacturing capacity so we don't have to rely on China in the first place.

He's turning the tide against deals made by previous administrations, both Democratic and Republican, that helped Wall Street but ended up costing American jobs and lowering American wages.

#2, Monopoly power. Biden is the first president in living memory to take on big monopolies.

Giant firms have come to dominate almost every industry. Four beef packers now control over 80 percent of the market, domestic air travel is dominated by four airlines, and most Americans have no real choice of internet providers. In a monopolized economy, corporate profits rise, consumers pay higher prices, and workers' wages shrink.

But under the Biden, the Federal Trade Commission and the Antitrust Division of the Justice Department have become the most aggressive monopoly fighters in more than a half century. They're going after Amazon and Google, Ticketmaster and Live Nation, JetBlue and Spirit, and a wide range of other giant corporations.

#3, Labor. Biden is also the most pro-union president I've ever seen. A big reason for the surge in workers organizing and striking for higher wages is the pro-labor course Biden is charting.

The Reagan years blew in a typhoon of union busting across America. Corporations routinely sunk unions and fired workers who attempted to form them. They offshored production or moved to so-called "right-to-work" states that enacted laws making it hard to form unions.

Even though Democratic presidents promised labor law reforms that would strengthen unions, they didn't follow through. But under Joe Biden, organized labor has received a vital lifeboat. Unionizing has been protected and encouraged. Biden is even the first sitting president to walk a picket line.

Biden's National Labor Relations Board is stemming the tide of unfair labor practices, requiring companies to bargain with their employees, speeding the period between union petitions and elections, and making it harder to fire workers for organizing.

Americans have every reason to be outraged at how decades of policies that prioritized corporations over people have thrown our economy off-keel.

But these three waves of change - a worker-centered trade and industrial policy, strong anti-monopoly enforcement, and moves to strengthen labor unions – are navigating towards a more equitable economy. It's a sea change that's long overdue.

The state's PFO designation lets corporate profiteers get away with providing fewer protections for Oklahoma communities they subject to the overwhelming stench, contamination, flies, disease, and other nasties inherent in caging more than 300,000 birds

# **BUILDING MICHIGAN:** Alabaster, our state gypsum capital HISTORY IN THE MAKING By Marty Mulcahy



A 1910 POSTCARD VIEW from the dock of the Iosco County town, Alabaster – named for the gypsum that was – and still is – mined at the site. Its location on the shores of Lake Huron made it economical to ship the heavy gypsum throughout the Great Lakes. Alabaster was a typical company town, tied to the fortunes of the company's sales. The town (current population, 480) never exceeded the 600 residents who lived there in its circa 1905 heydey.

Depending on where you live in Michigan, the glaciers that formed our topography gradually receded between 7,000 and 20,000 years ago. They left behind the basins for the Great Lakes that eventually formed our state's borders, but they also left behind all manner of rocks, minerals and metals.

The Upper Peninsula produced iron ore, copper, and nickel, among others. The Lower Peninsula, according to the U.S. Geological Survey, became a major source of cement products, sand and gravel, peat, potash, common clay, crushed and dimension stone, industrial sand and gravel, limestone, gemstones, and salt.

One of our state's underthe-radar mineral offerings is gypsum. Perhaps it deserves a little more renown, since it has been mined in Michigan since 1841. Today, Michigan's only gypsum mine is in the tiny town of Alabaster Twp., a few miles below Tawas City on the Lake Huron shore. "Alabaster" - defined by Webster's as a "hard compact calcite aragonite" - was the name given the site even before it officially became a town in 1866.

In 1837, the year Michigan became a state, state geologist **Douglass Houghton discovered** outcroppings of a variety of alabaster rock (gypsum) at the mouth of the Au Gres River. The discovery was followed by some unsuccessful mining attempts.

"It was William Patrick who developed the first successful gypsum mine in 1861, followed by Benjamin Smith who opened the present quarry in 1862," said *Water Winter Wonderland – The* Best of Michigan, Past and Present. "By 1863, when the (Iosco) county population was less than 400, the open-pit mine here employed 60 people. By 1870 production had reached 23,000 tons annually. The population was about 300 by 1880, including a plaster works, two hotels and a general store." Gypsum is a soft sulfate mineral. Among the first American uses for gypsum in the mid-19th Century was in plaster, as a fertilizer for wheat fields, and as a soil conditioner to improve water absorption. Gypsum is in no way native only to Michigan or even North America. (There was also another significant gypsum deposit mined near Grand Rapids). Gypsum has been used for centuries as an ingredient in plaster of Paris due to its abundance near France's capital city. Ancient Egyptians used the stuff in 7,000 B.C. and mixed it into the outer layers of the Giza pyramids. A federal geological report from 1881 said gypsum beds closer to the surface at Alabaster were 16 feet thick in the area, "with borings showing the "existence of lower lying beds of an equal value."

main buildings at the Chicago **Columbian Exposition of 1893.** These buildings on display in Chicago, with marble-like walls (made with a plaster-gypsumglue mixture, the forerunner of wallboard), earned that portion of the exposition the title, "White City," and greatly expanded U.S. gypsum sales.

"Incorporated into the U.S. Gypsum Co. (USG) in 1902, the quarry helped to make Michigan a leading producer of gypsum for over a century. By 1905 the village population had peaked at about 600, then declined to less than 400 in 1920," said Water-Winter Wonderland.

USG owned about 200 acres of land at the site and built a two-story warehouse and a unique pier into Lake Huron for loading ships. The company also moved its product with a rail spur connecting to the Detroit and Mackinac, and Pere Marquette railroads. 'At the present time the (U.S. Gypsum Co.) has established a hotel, post office, and some 40 dwelling homes for the workmen, forming a very comfortable town located six miles from Tawas City and 42 miles from the mouth of the Saginaw River, fronting Saginaw Bay," wrote George Grimsley in The Gypsum of Michigan and the Plaster Industry (1904).

located at the Alabaster Twp. site since its inception as a company.

"We formed in 1902, when about 20 gypsum companies came together as the United States Gypsum Co.," USG says in its company history. "Twenty more companies joined the next year, and a network of gypsum mines, quarries and processing plants spread across the United States. In 1916, we disrupted the construction world with our invention of Sheetrock panels, changing the way interior walls were installed. A sales representative named it Sheetrock and our most well-known product was born."

Indeed, gypsum today is mostly associated with the pressed material found in Sheetrock, which of course is also variously known as "drywall, "wallboard" even "gyp-rock." But gypsum also continues to have a wide variety of other uses, in plaster, plaster of Paris, tiles and masonry blocks, even in toothpaste.

The village of Alabaster quietly declined over the years, as did employment at the USG site. The company announced last year that it plans to "open its next quarry, on (adjacent) land purchased in 2018. The current quarry is near the end of its working life and offers a rare glimpse of geological history along the layers of its walls."

USG, which owns about 5,000 acres in Iosco County, said it plans to develop a new quarry starting this year on about 600 acres of land purchased from the State of Michigan, southwest of the current operation. They expect production to be about 500,000 tons of

# First college sports team seeks, gets, union rights from NLRB

HANOVER, N.H. (PAI) - The National Labor Relations Board's Boston regional director ruled Dartmouth College's 15 men's varsity basketball players are "employees" under labor law.

That means they can unionize - and they would be the first college team in the nation to do so.

Service Employees Local 560, which represents other campus workers, is campaigning for votes among the players. A union authorization voting date is uncertain. Dartmouth plans to appeal NLRB Regional Director Laura Sacks's ruling to the full NLRB.

"Because Dartmouth has the right to control the work performed by the men's varsity basketball team, and because the players perform that work in exchange for compensation" - scholarships, plus game tickets, room and board on road trips for all 15 and \$1,000 worth of sneakers per season - "the petitioned-for basketball players are employees within the meaning of labor law," Sacks wrote.

How tight is Dartmouth's control over the players' working conditions? Besides haircut requirements, coaches set when they can play and practice and urge players not to take classes during certain weekday afternoon time slots when the team practices. Dartmouth claimed its regulations on haircuts, classes and other issues apply to all students. "The record reveals no evidence other members of the student body," most, like the players, legally adults, are so strictly supervised," Sacks drolly said. Sacks's decision again raises the issue of whether athletes at private universities are "employees" under labor law. Almost a decade ago, the issue came up when Northwestern University's football team voted to unionize. Their coaches supported them. So did NLRB Chicago Regional Director Peter Sung Ohr. The full NLRB didn't. It ducked the issue, but didn't make any blanket prohibitions on college athletes organizing.

Increasing considerably over the past three years, strikes are an important tool for workplace and labor activism."

The Cornell researchers said "large, high-profile strikes" in 2023 included the SAG-AFTRA actors' union strike, the Coalition of Kaiser Permanente Unions (health care workers) strike, the Los Angeles Unified School District strike, and the UAW's Stand-Up Strike. Together they accounted for about 76 percent of all workers involved in work stoppages.

Some other nuggets from the Cornell report:

•The top three demands in workers' work stoppages were unchanged from 2022: better pay, improved health and safety, and increased staffing.

•Workers in the accommodation and food service organized the highest number of work stoppages of any industry (33 percent), but only accounted for 6 percent of the total number of workers on strike. Of these strikes, 82 percent were organized by Starbucks Workers United or SEIU's Fast Food campaign.

•Most work stoppages continue to be short, with the majority (62 percent) lasting fewer than five days.

"Despite considerable increases in the number of work stoppages and workers involved in stoppages since 2021," the Cornell researchers said, "the level of strike activity still does not approach rates in the 1970s and earlier, according to more comprehensive BLS data available at that time. The number of workers involved in stoppages in 2023 is similar to 21st Century highs documented by the BLS in 2018 and 2019, based on their narrower inclusion criteria. The total number of work stoppages, approximate number of workers involved in stoppages, and strike days have increased each year over the past three years."

Margaret Poydock, EPI senior policy analyst, said "A surge of workers went on strike in 2023 to fight back against record corporate profits, stratospheric CEO pay, and decades of stagnant wages. From the United Auto Workers to nurses across the country, these strikes provided critical leverage to workers to

gypsum per year.

During the mining process, according to Iosco News, "surface soils and clays are cleared until the gypsum layer is exposed. THE 400-ACRE ALABASTER Historic District was placed on the National Register of Historic Places, but there isn't much still standing. "The most visible and impressive structure in the district, the elevated marine tramway, was constructed in 1928 and the tramway stretched 1.3 miles out into the Saginaw Bay," says Lost in Michigan. "Like a horizontal ski-lift, the cable system carried 72 "buckets" of gypsum to a waiting ship or to the storage bin. Each bucket held more than two tons. The tramway included 6,450 feet of one- and three-quarter inch steel cable and 14,000 feet of three-quarter-inch cable. At a length of 6,350 feet, it was the longest over-water bucket tramway in the world." The tramway was demolished in the 1990s and the loading marine bin in Lake Huron was finally torn down in 2020. AFL-CIO President Liz Shuler called the latest ruling "gamechanging."

"The Dartmouth players' desire to form a union mirrors what we're seeing from young people throughout the country, in every industry," she said. " Nearly nine in 10 young people under 30 approve of unions because they know 'it's better in a union."

Player reps Code Haskins and Romeo Myrthil Haskins said the team is "thrilled" by Sachs's ruling. "This is a significant step forward for college athletes, and we are excited to see how this decision will impact college sports nationwide. We believe other athletes will recognize the opportunities this ruling presents," the two said.

ACCIDENTAL DEATH and DISMEMBERMENT IN-SURANCE FROM OUR INTERNATIONAL ASSOCIATION: Members who have their dues paid in advance (prior to the month of the accident) are eligible for accidental death and dismemberment benefits up to \$7,500.00. This benefit comes as a dues paying member of SMART International. WEEKEND WORK ASSIGNMENTS: Saturday and Sunday work assignments. Please remember that when performing work on a Saturday or Sunday the steward must report it to the hall, give each members name and obtain a form for signatures. Each member must sign the form along with the number of hours they worked. The completed form must be sent back to by hall by the end of the day on the following Monday. Weekend work assignments must be called or emailed into the hall prior to 3:00 pm on Friday. WORK ASSIGNMENTS: Everyone must obtain a work assignment prior to starting work. These are the By-Law rules for the Out-of-Work List. Your name will be removed from the list 14 days after receiving an assignment. It is very important to report to the union hall immediately after your layoff. Members get confused because the S.U.B. Fund allows you a period of up to seven days to apply for S.U.B. benefits after lay-off. LAY-OFF SLIPS/TERMINATION NOTICES: Lay off slips must accompany all applications for sub pay. Without lay off slips you cannot collect sub pay. It is the member's responsibility to make sure they get one from the contractor when laid off. Your application cannot be submitted without one. It is the contractor's responsibility to issue one in accordance with our contract. S.U.B. BENEFITS: Report to the hall promptly upon layoff. You must complete a S.U.B. Application within 7 days from your layoff date or you will forfeit S.U.B. benefits. Lay-off slips must accompany the application to be eligible. Proof of UIA benefit payments must be submitted within 21 days of when you were paid in order to receive SUB benefits. Do not submit your sub applications directly to the fund office. Your application must be signed by the hall or you will not collect benefits.

# **'Stunning progress' moves Gordie's bridge up, across and back**

(Continued from Page 1) together to deliver this muchneeded infrastructure to the thousands of eager travelers ready to cross North America's longest cable-stayed bridge."

Originally, the \$4.8 billion project was scheduled for completion in November 2024 with opening anticipated by the end of this year. "However, the project, like many others, experienced unprecedented disruptions as a result of the COVID-19 global pandemic," the authority said in its latest update. "The disruptions were even more prevalent for the Gordie Howe International Bridge project given the differing applicable restrictions in the U.S. and Canada, combined with the ramping up of construction

activities in early 2020."

The 1.5-mile crossing over the Detroit River, about a mile south of the Ambassador Bridge (1929), will be the 10th longest in the world, with a main span of .53 mile. Supporting the span now and upon its completion next year will be 216 metal-stranded stay cables, 108 on each side, which are attached to the tops of each tower and then anchored into 35 concrete ground-level boxes on each side of the river.

The six-lane bridge deck and road deck will have a total of 106 segments. Each floor beam weighs 55,000 lbs. and each edge girder for the road and bridge decks weighs 99,000 lbs. Each concrete precast panel for the road and bridge decks weighs between 35,000 lbs. to 55,000 lbs. Supporting all that weight are the aforementioned attached cables, which are connected to the second-tallest structures in the state and the region – the massive 722-foot-tall towers on either side of the river.

Construction is being managed by Bridging North America, and the project is being paid for by the Canadian government, with reimbursement from vehicle tolls on the American side. Since construction began on Oct. 5, 2018, on both sides of the river, about 10,000 people have worked more than 10 million hours on the project.

The bridge deck gap in the middle of the river is expected to be closed by the end of summer.

UAW sought at two Southern plants

(Continued from Page 1) – with employee captive audience events and other persuasive means – and from the business communities. Alabama Gov. Kay Ivey warned that the UAW's attempted incursion means that the state's "model for economic success is under attack."

The union-friendly votes are historic: the UAW has had zero success organizing plants in the South.

Kimbrell said several of the driving forces behind the workers' grassroots campaign to join the UAW, including workers going many years without meaningful raises, a two-tier wage system, and the abuse of temporary workers. Each of these issues also figured prominently in the UAW's Stand Up Strike at the Big Three, which has spurred an unprecedented amount of organizing activity and interest among America's nonunion autoworkers. "There comes a time when enough is enough," says Kimbrell. "Now is that time. We know what the company, what the politicians, and what their multi-millionaire buddies will say. They'll say now is not the right time. Or that this is not the right way. But here's the thing. This is our decision. It's our life. It's our community. These are our families. It's up to us."

The UAW said more than 10,000 nonunion autoworkers across 14 auto companies have signed union cards and begun organizing to join the UAW in the wake of the historic Stand Up Strike victories at the Big Three.

After the Detroit Three OK'd the contracts with the UAW last year, a number of nonunion carmakers announced worker pay increases. UAW President Shawn Fain has called the raises the "UAW bump," saying that they were given in an effort to thwart union organizing efforts. ing drive will target more than a dozen U.S. plants run by Tesla, Toyota, Honda, Hyundai, Nissan, Subaru, Mazda, Volkswagen, Mercedes, BMW and Volvo.

Zach Costello, who has worked at the Volkswagen plant since June 2017, told The Guardian that the UAW's success last year motivated his decision to became involved with the union campaign. "I had this feeling that something in the air was changing, that people were starting to see that something wasn't right and that there's something that we can actually do about it this time," he said.

The U.S. Point of Entry will have 13 buildings and include border inspection facilities for both passenger and commercial vehicles, control booths, and parking. # Safety first: OSHA ups the costs for negligent employers

(Continued from Page 1) \$100,000 – with 101 of those citations totaling \$250,000 or more. Compare that to 2022, when the agency issued 184 citations over \$100,000 - 51 were over \$250,000.

Those higher penalty numbers are being driven by more violations being categorized as "willful or repeated," which carry a maximum penalty of \$161,323 per violation. OSHA issued over 600 willful violations in 2023, topping the previous record set in 2015.

"The best way to avoid these large fines is to proactively invest the resources and effort necessary to create a top-notch safety and health program," said LHSFNA Management Co-Chairman David F. Rampone. "Steps like pre-job hazard assessments, regular refresher training and giving crews stop work authority if they encounter a hazard are all part of such a program."

In 2023, OSHA also conducted almost 300 inspections as part of its Severe Violator Enforcement Program (SVEP), which involves mandatory follow-up inspections for "employers that have demonstrated indifference to their OSH Act obligations by committing willful, repeated or failure-to-abate violations." The previous SVEP high was 108 in 2016.

Takeaways for Construction Employers. To recap, this was OSHA's 2023 enforcement strategy: more inspections, more willful violations when the situation calls for it and more resources focused on previous serious violators.

That's three very good reasons for employers – particularly employers in the construction industry – to take the safety and health of their workforce seriously. After all, about 50 percent of annual OSHA inspections happen in the construction industry.

The best reason for construction employers to have a strong safety and health program isn't to avoid OSHA fines – it's to eliminate potential hazards and protect their workforce from serious injuries and fatalities. However, hefty fines can impact a company's bottom line, limit its ability to compete for and win future projects and damage its reputation.

# <u>Outdoors</u> Getting to the bottom of Kitch-iti-kipi

In early May 1959, a small group of Michigan State Police troopers practiced their diving and recovery methods, probing the clear, cold waters of the state's largest natural spring, located 12 miles northwest of Manistique - the Big Spring called Kitch-itikipi.

Outfitted with wool mittens and socks, insulated underwear and heavy rubber suits, the troopers carried onion sacks with them to the bottom of the 40-foot depth to retrieve beer cans, pop bottles, a toy pistol and a golf club.

But to really get to the bottom of the Big Spring, you need to go back in time a few more years to uncover the efforts of John Ira Bellaire, a former schoolteacher and native of St. Joseph Co., who came to the Upper Peninsula pursuing a newspaper classified ad that sought a store salesman in Seney.

In spring 1893, Bellaire became a salesman for the Morrison and Schneider general store in Seney, purchasing the store three years later. Bellaire then spent a decade during the wildest days of the white pine bonanza in Seney – a then-drinking and whoring lumberjack town nicknamed "Hell" by some.

"In 1904, shortly after robbers blew open his safe, Bellaire sold the store building and moved the business to Germfask where he had previously operated a branch store," the Escanaba Daily Press reported. "Ten years later, he sold the Germfask business and went to Blaney to become manager of the Wisconsin Land and Lumber Co. general store."

In 1925, Bellaire moved to Manistique, purchasing the Riverside Coal and Produce Co. when it went bankrupt. About this same time, Bellaire began his nascent efforts to promote the Big Spring.

"Bellaire fell in love with the Big Spring when it was still a black hole all but hidden in a tangle of fallen trees," according to a state park brochure.

oval pool gushes more than 10,000 gallons per minute from numerous fissures in the underlying limestone.

Vegetation grew lush, draping the piles of trash dumped into the pool by the lumber company which operated nearby," the brochure stated.

In years past, the spring - with its constant 45-degree temperature and emerald-tinted waters – had been a popular picnic place. Visitors crossed Indian Lake-the eventual destination of the spring's outflow – by boat and then hiked to the spring.

At one point, a narrow-gauge railroad brought visitors to the spot from Thompson. Bellaire who became thoroughly enchanted with the spring – collaborated with a poet and writer to produce "Namesakes" and "Medicine Water," two booklets which sold in the thousands, describing the beauty of the area and the supposed American Indian legends surrounding this placid pool – the "Mirror of Heaven."

that it was tapped to a fast-flowing spring," the brochure said. "Bellaire saw through the debris, saw the beauty of the emerald bottom of the pool. He watched the sand bubble and roll as some hidden hydrostatic pressure forced water through the narrow opening left when the slumping occurred in the glacial drift near Manistique."

Bellaire, who could have purchased the spring and surrounding roughly 90 acres for himself, instead arranged for a sale of the property by the Palms Book Land Co. to the State of Michigan for \$10.

A deed stipulation required the property to be used "forever" as a public park – Palms Book State Park.

Around 1930, Bellaire operated a five-and-dime store in Manistique where he sold water and sand from the spring, promoting them as "magical." The sand was said to be called "Juggler's Sand" by the Indians and the water, "Juggler's Laughing Rain."

According to the packets con-The Big Spring wasn't too taining them, the sand and water "The sand as an all-around good

luck powder, and the water as a prevention against Bad Spirits. The sand, when mixed with a kind of bark the Indians smoked, becomes

Takosavos, 'Love Powder.' "Through the two books and other writings Bellaire succeeded in making the Big Spring one of the best-known scenic attractions in the Midwest," the Daily Press reported.

Into his 70s, Bellaire, still mesmerized, continued to visit the spring almost daily.

In 1955, the local Lions Club erected a 3-foot-tall stone memorial at the park. Attached was a bronze plaque honoring Bellaire for his "unselfish service in promoting and developing the Big Spring.'

Four years later, after an illness of several months, Bellaire died at age 87, roughly two months before the state police divers swam among the sparkling waters of "The Blue Sky I See"-one of numerous supposed Chippewa translations of Kitchiti-kipi.

Today, a state highway brings visitors to the Big Spring. There they sit and enjoy the eerie quiet

or turn a large metal wheel to propel a glass-bottomed raft across the surface of the pool.

Large brown and lake trout haunt these depths and hide among the encrusted branches of the cedar trees that guard the rim of the spring. At the bottom, coins dropped by visitors for luck lie half-buried in the churning sands. Last fall, members of the Manistique Lions Club, in coordination

with the DNR, cleaned up the Bellaire stone memorial at the park and erected a new interpretive sign to bring more attention to Bellaire and his work at the Big Spring.

Now decades after his altruistic efforts began, Bellaire's waters of the Big Spring remain magical. Find out more about Kitch-itikipi, the Big Spring, at Palms Book State Park.

# A few tips to keep birds safe at backyard feeders

To survive Michigan's frigid winter temperatures, some birds store food from feeders to eat later in winter, while others expand their food sources and change their diets.

Despite these incredible adaptations, winter can still be a stressful time for birds. We can help support winter birds by feeding them when other food sources may be scarce. Here are a couple of tips on how to feed them safely and responsibly in your space:

• Keep your bird feeders and birdbaths fresh and clean throughout



winter. Freshen the water every other day, if possible. Clean your feeders once every one to two weeks in a 9:1 solution that is nine parts water and one part bleach, scrubbing away any debris. Dry the feeder before refilling. • Clean bird baths with

a scrub brush in a 9:1 solution of water and vinegar.

•Don't place seed directly on the ground or use platform feeders, which tend to attract larger numbers of birds, deer and other unwanted guests. Mess-free birdseed options can help keep the ground clean. (From the Michigan DNR)
