#### Jobless rate falls 8 straight months in MI

LANSING – Michigan's unemployment rate dropped a tenth of a point in August to 4.7 percent, according to a report released Sept. 15 by the state's Department of Technology, Management & Budget. In real numbers, unemployment declined by 3,000 and employment advanced by 11,000 jobs.

Gov. Gretchen Whitmer was quick to point out that the state has experienced eight straight months of declining unemployment, and the lowest jobless level since March 2020.

"Michigan's economy is headed in the right direction, but we know we still have more to do to get Michiganders back to work," Whitmer said. "Our unemployment rate is below the national average, businesses are staffing up, and personal income is up 19.1 percent, year over year, the fourth-highest nationwide."

Nationally, U.S. unemployment declined by 0.2 percent in August, to 5.2 percent, the Bureau of Labor Statistics reported on Sept. 3. In the August report, based on data from early in the month, the number of jobless dropped by 318,000, to 8.38 million. In February 2020, prior to the onset of the pandemic, the U.S. unemployment rate was 3.5 percent, and the number of unemployed people was 5.8 million. But the bigger news was the Sept. 4 halt of federal unemployment assistance that delivered \$300 weekly unemployment checks to jobless workers in the nation. Some 218,830 people applied for the pandemic-assistance checks in the two weeks ending Aug 28 – and falling off the rolls were 9.21 million jobless who were getting the aid before that. Congress and the Biden Administration show no signs of extending that aid, which went to three sets of workers those who exhausted their regular state-paid jobless benefits, those who got the state benefits and the \$300 checks on top of that, and the "gig economy" workers, "independent contractors," home health care workers and others who legally aren't part of regular state-paid jobless aid. It remains conjecture whether those \$300 checks were contributing to workers sitting on the sidelines as job opportunities went unfilled. It's probably true in many cases, but the Economic Policy Institute pointed out that the U.S. economy isn't exactly on fire. It cited the Bureau of Labor Statistics (BLS) which said "5.6 million persons reported they had been unable to work because their employer closed or lost business due to the pandemic" in August. "This measure," the BLS said, is up from 5.2 million in July."

Gallup's initial reading of the public's support for labor unions was 72 percent in 1936, at the advent of the modern U.S. organized labor movement, and approval peaked at 75 percent in 1953 and 1957. The lowest ratings to date have been recorded during particularly weak economic times.

This includes the late 1970s and early to mid-1980s - when support fell below 60 percent for the first time – and 2009 through 2012, when it hovered around 50 percent.

While the latest reading, from a July 30-Aug. 12 poll, comes at a time of severe economic upheaval, this has so far not had a

### Stronger together: **Everyone does** better under a union contract

WASHINGTON, D.C. (PAI)-Unionized working women enjoy a large wage edge over their nonunion sisters - and non-union workers in general - state by state, a new report shows.

And while there's still a wage gap between working women and working men overall, the Institute for Women's Policy and Research confirms, in unionized states it shrinks.

"In every state, unionized women out earn women in nonunion jobs," the report, Stronger Together, from the Institute on Women's Policy and Research, says. "Women covered by a union contract earn on average \$195 (22.6 percent) more per week than non-unionized women." Union men have a wage edge over non-union men, too: \$159 weekly (15 percent).

### **Union brothers enter residential HVAC market** tial mechanical work. In most mar-

"Hey, you guys are union!" said a retired west Michigan iron worker, delighted to see a familiar union electrical contractor's truck pull up in his driveway to install a wholehouse backup generator after ordering the unit from a third party.

We remember that retiree's reaction from an article we published a few years ago about how relatively rare it is to find union contractors who perform residen-

kets, but not all, the residential sector was generally given up decades ago by union contractors in Michigan and across the nation, as higher wages and likely lower profit margins compared to commercial and industrial work dictated the decision to let nonunion contractors basically have free rein.

Maybe the tide is turning, a bit. Meet brothers Ryan and Jon Nevedal, members of Pipe Fitters, (Continued on Page 4)

### Let's fix what's broken

you: Unions are at their highest peak of popularity in decades, with poll ratings of 60 percent "favorable" or more. At the same time, and by roughly the same share, respondents say the corporate class, also known as the 1 percent, has too much power.

But the popularity number isn't matched by actual membership. Unions are 6.5 percent of private sector workers, their lowest point since the Roaring 20s, a time of worker repression. If it weren't for the public sector, where the union share is more than five times as high, the union movement would be as powerless as it was in the days of Calvin Coolidge.

So how do you explain that contradiction? And then, how do you get more people to join unions, to increase their collective clout against greedy bosses and purchased politicians?

The answers are many and varied. Some depend on defining the causes and reasons.

"Automation" and "computers" says one reason. In so many words, machines do the work people used to do. Simple examples: There are no more newspaper printers. Computers do layout now. Auto workers used to make cars. Now fewer workers and more robots do.

In the heyday of the Monongahela Valley outside Pittsburgh, a steel plant employed thousands of workers at blast furnaces, turning out steel. Now it employs 30. They sit at computer consoles, crafting monorails for maglev trains at tolerances of thousandths of an inch. And don't even get us started on how many coal miners there used to be – and the machines that are doing their jobs now.

"Free trade" is another reason, and that, like automation, has its backers and its truths. NAFTA, CAFTA, the WTO, "free trade treaties" on and on and on were one-way highways for firms to close U.S. factories and ship their machinery to Mexico, or Honduras, or Paki-

Corporations favor repressive regimes, moguls' rule – often by violence – worker exploitation, lax environmental rules and non-existent worker rights.

And let's not forget the giant of them all, China. Or the corporate giant, Amazon. So the Walmarts and the Nikes and the Mondelezes, seeking ever-higher profits, kowtowing to the bidding of Wall Street hedge funds, financiers and crooks, decamped. Jobs went with them, workers couldn't. The same is true for GM, GE, Motorola, et al.

"Wall Street" is yet another reason. That's shorthand for the financial sector and its venal, vicious rapacity. Hedge funds *uber alles*, to conscript the German expression. When it comes to destroying companies, selling off assets, leaving firms wrecked and families in tears, bankruptcy, homeless, pensionless or all of the above – all in the name of the almighty dollar for the pockets of shadowy financial finaglers – Wall Street as a class has no peers.

For Wall Street, workers and unions are literally disposable. So it forces firms to do just that, if they want to borrow cash or sell stock. Their former favorite CEO: "Chainsaw Al" Dunlap, for how he destroyed workers and unions. Their new favorite: Take your pick. Alden Global Capital? Just ask The News Guild what Alden is doing to its members and their newspapers.

"Politics" is yet another reason, and it too, is true. Sens, Elizabeth Warren, D-Mass., and Bernie Sanders, Ind-Vt., are right when they declare the economy is rigged in favor of the 1 percent.

How do the rich do the rigging? They take the ill-gotten gains, garnered from exploiting workers, and use them to-bluntly – buy political clout. That clout trumps workers' votes.

We intentionally use that word. Because Donald Trump admitted it, at a 2015 GOP presidential hopefuls' debate. He told the truth.

"I will tell you that our system is broken," he said that August. "I gave to many people before this. Before two months ago I was a businessman. I give to everybody. When they call, I give. And you know what, when I need something from them two years later, three years later, I call them. They are there for me. That's a broken system."

When pols "are there for me" and the rest of the 1 percent, pro-worker legislationeven before losses in 1965 (repeal of federal OK of right to work), 1977 (labor law reform) and 2009 (the Employee Free Choice Act) – is buried by corporate campaign cash and clout.

Plus ideology. It was abetted by an infamous 1971 memo from a top corporate lawyer, Lewis Powell. He raised the specter of radical workers, students and leftists undermining the capitalist system. He proposed an all-out coordinated campaign to stop them. CEOs heeded Powell, building "neoliberalism" and the rightwing ecosystem/echo chamber. It was right-wing ideology, remember, that prodded Ronald Reagan to fire the Air Traffic Controllers in 1981, thus unleashing the corporate dogs of war against workers and unions.

Add all this up and you get the giant disparity between the favorable ratings unions enjoy and the unfavorable private sector density unions have.

Frankly, even the Protect The Right To Organize (PRO) Act, as comprehensive and as pro-worker as it is, may not be the entire answer, because changing the law may not be the entire answer. Because, you see, just like in an organizing drive, changing people's hearts and minds about unionizing goes one by one by one. That's a long, hard, continuous slog, fighting law, bosses and, yes, people's desires not to rock their personal boats. And U.S. "individualism."

Which means there is no easy answer to the second question we pose, about how to get more people to join unions. But it doesn't mean we should stop seeking an answer – even if it turns out to be a radical one, such as upending the entire antiworker system forever.

(Continued from Page 1) as well as convention space are planned for the top floor, and the expansion includes a pool with water park features for kids and

young adults. "Basically we have nearly every trade out here, maybe averaging 65-75 every week," said Peter Dupuis, project manager for Gundlach Champion, earlier last month. He reported four floors as being complete, and everything else right on schedule to be ready by Dec. 31.

"We peaked out at about 85 tradespeople, and they have been excellent, outstanding," Dupuis said. "Good workmanship, and a good safety record. I'm happy with what we're seeing." The Hannahville Casino

opened in 1998, and over the years a convention center (1999), wastewater treatment plant (2005) Palm Tower (2007), golf course (2008) and convention center expansion and renovation project were completed (2008). This addition to the hotel will bring it to 326 rooms.

"This isn't just about the added hotel rooms, but that's a key part of the project," Dupuis said. "The entire 12th floor will be a really nice, full-service banquet hall. And on the first level will be a 34-foot-tall water park." The facility is about 15 miles west of Escanaba.

The Hannahville Indian Community Tribal Council said the project is in response to "high customer demand," with a frequent waiting list for rooms.

"It'll be exciting. I mean it'll be a brand new wing on our facility, it'll compliment everything we have and it's going to be a lot of new offerings," said Island Resort and Casino General Manager Tony Mancilla to the *Escanaba Daily Press.* "So we're really excited about it, and every time we've done an expansion it's been really well received by the public, and we don't see how this would be any different."

The casino offers 1,200 slot machines, traditional table games, a poker room, bingo and

a sportsbook. The property includes the hotel with the Drift Spa, an RV park with 42 spaces, eight food and drink venues, a 1,315-seat live entertainment theater and two 18-hole golf courses.

Dupuis said they have been "fairly lucky" in having sufficient manpower during the Covid crisis, although they have had to work through several product and material shortages and delays. He said Gundlach Champion was fortunate to have prepaid for much of the building material that went into the project, and they encouraged their subcontractors to do the same, and to order early and request early delivery to ensure availability of materials to the greatest extent possible. "It worked incredibly well for us," he said, considering the project started not long after the pandemic began.

The 20-year anniversary this month of the awful attack on the World Trade Center in New York City brought another opportunity to remember those who were lost, the incredible bravery of the first responders, and the rage at those who were responsible.

The loss of the Twin Towers also left an indelible gap in the great city of New York, where older movies and TV shows can be time-stamped before or after 2001 when views of the city's oftphotographed skyline are showed.

Nothing can replace the 1,363-foot-tall Twin Towers – although the 1,776-foot-tall "One World Trade Center" tower was completed at the same site in 2014, along with some other buildings. But Detroit has its own "miniature" version of the original Twin Towers: a 430-foot, **32-story skyscraper built just as** the World Trade Center was being planned, and likely providing some inspiration for the much-taller NYC buildings. We refer to the One Woodward **Building, completed in March** 1963. Historic Detroit called it "one of Detroit's most celebrated mid-century modern structures."

"So we know that Detroit's One Woodward is the big, white, boxy looking skyscraper everybody passes on their way to Hart Plaza to enjoy Detroit's riverfront," says Daily Detroit. "It's really obvious, as it is opposite the Spirit of Detroit sculpture.

"And our children, and our children's children will have it seared into their memory what happened on 9/11 when the original World Trade Center was destroyed in Osama Bin Laden's terrorist attack. So what does one have to do with the other? Two words. Minoru Yamasaki. The Japanese-American Detroitbased architect worked on both projects."

The One Woodward Building is located on the northwest corner of Woodward and Jefferson avenues, and **Detroiters may remember it by** its many corporate nameplates over the years, depending on its primary tenant at the time. It was originally commissioned in 1958 by the Michigan Consolidated Gas Co. It later was called the **American Natural Resources** Building, then the National City Center. Today it is owned by Dan Gilbert's Bedrock Co. and is called Fifth Third Bank at One Woodward.

The building, with a \$19.3 million price tag, was commissioned in 1958 by MichCon. They hired Yamasaki to design the

DETROIT'S ONE WOODWARD BUILDING, just before contruction was complete in March 1963. Still standing and in excellent condition, the building is widely understood as architect Minoru Yamasaki's "warm up" for his most famous work which began later that decade, the World Trade Center Towers in New York City, below. The building's narrow windows are a motif Yamasaki used in several later buildings," said Historic Detroit, including the World Trade Center towers. "They serve both an aesthetic and practical purpose." Yamasaki had a severe case of acrophobia (fear of heights) and expressed concern for office workers in all-glass buildings who might walk up to a floor-to-ceiling window and feel as if they might fall. "His solution was to frame the glass in pre-cast concrete modules at a width of 1 foot, 11 inches. This way, he said, one would feel secure while experiencing the full views looking out from the building. From the exterior, the windows emphasize the verticality of the building.'

joyed the construction of a remarkable run of buildings through the 1920s, but that came to an abrupt end with the onset of the Great Depression. This would be Detroit's tallest building erected in 30 years and create 370,364 square feet of office space.

Historic Detroit's account says visitors to the building are greeted by a three-story recessed glass lobby consisting of 82 30-foot-tall glass panels that wrap the entire building at the ground level, "inviting the public into a starkly white interior that is nearly indistinguishable from the concrete and marble of the exterior grounds and walls. The upper stories are supported on white-marble-clad square columns that form a loggia

surrounding the building. The columns align with the edges of the concrete panels above, accentuating the building's verticality.

A four-story recessed penthouse sits atop the building and contains the heating, ventilating and cooling systems.

A subsequently constructed pedestrian bridge at the 15<sup>th</sup> floor connects to the Guardian **Building across Larned.**

struggling to pass along even a fraction of these added costs onto their clients.'

The producer price index for new nonresidential construction a measure of what contractors say they would charge to erect five types of nonresidential buildings - rose 5.6 percent over the past 12 months. But, the costs that producers and service providers of construction inputs, like distributors and transportation firms, were charging rose 20.6 percent increase in that time. Contractors are having to sharpen their pencils bidding against multiple contractors, and the price they give today may not create a profit for them tomorrow as prices for materials increase. Bidding "is a real gamble," one contractor told The Wall Street Journal.

The AGC said there were double-digit percentage increases in the selling prices of materials used in every type of construction over the past year. The producer price index for steel mill products increased by 123 percent compared to last August. The index for lumber and plywood was up 15.9 percent during the past 12 months. Others include copper and brass mill shapes (up 45.3 percent), aluminum mill shapes (up 35.1 percent), plastic construction products (up 29.6 percent), gypsum products, such as wallboard (up 22.9 percent), insulation materials (up 17.2 percent) prepared asphalt and tar roofing and siding products (up 15.8 percent). Tansportation and fuel costs also spiked.

AGC officials added that a survey of construction firms found that most contractors were experiencing delays in material shipments.

Seattle-born Yamasaki (1912-1986) moved to Detroit from New York in 1945 to work as head designer for Smith, Hynchman & Grylls, and founded Yamasaki & Associates in 1955. Yamasaki had designed projects in the Detroit area in the past, including Wayne State University's McGregor Memorial Conference Center in Detroit (1958), but he also had dozens of major commissions across the nation.

"The building would open March 18, 1963, and marked a first for Yamasaki, who had never designed a skyscraper before," wrote Denise McGeen for Historic Detroit. "The building incorporates a pre-cast concrete exterior, narrow windows, Gothic arches, decorative tracery and sculptural gardens that later became the architect's signature motifs. It has been called the forerunner to Yamasaki's renowned World Trade Center in New York."

In his 1979 autobiography, Yamasaki wrote that he understood that the prominent building, built in the heart of the city's Civic Center, needed to harmonize with those around it.



The Skyscraper Page said it was the tallest all-welded steel frame building in the world when it was constructed, and was the tallest building built in Michigan in the 1960s.

As Yamasaki's Detroit building was under construction, according to ArchDaily.com's Denim Pascucci, "in 1962 the New York Port Authority sent a letter to Yamasaki asking if he would be interested in pursuing the estimated \$280,000,000 (World Trade Center) project. The architect assumed they must have accidentally added an extra zero, as he felt it would be impossible for his then 55-person office to manage a

project of such magnitude.

"Nevertheless, he was selected over the 40 architects considered to design the World Trade Center."


(Continued from Page 1) weekly pay for unionized working women in 2020 was \$1,085, while for white working unionized men it was \$1,243, a pay gap of 13 percent. By contrast, median weekly pay for nonunion white men was \$1,080 (13.2 percent gap) and \$877 (29.5 percent) for nonunion white women.

In addition, Black unionized men earned \$1,020 weekly and Black union women earned \$917, BLS reported then. Compared to non-union Black men who trailed by \$200 weekly and non-union Black women by \$175. Unionized male Latinos earned \$306 more per week and unionized female Latinas earned \$185 more per week

"Women, and especially women of color, who are either affiliated with a union or whose job is covered by a union contract, earn higher wages and are much more likely to have employer-provided benefits than women who are not in unions," the IWPR report says.

"The role of unions and collective bargaining are especially critical to securing women's prosperity now, as the United States seeks to recover from the pandemic and its resulting 'she-cession.' Covid-19 has made clear: Workers in unions fare better in economic crises

# Local 636 union brothers work residential HVAC market

Heating and Air Conditioning Local 636, who started up a company in September 2020, Coastline Mechanical, performing residential and commercial heating and air conditioning service.

A nine-vear member of Local 636 who was organized into the union, Ryan Nevedal, 38, said the last couple of years prior to starting Coastline he had worked on typical commercial and industrial jobs. "I was looking to get into a company ownership role, and you need a lot of capital if you're going to go into commercial and industrial," he said. "But that wasn't really the case on the residential side, and I saw the opportunities that were available. And it seemed to me that working union, residential had a lot of appeal, and seemed like a tremendous opportunity. So we launched Coastline together."

His business partner is his brother and fellow Local 636er Jon Nevedal, 36, a Navy veteran and former Boilermakers Local 169 member, who came into that union through the Helmets to Hardhats program. The brothers, both avid boaters, settled on the Coastline name because of their affinity for sailing and the Great Lakes.

Starting up a company during a pandemic wasn't ideal, but Ryan said business has been great so far. They hired legal and accounting help to set up the business. Relying on connections and advice from a group called Business Network International, word of mouth, and a presence on social media and at union meetings, the brothers have had plenty of business, typically working 80 hours a week. Unlike going to work for other contractors as fitters, much of what they're doing is non-billable estimating, invoicing, accounting, processing payments, and contacting suppliers. "It's a crazy amount of

work," Ryan said. "But I'd like to see us grow and be able to hire more people who do HVAC, and help with the bookkeeping. What I envision is being the big, go-to union residential outfit in the area "

He said their philosophy is to bid competitively, but to "build value into yourself. We earn a fair union wage, but we offer a degree of quality, in having a union background, with our apprenticeship training. We deliver on our promises, and we treat people the same way we want to be treated."

Jon said the brothers initially started to work together doing jobs on the side for their family, and enjoyed it. "We always wanted to work together, and we work well together," he said. "I'm proud that we have been able to handle the amount of work that we've had."

Sometimes the brothers work separately, sometimes together, depending on the job.

"Of course I wish them the best, they know what they're doing and it seems to me they have a great plan," said Local 636 Business Manager Terry Gilligan. "And we've always said, we know there are challenges, but there seems to be a lot of room for union residential HVAC contractors. There are people who really want to hire union.'

For now, the duo only does business in Macomb, Oakland and St. Clair counties, working out of their two fully stocked trucks. Both said they would like to expand, and have approached business managers at other unions about recruiting workers.

"Part of our mission statement is to bring the quality of the work we've done in the union industrial sector to the residential market," Jon said. "We think we've done that and we're looking forward to expanding the business."

Americans' approval of labor unions, 1936-2020

with unionization helped protect union workers from the economic shock of the pandemic recession. Additionally, unionized workers were able to negotiate additional pay, health and safety measures, and paid sick leave during the pandemic—vital benefits that boost economic security and protect the health and well-being of workers."

But those wages and economic security vary widely, state by state, IWPR reports. And the gap widens in so-called "right to work" states, it notes. Organized labor calls "right to work" "right to work for less," and the report confirms that: state by state, for working women.

"In 2019, the median weekly earnings for full-time women workers in right-to-work states was \$768, which is about 16.7 percent lower than in states with full union rights. Similarly, men in right-to-work states earn roughly 11 percent less than their counterparts in other states," IWPR said.

"When it comes to the economic security of American families, the data is clear: Union membership means better wages and narrower gender wage gaps across the board," said IWPR President C. Nicole Mason, in a statement accompanying the report. "For women, that can mean the difference between making rent and the fear of eviction, between feeding their family and child hunger.'

AFL-CIO President Liz Shuler, who's a board member of the institute, said the report reinforces the union advantage.

"For America's workers who join together and have a union voice on the job, the higher wages, better benefits, and safety protocols are undeniable," she said "This report reaffirms that being in a union has a direct and significant impact on equity for working women and their families - from improved day-to-day financial stability to retirement security. We want all working people to have the benefits of a union.'



83 percent approval of labor unions is the highest on record since then. At the same time, 45 percent of Republicans and 64 percent of independents approve of unions.

In 2009, 66 percent of Democrats, 29 percent of Republicans and 44 percent of independents viewed labor unions favorably. Since the Great Recession, union approval has recovered among all three major party groups.

Implications. Americans' approval of labor unions has been consistently high for several years and has more than recovered from low points around the Great Recession. Even as the ally, when economic indicators

The public is divided in its assessments of the biggest U.S. problem, with roughly one in five each citing the coronavirus, the economy, race relations and leadership. Yet, if the economy continues to struggle and it eclipses other issues in importance, Americans' views of unions could very well worsen.

AFL-CIO President Liz Shuler on Sept. 2 said the good news from the polling "comes as no surprise that public support for unions continues to rise across the country. Union members have delivered for our communities throughout the country, as workers have finally been recognized as essential to our economy and society during the coronavirus pandemic.

"This polling data should send a clear message to Congress that union jobs are vital as we re-emerge from this pandemic with a stronger economy that is built upon the principles of fairness and equality. The writing is on the wall, and it is time for Congress to respond to public opinion and the will of their constituents by passing the PRO Act."

# part of budget package

WASHINGTON (PAI) - "Hit 'em in the wallet," hard. That, in so many words, is the message the Democratic majority

on the House Education and Labor Committee sent on Sept. 9-10 in its part of the Democrats' \$3.5 trillion tax and program package which lawmakers will vote on in mid-September.

We passed penalties for firms that break the law on wage theft, on safety and health and when" firms prevent workers who "try to bargain collectively," said Rep. Andy Levin, D-Mich., a former top union organizer and Deputy AFL-CIO Organizing Director.

"I do not expect or want to see these provisions eliminated or see them watered down," he told a zoom press conference on the legislation on Sept. 13. "They raise revenue, but they're also provisions to fight wealth and income inequality.'

Education and Labor's fines against firms that harm their workers aren't the only ones that will be in the final legislative package. Indeed, they aren't even the main ones. The tax-writing House Ways and Means Committee voted, also on party lines, to raise corporate income tax rates and individual income tax rates on high earners, too.

The tax provisions that panel's chair, Richard Neal, D-Mass., unveiled on Sept. 13 would raise the corporate tax rate from its current 21% to a new 26.5% rate, raise the top capital gains rate from its current 20% to a new 25% and raise the top individual tax rate from 37% percent to 39.6%, plus a 3% surtax on individuals' income above \$5 million.

The package, now being assembled on Capitol Hill, envisions the societal overhaul Democratic President Joe Biden proposed in his Build Back Better Agenda. Besides the fines, it has many positive aspects

All the tax hikes, though, including the labor law-breaking fines, are to meet the requirement of the \$3.5 trillion "reconciliation" resolution lawmakers passed in August that its programs be paid for. Reconciliation is supposed to deal only with taxes and spending limits. And that was the Education and Labor Committee's dilemma.

It wanted to include the entire Protect The Right To Organize (PRO) Act in the legislation, thus enshrining the most wide-ranging pro-worker rewrite of federal labor law since the original National Labor Relations Act of 1935. But under reconciliation rules, it couldn't.

So, for instance, the PRO Act's language banning captive audience meetings can't go in. But fining firms-and bosses, from CEOs down to line managers, plus board members-who call the meetings can.

Please remember it is our responsibility to always have our dues slip current and on our persons at all times. This is our "Ticket" to the middle class. If asked, it is our responsibility to show.

Soon you will be receiving a letter in the mail regarding the \$3,000 Accidental Death & Dismemberment benefit available through a partnership with the IBEW and American Income Life. The letter states that you need to return the enclosed beneficiary card in order to qualify and name your beneficiary. Please note you are **NOT RE-QUIRED** to return this card in order to name your beneficiary; the beneficiary you have on file at the hall is sufficient.

**Work Report.** Commodity prices continue to have a dramatic impact on our work outlook. In partnership with our signatory contractors, we continue to be low on a significant percentage of projects as of late only to find that the project has gone over budget due to material prices. The good news is these commodity prices are beginning to trend in the right way. Hopefully we will see those prices reflected at the supply house soon.

The work picture continues to be steady for our local contractors. We are still looking for that one big project that will get our traveling Brothers and Sisters back home where they belong. Zone 2 continues to be quite busy for the amount of man power that we have available. If you are interested in working in Zone 2, please contact Brother Klele.

The jobs our signatory contractors are performing in our jurisdiction are as follows: Work on the two Bay City bridges will begin later this fall with a large-scale remodel of the Liberty bridge followed by the construction of a new Independence Bridge in the spring. Master Electric has secured the new Meijer in West Branch as well as the new Isabella County Jail located in Mt. Pleasant. The Meijer project is underway but has seen delays as other crafts have had issues securing material. The new jail is also seeing some delays, we will keep you posted. Master has also secured the stadium lighting project at Dow High School in Midland. Ted's Electric was awarded the Bay County lift station project.

Alpena Schools have been awarded to Zone II contractor John's Electric. Clements Electric is wrapping up work on the Monitor Township Fire Department and also the Bay-Arenac ISD bus garage. Work continues for them at multiple marijuana dispensaries and the new Drift in Bay City. Countyline Power has secured the Mackinaw City lift station and the Roscommon Airport. We also just found out Friday Countyline has indeed secured a nice project at the Cheboygan Wastewater Plant and will begin work immediately. Consumers Energy is slow at the Karn but does have a nice project bidding at the service center on Wilder Road here in Bay City. Northern Valley Electrical has the LaFarge PLC upgrade and also JoBurg Schools. Nelson Electric out of Local 557 has secured a nice project at two of the high rises in Bay City. Renton Electric out of Local 58 has a nice fire alarm project in East Tawas that will be wrapping up in the coming weeks. There are also a large number of solar projects that are slated for our jurisdiction. Solar work continues to be a bit of a unicorn.

Rest assured both organizers and myself are working very diligently to secure whatever work is being bid in our jurisdiction for our membership. Work remains very good in Detroit, Ann Arbor, Kalamazoo, and Lansing. Please contact the hall if you would like to sign any books.

Organizers Report. 692's Organizing team continues to reach out to unrepresented workers in our jurisdiction about the benefits of joining the IBEW. Zone 2 continues to be a priority as we anticipate larger-scale projects coming to the area over the next few years. The ability to provide adequate manpower to these projects will only strengthen our contractors' chances of securing this work. The Alpena Hospital and PIE&G service center in Onaway were two recent Zone 2 projects that our contractors were not able to secure. Although this was unfortunate, signatory contractors have picked up a lot of work that the merit shops have let go while they have been focusing on obtaining manpower to complete those bigger jobs. John's Electric, Hardies Electric, Harfert Electric and Northern Valley Electric have all picked up work as a result. They continue to strengthen the relationships they have forged with this new customer base, and our members will only benefit from these resulting partnerships. Agents continue to push for local city and county commissions to adopt Responsible Contracting ordinances that will ensure projects funded by taxpayers are completed by reputable firms. In the view of the IBEW, Responsible Contracting language guarantees that contracts for larger-scale construction projects are awarded to companies who value workplace safety, adhere to licensing and permitting requirements, and provide their skilled employees a living wage and solid benefits. 

## **Upgrades burnish Sheet Metal** Local 7, Zone 1 training center

#### By Marty Mulcahy Editor

MARSHALL - The Sheet Metal Workers Local 7, Zone 1 Training Center is ready as it's ever been to meet the needs of the industry and its contractors.

In the past three years the 20,000 square-foot facility has seen the installation of an updated shear and 100-ton press brake, an improved drafting room, new welding booths, a new autocad room, a new water-cooled plasma table and a 3-D printer.

Zone 1 Training Coordinator Kevin Dowdy, who started his job in 2014, said the training school was moved from Battle Creek to its present site in 2007 - a transition that not only created more space, but has allowed the union to markedly improve its hardware for training apprentices.

"The equipment is important, but my biggest brag are the apprentices themselves," Dowdy said. "We have a good quality, well-rounded group of people who have come through the program, and instructors who care about them, and make sure everything they have learned they

### to work for our contractors.

'My second brag is the support for training from the membership of Local 7, Zone 1. "There has been a boost in funding to support our training over the last several years, and I am gratified that there is so much interest in investing in our future."

Dowdy said the new equipment opens a wide variety of improved training opportunities. The new 4x8 foot plasma table, acquired this summer, was an upgrade from the facility's 4x4 foot model and has improved software, faster productivity and a higher volume of work, while eliminating smoke and reducing distortion while the device cuts through metal.

The 3-D printer is used to make fittings and provides apprentices an opportunity to try out the software and hardware to become familiar with the device's capabilities.

The school's new sheer offers apprentices the opportunity to make cuts of 10-feet of metal up to seven gauge thick, an upgrade in capacity from the site's

will take with them when they go previous model. "That gives the school a better range for working in different types of construction, and work with heavier and lighter gauges of all types of metal," Dowdy said. The new 100-ton press brake is much more robust than their previous model, and can bend metal up to seven gauge.

The welding booths have more versatility and better technology

Sheet Metal Workers Local 7 has two other apprenticeship schools, Zone 2 in Fruitport and Zone 3 in Saginaw, and all three are separate entities. Dowdy said there are currently about 100 apprentices using the equipment while working and learning at the Marshall facility. He is aided at the site by instructor Ryan Lehmann.

Over the past five years our facility has invested about \$250,000 in new and upgraded equipment," Dowdy said. "Our JATC (Joint Apprenticeship Training Committee) has been very supportive and the investment has put us in the right place, big time, to help train our apprentices.



### Outdoors 2021 Deer Season preview

(From the Michigan DNR)

The Michigan Department of Natural Resources released its annual deer hunting preview just ahead of the deer hunting seasons, which began Sept. 11. Overall, conditions are looking excellent for the upcoming seasons, and deer hunters can expect hunting to be as good or better than last year.

Hunters who have viewed the 2021 Hunting Digest (Google: "Michigan 2021 DNR Hunting Digest") may have noticed a few regulation changes in place this year, including a universal antlerless license that can be used across deer management units in most of the state. Some northern Upper Peninsula Deer Management Units (DMUs) are closed to antlerless deer hunting, and two U.P. DMUs, 351 and 352, require an access permit along with the pages 60 and 61 in the 2021 Hunting Digest for more details.

"These regulation changes reflect the evolution of deer hunting in Michigan," said Chad Stewart, DNR Deer and Elk Program specialist. "The last 20 years have resulted in dramatic and sustained declines in hunter numbers. When combined with an abundant and resilient deer herd that continues to grow, and the added challenge of managing deer diseases, a change that represented this shifting dynamic was necessary."

Upper Peninsula. Last year was challenging for U.P. deer hunters, with overall harvest down nearly 6 percent from 2019 and buck harvest down nearly 11 percent. Though harvest numbers were not as low as those seen in 2014-2016 after the severe winters in 2013-2015, they are down from harvest numbers in 2017 and 2018.

The 2020 U.P. winter was far milder than normal, which was a welcome respite for the deer

Mast production this year seems very spotty. Look for areas with oaks producing acorns, as they are sure to attract deer. Buck numbers seem to be improving, but there are still areas where persistence is going to be necessary to be successful. Overall fawn production seems to be good. With the new changes allowing antlerless deer to be taken in the lower two-thirds of the peninsula, hunters have an increased opportunity to fill their freezer for what is hopefully another mild winter ahead.

Northern Lower Peninsula. In the 2020 hunting season, the northern Lower Peninsula saw an estimated harvest of 135,906 deer, which was up 7 percent from 2019. While buck harvest declined about 5 percent, from 68,168 in 2019 to 64,725 last year, antlerless harvest increased by 21 percent, with over 12,000 additional antlerless deer taken in 2020 than in 2019

The winter of 2020 didn't seem to have adverse effects on the deer herd in this region due to fewer periods of extreme cold and an overall shorter winter. Another important factor that ensured winter survival was forest management practices (new growth of young trees and leaving treetops The DNR is still focusing on from harvested trees) that provided plenty of browse for deer

The mast crop in the north-

were affected by gypsy moth infestations. Those areas are not likely to see much in terms of acorn production. Elsewhere, acorns and soft mast, including apples on old homestead sites, blackberries and hawthorn are all producing nicely.

Deer numbers look very good in many locations, though it's important to point out that deer are not evenly distributed across the landscape, and certain areas may hold fewer deer than others. Overall, DNR staff is seeing good fawn production this year, with many twins trailing does

The spring and summer rains seemed to provide optimal forage for deer, and the bucks have been turning that into nice antler growth. There are some reports of people seeing better bucks relative to recent years - something hunters can start getting excited about. In some locations, there is still a long way to go toward balancing the buck-to-doe ratio, so hunters are encouraged to take advantage of new regulations that allow antlerless deer to combo license during firearm and muzzleloader seasons.

Bovine tuberculosis surveillance is still a priority in the northern Lower Peninsula, with testing occurring in the primary counties of Alcona, Alpena, Montmorency and Oscoda, but also in all surrounding counties (Cheboygan, Crawford, Iosco, Ogemaw, Otsego, Presque Isle and Roscommon). TB is a significant threat to the livestock industry, and hunters wanting to do their part to assist with surveillance can have their deer tested at any check station this year.

Southern Lower Peninsula. 2020 was quite a year in the southern Lower Peninsula, with antlerless harvest increasing 29 percent from 2019. Buck harvest also increased by over 12 percent, and – when factoring in deer harvested by deer management assistance permits - nearly 250,000 deer were taken in this region alone. Much of this pressure on antlerless deer has been needed, as numbers throughout most of the area have been on a steady rise for years.

With winter rarely being a factor for population-level impacts on the southern Lower Peninsula deer herd, the DNR relies on hunters for the bulk of the deer management in this region, and the recent regulation changes seem to be a step in the desired direction for deer management

be taken on the deer and/or deer weak this year, likely due to the drought conditions experienced through June and the heavy rains throughout July. Though there doesn't appear to be a bumper crop of acorns in the region this year, some oaks are producing, and for those in an area with acorns, it's sure to be a magnet for deer in early fall.

> With the agricultural fields performing well, deer certainly haven't been hungry this summer. The corn progression is on par with 2020 and ahead of the five-year average, so with any luck, many of the fields will be picked by the firearm opener, which should lead to continued success this season.

> Deer numbers seem consistent with previous years, and as always, there have been some nice bucks observed. The fawns observed are well-developed and on their way to entering winter strong and healthy.

> It's important to note that surveillance for chronic wasting disease is occurring in the southernmost counties of the southern Lower Peninsula. Hunters are encouraged to visit check stations and submit their deer for testing. A complete list of check stations is available at Michigan.gov/DeerCheck.
