Detroit Labor Day parade hits reset

The Detroit Labor Day Parade is back, but it won't be the same route as in years past.

The parade has taken a pandemic-related hiatus, and it will be held this year for the first time since 2019.

This year, the march will start at 9 a.m. at Michigan Avenue and Sixth Street (at the Lodge Freeway overpass) and proceed east toward the Ford Motor Co. train station. Then the march will proceed back to Dean Savage Park at Porter Street and Trumbull, next to IBEW Local 58, for a celebration.

MI college athletes could unionize?

LANSING — College athletes can now earn money like the pros, by putting their name on merchandise, making personal appearances, and the like.

In Michigan, maybe it won't be long before the college athletes, and graduate research assistants, also have the privilege of working under a union contract.

Senate Bill 0185, sponsored by State Sen. Jeff Irwin (D-Ann Arbor), would classify college athletes and research assistants as public employees, which in turn would open the door for them to collectively bargain for a union contract.

Irwin's bill overturns a Republican-backed law that specifically banned unionization among graduate research assistants, after they made an effort to unionize at the University of Michigan in 2014. College athletes were added to union-eligible list under Senate Bill 0185, which was adopted along party lines and now goes to the state House for consideration.

In general the argument for allowing college athletes to unionize — especially football players — is that they make money for their university and deserve a say in their working conditions. Detractors point to the athletes' scholarships and other privileges and claim that as a group they're a poor fit for union representation.

The overall future for unionizing on the university level is as clear as mud. The conservative U.S. Supreme Court in June 2021 threw out decades of precedent and allowed for compensation of student-athletes. The National Labor Relations Board ruled in December that student-athletes were "employees" of a university, and thus eligible for union representation. But the NLRB's jurisdiction technically only applies to labor relations in the private sector. Legal action would likely follow passage of a state law.

New technology drives battery plant construction

LANSING — The footprint of the 2.8 million-square-foot Ultium Cells facility under construction here is impressive enough — few and far between in Michigan or elsewhere are projects that require about 1.5 miles to walk the perimeter.

But this plant will be no empty shell, like a warehouse, or even an Amazon fulfillment center, which can be similar in size but contain material handling equipment that has nowhere near the high-tech intensity found here.

Construction of the \$2.6 billion battery cells plant began last summer along I-69 near I-96.

"The size and scope of what we're doing, from start to completion, is just so immense," said Ethan Eickelberg, project manager for one of the project's key contractors, Superior Electric Great Lakes Co. "Just moving within and around the building is a

Consumers Energy shuts Karn 1 & 2 units

ESSEXVILLE — They were hot, grimy places and offered tight work spaces, but they were golden to generations of building trades union workers.

We refer to Karn Units 1 and 2 at Consumers Energy's Karn-Weadock Generating Complex near Bay City, which the utility shut down on June 14 as part of its long-term move away from coal-burning boilers.

Coming online in 1959 and 1961, respectively, the units over the years were upgraded, rebuilt, renovated and had various emissions control systems installed on them in what were usually multi-million-dollar projects employing hundreds of trades workers.

"We are deeply grateful to the hundreds of employees who helped make Karn 1 and 2 an

important part of our energy story here in Michigan," said LeeRoy Wells Jr., Consumers Energy's senior vice president of operations. "The legacy of their work at these plants continues, as it will now serve as a reminder of what we are capable of accomplishing together when we prioritize doing what is right for our customers and for the planet."

The closures are part of Consumers Energy's Clean Energy Plan, the company's roadmap in the shift away from burning coal toward renewable energy sources. The ongoing transition, according to the utility, "balances the responsibility to provide safe, reliable energy to power nearly 2 million Michigan homes and businesses with the need to protect the state's natural resources."

Consumers Energy said it continues to evaluate the site

"and is working closely with local leaders to determine next steps for the grounds." The closure of the units will result in the loss of 515 megawatts of power.

Two additional generating units on the grounds, Karn 3 and 4, were built in the mid-1970s and will continue to pump out about 638 megawatts each, burning natural gas and oil. The company

plans to keep them operating through 2031 as it continues to build its renewable energy portfolio. Consumers Energy's goal is to have 90 percent of its energy coming from renewable sources by 2040.

The site's coal-fired Weadock Units 7 and 8, each rated at 155 megawatts came on line in 1955

Bring the power back home: state Dems urged to return local control laws

LANSING — After the re-adoption of a statewide prevailing wage law and rescinding of Michigan's right-to-work law in March, there's been a bit of a lull in the state Legislature when it comes to adopting pro-union, pro-worker legislation.

But there was movement in that direction on June 15 in the Democrat-led Legislature, when labor union leaders and local elected officials testified before the House Labor Committee in favor of a pair of bills that would restore the ability of local governments to adopt their own labor and workforce policies.

For the building trades, one of the most infuriating laws adopted by majority state Republicans and Gov. Rick Snyder eliminated the ability of local units of government from entering into construction project labor agreements. Even though such agreements are sought and encouraged on private projects by many large corporations and contractors, GOP lawmakers continued their vendetta against labor unions by simply taking away any alternative for local governments

to enter into such contracts.

"Project labor agreements save many municipalities money in the long run," said Lansing Councilman Jeremy Garza. "When construction is completed with higher quality labor it lasts longer and provides a better value to taxpayers."

House Bills 4231 and 4237, both still in the House Labor Committee, address more than project labor agreements. They would restore the ability of local governments to pass labor and workforce policies that are best for their communities and give power back to local elected officials and the residents they serve.

A "citizen lobby day to restore local control" sponsored by the Michigan AFL-CIO was held in Lansing on June 22, in an effort to push lawmakers to restore the authority of city, township and county governments.

Happier inflation trend mirrors falling prices for construction materials

Inflation is easing. The latest numbers from the U.S. Labor Department's Consumer Price Index released on June 13 show that the overall United States inflation rate dropped for the 11th straight month in May. Consumer prices increased at a 4 percent rate in May, down from 4.9 percent in April and from a 40-year high of 9.1 percent last June.

The better inflation numbers

had a downstream benefit with the Federal Reserve Board, which declined to raise interest rates at its June 14 meeting for the first time in more than a year.

"Inflation is still much too high, but the trend is in the right direction, and the Fed is ready to

No slowdown for Michigan construction approaching mid-year 2023

There's been talk of a coming downturn in the U.S. construction industry, but it's hard to see evidence of one as 2023 approaches its halfway point.

For now, the good vibes are widespread: 42 states added construction jobs in the month of May, and Michigan was one of them. In analyzing federal Bureau of Labor Statistics numbers, the Associated General Contractors said June 16 that more needs to be done to expose young people to construction careers. "Firms are struggling to find new workers amid a lack of funding for construction education programs, keeping monthly employment gains lower in many parts of the country," the AGC said.

Michigan is enjoying a nice boom in employment. Not only

The myths of worker value

You've probably heard that everyone is "paid what they're worth." Don't buy it.

According to this mythology, workers at the bottom are "unskilled" and don't deserve more than what they currently earn. Minimum wage workers at McDonald's are paid what they are worth in the so-called "free market." If they were worth more, they'd earn more. By the same logic, the CEO of McDonald's is worth his multimillion-dollar compensation package.

The notion that people are paid what they're "worth" is by now so deeply ingrained in the public consciousness that many who earn very little assume it's their own fault that they don't earn more. That they simply lack the skills they need to be paid more.

But there's no such thing as unskilled workers. Only underpaid workers. Their productivity – that is the value of what they produce – has been growing for decades. The problem is that their wages haven't kept pace with their productivity.

The "paid what you're worth" mythology also lures the unsuspecting into thinking nothing can be done to change what people are paid. It's simply the way the market works. Meanwhile, according to this same view, CEOs who rake in tens of millions and Wall Street traders who rake in hundreds of millions, are simply being paid what they're "worth" because that's what the market has dictated.

Rubbish. The "paid what you're worth" fairytale ignores power and disregards policies that have made inequality skyrocket. Like the demise of antitrust enforcement, which has given big corporations the power to set prices, make record profits, and reward their CEOs unprecedented compensation. This fairy tale ignores the attacks on labor unions that have reduced union membership from over a third of all private-sector workers in the 1950s to just 6 percent today. All of this resulting in a massive shift in power and wealth from workers to owners.

Those at the top justify their staggering wealth, and they're "worth," three ways:

The first is trickle-down economics. They claim that their wealth trickles down to everyone else as they invest it and create jobs. Just wait for it... But as we know, wealth at the top has soared for decades and nothing has trickled down.

The second is the "free market." They talk about market forces beyond their control. But remember, markets are created by rules. These rules don't exist in nature; they are human creations. The political power of the wealthy has let them change the rules for their own benefit – busting unions, monopolizing industries, and reaping big tax cuts.

The third is the idea that they're superior human beings. Sure, they may be talented, but this doesn't justify the staggering amount of wealth they are now taking home. Nor does it justify the amount of wealth they will pass down to heirs. The biggest inter-generational transfer of wealth in history will occur over the next 25 years as the richest 1.5 percent of Americans hand down roughly some \$36 trillion to their children and grandchildren. That doesn't make those heirs superior. It makes them lucky.

The reality is there's no justification for today's extraordinary concentration of wealth at the very top. Or for how little people are paid at the bottom.

The "paid what you're worth" myth has proven to be a cruelly effective way to put the blame on workers for not getting ahead – while giving the rich and powerful cover to rig the game for their own benefit. It is distorting our politics, rigging our markets, and granting unprecedented power to a handful of people while millions of Americans struggle to get by. Don't fall for it.

The utility said it has prioritized the transition for Karn employees who wish to remain with the company, and said it would provide support for those electing to retire with the plant or move on to other opportunities.

THOUSANDS of building trades workers earned a living building, renovating and supplementing the works at Consumers Energy's Karn-Weadock Generating Facility near Bay City. As recently as 2010, the utility was spending \$189 million on a new Pulse Jet Fabric Filter project on both coal-burning units 1 and 2, with work at Unit 1 shown here. Then in 2013, the utility spent \$250 million on the installation of spray dry absorbers onto Karn Units 1 and 2 for further emissions controls.

This isn't fake news: corporations control news content

Why would your local newspaper not even mention an important local news story? Perhaps



because it's a damning story about the conglomerate owner of the paper. This month, hundreds of journalists working for major dailies in some two dozen cities across America joined in an extraordinary mass walkout from their jobs. They were protesting

the rank greed, gross mismanagement, and abandonment of democratic duty by the owner of their papers. That owner is Gannett, a massive financial conglomerate that has grabbed control of more than 200 dailies in 43 states. This is a huge, multi-dimensional news story about news itself – but where was the coverage?

Big Story No. 1: Unbeknownst to most people in these communities, they no longer have a daily paper – control over everything from news content to price now belongs to bean-counting strangers at Gannett headquarters hundreds of miles

away.

Big Story No. 2: More fundamentally, control has moved from journalists to bankers. Gannett is owned by SoftBank, a Japanese hedge fund that has rapaciously looted American newsrooms to grab extravagant fees, salaries, and profits for its rich financial hucksters.

Big Story No. 3: The workaday hometown reporters, photographers, and others who actually produce Gannett's papers are making a gutsy stand against the profiteer, not just for themselves, but for the essential ideals of journalistic integrity and grassroots

democracy.

Biggest Story of All: Gannett's 200-plus papers cravenly joined in a concerted blanket cover-up of this momentous story, stifling the public they're supposed to serve and disrespecting the ethical stand of their own employees. Even Gannett's flagship paper, *USA Today* – which regularly reports on other labor actions – took a dive on covering the journalistic malfeasance of its own overseer.





BUILDING MICHIGAN: Early bridge building HISTORY IN THE MAKING

BUILT IN 1914 – AND SHOWN here in 1930 abandoned because of the re-routing of US 41 – is the still-standing Peshekee River Bridge, five miles east of Michigamme in Marquette County. The bridge, now used by pedestrians, is still standing because it was abandoned. It is of reinforced concrete design that set the pattern for the construction of hundreds of bridges in Michigan for the following 15 years. “How many states can claim in the 21st Century to still have the first state highway bridge ever built in the state still standing?” asks *Historic Bridges*. “The bridge is highly significant since it marks the beginning of bridge construction by Michigan’s state highway agency. The bridge is also structurally significant. It is the longest straight chord concrete through-girder bridge in Michigan.”

Given Michigan’s history with underfunding the maintenance of its highway bridges over the last half-century or so, it’s a good thing we usually built them right – even over-built them – when they were first constructed.

The steel and concrete spans that were constructed in our state a century ago often lasted for decades – and many are still in service today – because of the largesse, foresight and philosophy of (surprise!) the state’s taxpayers, federal construction policies, as well as a highly progressive State Highway Department that served a leadership role for other states in the early decades of the 20th Century.

Just like automotive assembly lines, standardization became the key to Michigan’s early leadership in bridge-work.

“Standardizing the design of small bridges was a rational, economical approach to a massive problem confronting Michigan’s highway engineers in the early 20th Century – how to build enough highways and bridges to keep up with the state’s enormous growth of automobile traffic,” says *Historic Highway Bridges of Michigan*. “The state Highway Department did not, however, limit themselves to standardized, short-span bridges. They also completed innovative and aesthetically appealing designs for large bridges as well.”

Today, Michigan isn’t alone among the states for having scores of all manner of century-old steel and concrete truss bridges, viaducts and metal stringer spans that are still in operation. But after our state birthed the proliferation of the automotive industry, Michigan was also among the leaders of highway and bridge construction, an industry that had few standards as the need grew for stronger infrastructure.

The railroad industry, which existed for decades before cars and trucks came along, provided a template, sort-of, for the construction of bridges in Michigan and elsewhere. After the turn of the last century, rail bridge designers showed how high-strength bridges could be built, but consensus on standards among them proved slow to achieve. So much was changing in the world.

“The perfection of steel manufacture, the development of bridge shop tools of great accuracy and large capacity, the doubling of capacities of freight

cars... have greatly encouraged and facilitated the construction, shipping and erection of girders of dimensions previously impracticable, and have made comparatively long plate girder spans common,” wrote civil engineer Frank Skinner, in a 1908 publication of the *Engineering News Record*, “Types and Detail of Bridge Construction.”

Skinner implied that rail bridge designs had been all over the place before standards started to become accepted among the nation’s structural engineers.

“The specifications are the fundamental element of design in structural work, and these have been widely revised and perfected by all bridge engineers within the last decade,” he wrote.

A few years later, as roads were improved and bridges were constructed to accommodate motor vehicles, the bridge standardization example of the rail industry would be hard to ignore. And Michigan’s transportation leaders would be among the first to apply its lessons.

During its first eight years of existence beginning in 1905, said *Historic Highway Bridges of Michigan*, “the State Highway Department had little direct involvement in bridge design or construction, beyond occasionally giving advice to local officials. Two pieces of legislation radically changed this.” In 1913 a state law required the state Highway Department to build and maintain all trunk line roads, while a 1919 law made the state responsible for construction supervision and half the cost of building state roads.

Michigan began to dip into available 50 percent match of federal road money in 1917, then the good people of Michigan in 1919 also took it upon themselves to vote to authorize the state Legislature to issue up to \$50 million in bonds for road and bridge work. Michigan taxpayers thus had plenty of skin in the road- and bridge-building business.

C.V. Dewart was the state’s first bridge engineer, hired in 1914 to head Michigan’s new bridge division. His go-to bridge design: Reinforced concrete through-girder bridges, composed of a pair of cast-in-place longitudinal girders and a deck slab connected by steel reinforcing bars.

“Dewart quickly developed a set of standard bridge plans to use on the trunk line system

and to supply local governments upon request,” said *Historic Highway Bridges of Michigan*. “He began in 1915 with concrete girder designs because they could be built by local contractors employing carpenters and unskilled laborers, used readily available materials, required little maintenance and because of their massive size, provided a wide margin of safety.”

“Several national publications discussed Michigan’s efforts at least a year earlier, one indication of Dewart’s pioneering work. In part because it used standard designs, the Michigan Highway Department was able to build a large number of bridges economically.”

The first bridge built under this standard was a span over the Peshekee River near Michigamme in Marquette County. “For the crossing, Dewart delineated this large-scale concrete bridge, designating it as Trunk Line Bridge No. 1,” says *Michigan’s UP*. “The structure would be massive, extending 240 feet and consuming some 600 cubic yards of concrete. It featured, according to Michigan State Highway Department, ‘reinforced concrete construction throughout, in which all steel is bedded in concrete, which makes an absolutely permanent structure.’”

Completed in 1914, the bridge was later incorporated into US-41. It carried increasingly heavy traffic until its subsequent abandonment in a highway re-alignment. “Today,” said *Michigan’s UP*, “it stands deteriorating and overgrown in a county park.”

The Michigan State Highway Department said in 1923 of its favorite bridge scheme: “the reinforced concrete through girder... lends itself in the majority of cases on account of its very shallow floor system, thereby giving the waterway a maximum clearance under elevation of roadway crossing the bridge.”

By 1930 “the through-girder had largely fallen out of favor with the state and county highway departments, but before it was discontinued, perhaps hundreds of these utilitarian structures were built throughout Michigan,” said *Historic Highway Bridges of Michigan*.

Bridge builders then often moved into constructing bridges with exposed steel supports – a design where deterioration can more easily be seen and less susceptible to cracks from the freeze-thaw cycle.

promise of a good union job.”

The George Meany Award, named for a past AFL-CIO president, was established by the Boy Scouts of America and the National AFL-CIO in 1974 and recognizes outstanding union members for their service to their communities’ young people. Individuals are nominated by their Central Labor Council and must exemplify the values of the Boy Scouts by upholding the Scout Oath and Scout Law in their communities, workplaces, and personal lives. Since its inception, only 2,500 union members have received this honor.

“The work the Boy Scouts of America does to educate today’s youth about career opportunities in the skilled trades could not be more important or more timely,” said Michigan AFL-CIO President Ron Bieber. “As support for the labor movement experiences a historic resurgence in support across the nation, the Boy Scouts of America continues to invest in educating young people about careers in the skilled trades, and, in turn, helps grow the labor movement.”

Both Claywell and Bottorff were honored and presented with their award at a celebratory dinner, which was a joint effort between the Boy Scouts of America and the Michigan AFL-CIO.

The Michigan AFL-CIO, Michigan’s largest labor organization, is a federation representing 40 different labor organizations, 18 different central labor councils, and eight constituency groups representing over 1 million union members and their families.

Don’t let mosquitoes and ticks wreck your summer fun - here’s how

AHH SUMMER! It’s great to be outside this time of year, though we’ve all experienced the not-so-fun problem of bugs.

Bugs bites are primarily a nuisance, causing temporary itching and red, irritated skin. More rarely – though potentially more serious – mosquitoes can carry diseases such as West Nile or the Jamestown Canyon virus, and ticks may transmit Lyme disease.

All of these diseases can bring on fever and fatigue, and escalate if left untreated. Ailments including respiratory problems and musculoskeletal conditions such as painfully enlarged joints and movements you can’t control are some of the later-stage symptoms that will require professional medical attention.

Follow these four “D’s” to help you avoid the discomfort and health threats posed by these pesky critters.

Defend.

Insect repellents containing DEET and Picaridin have been extensively studied and are approved by the U.S. Environmental Protection Agency (EPA) to safely prevent bites from mosquitoes, ticks and other insects. Both products are just about equal in their ability to combat bugs, and can be safely used on children, and pregnant and breast-feeding mothers.

DEET, long considered the gold standard for repelling bugs, doesn’t actually kill the insect, but blocks its ability to feed. Bugs may still land on you, but they won’t bite. Health concerns about DEET were prevalent in the 1980s when people died after drinking it, but since establishing clear safe use standards, health issues mostly involve skin irritations and lip numbness

when applied near the mouth.

Experts advise applying a DEET product to your hands first and then rubbing ankles, wrists, neck and other exposed parts of the body. Do this outside to avoid inhaling it. Apply the product on children, avoiding contact with mouth, eyes, or other sensitive areas.

Picaridin has been available since 2005 in the U.S. A picaridin product may be right for you if DEET irritates your skin, or you want to avoid the smell and oily feel of DEET. Picaridin also doesn’t damage clothing or sunglasses, as DEET can sometimes do.

A higher amount of DEET or picaridin in a bug repellent won’t make it more effective, but it does impact how long the product repels bugs. For example, a product containing 5-10% DEET or Picaridin works for 1-2 hours. A spray containing 20% is effective for 4-5 hours. Choose the product that suits your activity. Over-doing it may just invite skin sensitivity.

When using sun screen, apply it first, and the repellent second. Products combining sun screen and bug repellent aren’t recommended because you generally need to apply more sun screen than repellent.

Dusk and Dawn.

Mosquitoes are most active when the sun isn’t at its peak, so you’re more likely to encounter them between dusk and dawn. During the day, bugs hang out in cool, shaded places, so avoid thick weeds, bushes and tall grass. Ticks can be active any time of day, and they’re known to linger

in tall grass and wood piles.

Drain.

Mosquitoes and ticks need standing water to reproduce, so keep it away from areas you’ll be in. Check that gutters don’t drain to places where you spend time outdoors. Cover containers that hold water such as rain barrels and watering cans. Use mesh with holes small enough to contain a mosquito to cover vents or plumbing pipe openings.

Dress and Inspect.

The hot summer months are when we look forward to wearing sandals and shorts. Unfortunately, that type of outfit won’t protect against insect bites. Closed-toe shoes and loose-fitting long sleeves and pants are best to avoid bug bites.

Shower after being in areas that may have ticks and thoroughly inspect your body for signs of them, removing any you find with a pair of fine-tipped tweezers grasped as close to the skin as possible. Inspect pets too. Put clothes in a hot dryer for at least 10 minutes to kill ticks before putting in the laundry.

Bring the power back home: state Dems urged to return local control laws

"The Snyder administration passed law after law hurting working families, and Public Acts 105 and 98 were among the worst," said Michigan AFL-CIO President Ron Bieber. "These laws took power away from local communities just like gerrymandering and voter suppression do. Restoring local control will give power back to working people and the local leaders they elected to represent them."

The Michigan AFL-CIO submitted letters to the Labor Committee signed by more than 120 local elected officials, calling on the Michigan House to adopt House Bills 4231 and 4237.

Sponsored by state Rep. Joey Andrews (D-St. Joseph), HB 4237 repeals the PA 105 of 2015, also known as the "Death Star" bill. Backed by corporate lobbyists, the GOP-sponsored law took away local elected leaders' ability to pass measures regarding workforce issues like job quality, wages, benefits, hours, and scheduling, all in the name of making it easier for corporations to keep wages low and make a bigger profit for themselves.

Unsurprisingly, the Michigan Chamber of Commerce is no fan of the repeal legislation. "Without such a law in place, Michigan's 1,800-plus local units of government hold the power to enact different inflexible and burdensome employment regulations on businesses," the Chamber said. "These mandates can be costly and complex for businesses and significantly deter economic development in jurisdictions that choose to enact them and hurt our state's overall competitiveness."

Countered Kalamazoo County Commission Chair John Taylor last month: "These laws should have never been passed in the first place. They were nothing more than a transparent attack on local communities and the hard-working people who make our towns and cities thrive. It's time that our leaders in Lansing repeal this abusive preemption law and allow local communities to better support working families."

Added Jackson Mayor Daniel Mahoney: "Too often, our state and federal officials are in gridlock or unable to move quickly enough to address the needs of local communities like ours. Our officials right here in Jackson, not Lansing or Washington, know what's needed to respond to the issues affecting our workers and the Legislature should act swiftly to let us do our jobs."

House Bill 4231, sponsored by state Rep. Jenn Hill (D-Marquette) repeals PA 98 of 2011 which banned municipalities from entering into project labor agreements, which are collective bargaining agreements made between unions and contractors to ensure workers on taxpayer-funded construction projects are getting fair wages and benefits. They can contain a number of elements, including scheduling and local hiring clauses, that are a benefit to the municipality. They protect taxpayers' investments by eliminating costly delays due to labor conflicts or shortages of skilled workers, and ensure the highest quality work for critical public projects.

A coalition of business groups, including the Michigan Chamber and the Michigan Associated Builders and Contractors, signed a memorandum to the Michigan House on June 12 protesting the pro-PLA legislation. "Current law," the memo says, "protects all Michigan construction workers, apprentices, and businesses from being discriminated against and denied work opportunities based on their labor status. No one should be denied equal access to opportunity because they decide to affiliate with a labor union or not affiliate with a labor union."

Left unsaid by the business lobby: current law does nothing to protect local units of government from another form of discrimination: their ability to enter into business contracts with groups, like labor unions and their contractors, who they feel might offer them better value, timeliness or quality in the work they perform.

"My constituents in Warren elected me to represent their values and interests on the City Council," said Warren City Councilwoman Angela Rogensues. "These preemption laws take away power from local governments to respond to their constituents' needs. Michigan's Legislature should act quickly to restore these rights to local communities."

Happier inflation trend mirrors falling prices for construction materials

take a break from raising interest rates," Chris Zaccarelli, chief investment officer for Independent Advisor Alliance, said in a statement. "They've raised rates for 10 consecutive meetings in a row... so they want to wait and see if their actions are sufficient to keep inflation moving in the right direction." The fed's goal is an inflation rate of 2 percent.

More narrowly, there was also some relief for prices in the construction industry material market, which had spiked in some sectors by 30 or 40 percent during and after the pandemic. A June 15 analysis of the numbers by Dodge Data and Analytics said prices for final demand construction goods decreased by 1.6 percent for the month, primarily due to a 6.8 percent drop in energy prices.

Dodge said the Fed's decision not to raise interest rates "is consistent with the theme that core inflation is improving." The group said that while interest rates may be raised again, the Federal Reserve is likely near the end of its cycle of raising rates, adding that it expects inflation "to improve in the back half of 2023."

A separate analysis released June 14 by the Associated General Contractors of America said that the price of materials and services used in nonresidential construction decreased 0.6 percent from April to May, while an index that measures contractors' bid prices inched up by 0.1 percent. The AGC said "contractors are finally seeing some relief from recent supply chain problems and price escalations but cautioned that some key materials are still very hard to find and warned that new federal "Buy America mandates" could lead to future price escalations.

"Contractors' bid prices have been virtually flat since January as supply and price shocks from Russia's attack on Ukraine and the pandemic have faded," said Ken Simonson, the association's chief economist. "But there are still exceptionally long lead times for electrical equipment and renewed or persistent price increases for steel and concrete."

Prices for most major construction inputs were stable or declined in May. But the index for steel mill products jumped 5.2 percent, following a 3.6 percent increase in April. The index for concrete products rose for the 30th month in a row, by 0.8 percent, producing a year-over-year increase of 12.5 percent.

However, prices for items like lumber and other wood products are lower, in good part because of the declining single-family residential market. And now structural metal and plastic products "are also experiencing deflationary pressures," Dodge said.

did our state add 700 construction jobs from April to May, but from the 12 months leading up to the end of May 2023, Michigan added 7,700 jobs in the building trades: a 4.2 percent leap in employment, ranking us No. 15 among the states in job gains.

"Contractors remain busy nationwide, with bulging order books for future work," said Ken Simonson, the AGC's chief economist. "But they are having trouble filling job openings when the industry unemployment rate

is only 3.5 percent. That probably accounts for the recent lack of job gains in many states."


Arkansas had the largest percentage increase over the past year among the states (+10.2 percent, 5,800 jobs), followed by Nebraska (+7.8 percent, 4,400 jobs), and then Oregon and Nevada (all +6.3 percent).

A positive sign among the states with job losses is that the declines were minor: over the past 12 months only Connecticut (-2 percent) lost more than 2 percent of its construction work-

force.

The AGC said the biggest challenge to recruiting new workers is that relatively few people are exposed to construction as a career opportunity while they are in school. That is because the federal government invests only 20 cents in career and technical education programs, including construction education, for every dollar it invests in encouraging students to go to college and work in the service sector.

"Many more people would likely be working in high-pay-

Each member must sign the form along with the number of hours they worked. The completed form must be sent back to by hall by the end of the day on the following Monday. Weekend work assignments must be called or emailed into the hall **prior to 3:00 pm on Friday.**

WORK ASSIGNMENTS: Everyone must obtain a work assignment prior to starting work. If you fail to do so you could be written up on charges.

Your name will be removed from the list (14) days after receiving an assignment. It is very important to report to the union hall immediately after your layoff. Members get confused because the S.U.B. Fund allows you a period of up to seven days to apply for S.U.B. benefits after lay-off.

LAY-OFF SLIPS/TERMINATION NOTICES: Lay off slips must accompany all applications for sub pay. Without lay off slips you cannot collect sub pay. It is the **member's responsibility** to make sure they get one from the contractor when laid off. Your application cannot be submitted without one. It is the contractor's responsibility to issue one in accordance with our contract.

S.U.B. BENEFITS: Report to the hall promptly upon layoff. You must complete a S.U.B. Application within seven days from your layoff date or you will forfeit S.U.B. benefits. Lay-off slips must accompany the application to be eligible. Proof of UIA benefit payments must be submitted within 21 days of when you were paid in order to receive SUB benefits. Do not submit your sub applications directly to the fund office. Your application must be signed by the hall or you will not collect benefits.

No slowdown for Michigan construction approaching mid-year 2023

ing construction careers today if they had a chance to learn about the profession when they were in school," said Stephen E. Sandherr, the AGC's chief executive officer. "Showing students that you can work in a team, earn a great living and build projects that will last for decades will encourage more people to pursue careers in construction."

The Dodge Momentum Index of U.S. Construction dropped 2 percent in May, with drops in commercial and institutional

work acting as the major drags.

Said Sarah Martin, associate director of forecasting for Dodge Construction: "Sustained elevation in the federal funds rate and tighter lending standards will likely constrain growth in the Dodge Momentum Index over the second half of 2023. However the index remains above the historical average.

"This paints an optimistic landscape for non-residential construction in mid-2024, as the economy recovers and the Fed begins to pull back rates."

OUT-OF-WORK LIST: You must be on the out-of-work list to collect S.U.B. benefits or SASMI. Members must re-register bi-annually: March 1 through March 20 and September 1 through September 20. If you fail to re-register you will be removed from the list.

SHORT WORK WEEK SUB PAY: If you work 16 hours or less in a week or have a short work week due to weather you may collect sub for that week but only if it is at the **beginning or end of a layoff.** You may NOT collect if you are not laid off. You must complete a sub application at the hall, provide a pay stub for that week and the hall will submit it to the fund office. If you are not laid off and it is due to weather the company MUST provide written documentation that it was weather related.



WORKING ASSESSMENT: Per Article XIX Section 15 (b) of the International Constitution and Bylaws, as of 6/8/2023 the Union office had to begin imposing a daily working assessment for any members working during the strike. The daily working assessment is as follows for each classification:

Mechanic: \$36 per day worked, 1st year Apprentice: \$18 per day worked, 2nd year Apprentice: \$21 per day worked, 3rd year Apprentice: \$25 per day worked, 4th year Apprentice: \$29 per day worked.

The daily assessment went into effect on 6/8/2023, meaning for each day you work during the strike on or after 6/8/2023 you owe the amount listed above that fits your classification. Please note: the daily assessment will continue until a new agreement has been ratified. The Union office has a list of people that are/were manning agreement jobs during the strike. Unless you present a paycheck stub showing less than 5 days worked during the weeks effected by the strike, you will be expected to pay 5 days' worth of assessment for those weeks. It is your responsibility to make sure your financial obligations are up to date. If you have any questions, contact the Union office.

PER CAPITA: Please be reminded, any member working 32 hours or less during a month must pay their own Per Capita of \$14 per month. Per Capita payments should be made **monthly**. If a member works as a traveler in another Local's jurisdiction, the member must remit double Per Capita of \$28. Please forward your payments **monthly** to Local 25, 21353 Bridge St., Southfield, MI 48033.

MUST SAFETY MODULES: In order to be eligible for the stipend, you must contact the Union Office **PRIOR** to taking the safety modules.

Anyone driving a personal vehicle during working hours, Mechanics can carry their personal tools, meter, safety bag and a drill, Apprentices can carry their safety bag. You are not to transport anything for the company in your personal vehicle, if they need something taken out to a job, they have company trucks, boss's trucks, and other means to transport the material.

As you are aware, individuals with a Mechanic Exam Pass Date on or after Jul 9, 2022, must take a Mechanic Required (MR) Continuing Education course in 2023 to receive their scheduled pay raises January 1, 2024. I

highly recommend if you fall in this category and haven't done so, take the course and keep up on it. If you are going to be working in another local's area, you and your Apprentice MUST call their hall to make sure it is ok to work, don't take your supervisor's word for it.

If you start a new job in MOD/construction, you MUST call those jobs into the hall! If you are going to be working a 4/10 job in construction or MOD, it MUST be submitted in writing to the Local Business Representative per Article VII Par. 2A. and Article VIII(A) Par. 2A.

Anyone interested in becoming a State of Michigan Elevator inspector, contact the State of Michigan or call the Hall.

New technology drives Ultium battery plant construction

(Continued from Page 1)

factor, logistically. But battery technology is changing so fast that the process work, the equipment that's coming in, is constantly being re-evaluated. We communicate with the engineers and the design team every day about plans and changes."

Barton Malow is managing the entire project. When it's complete, the Ultium Cells Joint Venture plant, supported by investments from GM and LG Energy Solution, will be the third Ultium Cells plant in the U.S., joining facilities in Ohio and Tennessee.

Sited next to the GM Delta plant, it will supply battery cells for a variety of the automaker's electric vehicle models. The plant will employ about 1,700 once it's

fully operational in late 2024 and it will support an annual battery production capacity equivalent to 50 gigawatt-hours.

The project began last year, and will take more than 500,000 construction hours to build. The building will feature an open floor concept, with a main corridor spanning a length of a half mile.

General Motors and LG Energy Solution are investing \$2.6 billion in the facility in their Ultium Cells joint venture, which will supply battery cells to Orion Assembly in Michigan and other GM electric vehicle assembly plants.

Ghafari, which designed the plant, called it a "sophisticated building" that "will house five distinct phases of cell construction: mixing, electrode, assembly, formation, and shipping – all contained in a massive facility the size of 30 football fields."

The company said the plant's mechanical systems will control both temperature and humidity in clean rooms/dry rooms that span 1 million square feet. Free-standing clean rooms, Ghafari said, allow for future flexibility of process equipment and design within the building envelope.

"Given the rapidly evolving

world of EV (electric vehicles) integrated project delivery and prioritized communication between multiple entities are necessary to maintain the accelerated schedule," Ghafari said.

Ultium Cells said its Lansing facility "will use the most advanced and efficient battery cell manufacturing processes to support annual capacity of 50 GWh. The plant will be extremely flexible and able to adapt to ongoing advances in technology and materials."

The structural steel on the plant was topped out by iron workers in late February. Some 20,000 tons of steel beams, trusses and the like were placed atop 47,000 cubic yards of concrete. At the time Barton Malow Project Manager Chris Peterson told the crowd that he has never managed a project of this size, but the construction team is up to the task. "My pride in this team, in you all, is profound," Peterson said. "This structure is a product of great teamwork. This project is a product of highly skilled tradesmen and women, coming together to build one common goal."

GM predicts that 40 percent of its product portfolio

will consist of battery-powered vehicles by the end of 2025. The Detroit automaker is among the industry's leaders in moving its vehicles away from the internal combustion engine, the powerplant of choice for more than a century from the world's automakers.

Superior Electric Great Lakes Co.'s Eickleberg said last month that the plant is employing 145 electricians. He said beyond the immensity of the plant, their construction team has all manner of other challenges.

They have no less than 59 electrical substations to install. There are lingering material supply chain woes, with shipments to be scheduled and monitored from far-flung plants in South Korea, Poland and Germany. Interested parties on- and off-site include a variety of company representatives and contractors with varying corporate cultures and languages, all working within a battery-making process that is evolving before them.

"The constant flow of new information is something we haven't seen before," Eickleberg said. "What's going on here is remarkable, and we're really part of a modern industrial revolution."

The moose among us

In survey results reported to the Michigan Natural Resources Commission in Roscommon on June 8, the moose population estimate for the western Upper Peninsula was not statistically different from the last moose survey conducted in 2019.

The Michigan Department of Natural Resources has been surveying the western U.P.'s core moose population since 1997, typically every other winter. The 2023 survey marks the first survey completed since 2019 due to scheduling conflicts associated with the COVID-19 pandemic.

"The 2023 moose survey estimate was 426 individuals, which is not statistically different from the 2019 estimate of 509 individuals," said Tyler Petroelje, northern Michigan wildlife research specialist with the Michigan Department of Natural Resources in Marquette. "This continues the trend of plateauing abundance

where population growth over the last 12 years is now less than 1 percent."

Aerial moose surveys are conducted over core moose habitat areas during winter to identify and tally bulls, cows and calves. This past winter's survey was conducted by the DNR during portions of January and February.

The western U.P. moose core range covers about 1,400 square miles in parts of Marquette, Baraga, and Iron counties. Moose were translocated there from Canada in two separate efforts in 1985 and 1987.

The remainder of the U.P. is not surveyed for moose but some pockets of higher quality habitat are occupied by lesser numbers of moose, as seen in the eastern U.P. region. Moose have been observed there since the 1950s.

During the 2023 winter survey, researchers tallied 212 individual moose, which was 20 percent fewer than the 266 moose observed on the 2019 survey. A point estimate indicated a 16 percent decline in moose abundance.

"Looking at demographic data, with respect to previous surveys, we observed a comparable – but low – cow-to-calf ratio and percentage of calf numbers," Petroelje said. "A potentially concerning

observation is the lesser percentage of twins seen during this survey (9 percent) compared to the 10-year average of 15 percent."

Petroelje said fewer twins, in combination with a lesser bull-to-cow ratio, could point to a recruitment issue, which is the number of individuals added to a population over a given time by either births or immigration.

DNR wildlife biologists will continue to monitor recruitment in the population in future surveys to determine whether a trend is developing or if 2023 was a poor calf year.

"Another factor that has affected the moose in the western U.P. is that 2022 was a high year for moose-vehicle crashes," said John Pepin, DNR deputy public information officer in Marquette. "Collisions involved at least 20 moose last year in the western U.P. We remind motorists to watch for moose, especially when traveling at night."

With the Moose Hunting Advisory Council's recommendation to only allow moose hunting if a growth rate of greater than 3 percent is maintained, the DNR is not recommending implementing a hunting season. The same was true over the past several survey result years.

Meanwhile, on Isle Royale in Lake Superior:

Winter study finds wolf count up slightly, moose population drops

Wolves, their count up by three, stabilize and organize. Moose, down by 379, starve and decline. Michigan Technological University researchers discuss the latest populations in the 64th Isle Royale Winter Study.

The annual winter study, led by Sarah Hoy, John Vucetich and Rolf Peterson of Michigan Tech's College of Forest Resources and Environmental Science (CFRES), is the longest-running predator-prey study in the world – now in its 65th year. As always, fieldwork for the winter study of wolves and moose was conducted during a seven-week expedition at Isle Royale National Park. Results were released June 14.

This year, MTU researchers visited the island from Jan. 20 to March 3. They found a stabilized wolf population with a dynamic, somewhat unexpected social organization that includes lone

wolves and small groups outside established packs. They also observed a moose population in dramatic but not unprecedented decline, succumbing to starvation due to a food shortage.

Three or four wolf litters born in 2022. Wolves are thriving, according to the research team. Isle Royale's wolf population is likely 31, including the East Pack with 11 wolves and the West Pack with five wolves, both established since 2019-20. Researchers also observed a small pack formed in the middle of the island – a deviation from the social organization seen over the last few years.

"Prior to the translocation of wolves to Isle Royale in 2018, the wolf population most commonly consisted of three stable packs and a small number of lone wolves," Vucetich explained. "By contrast, over the past 12 months the population appears to be characterized by three to four re-producing groups, of which only

two seem to have well-established territories, and many wolves that are not closely associated with an established pack."

Most of the wolf pups born on the island last year belonged to the established packs. Peterson said three or possibly four litters were born in spring 2022: one at the west end of the island, two at the east end and another probable litter in the middle. Both the East Pack and West Pack had three pups survive the winter, and more pups are expected to be born in 2023.

"During the 2023 breeding season, we observed evidence of four, possibly five, breeding females," said Peterson.

The uptick is a promising development for re-establishing a healthy wolf population. There were no litters observed on the island from 2015-18 – the island's wolf population had collapsed due to inbreeding. After new wolves were brought to Isle

Royale in 2018, there was one litter born in 2019, two litters born in both 2020 and 2021, and potentially four litters in 2022.

"The reproductive success of the wolf population has steadily increased over the last five years. The majority of wolves in the population were all born on the island," said Sarah Hoy, co-leader, Isle Royale wolf-moose study.

Hoy said there are also strong indicators pointing to the continued viability of adult wolves. "Over the past year, the survival of adult wolves was slightly higher than the long-term average observed on Isle Royale," she said. The average life expectancy of a wild wolf is 4.5 years.

The number of moose killed by wolves, another indicator of wolf population health, tallied 26 during the winter study period. That's slightly lower than the previous year, but in line with what researchers expected given the number of wolves and moose

currently on the island, Hoy said.

Food shortages, fewer calves, contribute to rapid decline. Updates on Isle Royale's moose population present a sharp contrast to the wolf observations. As was the case in last year's winter study, the number of moose declined by about 28 percent from the previous count. Overall, the moose population dropped from 1,346 to 967, continuing a downward trend.

The ongoing decline is not unprecedented. Hoy said it's comparable to the population collapse that occurred in the mid-1990s. At this point, moose numbers have shrunk by 54 percent since 2019, when they peaked at 2,060 on the heels of rapid growth from 2010-19.

Adult moose survival rates have declined by 30 percent over the past four years, and many fewer calves are being born.

Researchers, who survey the moose population by air, ski and snowshoe, typically find that

at least 13 percent of the moose counted are calves. This year, it was just 2 percent – the lowest ever observed.

Wolf predation is, of course, a factor. Researchers estimate that wolves killed about 10 percent of the moose population over the last year. It's the highest predation rate observed since 2011, but the increase was expected given the re-establishment of wolf packs on the island. And, the study found that wolf kills were a less significant cause of moose deaths. Starvation killed more moose than the wolves did.

"Starvation appears to be a more important cause of mortality than predation," said study co-leader Sarah Hoy.

"For every moose we found that was killed by wolves, one to three other moose had died of starvation. Forty-six percent of the dead moose we examined over the past year died of malnutrition," Peterson said.
