### UIA staff work OT to process claims

LANSING – Michigan Unemployment Insurance Agency benefits staff are now required to work three additional hours of overtime on weekdays and eight hours of OT on Saturdays to handle the onslaught of jobless claims.

In addition, says a memo by UIA Director Steve Gray, the agency is training 150 UIA staff to help with processing claims, and 100 limited-term workers and 200 contract employees last week were slated to be hired to help clear the backlog.

Gov. Gretchen Whitmer said last week that there have been an "unprecedented 800,000 claims for UIA benefits, and that, 'I want you to know: We will get to you,'" acknowledging the frustration of tens of thousands of claimants who have not been able to file claims with the state. She said the agency is quadrupling staff to meet the need. Claims have been up 3,500 percent from when life was normal.

The new OT requirements, says the news agency MIRS, will add one hour in the morning for UIA staff, and two hours in the evening, to create a 7 a.m. to 7 p.m. 12-hour weekday for staff for a period that will stretch from April 8-21. Weekends, staff will also work 7 a.m. to 3 p.m. on Saturdays. Total OT for staff will amount to 23 more hours per week.

The UIA plans to expand customer contact hours by one hour by making Monday through Friday hours 8 a.m. to 6 p.m., with Saturdays continuing from 7 a.m. to 2 p.m. Lesser amounts of overtime will also be required after that period.

"Many of you have jumped in and taken on new responsibilities and are doing whatever it takes to help Michiganders get through the unfamiliar and stressful time of unemployment," said UIA Director Steve Gray in a memo to the agency's staff. "You've been working long hours in the midst of a health crisis, home-schooling, tele-working and limited food resources. Your commitment to public service has been inspiring."

While acknowledging the delays, the state has said the [www.michigan.gov/uiaweb](http://www.michigan.gov/uiaweb) website is the quickest way to file a claim, particularly if it's done between the non-peak hours of 8 p.m. and 8 a.m.


The UIA has asked that those with the last names starting with the letters A-L are asked to go online Mondays, Wednesdays and Fridays while those with the last names starting with the letters M-Z are asked to visit the site Sunday, Tuesdays and Thursdays. Anyone can file on Saturdays.

Alternatively, the same last name schedule applies with to the UIA's Call Center for applying for claims, the call center can be reached at 866-500-0017.

The agency says where the process takes on average 20-25 minutes. The UIA assures that claims will be back-dated to reflect the date on which the claimant was laid-off.

## Trades transform TCF Center into COVID field hospital

DETROIT – A venue that's more familiar to building trades workers as a (former) destination for setting up the North American International Auto Show has been transformed into a field hospital for accepting COVID-19 pandemic patients.

During this era of The Great Quarantine, it's a sign of some mixed-up times when 250,000 square feet of the city's TCF Center, formerly Cobo Center, is being converted into a temporary medical care space for medical patients stricken with the COVID-19 virus.

The work was undertaken by the U.S. Army Corps of Engineers, Detroit District and their partners among building trades union employers, under an assignment by the Federal Emergency Management Agency (FEMA). The conversion will include two separate floors, where patients will be segregated based on severity of illness. Approximately 600 upper floor beds – with availability of oxygen but not ventilators – will be available for seriously ill patients and a lower floor with 400 beds for patients who are recovering from COVID-19.

"It has been great to see everybody come together to execute this incredibly important mission," said Nick Zager, Chief, Alternate Care Facility Project Office, Detroit District, U.S. Army Corps of Engineers. "We are moving out fast and we are going to make it happen."


"The neat thing about this is even before the ink on the contract was dry, the crews already were starting work. And so there are some incredible things going on in the halls," said Army Corps Major General Bob Whittle, deputy commanding general for the Corps of Engineers and the commander of the Great Lakes vision, to *The Detroit News*. "I've really never seen anything like it. Everyone is leaning forward because they want to help the citizens of Detroit and Michigan. And they're incredibly brave to do it," Whittle added, talking about the crews that were building out TCF.

"It's not when you're in a foreign conflict and bullets are coming at you. Instead, it's an invisible virus that's out there. And so these people are incredibly brave out here working in the face of that

## Mason may be trades' first COVID fatality in MI

Among what may be the first Michigan fatality in the ranks of the union building trades from the COVID-19 virus – and perhaps the very first – is ARon Jordan, a 49-year-old union bricklayer from Ashland, Kentucky, who died March 31 after traveling to Detroit's Zug Island to work at the site's coke battery.

Mr. Jordan was an otherwise

healthy husband, father of seven and grandfather to seven more. A report in the *Louisville Courier Journal* said ARon left his Kentucky home on March 16 to come to Michigan to work. According to the account in the *Courier Journal* as told by ARon's daughter Sarah Jordan, ARon realized he likely had been exposed to someone infected with the

coronavirus at his work site.

But he didn't want to expose his family to the virus, so he self-quarantined in a Detroit hotel room. He told his wife Mandy, but instructed her not to tell the rest of the family, so they wouldn't worry.

The account said ARon went to a hospital in Detroit, but he was turned away because he

## Coronavirus infects U.S. economy, and it's a sick feeling

The U.S. economy fell off a cliff in the second half of March due to the effects of the COVID-19 crisis. And the free-fall may not be over yet.

Where to start, when there are comparisons being made to the not only the Great Recession one decade ago, but the Great Depression nine decades ago. The job losses in the last two weeks of March, erased all the economic gains made during the Trump Administration.

And, economists were stumbling over themselves to tell the public to put aside the end-of-March economic numbers – they were much, much worse because statewide economic shutdowns in Michigan and elsewhere had only been in effect for half the month.

"Job layoffs broke the ceiling again this week, shattering records in a sign this economy has skipped recession mode and moved deep into Depression zone," said Chris Ripley, chief financial econo-

mist at MUFGBank, to the *Washington Post* on April 3.

"The abrupt plunge in economic activity is taking a swift and severe toll on construction," said Ken Simonson, the Associated General Contractor's chief economist. "It will likely be the end of April before we know the full, awful effects of the COVID-19 economic shutdown."

"The U.S. unemployment rate in early March, the number used to mark the entire month, was 4.4 percent," reported Press Associates, citing Bureau of Labor Statistics numbers said on April 3, "as the number of unemployed rose by 1.35 million. And that was before the roof really fell in."

The BLS conducted its jobless surveys, of both workers and businesses, in the week ending March 12. The crash accelerated the next week, thanks to the coronavirus pandemic and accompanying quarantines, shelter-in-place orders and business closures.

## COVID-19 crisis

Michigan grapples with a sickening foe that has brought a halt to life as we know it.

### Work at your own discretion, trades council suggests

In the wake of the COVID-19 crisis, the construction industry in Michigan largely remains in a "Wild West" scenario where owners and contractors are deciding whether to keep jobsites open, and individual workers are making personal decisions whether to go to work based on their own comfort level with the safety of their site.

"We have owners talking about re-starting projects, and we get inquiries about the availability of workers," said Steve Claywell, president of the Michigan Building and Construction Trades Council. "As a council, ultimately our position is that it is the workers' decision together with their local union whether or not he or she works."

While there aren't any Michigan-specific numbers on job shutdowns, the Associated General Contractors of America have conducted surveys of contractors across the U.S. to gauge construction activity. The most recent, reported on April 3, found that 59 percent of contractors in the U.S. report that their projects experienced "delays or disruptions" since the onset of the pandemic.

Patrick Devlin, secretary-treasurer of the Michigan Building and

### UIA chief offers some tips to navigate benefits

LANSING – Michigan's Unemployment Insurance Agency has been overwhelmed over the past few weeks, inundated by an historic influx of newly unemployed workers seeking jobless benefits.

The state UIA has acknowledged the difficulties claimants have experienced with their system, but have pledged that eventually, all of the state's jobless workers seeking benefits will be able to get through to the state via phone or online.

Steve Gray, director of the Michigan Unemployment Insurance Agency, offered to building trades workers some guidance on navigating and understanding benefits.

"We appreciate the patience all Michigan residents have shown with the unemployment system over the last few weeks as we continue to provide emergency assistance during this historical demand," Gray said. "We have seen over a 3,500 percent increase in claims in just two and a half weeks."

Gray suggests:

•If your claim was denied because you were "in school" (some apprentices have experienced this) you will be deemed eligible very shortly if not already. Your old determination will be cleared and a new redetermination will be made or is in the process of being made. Please keep your eye on your online MiWAM account for correspondence or to check your payment was released. You will also likely receive a letter in the mail, however our mail has been back-logged.

•Those who have exhausted their benefits (all 20 weeks) and filed their original claim since March, 15, 2019 (still in your benefit year) need to reopen their claim through their online MiWAM account. Some workers may have been denied because

### Need a union during the pandemic? Don't come knocking here for help, NLRB says

In the midst of the COVID-19 crisis, the anti-union work of the President Trump-appointed National Labor Relations Act continues.

On March 31, the NLRB, with a 3-1 Republican majority, issued a rule making it harder for workers to win and keep a union. The new policy says union elections will no longer be blocked in an atmosphere where there is the presence of pending unfair labor

practice charges at a workplace, but the ballots would be either counted or impounded – depending on the nature of the charges – until the charges are resolved.

"At the same time," said the labor-backed Economic Policy Institute, "the Trump NLRB has suspended all union elections, including mail ballot elections. The decision to finalize this rulemaking at a time when the agency is failing to fulfill its most basic statutory obligation – to enable workers to organize – is a disgrace. Congress must

hold the agency accountable for this decision."

In a statement released March 19, the NLRB said "due to the extraordinary circumstances related to the COVID-19 pandemic, the National Labor Relations Board today approved the suspension of all representation elections, including mail ballot elections, for the next two weeks effective immediately, through and including April 3, 2020.

"The Board deems this action

necessary to ensure the health and safety of our employees, as well as those members of the public who are involved in the election process. Moreover, given the closure of several Regional Offices and limited operations, the Board does not believe that it is possible to effectively conduct elections at this time."

The NLRB said it would "continue to monitor this evolving situation" and determine

## Strengthen the safety nets

The global coronavirus pandemic has put our economy in free-fall. Even through Donald Trump's reckless economic policies, like his pointless trade war with China or his deficit-busting tax cuts for his billionaire donors, the economy has somehow managed to keep chugging along – until now.

All of the stock market gains from Trump's time in office have been wiped out, and over the course of just over one week in March the Dow Jones Industrial Average experienced its five largest drops in history.

Worse than a plummeting stock market, businesses and major industries have been forced to shutter their windows to help combat the rapid spread of the virus, putting hundreds of thousands of workers' paychecks at risk.

A recession is inevitable at this point. Here are three things we can do to prepare.

**No. 1:** We need to reform unemployment insurance so it reflects the needs of today's economy. When it was first created in 1935, unemployment insurance was designed to help full-time workers weather downturns until they got their old jobs back. But there are fewer full-time jobs in today's economy, and fewer people who are laid off get their old jobs back again.

As a result, only 27 percent of unemployed workers receive benefits today, compared to 49 percent of workers in the 1950s. We need to expand unemployment coverage so that everyone is protected.

**No. 2:** We need to strengthen Temporary Assistance for Needy Families, also known as public assistance.

Since its creation in 1996, the number of families receiving cash assistance has declined dramatically – and not because they're doing well. Between 2006 and 2018, just 13 percent of families were lifted out of poverty, while the number of families receiving public assistance fell by 39 percent.

Already weak, the program didn't hold up well during the Great Recession. Funding doesn't automatically expand during economic downturns – meaning the more families are in need, the less money there is to help them. The program also has strict work requirements, which can't be fulfilled in a deep recession. Worse yet, many individuals in need have already exhausted their five years of lifetime eligibility for assistance.

We need to reform the public assistance program so that more families in need are eligible. It should be easier to waive the strict work eligibility requirements during the economic downturn, and the lifetime five-year limit should be suspended.

**No. 3:** We need to protect the Supplemental Nutrition Assistance Program, also known as SNAP or food stamps.

Unlike public assistance, SNAP responded well during the Great Recession. Its requirements are designed to expand during economic downturns or recessions.

Waiving work requirements during the Great Recession made thousands of people in need eligible for the program who otherwise wouldn't have been. Between December 2007 and December 2009, the number of SNAP participants rose by 45 percent. The program helped keep an estimated 3.8 million families out of poverty in 2009.

But that might not be an option this time around, as SNAP has come under attack from the Trump administration, which is trying to enact a draconian rule change that would kick an estimated 700,000 of our most vulnerable citizens off of the program. Luckily, a judge blocked the rule from going into effect, but the administration is still fighting to enforce it – even in the middle of a global pandemic. We need to make sure SNAP's flexibility and ability to respond to economic downturns is protected before the next recession hits.

Stronger safety nets are not only good for individuals and families in need. They will also prevent the looming recession from becoming an even deeper and longer economic crisis.

Construction Trades Council, said in many cases, the building trades are society's "fourth leg" of the stool when it comes to supporting the public, behind police, firefighters and medical personnel. And in many cases, the "essential" tag that Gov. Whitmer has placed on many building trades jobs to allow tradespeople to continue working during the crisis is warranted. "We build and maintain lighting, electrical power, infrastructure, plumbing – our people are key to keeping society operating. But I get it, some people want to keep working, others don't feel safe because of the virus."

Claywell said the Michigan Building Trades Council – a statewide umbrella group promoting the interests of about 100,000 unionized construction workers and their local unions – stands with the state's union workforce whether or not individual workers choose to work during the COVID-19 crisis. For those who have taken a voluntary or forced layoff, that means working with the state Unemployment Insurance Agency to broaden the distribution of benefits, including to potential recipients like non-working apprentices, and to workers who have recently exhausted their jobless benefits under the pre-COVID-19 rules.

On the other hand, for those who are working, the building trades council has, whenever possible, been urging owners, contractors and contractor associations to provide proper PPE for workers and to maintain other CDC standards, like social distancing, whenever possible.

Claywell and Devlin said there would be obvious legal implications for anyone – in the labor, contractor or owner communities – to set some sort of "requirement" for workers to work during the COVID crisis, especially if a worker should contract the virus on the job.

"Again, we are not directing members to go to work, or not to go to work," Claywell said. "But everyone should be aware, that there is at least one owner who is distributing false information that their work has been deemed essential. Now they have a serious problem with the attorney general's office."

## Trades transform TCF Center into COVID field hospital

Michigan Governor Gretchen Whitmer said in her announcement of the effort, "We are proud to partner with the U.S. Army Corps of Engineers, FEMA and the TCF Center to expand capacity in Detroit. By mobilizing quickly to construct a large alternate care facility in Detroit, we can help save lives." Last week the Army Corps announced that a second 1,000-bed field hospital in Southeast Michigan would be set up at the Suburban Collection Showplace in Novi.

The facility opened to patients on April 8, well ahead of schedule. The state is leasing TCF, formerly known as the Cobo Convention Center, through Sept. 30 at a cost of nearly \$8.2 million. It's still not clear how much of the facility can be staffed with medical professionals, who are already overworked at their own facilities.

Kristin Aussiker, an IBEW Local 58 journeyman, was one of the tradespeople who helped transform the TCF Center.

She posted the following on Facebook: "As some of you know TCF Center (Cobo) is being transformed into an emergency field hospital. As most of you may not know, while the Army Corps of Engineers and National Guard assemble beds, your proud local tradespeople are performing the work necessary to make this transition possible.

"Carpenters are building each of these 'rooms.' Plumbers (98) are providing piping for clean water and installing sinks at all the nurse stations. IBEW Local 58 electricians are providing power to each and every of roughly 1000 'hospital rooms' to facilitate the use of necessary medical equipment; to nurse stations and to hot water heaters so that hand washing can happen properly; as well as installing fire

alarm systems to match the new layout.

"None of us HAVE to do this particular job. Each and every one of us either volunteered or said 'yes' when asked, because even though we are aware of potential risks THIS IS WHAT WE DO. THIS IS WHAT NEEDS TO BE DONE.

"We are here doing what we can to help society during

this craziness. Look out for each other. Appreciate each other. Help one another. It's the only way we're getting through this.

"Thank you to all of my brothers and sisters out there working to create space to care for the ill in our communities and those maintaining the existing places so that people, our people, can get the care they need."

whether additional extension of this suspension may be necessary.

"The new rule would eliminate the NLRB's 'blocking charge' policy, which permits the delay of union election results if the employer is accused of union-busting or coercion," writes Brian Young for the Union Communications Blog. "It would also allow a de-certification campaign to start just 45 days after an election and with as few as 30 percent of the workforce supporting a de-certification effort. This would give bosses much more power over a union election."

The EPI added, "at a time when more and more workers are voicing concerns over the terms and conditions of their work as the entire country grapples with the COVID-19 pandemic, workers are being forced to work without adequate protective gear or sick leave if they or their family members get sick. As a result, workers at places like Amazon, Instacart, and Whole Foods are walking off the job to demand stronger protections, and many are seeking to form unions."

In addition, the EPI said "at a time when many workers deemed 'essential' during the COVID-19 pandemic are navigating issues of health and safety, and looking for ways to have their voices heard, it is unconscionable that the agency responsible for ensuring workers have the right to a voice in the workplace has denied them the ability to exercise these rights."

# BUILDING MICHIGAN:

## St. Clair Rail Tunnel

### HISTORY IN THE MAKING By Marty Mulcahy

Historically in Michigan, for land-based vehicles and rail traffic, engineers have had to devise ways to get through, over and under the Great Lakes and their associated waterways, using bridges, ferries and tunnels.

In the 1880s, with the lakes taking up an enormous amount of geography in the middle of the North American continent, and with westward expansion ever-increasing in the United States and Canada, going under or above the Great Lakes was seen logistically as a lot less costly and time-consuming than going around the lakes.


“There was one major challenge for the Grand Trunk Railway” which owned track from Canada’s eastern seaboard to the Great Lakes, says *Detroit 1701*. “Everything and everybody had to be unloaded in Sarnia (Ontario), put on a ferry for the short ride across the St. Clair River and then back onto railroad cars for the continued trip to Detroit or Chicago.”

Enter the Port Huron to Sarnia rail tunnel. Completed in 1891, the tunnel extended under the St. Clair River for 2,290 feet, and was the first underwater tunnel on Earth between two nations. It allowed the easy movement of Grand Trunk rail traffic connecting Atlantic Ocean shipping ports in Canada and the north-eastern U.S., with hubs in Detroit, Chicago and points south and west.

In 1882, engineers opined that soil conditions along both banks of the St. Clair River precluded construction of a bridge. That meant building a tunnel under water – but at the time, that was easier said than done. Designers were watching construction of the first tunnels under the Hudson River between New Jersey and Manhattan, which were progressing very slowly.

Grand Trunk finally committed to building the tunnel in 1887, having earlier formed the St. Clair Tunnel Co.

“Perhaps because of this lack of precedent for a work of such size, nothing was done immediately,” said the Smithsonian Museum of History and Technology. “In 1884 the railway organized a tunnel company; in 1886 test borings were made in the riverbed and small exploratory drifts were started across from both banks by normal methods of mine timbering. The natural gas, quicksand, and water

encountered soon stopped the work.” In the 1880s, the Smithsonian said, pioneering engineers learned “the three fundamental elements essential for the practical tunneling of soft, water-bearing ground: compressed-air support of the work during construction, the movable shield, and cast-iron, permanent lining. The marriage was a happy one indeed; the limitations of each system were almost perfectly overcome by the qualities of the others.”

With some funding from the Canadian government, construction began in January 1888, with crews working on both sides of the river.

“The tunnel was an engineering marvel,” says *Detroit 1701*. “Underneath many broad rivers, the soil is soft and porous making digging challenging. The new shield method used for this tunnel involved excavation in a compressed air environment. A cast iron lining was put in place as the digging progressed. The crews met at the appropriated location on Aug. 30, 1890.”

The Beach Tunneling Shield, designed by Alfred Ely Beach, removed material from the site and was used to assist workmen in removing material from the route of the tunnel and left a continuous iron tube in place. The portal-to-portal length of the tunnel is 6,025 feet, and the structure’s diameter is 19 feet, 10 inches. The \$2.7 million tunnel was completed and opened

But there was still one big problem for the tunnel in the Age of Steam: steam from locomotives. And, smoke and embers could suffocate crews and passengers, especially if a train were stalled in the tunnel. There is no record of that happening, but in 1908, Grand Trunk ordered a set of powerful electric engines that pulled trains during their short tunnel journey, and such electric powered locomotives were used until the whole North American rail system went to diesel-electric locomotives in the late 1950s.

Ironically, in the 1970s, rail ferries over the St. Clair River made a comeback. Some new double-stacked train cars were too tall for the nearly 20-foot tall tunnel, and the ferries were the only option to move the goods. So, in 1995, the railroad completed a new \$155 million, 27.5-foot-tall tunnel parallel to the old tube.

Today, the old, pioneering tunnel remains in place, unused, but it set an example for those that followed. “As the first major subaqueous tunnel completed in America and the first in the world of a size able to accommodate full-scale rail traffic, the St. Clair Tunnel served to dispel the doubts surrounding such work, and established the pattern for a mode of tunneling which has since changed only in matters of detail,” said the Smithsonian.

(Continued from Page 1) the system was not yet updated and was reading that they had exhausted, they are now eligible for up to six additional weeks. Once UIA implements the federal CARES Act they will be eligible for an additional 13 weeks and will receive the \$600 weekly benefit assistance.

•Everyone currently receiving UI benefits or soon to be during this crisis is allowed the 13 additional weeks (total of 39) and \$600 weekly on top of what they

otherwise are owed as soon as the UIA is able to implement the federal CARES program. The 13 additional weeks are available until Dec. 31, 2020. The \$600 weekly assistance is available until July 31, 2020. The \$600 will automatically be applied to your benefits, no further action is needed. Continue to certify as usual.

The Agency is awaiting guidance from the USDOL on the CARES program, Gray said the UIA expected the \$600 and 13-week additions will be active

## Coronavirus infects U.S. economy, and it’s a sick feeling

“Things deteriorated so fast in the last half of March that a mid-month measure will not come close to capturing the current state of the labor market,” said Economic Policy Institute analysts Heidi Shierholz and Elise Gould on April 3. “In the coming weeks, we expect millions more job losses as the economy continues to contract. Based on estimates from Goldman Sachs, we expect 19.8 million to be laid off or furloughed by summer, even accounting for the effect” of the \$2.2 trillion stimulus law Congress enacted, they said. That could bring the total to 30 million – a level unseen since the Great Depression.

“The unprecedented increase in unemployment claims demonstrate the economic hardship that COVID-19 has caused for so many across our country and here in Michigan,” said Jeff Donofrio, director for the Department of Labor and Economic Opportunity. In Michigan, more than 300,000 residents filed for unemployment in the last week of March. That more than doubles the 128,000 who filed during the prior week.

The nonpartisan Congressional Budget office reported on April 2 that it “expects that the economy will contract sharply during the second quarter of 2020 as a result of the continued disruption of commerce stemming from the spread of the novel coronavirus.”

In addition, the CBO said the nation’s unemployment rate is expected to exceed 10 percent during the second quarter.

That’s because 10.236 million more people had filed first-time claims for jobless benefits since March 12 through the first week in April, according to the BLS. And 6.64 million people first-time filed jobless claims in the week ending March 28. “The 6 million new unemployment claims is just the tip of this iceberg of loss,” East Lansing-based economist Patrick Anderson of the Anderson Economic Group, on April 2. “I expect 90 percent of those losing income have not filed for unemployment, particularly those who are self-employed or in small businesses struggling to keep their doors open.”

Name a category of workers, and that area saw people laid off in March, with worse to come. Besides the bars and restaurants, the retail trade shed 46,000 workers, construction dropped 29,000, factories reported shedding 18,000, including 2,200 in cars. Even laundries lost 13,000 jobs. And you couldn’t find temp work, as that category shed 50,000. And 19,000 day-care workers lost jobs.

The CBO said it expects the gross domestic product to decline by more than 7 percent during the second quarter. “If that happened,” the Congressional Budget Office said, “the decline in the annualized growth rate reported by the Bureau of Economic Analysis would be about four times larger and would exceed 28 percent. Those declines could be much larger, however.”

## Construction industry struggles to navigate the COVID-19 world

LANSING – Gov. Gretchen Whitmer’s Executive Order No. 2020-21 on March 24 has just enough ambiguity to prompt Michigan’s construction industry to collectively say... maybe... when it comes to deciding whether their project(s) can continue during the COVID-19 crisis.

Under the order, a business cannot require workers to leave their homes unless the workers are “necessary to sustain or protect life or to conduct minimum basic operations.”

Furthermore, under the order, “Some limited forms of construction are permissible, including construction to maintain and improve essential public works like roads, bridges, the telecommunications infrastructure, and public health infrastructure. Construction workers may also undertake such projects as necessary to maintain and improve the safety, sanitation, and essential operation of residences.

“In addition, businesses may designate construction firms to provide necessary support to the work of the businesses’ critical infrastructure workers. All construction work that is carried out while the order is in effect must be done in accordance with the mitigation measures required under section 5(c) of the order.”

Contractor and contractor association responses to the directive, to say the least, are varied. In general, Small Business Administration of Michigan President Brian Calley told MiBiz “there is a tremendous amount of confusion around what’s in and what’s out.”

North America’s Building Trades Unions and the Associated General Contractors of America are all-in when it comes to keeping the construction industry humming. NABTU President Sean McGarvey and Associated General Contractors of America CEO Stephen E. Sandherr issued a joint statement urging government officials to exempt construction work from regional, state and local work shutdowns.

“Government officials at all levels should treat the construction industry and the work it performs as vital and essential to the critical industries that must remain in operation.

They added: “Labor and management construction industry partners continue to monitor and provide guidance on all recommended health and safety job site precautions for construction workers so that proper measures are deployed to ensure a safe work environment for those on the job.”

The websites of most of Michigan’s major construction contractors earlier this month were completely silent on COVID guidance.

On April 1 the Michigan Infrastructure & Transportation Association said they “officially asked Gov. Whitmer to deem all construction field operations as non-essential to protect the health and safety of industry employees and to allow for all Personal Protective Equipment (PPE) to be focused on the front lines of the COVID-19 pandemic (at hospitals and medical facilities). After discussing the request with the administration, MITA Executive Vice President Mike Nystrom issued the following statement:

“We respect the governor’s decision to continue work on state projects where and when our contractors and their workers can stay on the job in a safe manner. Our understanding is that essential construction projects will proceed where possible and where the health and safety of workers can be protected following the universal precautions recommended by public health agencies and the U.S. Centers for Disease Control and Prevention.

“Michigan Department of Transportation projects will continue unless it is determined that there are COVID-19 concerns that precipitate a delay or shutdown. Local agency and other critical infrastructure projects can also proceed, if the local government owner deems the project essential with the above public health conditions and precautions also being respected.”

MITA, which primarily works with the state DOT, further clarified that “the cornerstone of the agreement is that a contractor, who has workforce concerns and/or other project impacts directly related to COVID-19 (labor force shortages, supply chain challenges and/or PPE concerns), can make those concerns and impacts known to the Department and request the project be shut down (delay). The Department will agree to shut down (delay) the project, with the acknowledgement that an extension of time for the delay will be granted.”

The Associated General Contractors of Michigan’s April 6 update said the group is “continuing discussions with the governor and her administration about getting all of Michigan’s construction industry back to work,” and earlier said they have been “aggressively working with Governor Whitmer’s office to clarify which construction is exempt from the Stay at Home Executive Order.”

The national AGC group added: “The construction industry and the work it performs is vital and essential to the critical industries that must remain in operation to respond to this pandemic and crises to come. AGC is lobbying Congress to specifically add construction to the U.S. Department of Homeland Security’s guidance on critical industries whose workforce should maintain their normal work schedules.”

**Brothers and Sisters,** Your Officers and Myself hope this letter find you and your family safe during these strange times. I'm sure this will be one of those once in a lifetime memories of a holiday weekend none of us will soon forget. I completely agree with our Governor's decision to extend the stay at home order until the end of this month. Even though the CDC and our affiliated Governmental agencies have seen the epidemic peak in our state and have stopped the building of surge centers in our state or at least in our jurisdiction for now. Detroit Mayor Mike Duggan, our county executives, Oakland County Dave Coulter, Macomb County Mark Hackel and Wayne County's Warren Evans, have been working tirelessly with their staff to get our members to anyone who needs us. I pray all these relationships here and across our country will continue and move our nation forward. This virus does not care if you are a Democrat or a Republican. If you are not working stay home.

Our Local 98 PAC committee has come out in support of past V.P. Joe Biden for President of the United States. With all the twisted things that Washington and our great state has done to the working class and every Local Union in this country, it did not take long to come to this conclusion. That does not mean in any way shape or form we have

I can't hold a gun to your head but please wear a mask and gloves, I personally seen many members who will not wear a mask, my hats off to Macomb guys whose wives all made them masks. We are looking for Residential and Service Plumbers at this time, when we get the green light to return to work, it will be a great chance to expand and grow again as many members are looking to retire. So if you know anyone working nonunion or is a past member that may be interested in us, have them call 98's Organizer Rob Moses on his cell phone 248-763-2187.

The new U.A. Union cards are available at the hall when you pay your 2020 Union dues, these cards are good for 2020, 2021 and 2022. If by chance you are in arrears and you are struggling financially, please contact the hall and make arrangements. We do not want to fine anyone for something that can be avoided.

If you are thinking of retirement or are having any issues relating to SUB, Unemployment or Benesys please contact Jon on his cell phone or at the hall at 248-762-9238. Sorry to say but we have run into problems with the new UA cards as there is no way to know if a person is current. Jon has been able to make a second card to be carried to our meetings as well as job sites, this second card can now be stamped monthly or yearly as we have done in the past.

Now all of our members and stewards on the jobs will not have to waste time calling the hall to see if another member is current. Our hope is this will not only stop accidental reinstatement fee's from occurring but this will help examining board members at union meetings who are at the door checking cards to lessen any confusion.



**KALAMAZOO – COVID-19 UNION UPDATE:** As we are moving into unprecedented times as it relates to the Coronavirus, please take precautions and be respectful of others. **UNEMPLOYMENT FILING: All Eligible Workers Will Receive Benefits** – The UIA assures that every eligible worker in Michigan who applies for unemployment benefits will receive them. The UIA will be accepting claims and benefit applications back-dated to reflect the date on which the claimant was laid-off due to COVID-19, beyond the previously established 28-day period (\$600 federal payment is only retroactive back to March 28).

**Historical Demand** - The latest U.S. Dept of Labor report shows that since March 15, more than 800,000 Michigan workers filed for unemployment, a more than 5,000 percent increase. Michigan has seen a record number of claims each of the last three weeks.

# Painters Union seeks COBRA subsidies in COVID-19 aftermath

International Union of Painters and Allied Trades (IUPAT) General President Ken Rigmaiden is calling on Congress to subsidize COBRA health plans for 11 million U.S. construction workers who may lose their jobs as the COVID-19 virus "spreads and wipes out the sixth largest employment sector in America."

"The construction industry is the backbone of the U.S. economy. If Congress fails to take additional steps to support blue-collar construction workers, the short-term and long-term consequences will be dire for every industry," Rigmaiden said. "Supporting construction workers begins with ensuring they have access to medical care and prescriptions by shoring up the health coverage that thousands are losing every day as layoffs sweep across the industry."

COBRA (The Consolidated Omnibus Budget Reconciliation Act) is a health insurance program that allows eligible employees and their dependents the

continued benefits of health insurance coverage in the case that an employee loses their job or experiences a reduction of work hours.

The IUPAT estimates that at least 50 percent of construction sites across the country have already been shut down, and fears that number could rise as high as 90 percent. The union said it is working with industry stakeholders to develop new best practices and safety protocols for active jobs and essential job sites, and is calling on Congress to do its part in protecting the health of the millions of families that face potential loss of coverage in the construction industry and beyond.

The AFL-CIO, a federation of 55 labor unions representing 12.5 million workers, issued an executive council statement last month that also advocates for emergency subsidies to cover COBRA health insurance payments.

Nationwide trends indicate that sites could be shut down entirely. Major U.S. construction stoppages in Michigan, San Francisco, Boston, Pennsylvania, in addition to nationwide private and local site shutdowns, have workers experiencing anxiety and uncertainty.

"Congress had a chance to grant real relief to this vulnerable workforce and didn't. These financial assistance proposals are a band-aid when we need a tourniquet. Working people are being hit with waves after wave of setbacks - finances, healthcare loss, and now an indefinite date for a job to go back to. The IUPAT is demanding urgent assistance for America's working people before they are bled dry and before this economy bleeds dry," said IUPAT General Vice President Jimmy Williams. "We're already behind and the clock is ticking. Congress and the Senate need to get in front of this with bold action and subsidize COBRA benefits so that the millions of workers facing the very real possibility of indefinitely losing their jobs have a very real option for health coverage."

"In the midst of a pandemic, it is more important than ever that our nation ensures workers can go to the hospital without fear of financial ruin," said Michelle Hennessey, a commercial painter and mother of two. "Any worker who has been laid off; is immunocompromised and unable to work; or is responsibly participating in isolation or quarantine shouldn't have to choose between putting food on the table and the health and safety of themselves, their family and the public."

In addition to the subsidization of COBRA health plans, the IUPAT's "Bold Action Platform for Working Families" urges Congress to secure retirement plans affected by the crisis and invest in American infrastructure to quickly put construction workers back to work.

plication within seven days from your layoff date or you will forfeit S.U.B. benefits. Lay-off slips must accompany the application to be eligible. Proof of UIA benefit payments must be submitted within 21 days of when you were paid in order to receive SUB benefits. Do not submit your sub applications directly to the fund office. Your application must be signed by the hall or you will not collect benefits.

**OUT-OF-WORKLIST:** You must be on the out-of-work list to collect S.U.B. benefits or SASMI. Members must re-register bi-annually: March 1 through March 20 and September 1 through September 20. If you fail to re-register you will be removed from the list.

**SHORT WORK WEEK SUB PAY:** If you work 16 hours or less in a week or have a short work week due to weather you may collect sub for that week but only if it is at the **beginning or the end of a layoff.** You may NOT collect if you are not laid off. You must complete a sub application at the hall, provide a pay stub for that week and the hall will submit it to the fund office. If you are not laid off and it is due to weather the company MUST provide written documentation that it was weather related.

The future of work will also be reshaped as we determine Covid-19 and the effect it has on the economy. **COVID-19 Guidance from The Center for Construction Research and Training**

In response to the construction industry's questions regarding the COVID-19 outbreak, the following are steps everyone should be taking now:

- If you are feeling sick do not go to work.
- Don't shake hands when greeting others.

• Try to stay three to six feet away from others in gatherings, meetings, and training sessions.

• Avoid contact with sick people.

• Avoid touching your eyes, nose, or mouth with unwashed hands.

• Clean your hands often by washing them with soap and water for at least 20 seconds or using an alcohol-based hand sanitizer that contains 60%-95% alcohol. Soap and water should be used if hands are visibly dirty.

• It is especially important to clean hands after going to the bathroom, before eating, and after coughing, sneezing or blowing your nose.

Construction industry employers should also:

• Provide soap and running water on all jobsites for frequent handwashing.

• Provide hand sanitizer when soap and running water are impossible.



Upon registering you can take the Free Health Assessment test and find instant results that can lead to living a healthy lifestyle.

**BLUE CROSS APP-** Download the Blue Cross/Blue Shield of Michigan app for your smartphone. Search for "BCBSM" on the Google Play app or Apple store. Benefits to utilizing the app include: instant access to EOB's, a virtual ID card on your phone, information on deductibles, explanations of coverage and other helpful tips related to your Health Care coverage. EOB's can be downloaded to smart phones or computers and used to substantiate WEX receipt requests.

**WEX APP-** Search for the "TIC HRA" app in Google or Apple and download it today. Utilization of this app will give you access to account balances, receipt reviews and submittals, barcode scanning for covered items, other helpful services.

Please call me at the hall if you have any questions about the process that the Executive Board came up with to address the Pandemic and our meeting dates. This is to alleviate exposure to Covid 19 at an in-person meeting and still try to keep our election on course per US Department of Labor Requirements that Covid 19 is NO EXCUSE for union members to not keep an election schedule. Apparently the USDOL thinks union members are immune to Covid 19.

Nominations and Election dates subject to change to address COVID-19 response.

**ELECTIONS** - In Accordance with Article 16 of the IBEW Constitution and Article 3 of the Local Union #498 Bylaws, there will be a special order of business during the Regular membership meeting of Wednesday May 6, 2020. The purpose of the special order of business is for the nomination of Local Union #498 Officers, Delegate, and Alternate to the International Convention. Officers will be elected to three-year terms, commencing July 8, 2020 and concluding July 12, 2023. A member must have two years of continuous good standings in the local immediately prior to being nominated and must be present to accept the nomination, or must submit, to Recording Secretary Ryan Lautner, not later than noon of May 6, 2020 their written willingness to be nominated.

The written notice of nomination shall specify a single office that they are willing to be nominated to. No member may be a candidate for more than one office. No Apprentice shall be eligible to hold office in the Local Union as stated in Article III, Section 8 (e) of the Local Union bylaws. Nominations shall include President, Vice-President, Recording Secretary, Business Manager/Financial Secretary, Treasurer, Executive Board (six to be elected), Examining Board (five to be elected) and Alternate to the IBEW Convention. An election judge and tellers will be appointed at the close of nominations. None of these may be a candidate for any office.

Ballots are to be mailed on May 15, 2020 and will be picked up for counting at noon on June 10, 2020 from the post office and counted at the union hall. The election results shall be announced immediately after all ballots are counted. In the event a run-off election is required ballots will be mailed no later than June 16, 2020 and will be picked up at noon on July 1, 2020 from the post office and counted at the union hall with the results immediately following. All officers shall be installed and begin their 3-year terms at the regular meeting of the Local Union on July 8, 2020. Any member who believes a protest of the election is warranted is urged to contact the election judge within a few days after the ballots are counted. Further protests of the election may be filed in writing with the International Vice President of the 6th district within 30 days following the election.

The decision of the International Vice President shall conclude the processing of a protest within the IBEW. In the event the protesting member is not satisfied with the decision of the International Vice President, the member may submit his/her protest to the U.S. Department of Labor. Get involved and run for an office. Even if you only serve one three-year term you will gain a much better understanding of how the Union is run and a much greater appreciation for the members that serve us.



## HR 748, the CARES Act: What the Bipartisan COVID-19 Stimulus Means for UA Members

### Expanded Unemployment Insurance

The CARES Act expands unemployment insurance (UI) in four key ways: (1) expanded access to UI benefits; (2) increased amount of UI payments; (3) extended duration of UI benefits; and (4) eliminated waiting periods.

#### For workers who qualify for regular Unemployment Insurance:

- All weekly benefits increased by \$600 through July 31
- Mandated "waiting periods" are waived
- Benefits can be received additional 13 weeks beyond what is typically allowed
- Covers unemployment for *any* reason

#### For workers who would not qualify for regular Unemployment Insurance:

- Independent contractors, sole proprietors, those without wage history, and others are now eligible
- Up to 39 weeks of UI benefits available to individuals impacted by COVID-19
- All weekly benefits increased by \$600 through July 31
- Mandated "waiting periods" waived

### Paid Sick Leave and Expanded Family Medical Leave

- Paid sick leave expanded to cover employers with less than 500 employees. All employees are eligible.
- If you are unable to work due to public isolation orders, self-quarantine, or COVID-19 symptoms and diagnosis, you are entitled to full sick pay.
- If you are caring for a family member subject to self-quarantine, or a child due to childcare closures, you are entitled to paid leave (2/3 of your regular wages).

### Prevailing Wage on COVID-19 Related Construction Projects

- US Army Corps of Engineers (USACE) has confirmed that prevailing wage will be paid on federal contracts to construct temporary hospitals.
- The CARES Act provided \$10 billion in funding to airports, with construction covered by prevailing wage provisions.

### Individual Recovery Rebates

- Individuals with Adjusted Gross Income up to \$75,000 (\$150,000 married) will receive a \$1,200 payment.
- Individuals are eligible for an additional \$500 per child.
- Rebate amount is reduced on a scale for incomes up to \$99,000 (\$198,000 married).
- Amount is completely phased out above that threshold.

# Amazon fires walkout leader over COVID-19 response

NEW YORK (PAI)—Amazon's arbitrary firing of Cristian Smalls, who led a walkout from the monster retail distributor's Staten Island, N.Y. warehouse over the coronavirus threat to himself and his colleagues, has drawn both union flak and a potential investigation by state Attorney General Letitia James.

Smalls raised concerns about exposure of himself and his colleagues to another worker who tested positive for the coronavirus, officially known as COVID-19. He cited Amazon's "lack of safety protocols" for the workers at the warehouse.

"We're not asking for much. We're asking the building to be closed and sanitized, and for us to be paid," Smalls told CNN before the walkout from the firm's JFK8 warehouse. He called it a "virtual breeding ground" for social transmission of the coronavirus.

When Amazon responded with vague statements dismissing the workers' concerns - even though New York City, including Staten Island, is the current U.S. epicenter of the coronavirus pandemic - Smalls, a 31-year-old assistant manager, led more than a dozen colleagues in the March 30 walkout.

About 20 Amazon workers in Michigan also walked out of the company's Romulus warehouse on April 1 to protest work conditions, fearing for their health and pointing out that three of their coworkers had the COVID-19 virus.

An Amazon spokesperson said the company goes "to great lengths to keep the buildings extremely clean and help employees practice important precautions such as social distancing and other measures."

Aggressively anti-union Amazon, owned by Jeff Bezos, one of the three richest people in the U.S., responded by accusing Smalls of "violating social distancing guidelines and putting the safety of others at risk" himself, a charge Smalls denied on his Twitter feed.

Then Amazon arbitrarily, and on the face of it illegally, fired him that afternoon.

Amazon also responded it's cleaning the Staten Island warehouse, but refused to close it. It had no response to a petition signed by more than 6,000 warehouse workers - and counting - nationwide, demanding stronger worker protections against the virus's spread.

Including the Staten Island worker who tested positive, at least 13 other Amazon warehouse workers have contracted the virus, *Forbes* reported.

Smalls' firing angered Stuart Appelbaum, president of the Retail, Wholesale and Department Store Union, an UFCW sector, and prompted New York AG James to both demand the National Labor Relations Board launch an labor law-breaking - formally called an unfair labor practices - investigation and start one of her own.

"Workers should be protected when speaking out about safety conditions during this crisis. They are performing a public service. It is unacceptable that Amazon has terminated Chris Smalls for doing that today rather than addressing their serious COVID-19 safety problems," Appelbaum said.

## Interim Guidance for Implementing Safety Practices for Critical Infrastructure Workers Who May Have Had Exposure to a Person with Suspected or Confirmed COVID-19

To ensure continuity of operations of essential functions, CDC advises that critical infrastructure workers may be permitted to continue work following potential exposure to COVID-19, provided they remain asymptomatic and additional precautions are implemented to protect them and the community.

A potential exposure means being a household contact or having close contact within 6 feet of an individual with confirmed or suspected COVID-19. The timeframe for having contact with an individual includes the period of time of 48 hours before the individual became symptomatic.

Critical Infrastructure workers who have had an exposure but remain asymptomatic should adhere to the following practices prior to and during their work shift:

- Pre-Screen: Employers should measure the employee's temperature and assess symptoms prior to them starting work. Ideally, temperature checks should happen before the individual enters the facility.
- Regular Monitoring: As long as the employee doesn't have a temperature or symptoms, they should self-monitor under the supervision of their employer's occupational health program.
- Wear a Mask: The employee should wear a face mask at all times while in the workplace for 14 days after last exposure. Employers can issue facemasks or can approve employees' supplied cloth face coverings in the event of shortages.
- Social Distancing: The employee should maintain 6 feet and practice social distancing as work duties permit in the workplace.
- Disinfect and Clean work spaces: Clean and disinfect all areas such as offices, bathrooms, common areas, shared electronic equipment routinely.

If the employee becomes sick during the day, they should be sent home immediately. Surfaces in their workspace should be cleaned and disinfected. Information on persons who had contact with the ill employee during the time the employee had symptoms and 2 days prior to symptoms should be compiled. Others at the facility with close contact within 6 feet of the employee during this time would be considered exposed.

Employers should implement the recommendations in the Interim Guidance for Businesses and Employers to Plan and Respond to Coronavirus Disease 2019 to help prevent and slow the spread of COVID-19 in the workplace. Additional information about identifying critical infrastructure during COVID-19 can be found on the DHS CISA website or the CDC's specific First Responder Guidance page.

**INTERIM GUIDANCE**

This interim guidance pertains to critical infrastructure workers, including personnel in 16 different sectors of work including:

- Federal, state, & local law enforcement
- 911 call center employees
- Fusion Center employees
- Hazardous material responders from government and the private sector
- Janitorial staff and other custodial staff
- Workers - including contracted vendors - in food and agriculture, critical manufacturing, informational technology, transportation, energy and government facilities

**ADDITIONAL CONSIDERATIONS**

- Employees should not share headsets or other objects that are near mouth or nose.
- Employers should increase the frequency of cleaning commonly touched surfaces.
- Employees and employers should consider pilot testing the use of face masks to ensure they do not interfere with work assignments.
- Employers should work with facility maintenance staff to increase air exchanges in room.
- Employees should physically distance when they take breaks together. Stagger breaks and don't congregate in the break room, and don't share food or utensils.

DNR Q&A during the COVID crisis



Answers to your questions during the COVID-19 crisis, by the Michigan Department of Natural Resources.

**Can I still go fishing?** Yes. The governor's executive order states that individuals may leave their home or place of residence, and travel as necessary, to engage in outdoor activity, including walking, hiking, running, cycling, or any other recreational activity consistent with remaining at least six feet from people outside an individual's household.

**Can I still go boating?** Non-motorized boating, such as kayaking, canoeing and sailing, falls within the outdoor activities permitted under the "Stay Home, Stay Safe" Executive Order. Any outdoor activity, including boating, must be done in a manner consistent with social distancing, and individuals should use only their own equipment to prevent the transmission of the virus through the touching of shared surfaces. Additionally, persons not part of a single household may not boat together.

While some boating is permitted under the order, the provision of boating services or supplies does not itself constitute critical infrastructure work. Accordingly, marinas, canoe liveries, and other similar businesses and operations may not designate workers to come to work for that purpose. As needed, however, these businesses and operations may designate workers to leave their home for work if their in-person presence is strictly necessary to conduct the minimum basic operations. Minimum basic operations do not include serving members of the public, but do permit work necessary to maintain the safety and sanitation of sites otherwise open to the public for outdoor recreation.

**Am I able to use my motor-powered boat for recreational purposes, including fishing?** No. Under the governor's revised "Stay Home, Stay Safe" Executive Order 2020-42, physical outdoor activity, such as kayaking, canoeing and sailing, remains

permissible. However, the use of a motorboat, jet ski or similar watercraft is not permitted for the duration of the Executive Order, which is currently set to expire at 11:59 p.m. April 30.

**Will the DNR extend the term of 2019 fishing licenses?** No. The new license year began April 1. On that date, anglers will need a 2020 fishing license and to follow regulations set in the 2020 Michigan Fishing Guide.

**How can I get a new fishing license or 2020 fishing guide?** Fishing licenses may be purchased online and either printed at home or downloaded to mobile devices that are carried with you. The 2020 Michigan Fishing Guide is available online. [www.michigan.gov/dnr](http://www.michigan.gov/dnr)

**Are DNR boating access**

**sites open?** Yes. Boating access sites remain open, but restrooms at these facilities are closed and other amenities, such as courtesy piers, may not be available. State harbors and marinas are closed.

**Do I still need a Recreation Passport to access boating access sites and other recreation areas?** No. This requirement has been suspended temporarily.

**Does my boat need to be registered with the Secretary of State when it is not allowing title transfers at this time?** Yes. The Secretary of State is able to process boat registration renewals online. The office is not able to process title transfers electronically. [www.michigan.gov/sos](http://www.michigan.gov/sos)

**Are state parks open?** Yes. State parks, state forests, recreation areas, scenic sites and other

state-managed lands remain open to help provide the public with places to hike, run and otherwise engage in healthy outdoor activities, with the exception of Tippy Dam Recreation Area in Manistee County, which is closed to visitors. Visitors should not travel long distances, unless it is for a purpose considered critical under the governor's "Stay Home, Stay Safe" Executive Order. This type of nonessential travel could unintentionally increase the spread of COVID-19.

**By keeping state parks open, doesn't this contradict the governor's executive order?** No. The executive order states that individuals may leave their home or place of residence, and travel as necessary, to engage in outdoor activity, including walking, hiking, running, cycling, or any other recreational activity consistent with remaining at least six feet from people outside an individual's household. Long distance travel is discouraged unless it is for a purpose considered critical under the governor's "Stay Home, Stay Safe" Executive Order.

**Do I still need a Recreation Passport to get into a state park or other recreation areas?** No. This requirement has been suspended temporarily.

**Are family picnics allowed on state forest lands?** State forest campgrounds are closed to camping, but the lands are not closed. The executive order states that individuals may leave their home or place of residence, and travel as necessary, to engage in outdoor activity, including walking, hiking, running, cycling, or any other recreational activity consistent with remaining at least six feet from people outside an individual's household.

Visitors should not travel long distances, unless it is for a purpose considered critical under the governor's "Stay Home, Stay Safe" Executive Order. This type of nonessential travel could unintentionally increase the spread of COVID-19.

**Can I go camping at a state**

**park or state campground?** No. State park and state forest campgrounds are closed through at least April 13.

**Am I able to make reservations for camping or overnight lodging?** Overnight lodging is closed until May 15. Reservations for lodging after that date are being taken. At this time, camping reservations can be made for dates April 14 and beyond. From April 14 - May 15, campgrounds at state parks will remain semi-modern, with no shower building open, and rates will reflect this. Normal rates will apply after May 15 for camping and overnight lodging.

**Are off-road vehicle and all-terrain vehicle trails still open?** Yes. State-managed trails remain open for public enjoyment. However, grooming and other maintenance operations have ceased temporarily. Long distance travel is discouraged unless considered critical. Riders must observe all social distancing requirements in the Governor's "Stay Home, Stay Safe" Executive Order and remain at least six feet from people outside an individual's household.

**Is hunting still allowed?** Yes, licensed individuals may still hunt while following social distancing guidelines. The executive order states that individuals may leave their home or place of residence, and travel as necessary, to engage in outdoor activity, including walk-

ing, hiking, running, cycling, or any other recreational activity consistent with remaining at least six feet from people outside an individual's household.

**How can I get a hunting license?** Hunting licenses may be purchased online and will be mailed within 7-10 business days. Unlike fishing licenses, kill tags are not sent via email and cannot be downloaded. The physical kill tag must be used.

**Can I cut fuelwood on state forest lands?** The start of the season for cutting fuelwood from dead or downed trees in Michigan's state forest is delayed until May 1. The public is asked to apply for fuelwood permits by mail. DNR staff recommends that you visit the site where you plan to cut before applying for a permit. The quality and quantity of dead wood varies by location.

Current maps of areas where cutting will be allowed are online. Permits are for use on designated state forest land in the Upper Peninsula and the northern Lower Peninsula. Permits allow for collection of up to five standard cords of wood per household. Wood is for personal use only and cannot be resold or traded.

**Do I need an ORV/ATV permit to ride?** Yes.

**How can I get an ORV/ATV permit?** Permits are available online at [Michigan.gov/DNRLicenses](http://Michigan.gov/DNRLicenses).
