Momentum remains for U.S. construction The Dodge Momentum Index for U.S. construction continued to climb, improving 9.6 percent from September to October.

On a year-over-year basis, said the Dodge Construction Network on Nov. 7, the DMI was 28 percent higher than in October 2021, the commercial construction component was up 29 percent, and institutional planning was 25 percent higher. The index was pushed up by a total of 15 projects with a value of \$100 million or more that entered planning in October.

The index is a monthly measure of the initial report for nonresidential building projects in planning, shown to lead construction spending for nonresidential buildings by a full year.

"The sustained upward trajectory in the Momentum Index shows optimism from owners and developers that projects will continue to move forward, even with rising concerns of an economic recession," said Sarah Martin, senior economist for Dodge Construction Network

"Specific nonresidential segments, such as data centers and life science laboratories, have thrived in 2022 and continue to support strength in planning activity. As we move into next year, however, labor and supply shortages, high material costs and high interest rates will likely temper planning activity back to a more moderate pace."

Growing Shouldice takes diverse approach to building its business

BATTLE CREEK - From its century-old roots as a sheet metal fabrication shop primarily catering to local cereal makers and farm industries, Shouldice Brothers has evolved into a diversified industrial equipment fabrication company that has, to put it mildly, expanded its customer base.

Today, Shouldice's management leaders and its building trades union workforce continue to service the needs of local customers like Post Foods, and a host of Michigan-based customers. But the company also proudly displays a pair of push-pinned map of locations around the country - and around the world – where its products are shipped, or where its services are employed.

Company president and co-owner Dan VanMiddlesworth - whose father purchased the company in 1997 after four Shouldice generations operated the firm - said Shouldice was strictly a sheetmetal manufacturer until his dad took over and moved it into a "multi-trades approach," expanding its services and product offerings. Today, in addition to sheet metal workers, the company also has an in-house staff of union carpenters, electricians, iron workers, laborers, millwrights and pipe trades workers. And they expand their workforce as necessary by hiring more of those and other union trades as job requirements necessitate. New Dem majorities in House and Senate: 'great news for labor'

LANSING - Well, that was unexpected.

The Michigan Senate hasn't seen a Democratic majority, incredibly, since 1983. But following the Nov. 8 election, a 20-18 Dem advantage will exist in that governing **** body starting in Januvote 2022 ary.

Perhaps more surprisingly, Democrats, through the state's voters, also wrestled control of the state House from Republicans, winning a similarly slim 56-54 majority after the Nov. 8 election. Dems haven't controlled the House since 2009.

Combined with Democratic Gov. Gretchen Whitmer's reelection, state Dems have unified control over all the lawmaking power levers in Michigan, and have essentially been given a once-in-a-lifetime opportunity to set public policy in the state. "For the first time in a gener-

In Michigan: Labor 'ensured victory for legislators who will support working people'

WASHINGTON, D.C. -With better results for pro-worker candidates than the pundits predicted in the Nov.

8 election, AFL-CIO President Liz Shuler **** said workers propelled Vote 2022 their favorites to victory in key races. She also reiterated workers would continue to defend democracy and "commit to strengthening the organizing wave that is reshaping America."

"It's clear the tireless orga-

this year in many races," Shuler said. "At a time when big corporations and the wealthiest among us are doing better than ever, workers are facing steep challenges to just make ends meet. Extremists in Congress aren't offering solutions to the problems working families face. Their only interest is rewarding the corporations and wealthy individuals that bankroll their campaigns while working people pay the price."

Republicans won control of the House of Representatives, as expected, but by a much smaller

PHILADELPHIA (PAI)-Rampant company labor lawbreaking led to a unionization vote loss for the independent Home Depot Workers Union at the first store they targeted, in northeast Philadelphia. The Nov. 6 vote was 51-165 among 224 eligible workers.

The company law-breaking was so bad that three weeks before the balloting, HDWU had already filed a complaint with the National Labor Relation Board's Philadelphia regional office, saying bosses illegally quizzed workers about their union views and illegally spied on them, too.

HDWU had approximately a week to file more charges with the board, and to argue the lawbreaking was so bad the NLRB should throw the results out and order a rerun. NLRB previously did so in ordering a second vote, a year after the first election, among workers at Amazon's giant warehouse in Bessemer, Ala

HDWU may seek rejection of the first vote. News reports and tweets quoted Vince Quiles, 27, the five-year worker and union founder, as saying Home Deport also "flooded the store with managers" brought in from other stores to campaign against and vote down HDWU.

"Not shocked. Home Depot hates unions and makes employees watch anti-union propaganda twice a year. The fact that this vote even happened is huge though!" a tweeter named JimmyV38 wrote via the More Perfect Union group's thread.

DTE Energy and Consumers its "Clean Vision" plan, a 20year proposal by the utility to "dramatically transform how the company generates electricity as part of its clean energy journey."

"The proposed plan increases investment in solar and wind energy, accelerates the retirement of coal plants, and includes the development of new energy storage - all reinforcing DTE's commitment to cleaner energy,' the utility said in a statement.

The plan would:

•End DTE Energy's use of coal in 2035 "with a responsible, phased retirement schedule of the Belle River and Monroe coal power plants, which account for approximately 40 percent of the company's current energy mix."

•Accelerate the retirement of coal at the Belle River Power Plant (rated at 1,260 megawatts) to 2026 from 2028.

•Launch the phased retirement of the Monroe Power Plant (3,279 megawatts), one of the largest coal plants in the country, in 2028, nearly 12 years earlier than the original planned date of by 2040, "supported by future 24/7 emerging technologies." Two of the units at the Monroe Power Plant would be retired (Continued on Page 3)

Inflation transcends hopeful economic numbers

Are we seeing the first signs of a highly sought "soft landing" for the U.S. economy – or is a recession is on the way?

In general, the nation's economic numbers are pretty good - as they are more narrowly in the construction industry. But the ugly, all-enveloping backdrop of higher prices for gasoline, building products and consumer goods is casting an immense shadow over the entire economy.

"The labor market is a key factor in the equation of how we measure our economic health," writes Rebecca Rainey and Chris Marr for Bloomberg Law. "Fri-

from the U.S. Labor Department showed that businesses added 261,000 new jobs in October – above expectations - and earnings went up from the month prior.

While unemployment ticked up slightly to 3.7 percent, the report suggests that the labor market is still tight. Another DOL report released earlier last week showed 10.7 million job openings at the end of September, suggesting that employers are still struggling to find workers."

U.S. employment is strong, day's (Nov. 4) employment report but cooling, as are wage hikes,

which are historically good compared to recent years. Wages are up 5.2 percent for the 12 months ending in September, but that decelerated to a 3.9 percent increase over the past three months of that period.

The bigger news on Nov. 4 from the U.S. Department of Labor was regarding construction workers' wages: The average hourly earnings in construction went from \$33.41 in October 2021 to \$35.27 in October 2022, an increase of 5.6 percent, 1.2 percent higher than the increase in total private sector earnings for

'Just Build It' exposes high schoolers to construction apprenticeships

YPSILANTI – The longest-running and most comprehensive career exploration program in Michigan extended its run in 2022, with the "Just Build It" Career Expo taking place on Oct. 18 at Eastern Michigan University's Convocation Center.

The Washtenaw Contractors Association hosted the annual event, providing students in grades 8-12 and their teachers and counselors exposure to building trades union apprenticeships. The event included hands-on activities, with demonstrations by industry professionals such as architects and engineers, exhibits by construction firms and educational and industry organizations.

Since the expo was introduced, more than 34,000 students from 178 schools and 12 counties from southeast and central Michigan have participated.

A new day in Lansing

One of the little-known facts about state government over the past four decades is that Democrats have not held unified control over the governor's seat and both the state Senate and House since 1982.

It's a fairly remarkable under-the-radar-Michigan situation: Republican have held a majority in the state Senate since 1984, and thus have had veto power or input into every single law that has been adopted in our state in the last four decades.

Certainly, that might not necessarily a negative - if the levers of state government were controlled by a balanced government, with a Dem in the governor's chair or with Dems controlling the state House at the same time. But primarily by having unified majorities in place, as old decades have rolled into new, the GOP has consistently controlled the re-districting process, which has helped their candidates win elections.

That is, until this year's election, when a nonpartisan citizens redistricting committee re-drew the state's district lines more equitably, resulting in fairer distribution of voters.

Republican lawmakers have held power - or at least had veto power – in the state for so long, that it's easy to forget all the damage that they have done to the Michigan labor movement. It is true that there were some Republican lawmakers who support prevailing wage and hated the idea of right-to-work in Michigan. But not nearly enough.

"The thing is, there isn't much more the GOP can do to screw the labor movement in Michigan," one labor lobbyist told us at the end of the Rick Snyder administration four years ago, "What else is there?" Some of the worst damage to organized labor came during years of complete GOP control during the Snyder Administration, from 2010-2018.

For the entire labor movement in Michigan, easily the biggest affront from the Michigan GOP came in the form of passing a rightto-work law in 2012. Backed by the deep pockets of the Devos family, it was the ultimate middle finger to the state's labor unions, allowing workers in a bargaining unit to avoid paying union dues while enjoying the benefits of a collectively bargained contract.

Right-to-work was adopted with the argument that it would make Michigan more business-friendly. But a decade later, there not been a single academic study published supporting the idea that Michigan has benefited or become a more business-friendly state with the passage of right-to-work. It was simply a way to screw the state's unions.

Then came GOP-led vote in 2018 to repeal the state's Prevailing Wage Act of 1965. It was a complete Republican cooperative effort with the anti-union Associated Builders and Contractors, whose contractors thrive on the low-wage business model, helping them to under-pay workers and win construction contracts.

There were other easy-to-forget actions by Republican lawmakers during this century that checked off the wish lists of their big business donors. Unemployment insurance week benefits for workers were permanently reduced from 26 to 20 - an action that made Michigan the first state in history to reduce benefit weeks.

The Republican Legislature "intercepted" a successful statewide petition drive that would have raised the minimum wage in 2018 with automatic increases tied to the inflation rate - and then the GOP instituted a lower wage.

One of the first items on Gov. Snyder's plate was impose a new 4.35 percent tax on pensioners in Michigan. It was a direct offset to a \$1.8 billion business tax break.

A law state Republicans adopted in 2012 prohibits public employees' unions from negotiating for anything but salary and prohibits school districts from collecting union dues through a payroll deduction – an onerous paperwork headache for unions.

The GOP then inserted themselves onto construction jobsites: the apprenticeship ratio for the electrical industry was lowered from one journeyman to one apprentice, to one journeyman to three apprentices - in another nod to their friends in nonunion contracting.

In 2011, Public Act 165 was signed into law: the GOP took away the right of local governments to enter into construction project labor agreements. It was an absolute repudiation of their professed values of local control and common sense – since big companies have been successfully, and voluntarily, been using union-only PLAs

"Each of our divisions feeds off each other, we help each other, and we're a team that knows what each other are doing," Middlesworth said. "For us, that cooperation has really helped smooth out the peaks and valleys in this industry, and it has helped keep our people busy and employed. Plus we have sought out more opportunities for expansion into different industries, and that diversification has made us a better company."

Founded in 1907, today Shouldice employs between 130-150 workers, having expanded from 15 in the mid-1990s. It utilizes a pair of fabrication shops: their main 55,000-square-foot location is at their Elm Street headquarters, which is being eyed for significant expansion; the other at its 18,000-square-foot piping shop 2.5 miles away on Dickman Road.

Shouldice has grown in part by undertaking unique projects. One contract last summer had them moving the entire manufacturing operation of Snyder's Lance (think snack foods like pretzels) from its location in Stockton, Calif. to a facility in Charlotte, North Carolina. Similarly, they moved entire operations for Hormel from Nebraska to Iowa, and those of Simplot foods from Arkansas to Washington State.

Those type of projects have to be done quickly and skillfully, as the companies have a limited amount of product backlog to accommodate any delays. Sometimes local tradespeople accompany Shouldice project managers to move and set up the equipment, more often they hire from local unions at the sites.

They have also shipped products to a host of European countries, as well as to locations in Asia, Mexico and South America. But the bulk of the project and customer push pins on the office map are in Michigan. Shouldice offers design-build services for a wide variety of customers. A"turnkey" approach allows the company to perform a project from A-Z, starting with computer-aided design, to in-house manufacture of equipment to delivery, to installation, to start-up.

They manufacture and install power piping, as well as other specialized piping systems such as for renewable energy - one stainless system they're currently working on will serve a Michigan methane plant.

"We work really well with the union halls, and we're proud of the people we have working for us," Van Middlesworth said. "The nice thing about working with our skilled trades is that we can expand and contract with the times, depending on our

workflow. We have great people; fantastic workers."

The Shouldice management team have all come out of the trades, and includes: President and co-owner Dan VanMiddlesworth, Vice President of Construction Trades and company co-owner John Reed; Vice President of Mechanical Trades Randy Sample, and Piping Division Manager Jeff Warren.

"The morale here is very high, we all work very well together, and help each other out," Reed said.

levels are up 266,000, or 3.6 percent, from a year earlier.

"The construction sector would likely have added more jobs in October if only firms could find people to bring on board," said Stephen E. Sandherr, the AGC's CEO. "Labor market conditions are so tight, however, that the sector barely increased in size even as demand remains strong for many types of construction projects.'

The wage hikes, while substantial, have still been no match for the inflation rate, which is at levels not seen since the early 1980s – but they're dropping. From a political and pocketbook perspective, the elevated Consumer Price Index has trumped just about everything.

Inflation slowed to 7.7 percent in October from 8.2 percent in September. It's the fourth straight month of moderation since inflation hit a peak of 9.1 percent in June

The inflation numbers have been worse in construction, with input costs for materials jumping 12.6 percent from September

back of labor share (as corporate profits remain high)."

The aforementioned "soft landing" for the economy would look like lower interest rates, strong employment, and lower prices for goods and services without the nation seeing two consecutive quarters of a drop in gross domestic product – the technical definition of a recession.

President Joe Biden said the latest jobs report "shows that our jobs recovery remains strong," and dismissed criticism from Republicans that the economy is headed toward a recession. Biden's handing of the high inflation rate is getting low marks

among the public.

The Republican National Committee called the Nov. 4 numbers "the worst jobs report of the year, the worst jobs report of the Biden presidency, and the second fewest jobs added since the COVID recovery began."

Josh Bivens, director of research at the Economic Policy Institute, sees a somewhat rosier future for the economy. "There is substantial disinflation in the pipeline that will allow inflation to normalize in coming months even if the labor market remains strong," he said. "Policymakers can't ignore the latest deceleration in wage growth for a soft landing."

for decades. There is no logical explanation for the law other than it reduces the potential for union contractors to win work.

In 2012 alone, the Michigan AFL-CIO counted 89 anti-labor bills on the GOP agenda. The state's unions spent many resources that year and every other subsequent year in the Snyder Administration playing defense and fighting anti-union legislation. It was exhausting.

With Democrats unexpectedly winning control of state government for the first time in four decades on Nov. 8, a full day hadn't passed before Lansing lawmakers and the people whispering and shouting in their ears started talking about the possibilities of what could be done, and undone, for working people, for tax policy, for regulations – for... you name it. It can only get better.

The Democratic takeover in Lansing is a welcome change for the labor movement in Michigan, and it should come as no surprise that nearly every candidate on the election endorsement list in the past few issues of this paper was a Democrat. Conversely, and tellingly, a look at the anti-union ABC's website showed a contingent of 100 percent endorsed Republican candidates.

There will be many union members who prioritize their own issues when voting, and that's fine. But it's important to point out why labor unions, their leaders and many of their members are happier today with the Dems taking over: they can finally start planning how to bring life back into the labor movement, instead of trying to fend off its death by a thousands cuts.

Shouldice performs custom fabrication of sheet metal for various food industries - spe-

cialized items like dryers, tanks, drums and conveyors - meeting their upgraded needs for hygienic and sanitary installations. And it has won projects to serve the various plant needs of automotive manufactures and their suppliers, like BMW in South Carolina and American Axle in Three Rivers, as well as pharmaceutical and paper industries, and others.

Their electric division does everything from lights to motor controls to high voltage installations and automation. The company also performs traditional iron work and rigging.

Shouldice employs union tradespeople performing service work at local plants, and a smaller but growing part of their portfolio is working on area construction projects.

2021 to September 2022, although the prices started to dip slightly at the end of that period. The Federal Reserve, which

controls interest rates, has sought to cool the nation's economy by lowering demand and making money more expensive to borrow by raising rates paid by borrowers. But when they see strong employment numbers, the panel tends to keep rates higher, seeking to lower demand, and prices, for goods and services. Federal Reserve Chairman Jerome Powell has called the U.S. labor market "overheated" and said the current pace of wage gains is "well above" what would be consistent with their 2 percent inflation target.

"Overall," said the laborbacked Economic Policy Institute, "today's report was fairly strong with notable signs of cooling, particularly in wages. Wage growth over the last three months is consistent with long term productivity and inflation targets and a reasonable claw

BUILDING MICHIGAN: Detroit's State Theatre HISTORY IN THE MAKING By Marty Mulcahy

In Detroit, the State Theatre perhaps isn't an architectural icon, like its over-the-top neighbor, the Fox Theatre, located a couple of doors down Woodward Avenue.

But it's still a beautiful, historic, remarkable venue that Detroit is lucky to have - in a city that hasn't exactly had a stellar record of keeping its architectural gems away from the wrecking ball.

Completed in 1925 as the State Theatre, the facility is approaching its 100th anniversary as a busy concert and event venue. It was given its current moniker - Fillmore-Detroit, as part of a national re-branding in 2007 - and it has been named and renamed over the decades as the Palms-State, the Palms and even "Clubland" for a couple of years in the early 1990s. For our purposes, we're going to call it by its original name, the State.

Located within a 12-story office building along Woodward Avenue just north of **Grand Circus Park (and today** across the street from Comerica Park), the State was part of a slew of movie/ vaudeville/ stage venues that were erected in Detroit in the 19-teens and 1920s. The State and the midrise Palms office building it was built into, were designed by C. Howard Crane, who moved to Detroit in 1904 and spent some time working for another legendary Detroit architect, Albert Kahn.

"Crane designed the 12-story, terra cotta-sheathed building in the Renaissance Revival style for theater mogul John H. Kunsky's chain of movie houses," writes Dan Austin for Historic Detroit. "The theater itself is six stories tall and is in the back of the building. The theater was one of the city's larger movie houses, seating just shy of 3,000 people. But it was a more subdued affair" compared to the Fox Theatre.

Detroit once boasted scores of historic movie theaters, and certainly has seen its share of theatre demolition over the years – the United Artists (1928) on nearby Bagley Street is in the process of being taken down.

Says the American In*titute of Architects Guide to* theaters, designed between Detroit Architecture: "Like the **Crane-designed Fox Theatre** next door, the State was of the many ornate movie palaces built in the Grand Circus Park vicinity in the 1920s, and too, was encased in a larger office building." By 1925, said Michigan History Magazine, "when Detroit's elite Grand Circus Park area held 25,000 theater seats, Crane had designed the Madison, Adams, Capitol and State theatres for Kunsky.' To its credit, the city has managed to retain one of the finest collections of centuryold entertainment venues in the nation. Orchestra Hall (1919), The Detroit Opera House (1922), Masonic Theatre (1926), the Fox (1928), the Fisher Theatre (1928) the Music Hall (1928) and the Gem (1928) all survive. Crane also designed Orchestra Hall.

sides of the house."

Crane "designed aesthetically pleasing approaches to the balcony so patrons wouldn't feel inferior to those holding main floor seats," said Michigan History Magazine.

The building and theatre remain, but "modernization" in the mid-20th Century left its mark.

"Like many Detroit landmarks," says Historic Detroit, "the Palms Building was modernized in the late 1950s or early 1960s. This stripped the lobby and floors of much of their original splendor. The first floor of the building's exterior also was destroyed, covered in a concrete and given aluminum storefronts. **"Fortunately, the theater** itself was largely sparred and still maintains much of its glamor. However, when the theater was converted from a movie house to a concert venue, its floor seating was ripped out to provide for standing room events. The balcony and mezzanine levels still have their seats, however."

New Dem majorities in House and Senate: 'great news for labor'

(Continued from Page 1) state's right-to-work law and fully reinstituting the Michigan Prevailing Act (which was rescinded by the GOP in 2018).

The day after her victory over GOP challenger Tudor Dixon, Whitmer pledged to "step on the accelerator" to change the direction of the state, pledging to "focus on solving problems, not demonizing others." She added: "We have come a long way, Michigan."

Tennis said four years ago, when Dems (incorrectly) thought they had a chance to win the House and Senate, their top priority would have been repealing the state's right-to-work law, and reinstituting prevailing wage wasn't far behind. He expects Dems to push similar priorities upon being sworn in in January, but he cautioned that with such narrow margins in their majorities - and a number of new lawmakers – perhaps not everything will be a slam dunk for passing the wish list of organized labor.

In recent years Michigan House Democrats formed a "Labor Caucus," intent on pursuing legislation that promoted the needs of workers and labor unions. There was zero chance of passage of any of their proposals in the GOP-dominated Legislature, but that didn't stop the group from promulgating an array of ideas last February under the heading: "Legislative Package That Puts Workers First."

"We wouldn't have made the progress we've made for workers' rights if not for the unions, organizing and collective bargaining that got us here," said state Rep. Terry Sabo (D-Muskegon), chair of the Labor Caucus, who lost his re-election on Nov. 8.

Their proposals would rescind a host of anti-labor laws adopted by the Republican-led Legislature, and introduce new laws helpful to organized labor.

Suggested were laws that restore allowing school districts to collect union dues or fees via payroll deduction, and prohibiting the use of replacement workers during labor disputes.

The 34-point package would also prohibit health care facilities from using taxpayer money to deter unionization, and enact the "Workers' Freedom Act" to protect an employee's right of association and free speech and provide a check on employers

forcing their employees to listen to anti-union, religious and other political rhetoric, among others.

The group also wants to amend the Public Employment Relations Act to require every public sector employee's employment introductory packet to contain information about their rights to organize, join or assist a labor organization and bargain collectively through representatives of their choice.

Tennis also suggested that the building trades and the rest of organized labor would be pushing to restore apprentice-tojourneymen ratios that had been weakened during the Snyder administration, as well as restore the ability of local governments to enter into project labor agreements for construction projects (as private sector employers do all the time).

And he said the playing field should be leveled on a 2015 GOP law, which imposed new paperwork requirements on union workers wishing to have union or political deductions taken from their paychecks.

"The results of this election did come as a surprise," Tennis said. "There was a blue wave in Michigan, but there was also a red wave, and Dems did just a little bit better. For the state, I think the biggest benefit is that this is going to be a win for the continued existence of organized labor – if they target removing right to work and stopping the attacks on our ability to work. The results are great news for labor."

DTE Energy hastens its breakup with coal

by 2028, while the final pair of DTE's coal-fired units are planned to end generation in 2035 instead of 2040. The Monroe plant creates about 30 percent of DTE's energy portfolio, which services about 2.3 million customers in Michigan.

"Across the country, and here in Michigan, the energy landscape is changing rapidly and fundamentally," said Jerry Norcia, chairman and CEO, DTE Energy. "We are excited to drive this transformation by powering the grid with Michigan-made renewable energy, existing nuclear and natural gas. These new solar and wind assets, enough to power approximately 4 million households, will replace our retiring coal power plants, resulting in a cleaner environment for Michigan families, communities and businesses."

Closure of the coal burners will mark the end of an era for that form of energy production in Michigan-and for generations of building trades workers who have enjoyed good incomes building and maintaining the Monroe and Belle River plants and others that have been retired or are moving in that direction.

Certainly the plan will benefit the environment: DTE said the closures would achieve 85 percent CO2 emissions reductions by 2035, on the way

to meeting a net zero goal by 2050.

The replacement energy has to come from somewhere, and the DTE plan proposes accelerating wind and solar production to the tune of more than 15,000 MW of energy, enough to power about 4 million homes. The utility also said it plans to more than double their current energy storage capacity to 1,800 MW.

Overall, DTE said it also plans to invest \$9 billion into Michigan's economy over the next decade, supporting 25,000 iobs

"This transformational plan is complimented by our announcement last year to invest an additional \$8 billion to modernize the electric grid," Norcia said, "making it more resilient to extreme weather and more reliable as we plan for increased customer demand."

Built into what was originally the Palms Realty Co. Building, it had retail spaces at the ground level and office spaces occupying the upper nine floors.

The \$2 million State Theatre "opened with great fanfare on Oct. 29, 1925," said DiChiera's paper. She cited a contemporary newspaper article that said Kunsky had "added another monument to his already lengthy string of palatial theatres dedicated to the art of motion picture presentation...."

Her paper added: "Crane truly did create a palatial environment in the State Theatre. The local papers raved over the massive marble staircase leading to the mezzanine, the dazzling colors of blue, gold and touches of pink, and the 'oriental canopies' on both

Both the Palms Building and theater were added to the National Register of Historic Places on Nov. 25, 1984.

Today The Fillmore-Detroit is a musical concert/special events venue, with a seating capacity of 2,900. Live Nation assumed operation of the venue in 2007 and announced the new Fillmore Theatre name. The site's lobbies were restored in the 1990s, and the three-story grand foyer and proscenium in the auditorium underwent more recent restorations.



ALMOST ABSURDLY ornate by today's standards, the State Theatre in Detroit was built in an era of over-the-top theatre architecture. Commenting on all the ornamentation, theatre historian Ben Hall said the design of the State and others were examples of architects gone wild. "During the 1920s, "these pleasure domes gave expression to the most secret and polychrome dreams of a whole group of architects who might otherwise have gone through life doomed to turning out churches, hotels, banks, and high schools. Big money suffocates democracy

America exists today as a bizarre anomaly – we profess to be an electoral democracy, yet we are ruled by a governmental plutocracy.



One especially gross example of this incongruity is the overwhelming power of big money over the people's will. By a wide margin, Americans of all political stripes want to ban the distorting force of huge, electoral campaign donations by favor-seeking corporations and ultra-rich elites. Yet... nothing. National and state lawmakers take the plutocratic money and promptly bury democratic reforms that could stop the gusher of corrupt cash.

An analysis of donations in this year's congressional races shows that this plutocratic perversion of our politics and government has reached absurd levels. Historian Nancy McLean and public interest advocate Frank Clemente have documented that the two main Super-PACs trying to put Republicans in Congress got about half of their \$188 million election fund from just 27 billionaires.

Also, a corporate front that backs GOP candidates, Club for Growth, got nearly \$35 million from only three billionaires.

Thanks to years of congressional stonewalling and the steady partisan stacking of our top courts with corporate idealogues, there is essentially no limits on this purchase of lawmakers. Indeed, the biggest donors are even allowed to undermine democracy in secret, not revealing their identity.

The money-dealing in politics translates directly into anti-democratic public policies. Lawmakers elected with this money not only support the billionaires' special-interest agenda (which the people don't want), but also are fierce opponents of any reforms to increase voter participation in our governing process (which people do want).

That's why, for example, efforts to guarantee every eligible American a Constitutional right to vote have not moved forward in Congress – even though the great majority of people favor it. It's a simple political equation: Plutocratic money quashes democratic will, producing plutocratic public policies.

Work Report. The first and most important thing I am going to say about the work outlook is supply issues continue to slow or stall projects. This is our work outlook to the best of my knowledge.

Ongoing projects in our jurisdiction that may require additional manpower include: Nelson Electric – GM Powertrain work started on October 3rd and will run through the end of the year. Swan Electric – Multiple DTE natural gas pumping stations throughout Zones 1 and 2. This project just as many others have seen delays due to supply issues. J.Ranck Electric – continuing work on phase 1 of the SK Siltron semi-conductor chip manufacturing facility, the second phase of which is valued at over \$300 million and slated to kick off in January 2023. Ranck Electric has also secured the Balance of System work on a Solar Farm in Gladwin County. Goyette Mechanical continues PFAS filtration and mitigation work in Oscoda.

Countyline Power has secured upcoming wastewater treatment facility work at Sagining Eagles Landing in Standish, multiple pump stations in the Mt. Pleasant and Clare areas, MDOT Welcome Center remodel in Clare, and runway lighting at Gladwin Airport.

Bay City's Karn 3 & 4 seems to be remaining operational until 2031, which will likely lead to multiple electrical projects this Fall. Robinson Industries in Coleman plans to rebuild facilities damaged in their recent fire, our contractors are expected to secure that work and hire late this year. Northpointe Distribution Center (Frito Lay) has been secured by Clements Electric. You have been seeing dirt being moved on this project with steel to follow in the next couple weeks.

Future projects we are keeping an eye on include North Peak Brewing in Bay City, and further De-sugarization Process upgrades at Michigan Sugar.

Rest assured both organizers and myself are working very diligently to secure whatever work is being bid in our jurisdiction for our membership. Detroit, Traverse City and Lansing may soon have calls getting into Book II if you are looking to travel. Please contact the hall if you would like to sign any books.

Organizers Report. After a hectic midterm election, labor-endorsed candidates were very successful in gaining the electorate's trust through the ballot box. We also expect our elected officials to deal with issues such as combatting inflation, increasing unemployment compensation, continued investments with infrastructure improvements, supporting our public schools, and population retention by providing jobs that pay a livable wage. SUBSTANTIATION REQUEST: Many members have been receiving Substantiation Request letters from the Local 292 Benefit Fund office. IRS regulations require that every use of the Benny Card be substantiated or validated as an eligible covered expense under the Plan. This validation is required by the IRS, the Fund cannot make exceptions. It is the member's responsibility to ensure all requested documentation be returned to the Fund office in a timely manner. By not responding to the Substantiation Request letter, your Benny Card may be suspended until all requested documentation has been received. If you have any questions, contact BeneSys at 248.641.4992 or the Union Hall. **DUES**: Membership dues are required to be **paid in advance** of the month for which they are due. The union hall is not open on Saturday or Sunday, therefore, if you pay dues on either of those days, it will not be processed until Monday. If you are on suspension warning, your dues are 60 days late. To avoid suspension, dues must be paid online or at the union hall by 4:00 p.m. on the last business day of the month. Payments received after 4:00 p.m. on the last business day of the month will not be processed and you WILL go suspended. All members are responsible for making sure any required fees, i.e. late fees or service fees, are included if paying online (sheetmetal292.com).



ACCIDENTAL DEATH and DISMEMBERMENT IN-SURANCE FROM OUR INTERNATIONAL ASSOCIATION: Members who have their dues paid in advance (prior to the month of the accident) are eligible for accidental death and dismemberment benefits up to \$7,500.00. This benefit comes as a dues paying member of SMART International.

WEEKEND WORK ASSIGNMENTS: Saturday and Sunday work assignments. Please remember that when performing work on a Saturday or Sunday the steward must report it to the hall, give each member's name and obtain a form for signatures. Each member must sign the form along with the number of hours they worked. The completed form must be sent back to by hall by the end of the day on the following Monday. Weekend work assignments must be called or emailed into the hall prior to 3:00 pm on Friday.

WORK ASSIGNMENTS: Everyone must obtain a work assignment prior to starting work. If you fail to do so you could be written up on charges.

LAY-OFFS: All members must report to the Union Hall immediately upon lay-off, even if you only work one day. These are the By-Law rules for the Out-of-Work List. Your name will be removed from the list 14 days after receiving an assignment. It is very important to report to the union hall immediately after your layoff. Members get confused because the S.U.B. Fund allows you a period of up to seven (7) days to apply for S.U.B. benefits after lay-off.

LAY-OFF SLIPS/TERMINATION NOTICES: Lay off slips must accompany all applications for sub pay. Without lay off slips you cannot collect sub pay. It is the member's responsibility to make sure they get one from the contractor when laid off. Your application cannot be submitted without one. It is the contractor's responsibility to issue one in accordance with our contract.

S.U.B. BENEFITS: Report to the hall promptly upon layoff. You must complete a S.U.B. Application within seven days from your layoff date or you will forfeit S.U.B. benefits. Lay-off slips must accompany the application to be eligible. Proof of UIA benefit payments must be submitted within 21 days of when you were paid in order to receive SUB benefits. Do not submit your sub applications directly to the fund office. Your application must be signed by the hall or you will not collect benefits.

OUT-OF-WORK LIST: You must be on the out-of-work list to collect S.U.B. benefits or SASMI. Members must re-register biannually: March 1 through March 20 and Sept. 1 through Sept.20. If you fail to re-register you will be removed from the list.

SHORT WORK WEEK SUB PAY: If you work 16 hours or less in a week or have a short work week due to weather you may collect sub for that week but only if it is at the beginning or the end of a layoff. Labor 'ensured victory for legislators who will support working people'

(Continued from Page 1) December between Republican Hershel Walker and Democrat Raphael Warnock.

While political pundits on TV and cable concentrated on Congress, the real gain for workers may have come in the states – and that's a reversal from prior off-year balloting. Michigan was at the forefront for worker wins. Democratic Gov. Gretchen Whitmer was reelected by 10 percentage points and worker-backed Dems won both houses. The sweep was particularly impressive in the state Senate, where 19 seats flipped Democratic.

"Michigan's labor movement helped elect an unprecedented wave of pro-labor leaders on Tuesday. Voters sent a clear message that Michigan is a union state, and we ensured

-Charles Caleb Colton (1780 - 1832) victory for legislators who will support working people," said Michigan AFL-CIO President Ron Bieber. "Union members and working Michiganders turned out to vote in record numbers and secured a landslide victory on election night. We now have the opportunity to repair the damage Republican leaders have done to our great state over the past 40 years, and we are ready and eager to get to work.

"Under the continued leadership of Gov. Gretchen Whitmer, Secretary of State Jocelyn Benson, and Attorney General Dana Nessel, we will rebuild Michigan for working people."

Benson said a record-setting 4.45 million Michigan voters cast ballots in the Nov. 8 election. The previous record for a midterm election elections, was 4.34 million votes cast in the 2018 contest. "When the unofficial results are finalized, they will reflect that it was the highest turnout in a midterm election in Michigan's history," Benson said.

In several states, gains for worker-backed candidates took two forms. One is adding and holding what are called "trifectas," where the same party controls both the governorship and

both houses of the Legislature. The other is in cases of one-party dominance, gaining enough legislative seats to prevent majorities from destroying progress for workers, by upholding gubernatorial vetoes.

As of Nov. 10, pro-worker forces had gained trifectas in Minnesota, by adding the state House, and by the complete sweep in Michigan. They also retained trifectas in New York, Illinois and California. And by adding governors, they gained trifectas in Massachusetts and Maryland.

The Michigan AFL-CIO said the state's election wins include 124 labor-endorsed candidates, including nine candidates who are union members. The labor federation said it executed the largest member-to-member campaign in over a decade. The statewide effort also targeted many competitive seats in Wayne, Oakland, and Macomb counties that have high labor-density per capita - "arguably flipping the state House and state Senate on the turnout of union members in those areas," the Michigan AFL-CIO said

By Casey Warner Michigan Department of Natural Resources Michigan's annual deer hunt-

ing seasons – to many, as much a fall tradition as football, apple cider and pumpkin patches - are once again underway.

The Liberty Hunt, for youth hunters and those with disabilities, the early antlerless firearm season and the Independence Hunt, for hunters with disabilities, have already come and gone. We're well into the archery season and firearm season, as hundreds of thousands of Michigan hunters have headed afield to pursue white-tailed deer.

Those who succeed in that pursuit will need to add one more step to their annual deer hunting ritual - reporting their harvest online to the Michigan Department of Natural Resources.

Starting with the fall 2022 deer seasons, all hunters who successfully take a deer are required to report it through the DNR's online harvest reporting system.

This new reporting system is something many hunters have been requesting for several years. During this first fall with mandatory online reporting, conservation officers will focus on educating hunters on the new process, rather than issuing tickets, then begin enforcement next year.

Since the 1950s, the DNR has gathered deer harvest information by mailing surveys to a sample of hunters. "The new system represents a major change for all Michigan hunters," DNR deer, elk and moose management specialist Chad Stewart said. "The system will provide us a near real-time estimate of deer harvest as it occurs, something Michigan has never experienced before."

One of the most important reasons for the move to online harvest reporting, according to Stewart, is more data. "A treasure chest of information is right around the corner!" he said.

Better deer data. The DNR has traditionally gathered most deer harvest information through check stations and mail surveys. Most biological data, like harvest date and location, animal's sex and age, antler beam diameters and antler points, came directly from harvested animals through face-to-face meetings with hunters at check stations. This biologi-

cal data was used to monitor the the deer herd.

The DNR has historically sent mail surveys to randomly selected license buyers after hunting seasons have ended and asked them to report information about their hunting activities and harvest. This information gathered from a sample of hunters was used to estimate the harvest and hunting activities for all hunters.

"Both ways of gathering data, check stations and mail surveys, assume that the information collected is representative of all the deer that are harvested, but biases, errors and insufficient data limit the usefulness of the biological data and survey estimates," Brian Frawley, DNR wildlife biologist and survey specialist, said.

Response rates to the mail surveys have declined from about 75 percent in the mid-2000s to 33 percent in 2021 and are expected to decline to about 25 percent by 2030. Low response rates can lead to an inaccurate, biased estimate of the harvest.

Because declining survey response rates, which are unlikely to reverse, increase the level of uncertainty with deer harvest estimates, the DNR needed to find another approach.

"We feel it's important to size, composition and health of have confident harvest estimates to make the best, most informed management decisions for one of our most prized natural resources," Stewart said.

> Mail surveys are also expensive and time-consuming. It costs about \$173,000 to print and mail a questionnaire to 60,000 deer hunters. The surveys take several months to compile and analyze, with the first survey mailing going out in December and the final report not finalized until the following summer.

> Online mandatory harvest reporting will more efficiently collect better, less-biased data at a finer scale and produce harvest summaries sooner than they were available before.

> "The speed of the information available, and the amount of information we'll now have available, is one of the biggest advantages to this new system," Stewart said. "Our new system, with its corresponding publicfacing dashboard, will show hunters every day how harvest is progressing across the season, with up-to-date accounts on total harvest in the state, harvest by county, season harvest and even harvest by day."

makes it cheaper and more convenient for hunters, since they can report harvest via smart device, compared to traveling to a check station. It is also available 24/7 rather than restricted to normal working hours.

The Deer Harvest Report Summary dashboard shows, as of this writing (Oct. 31), more than 52,000 harvests reported so far this season, and how many of those deer were antlered, antlerless and taken in each of Michigan's 83 counties.

Stewart said that if this year's total deer harvest in those seasons is similar to what it was last year, then the DNR is looking at capturing much of the total harvest with online reporting.

The number of deer harvest reports submitted by Michigan hunters is currently greater than those submitted in other states with mandatory deer harvest reporting and comparable hunter numbers and seasons, like Missouri and Wisconsin. This comparison suggests that most Michigan hunters are complying with the new rules.

"This would, in my opinion, exceed expectations for our first year," he said.

Currently, there are 14 counties

reported, and the top five counties are Lapeer, St. Clair, Montcalm, Sanilac and Newaygo. Stewart explained that because of the ability to tie deer harvests to individual licenses, a feature previously unavailable, the new reporting system will give the DNR a better understanding of how many hunters are using one of their combination license tags to take an antlerless deer in the archery season.

"Right now, we know what the estimated antlerless harvest is in the archery season, but don't understand what licenses hunters are necessarily using to make their harvest decisions," he said. "We'll also have a better understanding of reported harvests of button bucks, bucks with shed antlers and bucks with antlers less than 3 inches. Currently, all of those deer are reported as antlerless deer, but we have never been able to fully quantify the values for any of them."

Another function of the online reporting system is the integration of disease surveillance information. Hunters reporting deer harvested in disease priority areas will receive notifications and instructions on submitting their deer for testing, should they choose to volunteer their deer for either chronic wasting disease or bovine tuberculosis testing.

"The submission process, with hunters receiving a confirmation number from their successful harvest submission, will improve the convenience and flexibility for hunters to submit their deer for testing and allow additional sites, such as 24-7 drop boxes and convenient locations through partnerships with processors and taxidermists, to be used for submission," Stewart added.

How reporting works. Hunters will have up to 72 hours after taking a deer to report their harvest, either online at Michigan.gov/ DNRHarvestReport or through the DNR's new mobile app.

All successful hunters will be asked to report the unique kill tag license number that was attached to the deer, the hunter's date of birth, the exact harvest location, the type of deer harvested (fawn, antlered or adult doe), number of antler points (if a buck) and date of kill. Some hunters will be asked additional questions that will help the DNR understand conditions in the field that affect harvest.

So far in the 2022 deer Online harvest reporting with more than 1,000 deer harvests seasons, 81 percent of hunters

reporting deer kills have completed the harvest report in under five minutes. Hunters can watch short videos on how to report a harvest on the DNR Hunt Fish app and how to report through the eLicense website.

While it has shown to be a quick and easy process, technical assistance is available at a variety of locations around the state or by calling 517-284-9453 during normal business hours. Answers to frequently asked questions are available on the DNR deer harvest reporting webpage.

Moving online. With its long history of estimating deer harvests through a post-season mail survey, Michigan is behind many other states in adopting online deer harvest reporting technology.

A 2017 study of deer harvest reporting and data collection methods found that most wildlife agencies throughout the U.S. and Canada (64 percent) used internet harvest reporting as the primary means of collecting deer harvest data.

Hunters who can't report their harvest due to a lack of internet access or smart device may get help from a family member or friend with access, by providing them with their kill tag license number, date of birth and harvest location to report on the hunter's behalf.

Reporting by phone to the DNR is not possible because of the need for accurate harvest location data, which is provided by selecting the location on a digital map. For decades, hunters have pointed out their harvest locations on maps at DNR check stations.

Some hunters have expressed concern about sharing their harvest location using the new digital reporting method, but Stewart stressed the confidentiality and value of that accurate data and how it helps the DNR and, ultimately, hunters.

"While we will have near real-time harvest data available for hunters throughout the season on our website, that data is at the county level," Stewart said. "Only the DNR will have access to the GPS coordinates of the actual harvest location, which is needed for two very important reasons: more effective disease surveillance, and the ability to build a network of harvest locations over time so we can adapt management guidelines to better align with harvest numbers. That means better overall management recommendations for Michigan's deer population."
