#### **Construction costs** moderating; but rise

Price trends for key construction materials in the United States were all over the place in January, with steep increases for fuel, concrete, and gypsum products offsetting sharp declines in lumber and steel prices.

That's according to an analysis released Feb. 16 by the Associated General Contractors of America, which said that "a lack of clarity" from the federal government as to what materials may be used on federally backed projects is "adding to price disparities." The vast majority of the \$1.2 trillion set up by the Bipartisan Infrastructure Law passed by Congress in 2021 has still not been allocated.

"Producer price indexes for construction inputs moderated over the past year but many items increased again in January," said Ken Simonson, the association's chief economist. "With demand shifting among project types, prices for many inputs are likely to diverge further in 2023."

The producer price index for inputs to new nonresidential construction – the prices charged by goods producers and service providers such as distributors and transportation firms – jumped 0.9 percent in January but rose by a relatively modest 4.3 percent from January 2022. Falling demand

DETROIT – The Exchange Building is up. Or rather, down.

On Feb. 10, iron workers and Barton Malow and its subsidiary Liftbuild celebrated the placement of the last section of structural iron at the base of the 16-story building on the edge of Greektown. That iron work came nearly a month after another notable milestone in the construction of the building: the raising and placement of the last floorplate of the structure, which happens to be the building's first floor.


"The tradespeople have done very well, there was a great deal of collaborative interaction between the trades, and we worked off a lot of CAD (computed-aided design) modeling to make everything come together," said Ryan Ramirez, project manager for Barton Malow/Liftbuild. ## **Another report cites** the value in reviving prevailing wage law

Building trades workers, both union and nonunion, have good reason to cheer the potential reinstatement of Michigan's Prevailing Wage Act under the newly elected Democrat majorities in the state House and Senate.

And a newly released study illustrates why a state having a prevailing wage law on its books is a good thing, and repealing such a law-like Michigan's GOP Legislature did in June 2018 – is a bad thing. The study, "The Economic Impact of Prevailing Wage Law Repeals on Construction Market Outcomes," was released Jan. 17 by the labor-backed Illinois Economic Policy Institute and confirmed what numerous other studies have reported over the years.

"The data show that repeals of state prevailing wage laws have negative consequences for construction workers, businesses, and communities," researchers said. "Construction worker wages, benefits, and productivity fall behind, on-the-job fatalities increase, reliance on government assistance programs worsens, and fewer projects are completed by local contractors – all without saving taxpayers any money."

#### Prevailing wage repeal hasn't done a bit of good in Michigan, or elsewhere, study says

prevailing wage laws. Between 2015 and 2018, however, six states - Indiana, West Virginia, Kentucky, Arkansas, Wisconsin, and Michigan - repealed their prevailing wage laws. They said their report utilizes federal census and Bureau of Labor Statistics data to compare construction market outcomes in states that repealed their prevailing wage laws to those that maintained their prevailing wage laws.

Citing that data, the study found that in states that repealed their prevailing wage laws:

• Construction worker wage growth was between 4 and 13 percent slower.

· Construction worker benefits growth was between 7 and 10 percent slower.

 Construction worker health insurance coverage rates decreased by 2 percent.

· Construction worker reliance on food stamps increased by 2 percent.

· Construction worker employment growth was between 11 and 14 percent slower. (Continued on Page 2)

for new homes drove the index for new single-family construction down to a yearover-year increase of just 0.2 percent.

The increase in January was driven by several inputs. The producer price index for diesel fuel soared 7.1 percent for the month and 22.8 percent over 12 months. The index for cement leaped 7.7 percent in January and 17.8 percent compared to a year earlier.

That, in turn, fueled an increase in the index for concrete products of 1.8 percent for the month and 14.8 percent year-over-year. The indexes for architectural coatings, such as paint, gypsum building materials, such as wallboard, were flat for the month but climbed 15.8 percent and 11.1 percent, respectively over the year.

And those increases more than offset several declining prices. The producer price index for steel mill products slid 2.3 percent for the month and 30.1 percent over 12 months.

The index for lumber and plywood was unchanged in January but fell 30.8 percent from a year earlier.

"Unfortunately, more than 15 months after enactment of the infrastructure law, the administration's guidance about materials is still confusing, contradictory, and incomplete," said Stephen E. Sandherr, the AGC's chief executive officer. 'Uncertainty about eligible materials threatens to delay needed infrastructure projects and make them much more expensive."

The newest data from the Bureau of Labor Statistics (through December 2021) shows that fatal workplace injuries increased almost nine percent from 2020 to 2021. All told, 5,190 workers lost their lives on the job, creating profound losses for those work-

ers' families, friends, coworkers and communities.

However, as we look to identify workplace safety trends, we should keep in mind that in 2020. millions of workers were out of a job or working remotely because of the pandemic. In 2021, many of those people went back to work. If we compare 2021 fatality data to the pre-pandemic year of

It speaks volumes that celebrating his milestone 70-yearanniversary as a sheet metal workers union member here in the United States in December 2022 only scratches the surface of Gerard Verschueren's life story.

And the 101-year-old Sheet Metal Workers Local 80 retiree did indeed speak volumes with us about his life experiences, a few weeks after he was recognized by local union officers in January. The union officers gave Verschueren a plaque and medal honoring his seven decades of service to what is now the SMART Union - the International Asso-

#### **Unions make Michigan better**

Skilled trades labor unions and business owners are often cast as fierce opponents – one as the hero and the other as the villain, depending on your politics or personal financial interests. It's a dynamic that makes for compelling stories and one often wielded by those looking for where to place blame when our economy fails us. But the truth is, more often than not, unions and the businesses who employ our members work together to benefit us all.

Our first responsibility as a union is - and always should be to our members. We exist to make sure hard-working men and women have a seat at the table. We will always fight for the dignity of work and so that those who work can safely earn a decent living. At times, that means holding an employer accountable. As with any functional partnership, it sometimes requires difficult conversations and tough negotiations.

But to characterize unions as purely adversarial to employers is too narrow a view that misses the bigger picture. For those of us in the skilled trades, everything begins with recruitment and training. Unfortunately, Michigan faces a persistent skilled-trades gap that must be filled if we are going to build all the infrastructure and facilities needed to support our state's continued economic growth. This is how we can provide tuition-free training without relying on public funding. Working with our contractors can have a far larger impact than we would make by working separately.

Shifting to the job site, successful construction projects come down to three main elements: safety, productivity and quality. I list safety first because construction is inherently dangerous, and it takes the commitment of everyone on a site, including workers and contractors, to keep everyone safe. That is why Michigan's unions collaborate with contractor associations to uphold rigorous safety standards through jointly developed programs like MUST Safety.

With safety prioritized and addressed, we can next turn to productivity and quality. For a successful contractor, both elements drive profitability and market competitiveness. Fortunately, the same two elements are prized by our dedicated, skilled union members.

At the end of the day, it's very simple: When we work together, we all win. I believe in the power and the value of unions because they bring workers to the table as equals, creating the conditions for a true partnership that allows us to reach for something greater and share the rewards.

## **Report cites value in prevailing wage**

(Continued from Page 1) • The growth in total con-

struction worker hours was between 6 and 9 percent slower.

• The growth in construction worker productivity per hour was 1 percent slower.

Conversely, one of the few arguments for eliminating prevailing wage - saving taxpayer dollars - isn't borne out by the numbers.

"There is also no evidence that the repeals reduced public construction costs or benefited taxpayers," the study said, if only because labor is a relatively low overall cost point for contractors. "Labor costs only account for 23 percent of total construction costs, so minor changes in productivity and in materials and fuels usage can offset any effect of paying prevailing wages," the study said.

The Illinois Economic Policy Institute's study is just the latest among a long line of academically backed studies - both laborbacked and independent - that question the value of eliminating prevailing wage laws.

Prevailing wage laws assure that on projects involving public tax dollars, workers are paid a fair "prevailing" rate of pay, and outof-area contractors aren't able to win bids based on low-cost labor. This study said that 85 percent of peer-reviewed studies conducted since 2000 find that prevailing wage laws have had "no effect on the cost of traditional public works projects, such as schools and highways.'

There have been two candid, public observations about repealing prevailing wage. West Virginia's Legislature eliminated prevailing wage in May 2016.

Republican Gov. Jim Justice said in February 2021 that "we got rid of prevailing wage...and we've run to the windows – and they haven't come," lamenting the failure of repeal to attract businesses or create jobs, as promised by those in favor of repeal. And the assistant Republican Leader in the Indiana House of Representatives commented in May 2017 that after the Hoosier State repealed their law in 2015, "we

got rid of prevailing wage and, so far, it hasn't saved us a penny."

Building trades unions are pushing hard for majority Democrats in the state Legislature to reinstate Michigan's prevailing wage law.

"At a time when the United States is making historic investments in the nation's infrastructure and contractors are having difficulty finding qualified workers, prevailing wage laws can attract, develop, and retain experienced construction workers," the Illinois Economic Policy Institute said. "To ensure that American infrastructure is built locally by skilled construction workers, state lawmakers should consider strengthening or expanding their prevailing wage laws, implementing new prevailing wage laws, and reversing recent repeals of prevailing wage laws.



## **BUILDING MICHIGAN:** Macadam Roads HISTORY IN THE MAKING By Marty Mulcahy



IF YOU WERE A MACADAM road-building contractor in Michigan in 1911, you may have been in the market to buy this "Buffalo Pitts Road Building Outfit" made by the Banting Machine Co. of Toledo. The tractor could tug cars hauling 40 tons of gravel, and spread the rock in thicknesses up to 30 inches. A September 1911 advertisement placed in Michigan Roads and Forests magazine said this 22 horsepower, 2-cylinder rig could save a contractor 60 percent, presumably instead of hiring a bunch of guys spreading the gravel with shovels, or using horses (see below).

We know not what the next generations of road-building material will be made of, but for centuries, one or all of those materials have provided the transportation surfaces for our feet, our horse-drawn wagons, our cars and our 18-wheelers.

But here we give a little love to one of the long-forgotten roadbuilding methods that proved to be somewhat of a bridge from dirt roads, to our modern concrete and asphalt highways.

It comes from the gravel family: we refer to "macadam," a road building system that eased travel and transportation for decades in Michigan and around the nation, until concrete and asphalt took its place.

When Michigan achieved statehood in 1837, its interior was mainly swampland, with "roads" little more than paths created by Native Americans. Plank roads were among the first methods of road-building in Michigan, but the future of transportation was looking more toward nascent canalbuilding and railroads.

"In the United States," says the Federal Highway Administration, "macadam was first used in 1823 on a Maryland turnpike between Hagerstown Credit: Michigan Roads and Forests, 1911





In the U.S., McAdam's process was employed in a painfully slow manner. State governments and territories had zero money allocated for building or maintaining roads. The concept of spending money on roads would have dumfounded town fathers, anyway, since farmers and townsfolk rarely traveled 10 or 20 miles from their homes.

"During the Civil War, almost all roads were of dirt that became quagmires of mud after heavy rains," says Civil War Era Road Construction and Engineering. "Only a few hardsurface all-weather roads existed. These were called "macadamized" roads after their inventor. Scottish civil engineer John Loudon McAdam, who in turn was indebted to the road builders



of the ancient Roman empire." The popularization of bicycles, of all things, began to swing public sentiment toward better roads.

"The first group to agitate for better roads, the League of American Wheelmen, grew out of the 1890s bicycle craze, and the second group evolved with railroad company support," wrote Harvard University's John Stilgoe in his paper, Roads, Highways and Ecosystems. "Bicyclists adored paved roads, but away from cities found none. By 1900 the LAW had become the nation's largest special-interest group, and it advocated paving roads with crushed stones."

Stilgoe wrote that "the macadamized road... had a multilayered surface of crushed stone: the largest stones, about the size of an adult human skull, at the bottom, then another layer about the size of an adult fist, then a top layer of stones no larger than can go into an adult mouth. Macadamizing a country road meant backbreaking work in the days of horses, wagons, and picks and shovels, and until the development of steam-powered stone crushers, many states set convicts to work smashing stones with sledgehammers."

Macadam roads enjoyed a surprisingly long life. No, not the roads themselves - the nature of a gravel road - even an engineered road - made maintenance a constant factor. But as a major road building material, Macadam existed for about a century, and was in use well after the first mile of concrete road in the world was placed in Detroit in 1909.

Well before that concrete surface was placed, Michigan was an early leader in the good roads movement. Horatio "Good Roads" Earle was Michigan's first highway commissioner, serving from 1905 to 1919. As chief consul

Macadam roads were generally comprised of a compacted subgrade of larger pieces of granite or greenstone designed to support the load, covered by a surface of light stone to absorb wear and tear and shed water to the drainage ditches. In modern macadam construction crushed stone or gravel is placed on the compacted base course and bound together with asphalt cement or hot tar. A third layer to fill the interstices is then added and rolled. Cement-sand slurry is sometimes used as the binder.

> swamp roads. Less than 8,000 miles of roads were "improved" -7,700 with gravel and 245 miles with stone or macadam.

With mixes getting perfected and costs coming down, concrete began to be the preferred road building material after World War I. And with automobile registrations growing in cities - and large-wheeled tractors in greater use on farms - the drawbacks of macadam roads were evident in cities and on the farm.

"With the end of the war (in 1918), the greatest roadbuilding effort in history began in Michigan and across the country," Stilgoe wrote. "Demobilization brought a surge in the demand for autos, led by veterans returning from Europe with a desire to see more of the country and the world about them. Registrations rose from 262,000 in 1918 to 325,000 the following year.

"Michigan's state reward system had paid for improvements on 4,800 miles of roads, including 2,115 on the state highway system, but huge gaps remained in the state system. Motorists traveled through one county on a concrete road, traversed the next on macadam or asphalt and ended up in the third on gravel."

That patchwork of major state road surfaces existed, incredibly, well into the 1950s. In 1956, President Dwight Eisenhower signed legislation funding the construction of the U.S. Interstate Highway System.

Macadam roads are rarely in use today, but can still be found in countrysides and developing nations.

'The first automobiles with their low speeds did little damage to the macadam surfaces, but when speed increased and motors became more powerful the rear wheels of the cars with their heavily weighted rubber tires ground the brittle macadam like an emery wheel," said the July 1911 edition of Michigan Roads and Forests.

## Some cause for optimism in worker fatality trend

(Continued from Page 1) struction industry, the tireless efforts of the entire LIUNA family are paying off in safer jobsites and healthier LIUNA members."

Key takeaways across hazard categories:

•Transportation: Across all industries, fatal transportation incidents rose 11.5 percent and now make up 38 percent of all workrelated deaths. In construction, fatal transportation incidents decreased by 15 percent.

•Workplace violence: Workplace homicides increased and now make up 9.3 percent of all on-the-job deaths. Gun violence was responsible for 80 percent of these deaths, and women and Black workers were disproportionately the victims. In construction, workplace violence fatalities decreased from 55 in 2020 to 40 in 2021.

•Suicide prevention: Onthe-job suicides declined 8.9 percent across all industries, suggesting the increased focus on mental health and employers' role in supporting workers is having a positive effect.

Hazard area to watch: harmful substances and environments. Of the five major categories tracked by the BLS, construction industry deaths dropped in three of them. The two exceptions were falls and exposure to harmful substances and environments. In construction, deaths from exposure to harmful substances and environments rose 15 percent, from 174 to 204.

One major factor is that this category includes unintentional overdoses from drug use. For general industry, the number of deaths in this category hit an alltime high, and almost 60 percent of worker deaths were caused by unintentional overdose. It's likely the majority of these overdose deaths were caused by fentanyl, which is showing up much more

often in illegal drugs. However, the spike in this category can't be attributed to fentanyl alone. The share of unintentional overdose deaths was also just below 60 percent in 2020, which means other causes - such as overexposure to toxic fumes and gasses, contact with solvents or lack of oxygen in confined spaces – were also responsible. Both unintentional overdoses and contact with other harmful substances should be of special concern to construction employers. Construction workers are more likely to be prescribed opiods and to develop a dependence on them, and many toxic substances are common on construction sites. Black and Hispanic workers remain at higher risk across industries. Of all the trends in the 2021 general industry data, one came up again and again. Black and Hispanic workers experienced disproportionately higher fatality rates than their peers. The fatality rate for Black workers was 10 percent higher than average; the fatality rate for Hispanic workers was 20 percent higher. "This report makes devastatingly clear that workers of color are disproportionately losing their lives on the job, and it is the mission of the labor movement to fight for equity and ensure that safety is a guaranteed right," said AFL-CIO President Liz Shuler. Some of this safety gap is likely due to Black and Hispanic workers being more likely to hold riskier jobs. We saw this trend during the pandemic, when Black and Hispanic populations were hit hard by COVID-19 – in part because they are disproportionately in frontline jobs. In other cases, workers may not feel comfortable speaking up about unsafe conditions or haven't received sufficient safety training in a language they understand. Many racial and ethnic minority groups also experience health disparities around conditions such as diabetes, heart disease and cancer. The safety disparities faced by Black and Hispanic workers in the U.S., like these health disparities, are longstanding and persist across many different hazards. All in all, the latest report from the BLS points to progress being made in the construction industry when it comes to worker safety and health. By paying attention to trends and taking steps to ensure all workers experience a safe workplace, we can do even better.

## **101-year-old coppersmith** reflects on remarkable life

there is much more to his story. "I have lived a very good life," he said, "but I have to thank the unions for the very good life."

With a mind and memory that are still sharp, Verschueren has some knee pain but is otherwise healthy and content, living where he has resided for decades at his home in Rochester. A pensioner since 1981, he became a widower three years ago with the death of his wife Maria. Together they had three children, and six grandchildren.

Gerard was born on Jan. 4, 1922, in the ancient town of Venlo, Holland, near the German border, the second of three sons to Mathieu and Marie Verschueren. Gerard's father had a thriving business, where they made and sold a variety of goods like bicycles, water heaters and milk cans, and his sons practiced bicycle repair, copper-smithing, roofing and plumbing, and other aspects of construction.

Gerard had an advanced education, and learned seven languages and dialects, some of which he taught himself. Prior to World War II, he was working as a union craftsman on projects in France, then returned to the Netherlands in 1940 at age 18, the mandatory age to perform a stint in the Holland's military. His ultimate dream was to go to America to be a lawyer. "This was nullified because Holland was invaded by Germany (in May 1940) and now another chapter in my life was about to begin," Gerard wrote in a personal history.

With their country occupied by Germany, both of Gerard's brothers were forced to work at German plants to serve the war effort. The Germans "know you're Catholic, you have to go to mass on Sunday. So they parked a truck outside the church with a machine gun on it, and all the boys that came out, they picked them up and brought them back to Germany to work," Verschueren said. "So that's how my two brothers got picked up. You just didn't come home, that was it. Mama was crying for weeks and weeks until she got a letter from her kids in Germany. They never caught me – well they caught me a couple of times but I had my ways to get away. I was pretty lucky too."

Verschueren said he basically hid in plain sight around his town, working for his dad. But he also worked in the Dutch Underground, risking death to do what he could to undermine the German war machine and help the Allies. For example, he said there were six telephone lines between Holland and Great Britain before the war, and five were shut down by the occupying Germans, who didn't know about the sixth line. Verschueren, who could speak English, used the line for the Dutch Underground to converse with the British and spy



"the seat is empty." This is incredible." said the first man. "Who in their right mind would have a seat like this for the Super Bowl, the biggest sporting event in the world, and not use it?"

The second man replied; "Well, actually, the seat belongs to me. I was supposed to come with my wife; but

she passed away recently. This will be the first Super Bowl we we haven't been together since we got married in 1967.'

'Oh, I'm sorry to hear that - that's terrible!" said the first man. "But couldn't you find someone else - a friend or relative, or even a neighbor to take the seat?"

The second man shook his head. "No, they're all at the funeral."

on the Germans.

"You lead a regular life but if you know they are looking for you, you take extra measures so they can't find you," he said. "My father would go where I was working and say 'don't come home, the Gestapo, they want you again.' But you could run into any house and they would shelter you."

A dance instructor (when teaching dance was strictly forbidden by the Germans), Verschueren said he was caught once and given a date in court along with six others at the local Gestapo headquarters. The German officer told them they were headed for a concentration camp, and then left the room for 15 minutes. When he returned the officer said if he was paid 350 francs apiece for the German war cause, the men would be released in honor of Adolph Hitler's birthday. Verschueren happened to have enough money on him, having just sold a radio on the black market. He was released, but he didn't know what happened to the others.

Verschueren said another time his girlfriend and future wife Maria begged him not to accompany a downed American flyer on a risky trip to escort him to meet with the French Underground, and his heeding her advice likely saved his life because the airman and Dutch resistance were caught by Germans in a Paris subway.

Also working in the Dutch Underground, Verschueren told of grabbing and stealing German officers' coats and weapons from hangers at bars and restaurants. He helped blow up a high-voltage electrical tower. And he gave directions to General George Patton himself, who had come into his town as it was close to being liberated. One of the few English speakers around, Verschueren told Patton – only learning later who Patton was - that he could get a good vantage point to see the position where the Germans were shelling their city that night by placing spotters atop a tall building in the city. The U.S. army then found and neutralized the German position.


When the war ended, Verschueren found out the extent of the Dutch Underground – he didn't even know his dad and future wife were members. He owned a company in his homeland that specialized in the repair and restoration of historic buildings, some damaged during the war. He was certified as a coppersmith in Holland, and held a master's plumbing license.

Verschueren and his wife immigrated to the U.S. in 1950. During his time in the sheet metal trade he worked for companies like Milbrand, LaDuke and Rewold. He performed all manner of architectural work with the tools, working as a journeyman and foreman at church and synagogue projects, office buildings and storefronts. "I really liked the architectural and detail work, I enjoyed the craftsmanship," he said.

Realizing his dream to move to the United States, he and his wife settled in Hazel Park, where he got involved in a number of civic activities and boards. He worked on the city's Zoning Board of Appeals for 21 years, for many years as its chair. Moving to Rochester, he similarly worked on that city's Zoning Board of Appeals for decades, on a Water and Sewer Advisory Board and chairman of the local Development Finance Committee. He worked as an historical building advisor and consultant for the states of Ohio, Indiana and Michigan. Most of his time spent on public boards was done with donated time.

In recent years he has slowed down quite a bit with metal working projects that kept him occupied, but keeps busy reading and keeping up with world events and while keeping house and performing home repairs. "Here I am age 101, I am very abnormal," he said, smiling, referring to his relatively good health.

He said he considered his working career with the tools first as opportunity to make a living, but then as an opportunity to pass along knowledge and skills to younger people. "I carry my union card from the Netherlands from 1950, that tells you something," he said. "While I was working with the tools I still liked to teach people about the sheet metal business. Wherever I could I also wanted to teach people about the copper-smithing. I love the union. I could never work without a union."



Do not get caught without the necessary current job site credentials, although several state agencies have relaxed renewal requirements due to the pandemic.

Work in other areas of the region will be picking up in Ohio, Tennessee well as Kentucky. Winter/Spring outages in all areas in the region are on the horizon so make sure if you can travel that you make sure to get licensed as soon as possible.

With most state agencies working from home during this pandemic filling out on-line renewals is the way to go. They are processing much quicker than traditional mail in applications. If you have any questions about online applications or what states you may want to get a license for do not hesitate to call the office or my cell.

If you can recommend anyone that you know can handle this work have them call the office to get an application filled out and sent in so we can get them into the next class. 2022 labor statistics demonstrate need for organizing, pro-labor legislation

(From SMART, the International Association of Sheet Metal, Air, Rail and Transportation Workers)

The United States Bureau of Labor Statistics released its annual report in January 2023, revealing a growth in domestic union membership and illustrating the urgency with which unions like SMART must organize nonunion workers and lobby for new labor laws

American union membership grew by 273,000 workers 2 -matching the surge in organizing witnessed last year, as evidenced by a 53 percent increase in National Labor Relations Board union election filings.


tacks of CEOs like Jeff Bezos, Howard Schultz and others across industries, workers kept organizing in 2022," said SMART General President Joseph Sellers. "In our own union, we saw victories everywhere from Philadelphia to Ketchikan, Alaska. The fact that workers continue to persevere in the face of powerful, well-funded opposition serves as a reminder that we must keep up the fight to organize working people in every state."

Unfortunately, despite highfile victories at anti-labor corporations like Amazon and Starbucks, nonunion jobs were added to the U.S. economy at a faster rate, lowering American union density to 10.1 percent of the total workforce. That includes the construction industry,

where the percentage of unionized workers dropped from 13.6 percent to 12.4 percent, and the transportation and warehousing sectors, where the number of workers represented by a union grew by 46,000, but union density dropped from 16.1 percent to 15.5 percent.

Even with those decreases, though, the Economic Policy Institute calculates that more than 60 million workers wanted to join a union in 2022 but couldn't, often due to illegal union-busting by employers. Additionally, a Gallup poll found that 71 percent of Americans approve of labor unions - the highest number in almost 60 years. "These statistics tell us two things," explained SMART Director of Organizing Darrell Roberts. "First, U.S. labor law needs drastic overhaul, which Congress can take a first step towards by passing the Protecting the Right to Organize (PRO) Act. Second, every member of this union from international leadership to rank-and-file members across the country - needs to commit to bringing workers into our union at a mass scale." SMART members know first-hand the better pay, working conditions and family-sustaining benefits that unions achieve through collective bargaining and solidarity, Roberts added. That power can only be strengthened if we focus on bringing more workers into our ranks. "The open shop is adding jobs at a rate that aims to threaten our market share, but we know that workers want what we can provide: good, middle-class jobs," he said. "We will persevere in our organizing across the U.S. and Canada to make sure more workers can achieve that goal."



## New milestones set for top-down **Exchange Building in Detroit**

(Continued from Page 1)

Beyond being another midrise structure to enhance Detroit's skyline, the Exchange Building is unique in that it is being erected in a completely unique way: with individual floors being built at ground level and then jacked into place along two concrete structural spines to meet the floor above. The LIFTbuild system that's being used by Barton Malow is the first application of its type in North America, and is getting attention from all manner of publications and curious building architects, engineers, developers and trade groups.

The 166,700-square-foot building being erected on a former parking lot at Macomb and Brush streets will contain 165 residential units of various-size condominiums and apartments. Approximately 60-70 tradespeople have been working on site in recent weeks.

After the structure's concrete spines were erected, the halfmillion-pound roof was strandjacked into place on April 30 after a 10-hour process. Then work commenced on the top 16th floor, in a process where the floorplates are constructed on a concrete pad at the base of the structure. When ready, that floor was jacked into place, and then every two weeks or so, another floor would be constructed and similarly lifted.

LIFTbuild says building at ground level offers numerous ergonomic, quality and efficiency advantages and potentially cost savings, although Ramirez said they're still analyzing those numbers. He said each steel-framed floorplate has been built 20-30 percent more efficiently than conventional construction.

"We got progressively better as we moved along, there was a major learning curve for us, the trades, and everyone involved," said Kathryn Nelson, branding and communications manager for LIFTbuild. "Even the city inspectors had to learn along with us."

A significant amount of interior finish work remains even after each floor is placed. Drywall, carpentry, painting, and mechanical/electrical/ plumbing trades have work to do on each floor. Higher floors, as would be expected, are farther along. The interior of the concrete spines allow for the easy placement of elevators and vertical placement of utilities. The design allows for the elimination of vertical structural columns from floor to floor, resulting in uninterrupted views, flexible space design, additional square footage and more easily configured floor plans. Eight steel connections lock each floor into place with the one above.

The building will include ground-floor commercial space, a fitness room, a club lounge, and an outdoor deck. And greater residential density in that area will be most welcome/

Working throughout this winter, one significant advantage to the LIFTbuild method is to have the walls, floors and windows in place at the ground floor, allowing for a temperaturecontrolled interior once the floorplates are lifted. "We have power and heat and a nice working environment inside," Ramirez said. "That's a big deal for helping keep workers safe and happy.'

Nelson said the LIFTbuild system has been employed on two buildings in India several years ago prior to using it on this project. Barton Malow acquired LIFTbuild in 2017. "We're excited to bring this system here, and we're looking forward to using it more in the future," Nelson said.

The Exchange Building is expected to be complete in midsummer of 2023.

## Ford to build \$3.5 billion **Battery Park in Marshall**

took his state out of the running for hosting the plant, claiming it is a front for the Chinese Communist Party, which he said would arouse national security concerns.

Chinese battery manufacturer CATL will operate the Marshall plant, while Ford will own the land and the factory itself.

Ford is working to deliver an annual run rate of 600,000 electric vehicles globally by the end of this year and 2 million globally by the end of 2026. as part of its Ford+ plan. As the company rapidly scales up EV production, introducing LFP batteries allows Ford to produce more electric vehicles and offer more choices to new EV customers.

LFP batteries are very durable and tolerate more frequent and faster charging while using fewer high-demand, high-cost materials. This lower-cost battery, at scale, said Ford, will help the company contain or even further reduce EV prices for customers.

'This is a big deal," said Michigan Gov. Gretchen Whitmer. "It'll make sure that production lines aren't stalled by global shocks or shipping delays. We're going to make electric vehicles top to bottom right here in the state of Michigan. I am grateful to Ford, an American icon, for believing in Michigan."

These LFP batteries will power a variety of next-generation Ford EV passenger vehicles and trucks under development, most of which will be assembled in the U.S.

benefits due to your heirs from Local 80 pension, insurance, annuity and from international and SASMI. Each individual benefit needs to have a designated beneficiary unless you want it to go to your spouse or children. As always seek the advice of an attorney.

ADDRESS CHANGES: If you have a new address please make sure to let the hall know. We will take care of your account with the union hall which includes the Tradesman paper. You will need to call Benesys at 800-400-7710 and update your address with them as well. That is not done through the hall.

ACCIDENTAL DEATH and DISMEMBERMENT INSUR-ANCE FROM OUR INTERNATIONAL ASSOCIATION: Members who have their dues paid in advance (prior to the month of the accident) are eligible for accidental death and dismemberment benefits up to \$7,500. This benefit comes as a dues paying member of SMART International.

WEEKEND WORK ASSIGNMENTS: Saturday and Sunday work assignments. Please remember that when performing work on a Saturday or Sunday the steward must report it to the hall, give each members name and obtain a form for signatures. Each member must sign the form along with the number of hours they worked. The completed form must be sent back to by hall by the end of the day on the following Monday. Weekend work assignments must be called or emailed into the hall prior to 3:00 pm on Friday

WORK ASSIGNMENTS: Everyone must obtain a work assignment prior to starting work. If you fail to do so you could be written up on charges.

LAY-OFFS: All members must report to the Union Hall immediately upon lay-off, even if you only work one day. These are the By-Law rules for the Out-of-Work List. Your name will be removed from the list 14 days after receiving an assignment. It is very important to report to the union hall immediately after your layoff. Members get confused because the S.U.B. Fund allows you a period of up to seven (7) days to apply for S.U.B. benefits after lay-off.

LAY-OFF SLIPS/TERMINATION NOTICES: Lay off slips must accompany all applications for sub pay. Without lay off slips you cannot collect sub pay. It is the member's responsibility to make sure they get one from the contractor when laid off. Your application cannot be submitted without one. It is the contractor's responsibility to issue one in accordance with our contract.

S.U.B. BENEFITS: Report to the hall promptly upon layoff. You must complete a S.U.B. Application within seven (7) days from your layoff date or you will forfeit S.U.B. benefits. Lay-off slips must accompany the application to be eligible. Proof of UIA benefit payments must be submitted within 21 days of when you were paid in order to receive SUB benefits. Do not submit your sub applications directly to the fund office. Your application must be signed by the hall or you will not collect benefits.

OUT-OF-WORK LIST: You must be on the out-of-work list to collect S.U.B. benefits or SASMI. Members must re-register biannually: March 1 through March 20 and Sept. 1 through Sept. 20. If you fail to re-register you will be removed from the list.

SHORT WORK WEEK SUB PAY: If you work 16 hours or less in a week or have a short work week due to weather you may collect sub for that week but only if it is at the beginning or the end of a layoff. You may NOT collect if you are not laid off. You must complete a sub application at the hall, provide a pay stub for that week and the hall will submit it to the fund office. If you are not laid off and it is due to weather the company MUST provide written documentation that it was weather related.

MEMBERS ASSISTANCE PROGRAM: If you are experiencing problems in your family, marriage or relationships, stress or emotional difficulties, grief or loss issues or problems with alcohol and drug use please contact our assistance program. Ulliance is there (Continued next column) at the top of the home page. The Union Hall will also has hard copies for members who want one.

construction student, but sometimes you don't have great skills in terms of resume writing or interview skills," a spokesperson said. "So that's one of the first things that Upper Peninsula Michigan Works! did – provide workshops for resume and interview skills."

The UPCC collaborated with signatory contractors and UP building trades unions, as well as U.P. Michigan Works, Delta-Schoolcraft Intermediate School District, Dickinson-Iron ISD and Marquette-Alger Regional Education Services Agency to develop a program that is skill-based, labor- and industry-approved and directly linked to real workplace situations. Students attend school in the mornings, then spend the afternoons working, learning and earning – on job sites.

Construction Connect UP is operating as a pilot program for the second semester of this school year, with three students from Escanaba and one student from Kingsford. In May, students who successfully complete the program may be "drafted" into building trades apprenticeships.A full program will follow for the 2023-24 school year.

<u>Outdoors</u> Catching natural resource rustlers

**By Katie Gervasi** Law Enforcement Division **Michigan Department of Natural Resources** 

George Berkeley, an Anglo-Irish philosopher, originally posed the question: "If a tree falls in a forest and no one is around to hear it, does it make a sound?"

Considering there are about 20 million acres of forest land in Michigan, a lot of tree falls go unheard.

What else happens in the depths of the forest? How are forests and other remote locations - home to Michigan's finest natural resources - monitored? What happens when someone steals those valuable resources?

career officers is responsible for patrolling and protecting Michigan's natural resources.

In addition to policing hunting and fishing violations and performing a wide range of other duties, Michigan Department of Natural Resources conservation officers investigate crimes of natural resource theft that occur in these remote locations, where many people believe they will leave no trace.

Forest resources. "You don't know something is missing until it's gone," said Doug Heym, DNR Forest Resources Division unit manager for timber sales and utilization. "If you have forested property of any kind – keep your eye on it because timber rustling (theft) does occur."

Michigan's traditional forest industry generated an estimated \$22 billion in 2019. That's a significant source of income and jobs to local economies, especially in the northern two-thirds of the state, where most of the forest land is located.

The DNR manages about 4 million acres of Michigan's forests – about 20 percent of the market. The remaining 16 million acres are owned and managed by the federal government, private industries, agriculture subsidiaries and private landowners.

Michigan has an array of forest species that serve many

different purposes and industries and fencing, paper, cabinets, furniture, just to name a few.

The southern third of the state has seen a recent uptick in black walnut theft – which is an ideal material for furniture due to its high-quality grain and color.

However, it was mostly sugar maple that landed an Upper Peninsula logger in court for one of Michigan's largest known timber theft cases.

Stiff competition. "Many people don't realize the value of some of these trees," said Dustin Salter, DNR forester. "One tree might have four logs, and the value of those logs might get up to \$300-\$500 each; some are more."

On state-managed land, foresters and conservation officers are familiar with where timber harvest is occurring and what trees are being harvested. If an officer notices a random tree stump on state land, they're likely to investigate.

"Natural resource crimes are unique and are often solved over an extended period of time as evidence is pieced together," said Dave Shaw, chief of the DNR Law Enforcement Division. "Urban and people-versus-people crime comes to fruition sooner because people talk and it's easier to piece together evidence."

In late 2015, the DNR sent - structural lumber for houses out a standard timber harvest proposal for bid on a section of state-managed forest land in Menominee County. Most bids come back ranging within \$2,000-\$3,000 of each other.

However, one bid really stuck out. R&J Logging, based out of Stephenson, won the bid by \$40,000 - steep competition for what other honest bidders told the DNR was a "break-even job."

Suspicious circumstances. Conservation officers met with local foresters, who mark thousands of trees at a time that need to come down. Prior to R&J beginning the harvest, foresters noticed newly marked trees. "A forester's mark is like their signature," said Lt. Reid Roeske, supervising conservation officer of the investigation.

Conservation officers walked the 92 acres of land, becoming acquainted with what would become their "office." Together, officers and foresters physically and electronically documented high-dollar trees that were not included in the original bid.

Officers then worked one of their best skills – they patiently patrolled the land and waited.

Investigation. After about 12-18 months, R&J Logging finally started its harvest. Under close surveillance, the DNR confirmed new trees were being

was not supposed to harvest. When the Michigan State Police lab confirmed the chemicals on the newly marked trees matched chemicals Vetort was in possession of, Vetort confessed he marked additional trees to increase his profit margin.

"Vetort cut about half of the 92 acres," said Eric Thompson, DNR Escanaba unit manager with the forest resources division. It was determined that more than \$100,000 in timber value was involved in the theft. With every harvested tree documented, in 2016 the DNR reclaimed the timber sale.

The DNR followed up with mill operators who purchased the timber to determine the volume that was sold in comparison to what was harvested.

The DNR requested assistance from Michigan Attorney General Dana Nessel to shed light on the severity of stealing natural resources.

"Without the AG's office, I don't know if we would have gotten results this good," Roeske said.

In 2021, Vetort was charged

with trespassing or damages to state land, larceny, and malicious destruction of property. He pleaded guilty. He was ordered to pay more than \$119,000 in reimbursement to the state and serve three years of probation, with six months in jail suspended pending his successful completion of his probation term. The Michigan Department of Corrections currently lists the 59-year-old as on probation status.

Mineral resources. The heyday of the copper industry in Michigan's Upper Peninsula lasted for more than 40 years, from 1845 to 1887. During much of that time, Michigan produced more than three-quarters of the country's copper. Now, nearly 140 years later, copper is still a sought-after commodity.

Due to the high price of copper and growing demand, there is renewed interest in some known reserves of copper in Michigan, a return to past prospects and in exploring for new metal ore deposits that may contain copper, as well as other metals or critical minerals. "Currently, the main demand that is driving up the price of copper is for electronics and in lithium-ion batteries," said Kirk Lapham, DNR Minerals Management Section manager.

Copper crime. Despite copper being more difficult to find these days, conservation officers nabbed three copper thieves in 2020. Sentencing in the case concluded last month in Keweenaw County with fines for all three and 30-day jail sentences for two.

Officers received a tip about activity at a copper mine located in Central, part of the "Copper Country" in Keweenaw County.

The Central mine produced about 52 million pounds of copper over 40 years. Roughly 1,200 people established a town revolving around the mine, which became a "ghost town" when the mine was abandoned in 1898.

Conservation officers, the county mine inspector and the local sheriff set out to investigate, confirming the mine had indeed been broken into.

"The subjects were accessing a shaft of the Central Mine complex through a man-made mine cap," said Sgt. Marc Pomroy, DNR conservation officer. "The cap allows bats to use the mine shaft for hibernation. The top of the cap has a locked access door."

Within a day of surveillance, conservation officers and a Keweenaw County Sheriff's deputy went back to the mine on snowmobiles and waited until three people were caught leaving the mine. The three individuals were in possession of hundreds of pounds of copper.

"The copper ore that was taken from the mine was in rough form, and still needed to be treated and cleaned, but was still valuable," Pomroy said. "These folks make a living off of breaking into old mines and stealing the copper product to later sell in the clean polished form."

When conservation officers investigate natural resource crimes, it's usually based on a tip or complaint, often reported to the DNR Report All Poaching hotline, or directly to a conservation officer. When officers receive a tip or complaint, they visit the original location to look for anything out of the ordinary. But sometimes, while they're patrolling, something just seems off and is worth investigating.
