Minority workers fuel union gains

While there has been significant focus on union organizing efforts at places like Starbucks and Amazon, Bureau of Labor Statistics BLS statistics released in March indicate that it's actually Black and Brown workers in state and local government jobs, many in the South, who are driving union membership gains.

The BLS report showed that in 2022, the labor movement gained 200,000 net union members – not a big number by historical standards.

But the overall percentage of union workers actually decreased from 2021 to 2022, from11.6 percent to 11.3 percent (a record low).

"Workers of colors made up 100 percent of union growth in 2022," wrote Prem Thakker for the *New Republic*.

"The entire increase in unionization in 2022 was among workers of color who brought an increase of 231,000, while white workers saw a decrease of 31,000," said the Economic Policy Institute. "Of all major racial and ethnic groups, Black workers continue to have the highest unionization rates, at 12.8 percent. This compares with 11.2 percent for White workers, 10.0 percent for Latino workers, and 9.2 percent for Asian American and Pacific Islander workers."

Starbucks to union efforts: nope!

Starbucks Workers United, the grass-roots worker organizing campaign which the Service Employees aid, has organized its 300th store in the U.S., in Sacramento, Calif. The vote was 11-2 on April 14 at a store in the California capital.

And years after organizing efforts began, the coffee-serving giant still has yet to come to an agreement with a single bargaining group. The National Labor Relations Board said last month that Starbucks has illegally "failed and refused" to collectively bargain fairly at 144 sites.

Starbucks's anti-union and anti-worker campaign, orchestrated by founder and former CEO Howard Schultz, is so extensive that it's produced five federal court injunctions against the firm for labor lawbreaking excesses – and more than 1,400 complaints so far to the NLRB, leading to hundreds of charges.

Labor nominee too pro-union?

WASHINGTON, D.C. (PAI) - By an 11-10 partyline vote, the Senate Health, Education, Labor and Pensions Committee approved President Joe Biden's nomination of Julie Su as the next Secretary of Labor.

Her nomination will now go to the full Senate for a

Republicans accused Su, now the acting secretary, of being anti-business, too prounion, a bad administrator and an inexperienced negotiator. Organized labor is campaigning hard for Su, using TV ads. "Everywhere she goes, workers win," AFSCME President Lee Saunders said.

WASHINGTON (PAI) – In full-throated campaign mode, since he announced his bid for re-election just hours before, Democratic President Joe Biden launched his 2024 run for the White House with a stem-winding – and long and sometimes folksy – recapitulation of his and their achievements before an audience of 3,000 building

Biden was repeatedly interrupted by applause and sometimes by whistles, cheers and chants of "four more years!" from the North America's Building Trades Unions' legislative conference on April 25. Biden spoke so long that he even joked at the end "I'm taking up too much of your time."

Right-to-work rollback

Michigan's example offers potent symbol for U.S. labor movement

Michigan's repeal of its Labor groups celebrated, and "right-to-work" law could be a huge boon to labor – not because a flood of new members will instantly join unions, but because the entire country is hearing the message that the state will not tolerate flagrant union busting.

On March 24, Michigan Gov. Gretchen Whitmer signed legislation repealing a 2012 law that made Michigan a "right-towork" (RTW) state – the first time since 1965 that a RTW law was repealed and only the fifth time ever since these laws were first introduced in the 1940s. Michigan's repeal dropped the number

of RTW states to 26. Despite their name, RTW laws have nothing to do with guaranteeing a right to employment. Rather, they allow workers in unionized workplaces to opt out of paying for the costs associated with negotiating and enforcing their union contract. Employers tout them as a bulwark of freedom against "compulsory unionism," while unions decry them for sapping union solidarity and resources by guaranteeing a "right to freeload."

warnings about the consequences. Why do so many people care about what seems on its face to be an arcane piece of labor law?

Some labor partisans are excited that non-member workers at unionized shops will again have to pay "fair share" or "agency"

Surely many unions will appreciate the boost in revenue from the influx of agency-fee payers. Some might even use it to fund extra organizing, which can only help efforts to stem union decline. But as welcome as new agencyfee payers will be, they won't make much of a dent in union

First, thanks to the Supreme Court's ruling in Janus v. AF-SCME, which extended RTW to the entire public sector in all 50 states and the federal government, the RTW repeal in Michigan only directly affects private-sector workers in that state. The public sector in Michigan will remain RTW for now.



New research: RTW laws vex labor, but target of union ire may be misplaced

Right-to-work laws have historically been put in place to silence workers, make it more costly for unions to do business, sideline political power – or even push labor unions out of business completely.

That's according to labor unions. On the other hand, Republican lawmakers and the business community argue that a RTW law make a state more businessfriendly.

But how do you measure any of that? There's very little academic agreement – or for that matter, much research - on the effects right-to-work laws have on labor unions or society. Now, along comes an extensively researched paper, titled "What do right to work laws do to unions?"

For valued unions, free-riders are an irritant that's 'surprisingly small and insignificant'

that attempts to answer some of those questions.

Published earlier this year in the Journal of Labor Research, the paper asks that question – and then suggests that consequences of RTW laws on labor unions are relatively benign... with two significant exceptions.

And those exceptions both underscore the extreme displeasure Michigan union members expressed in late 2012 with the passage of RTW by the Michigan Legislature.

The paper was published a few weeks before the Michigan Legislature, in March, made our state the second in history to repeal its right-to-work law. Perhaps the most surprising takeaway of the study is that "free-riders" created by RTW laws may indeed be aggravating – but they are ultimately are a minor target of ire for labor unions. Yes, right-to-work laws allow workers to enjoy the benefits of a collectively bargained contract – but the paper finds that a surprisingly small number of workers toiling under a collective bargaining contract in RTW states actually take advantage of their ability to avoid paying dues.

"Right-to-work (RTW) laws prohibit union security agreements in many U.S. states, and are

Child labor... again?

Both violations of child labor laws and state legislative proposals to roll back child labor protections are on the rise across the country, according to a comprehensive new Economic Policy Institute report on child labor standards.

The number of minors employed in violation of child labor laws has increased 37 percent in the last year and skyrocketed 283 percent since 2015. Meanwhile, at least 10 states have introduced or passed laws rolling back child labor protections in the past two years (Arkansas, Iowa, Minnesota, Missouri, Nebraska, New Hampshire, New Jersey, Ohio, South Dakota, and Wisconsin).

The report comes as recent high-profile investigations have uncovered child labor violations across the country, including at Packers Sanitation Services, Inc., which illegally employed over 100 children between the ages of 13 and 17 in hazardous occupations at meatpacking facilities. These children worked illegally on overnight shifts cleaning razor-sharp saws and other high-risk equipment, and at least three suffered injuries.

Recent Department of Labor cases and media reports have also made clear that unaccompanied migrant youth left in limbo by a broken U.S. immigration system have become particularly vulnerable to exploitation by employers.

"Child labor laws are under attack in states across the country, just as violations of these standards are rising. The trend reflects a coordinated multi-industry push to expand employer access to lowwage labor, with the end goal of rewriting federal child labor laws and other worker protections for the whole country," said Jennifer Sherer, senior state policy coordinator for EPI's Economic Analysis and Research Network (EARN) Worker Power Project.

Already in 2023, eight bills to weaken child labor protections have been introduced in six Midwestern states (Iowa, Minnesota, Missouri, Nebraska, Ohio, and South Dakota) and in Arkansas, where a bill repealing restrictions on work for 14- and 15-year-olds was signed into law in March. Iowa's proposed bill has generated national headlines for being particularly extreme: The bill proposes lifting restrictions on hazardous work to allow children as young as 14 to work in meat coolers and industrial laundries, teens as young as 15 to work on assembly lines, and 16- and 17-year-olds to serve alcohol, among a long list of changes.

The primary proponents of these laws are business groups and their state affiliates, particularly the National Federation of Independent Business, the Chamber of Commerce, and the National Restaurant Association. Hotel, lodging, and tourism associations, grocery industry associations, home builders, and Americans for Prosperity - a billionaire-funded right-wing dark money group have also supported bills in various states.

Industry lobbyists have attempted to justify the changes to child labor laws by citing the decline in the labor force participation rate among 16- to 24-year-olds over the last two decades. However, the report shows that these declines are due to a larger share of young adults being in school to obtain more skills and education, a positive trend that should not be slowed or reversed.

Sub-minimum wages are in play, too, for young workers. A Nebraska bill proposes that 14- to 17-year-olds be paid only \$9 per hour, with an increase to \$10 by 2026, while minimum wage that year will be \$15.

The EPI urges Congress to increase penalties for child labor violations and address chronic underfunding of agencies that enforce labor standards and pass the union-friendly Protecting the Right to Organize (PRO) Act.

work compared to the year prior. Our state even bucked the nationwide trend and gained 300 workers in March. That month Michigan employed a total of 189,800 tradespeople.

Even among states that lost construction jobs during that 12-month period, only West Virginia (-7.5 percent) saw a significant decline. Milder losses were in Connecticut (-2.9 percent, No. 49) and South Dakota (-1.2 percent, No. 48) were also among the states that lost jobs.

Texas added the most jobs over the year (41,200 jobs, 5.4 percent), followed by New York (18,200 jobs, 4.7 percent), Florida (15,100 jobs, 2.6 percent), and Indiana (10,800 jobs, 7.0 percent).

AGC officials said demand remains strong for massive manufacturing construction projects in numerous states, while infrastructure and energy construction is expected to boom in the next few years, but the industry will need more skilled workers to produce these facilities. A conservative organization, they're now calling on officials in Washington, D.C. to allow more employment-based immigration and to increase funding for career and technical education to enable more Americans to gain the skills needed for construction careers.

"There's an immediate need for workers that can't be satisfied domestically," said Stephen E. Sandherr, the association's chief executive officer. "At the same time, Washington should help more Americans prepare for the expanding opportunities in construction by providing adequate funding for career and technical programs."

U.S. construction starts rose 19 percent in March to 1.09 trillion, according to Dodge Data and Analytics. The group said for the 12 months ending March 2023, total construction starts were 11 percent higher than the 12 months ending March 2022.

projects are breaking ground; pushing nonresidential buildings higher, while a nascent recovery in single-family starts has been supporting residential growth. Construction starts began the

year with gusto, but that is likely to erode as the year progresses, as seen by the declining trend in the Dodge Momentum Index, which tracks projects entering the earliest stages of planning.'

BUILDING MICHIGAN: Book Building and Book Tower **HISTORY IN THE MAKING**

Any city, large or small, would be proud to have Detroit's Book Building and Book Tower as a part of their downtown skyline.

The joined structures are imposing parts of Washington Boulevard's streetscape, adding an important element to the city's tremendous collection of pre-Depression mid- and high-rise buildings. And now, thanks to a glorious restoration project by Brinker/Christman Joint Venture, their subcontractors and building trades union workers over the past several years, the 16-story Book **Building and the 38-story Book** Tower are poised to reopen.

With that being said, the original exterior design choices made with the Book Building and Tower by architect Louis Kamper can run the gamut from quirky... to questionable... to "what was he thinking?" But it all kinda works.

"She's one of a kind. Some might even say beautiful in its ugliness," writes Dan Austin for Historic Detroit. "No skyscraper in Detroit, let alone the Midwest, looks quite like the Book Tower on Washington Boulevard. It's a rather awkward-looking building, whether you look at its unusual maze of an external fire escape or the intricate, over-the-top details on its crown that are tough to appreciate without a pair of binoculars. It's an undeniably unique piece of the city's skyline and a rare breed of classical Renaissance-style architecture and skyscraper. As an added bonus, joined at its hip is one of the city's oldest surviving office buildings."

The need for more office buildings downtown drove brothers J. Burgess Jr., Herbert, and Frank Book, Detroit-born entrepreneurs and real estate developers, to come up with a plan to redesign run-down Washington Boulevard. They hired Kamper as architect to build their 13-story Book Building, completed in 1917. It was Kamper's first foray into designing a tall building.

'The 13-story structure, built first, was a relatively straightforward modern office building," says The American **Institute of Architects Guide to Detroit Architecture, "although** Kamper unconvincingly loaded on a few details from antiquity, including 12 nude carvatids, or female statues, supporting the cornice." For parishioners exiting St. Aloysius Church across the street, who could see the nude figures if they peered closely at the top of the building, they were jokingly referred to as the wives of the 12 Apostles.

According to the Detroit Historical Society, Kamper designed both the Book Building and Tower in the Italian Renaissance style, clad in limestone. For the design of the exterior decorations, Kamper utilized the Academic Classicism style, seen in the intricately carved Corinthian columns, scrolls, florets, and crests covering nearly the entire surface of the building.

A year-long construction process under Sterritt-Dilks-Co. led to the completion of the Book Tower in 1926 on the corner of Grand River and Washington Boulevard. The ground floor spaces were occupied by shops; the floors above were for office space. Although limestone was an extremely common material to clad a building's exterior in the 1920s, Kamper was criticized for using it on the prominent Book Tower. Limestone is a porous material, and inevitably soot and other airborne contaminants discolored the building – for decades before the exterior received a transformational scrub during this renovation.

"A horizontal belt of Italian Renaissance sculpture surrounds the building's midsection, featuring twelve nude female caryatids supporting the cornice," the Detroit Historical Society says. "Many of these elements are difficult to appreciate from the ground." And on the tower, much of the exterior masonry "icing" decorations were placed - difficult to see and awkwardly placed some might argue - on the 25th floor and above.

The September 1926 edition of Building Age and Na-



tional Builder liked the building's figures and icing.

"These cornice breaks and ornamentation give a pleasing touch when viewed either near or from far," the publication said. But maybe that impression didn't wear well over the

"The artistic impression the tower leaves today is that Kamper didn't quite get the skyscraper idea," says The to regain the title of the tallest American Institute of Architects Guide to Detroit Architecture. "The icing almost oozes our from the multiple layers, as too much attention is paid to classical ornamentation at the expense of the building's elemental massing.'

And that lack of a mass in the slim tower created another problem unrealized by Kamper in the design phase. He made room for only a single staircase in the tower, leading the fire marshal to demand construction along the building of what might be the most prominent fire escape structure in Michi-

While there are nits to pick on the exterior of the Book buildings, the interior beauty and classic fixtures in the building are unassailable.


A 1928 postcard describes the building's "coffered ceiling, second-floor balcony and clock suspended from beam. All floors in the rotunda are of imported travertine stone, all marble columns, finish, etc. are imported Botticino marble. The four office elevators are entirely of bronze and steel." A rotunda dome in the tower was covered over decades ago to add more square footage to the building; it's now beautifully restored.

Ceilings feature painted and ornamental plaster. Marble walls line many of the upper floors' interior hallways.

The Book Tower was the tallest building in Detroit at the time of its completion, but it was overtaken in 1928 by completion of the 47-story Penobscot Building. The Book brothers had planned to build an additional 81-story tower building in Detroit, but plans were scrapped due to the start of the Great Depression in 1929.

The Book buildings had about 50 percent occupancy as late as 1993, but that percentage dwindled from competition from newer office space opening up downtown and the overall migration trend to the suburbs continued. The Book's ownership changed, and more tenants left as power was temporarily shut off to the building for nonpayment. The last tenant, a bar, left in 2009. Dan Gilbert's Bedrock company purchased the Book buildings in 2015, and like so many other historic buildings the mortgage czar has purchased downtown, it has been given a first-class renova-

Historic Detroit's Austin said "the building's uniqueness and quirkiness give it an undeniable charm." He cited William M. Worden, retired director of Historic Designation for the City of Detroit and respected authority on Detroit's architectural history, who said of the Book Tower: "How could anyone walk down Washington Boulevard and not look at that thing? Whether you consider it wonderful or grotesque, it's going to get your attention."

Generally, the assumption is that because RTW makes union membership optional, large numbers of workers will choose to "free ride" by quitting the union while still getting the benefits of union membership, leading to union decline.

But looking at the data, you see that this doesn't usually happen, at least not on a major scale. For the most part, especially in the private sector, when there is a union in a particular shop, strong majorities of workers in that shop remain union members, even if they can opt out.

Here we need to think about the symbolic power of RTW laws. "Symbolic" does not mean "irrelevant." Rather, it means that RTW serves as a symbol for a set of broader social and political changes that have very real material effects.

This is not unique to RTW laws. Other laws and events have played symbolic roles that powerfully shaped unionization dynamics in the United States. We can think of the National Industrial Recovery Act in the early 1930s. Section 7(a) of the act provided for the first time a mechanism for workers to join unions. But it was unenforceable, and employers ignored it.

Still, the law symbolized a shift in state attitudes toward unions and gave millions of workers a confidence boost to organize and fight, setting off a massive organizing wave. The law in no way caused the organizing, as it was a dead letter. But it had a powerful symbolic role in moving workers to action.

RTW laws send a message to employers that a state is 'open for business.' And one key part of that message is that it's open season on unions.

On the negative side, we can think of President Ronald Reagan's firing of the PATCO strikers in 1981. It in no way caused the subsequent collapse in union membership, since it only directly affected a small group of 11,345 workers. But it played a powerful symbolic role in crystallizing an ongoing process of labor decline and heralding a new era of aggressive anti-unionism. We can think of RTW in the same way. It arises at times when reactionary forces are ascendant.

Early on, in the 1940s, it symbolized a right-wing business backlash to the labor insurgency of the period – particularly in the Jim Crow South. It is no accident that RTW proponents first emerged in the South, where the Congress of Industrial Organizations (CIO) was building a model of solidaristic, interracial industrial unionism that threatened the white power structure.

The early architect of RTW was Vance Muse, a staunch white supremacist and head of the Christian American Association.

"white women and white men will be forced into organizations with black African apes . . . whom they will have to call 'brother' or lose their jobs."

As business sought to reassert its "right to manage" after World War II, and Southern segregationists sought to squash the incipient labor civil rights movement that the CIO represented, "right to work" served as its rallying cry. The first wave of state RTW laws came on the heels of the defeat of Operation Dixie, the CIO's effort to organize the South, in the late 1940s. It was part of a broader business countermobilization that successfully limited labor's gains won in the

previous decade. The RTW map stayed fairly stable after Kansas became the 18th RTW state with its constitutional amendment in 1958. Wyoming (1963), Louisiana (1976, after repealing a 1954 law in 1956), Idaho (1986), and Oklahoma (2001) joined in the ensuing decades.

Then there was a second raft of RTW legislation in the 2010s, spearheaded by Michigan and Indiana in 2012. Wisconsin (2015), West Virginia (2016), Kentucky (2017), and Missouri (2017, but overturned by referendum in 2018) all followed in rapid succession.

This second RTW wave differed from the first in that it involved states from the U.S. manufacturing and mining heartland, all with long histories of unionism and labor struggle. Whereas the first wave tamed a union upsurge that was threatening to spread, the second ratified long-standing processes of union decline in these states.

The justification for the second RTW wave was also different. The overtly racist appeals of the 1940s were gone, though the history was impossible to erase. Appeals to worker freedom and choice remained prominent. But what stood out was the economic rationale. Politicians promoting RTW touted its economic benefits, arguing either that it would entice businesses to relocate to their state, or that failure to enact RTW would lead businesses to leave for nearby RTW states.

This is not just rhetoric. Consulting firms that help corporations decide where to locate their reads it, holds it up, and operations often develop state 'economic competitiveness' or "business climate" metrics, and one of the factors they include is whether or not the state is RTW.

Here the actual provisions of the law are less important than what the law represents. RTW serves as a shorthand representing a whole package of proemployer, anti-worker qualities: low wages and benefits, weak unions, weak regulations, favorable tax laws, pliable politicians, and more. RTW may not directly cause all of these things, but employers know that RTW goes hand in hand with them.

Essentially, RTW laws send a message to employers that a state is "open for business." And one key part of that message is that it's open season on unions. That can shape employer expectations about what they can and cannot get away with when it comes to taking on unions, much

as Reagan's firing of the PATCO strikers did.

Likewise, it can shape workers' expectations of what they can and cannot do when it comes to fighting for their rights. Popular conceptions of RTW laws sometimes misconstrue them to mean that they make unions illegal or prevent workers from striking. These claims are false, but as any organizer knows, they can throw up barriers to organizing by constraining workers' sense of what is possible.

Legal specifics aside, the idea of a state being RTW means something much more than being a state where workers in unionized workplaces do not have to contribute to the costs associated with negotiating and enforcing their contracts. Workers and employers alike know that when they say, "X is a right-to-work state," what they're saying is "X is a state where unions are weak and employers have the upper hand."

But just as RTW's passage has emboldened employers and constrained workers, its repeal in Michigan could play the opposite role, sending a message that it's no longer open season on unions.

While labor in Michigan and elsewhere remains in tough shape for reasons that go far beyond RTW, recent developments like new organizing at Starbucks, Chipotle, and elsewhere, along with moves toward greater militancy in established unions like the Teamsters and the United Auto Workers, could take advantage of the opening that the RTW repeal has created to rebuild the labor movement.



Each individual benefit needs to have a designated beneficiary unless you want it to go to your spouse or children. As always seek the advice of an attorney.

ADDRESS CHANGES: If you have a new address please make sure to let the hall know. We will take care of your account with the union hall which includes the tradesman paper. You will need to call Benesys at 800-400-7710 and update your address with them as well. That is not done through the hall.

ACCIDENTAL DEATH and DISMEMBERMENT IN-SURANCE FROM OUR INTERNATIONAL ASSOCIATION: Members who have their dues paid in advance (prior to the month of the accident) are eligible for accidental death and dismemberment benefits up to \$7,500.00. This benefit comes as a dues paying member of SMART International.

WEEKEND WORK ASSIGNMENTS: Saturday and Sunday work assignments. Please remember that when performing work on a Saturday or Sunday the steward must report it to the hall, give each members name and obtain a form for signatures. Each member must sign the form along with the number of hours they worked. The completed form must be sent back to by hall by the end of the day on the following Monday. Weekend work assignments must be called or emailed into the hall prior to 3:00 pm on Friday.

WORK ASSIGNMENTS: Everyone must obtain a work assignment prior to starting work. If you fail to do so you could be written up on charges.

LAY-OFFS: All members must report to the Union Hall immediately upon lay-off, even if you only work one day. These are the By-Law rules for the Out-of-Work List. Your name will be removed from the list fourteen (14) days after receiving an assignment. It is very important to report to the union hall immediately after your layoff. Members get confused because the S.U.B. Fund allows you a period of up to seven (7) days to apply for S.U.B. benefits after lay-off.

LAY-OFF SLIPS/TERMINATION NOTICES: Lay off slips must accompany all applications for sub pay. Without lay off slips you cannot collect sub pay. It is the member's responsibility to make sure they get one from the contractor when laid off. Your application cannot be submitted without one. It is the contractor's responsibility to issue one in accordance with our contract.

S.U.B. BENEFITS: Report to the hall promptly upon layoff. You must complete a S.U.B. Application within seven (7) days from your layoff date or you will forfeit S.U.B. benefits. Lay-off slips

Majority of Americans like unions and don't want to see their decline: Pew poll

Majorities of Americans continue to see the long-term decline in the share of workers represented by unions as a bad thing for both the country and working people in the United States, according to a Pew Research Center survey conducted

from March 27 to April 2. Roughly six-in-ten U.S. adults say the large reduction over the past several decades in the percentage of workers who are represented by unions has been somewhat or very bad for the country (58%) and for working people (61%). These figures are nearly the same as last year.

The share of U.S. workers who belong to a union has fallen since 1983, when 20.1% of American workers were union members. In 2022, 10.1% of U.S. workers were in a union.

While there are modest demographic differences in the perceived impacts of the decline in union membership, partisan differences are much more pro-

nounced. About three-quarters of Democrats and Democraticleaning independents (76%) say the decline in the percentage of workers represented by unions in recent decades has been very or somewhat bad for the country, and an identical share say it has been bad for working people.

Among Republicans and GOP-leaners, 40% say the decline of organized labor has been bad for the country and 45% say it has been bad for working

people. Among Republicans, there are sizable age, educational and income divides in views about the impact of the decline of union membership on working people. The differences among Democrats are more modest.

Older Republicans are more likely than younger Republicans to view the decline in union membership as good for working people: 64% of Republicans ages 65 and older say the decline of unions has been very or somewhat good for working people, compared with 39% of those

under age 40. Upper-income Republicans (65%) are more likely than their counterparts in the middle- (53%) and lower-income (44%) tiers to view the decline in union membership as very or somewhat good for working people.

than a third across demographic groups see the decline in organized labor as good for working people. However, those without a college degree are 15 percentage points more likely than those with a college degree to say this (29% vs. 14%).

Lower-income Democrats (31%) are also more likely than middle- (21%) and upper-income (15%) Democrats to view the decline in union membership as a good thing for working people.

There are no substantial differences among Democrats by age.

A majority of White Republicans (57%) say the decline of union membership has been at least somewhat good for working people. The sample sizes for Asian adults and for Black and Hispanic Republicans are too small to analyze.

Meanwhile, White Democrats (17%) are less likely than Black (30%) or Hispanic Democrats (31%) to say the decline in unionization has been good for working people. The sample size for Asian Democrats is too small to analyze

Liberal Democrats are particularly likely to say the decline in organized labor has been very bad for working people: 51% say this, compared with 19% of conservative and moderate Democrats

LOCAL UNION 252: The nominations for all officers of Local Union 252 will be held on May 10, 2023, beginning at 6 p.m. at the local meeting hall located at 7920 Jackson Rd, Ann Arbor, MI 48103. Anyone desiring to be nominated must be present during the nominations, or, provide a written and signed statement that they will accept the nomination, email a written statement to 252electionjudge@gmail.com that they will accept the nomination, or mail a written statement to 252 Election Judge, P.O. Box 58, Adrian, MI 49221 that they will accept the nomination.

A member may nominate themselves for office. NO member may be a candidate for more than one office. Anyone nominated to more than one office must choose the office for which they will be a candidate.

Nominations will proceed in the order of offices as listed in the IBEW Constitution whose term of office shall be 3 years: President, Vice President, Recording Secretary, Treasurer, Business Manager / Financial Secretary, Executive Board (6 to be elected), Examining Board (3 to be elected).

In order to be nominated, a member must have a minimum of 2 years of continuous good standing in Local Union 252. Good standing means that the member is current in their payment of dues and has been for the 2 years preceding the nominations. Apprentices cannot be nominated or elected to any office EXCEPT if they have previously held a Journeyman's card at any time during their membership with Local Union 252 so they shall remain eligible to hold office (IBEW Constitution Art. 15, Sect. 14).

Pat Ulanowicz, was appointed Election Judge on Feb. 8, 2023 (IBEW Constitution Art.16, Sect.11, Amendment 30). The IBEW Local 252 President will appoint Tellers as required. None of these may be a candidate for any office. All Tellers will be vetted for a minimum of 2 years of continuous good standing in Local Union 252 by the Local 252 Financial Secretary (IBEW Constitution Art.16, Sect.11).

The election of officers shall take place between the hours of 9 a.m. and 1 p.m. on June 17, 2023 at the local union meeting hall located at 7920 Jackson Rd, Ann Arbor, MI 48103. The ballots will be counted immediately following the closing of the polls and the results shall be announced immediately after all ballots are counted. A complete listing of the results shall be posted on all union bulletin boards, union social media (or other appropriate place) by the close of business on the day following the election.

Absentee ballots shall be available to any member upon written request to the election judge. Written requests can be mailed to 252 Election Judge, P.O. Box 58, Adrian, MI 49221 or emailed to 252electionjudge@gmail.com. Such requests will be accepted up to 5 days prior to the date of the election.

Anyone receiving an absentee ballot will not be entitled to vote at the polls without first presenting the election judge with their unused ballot and the envelope used in the mailing. Absentee ballots received at the post office box after 8 a.m. on June 17, 2023, will not be counted. In the event a run-off election is required, same shall be held on July 8, 2023. The same rules shall apply to the run-off election as were applicable to the regular election. Members who requested an absentee ballot for the regular election will automatically receive same for the run-off. All officers shall be installed and begin their 3 year terms at the regular meeting of the local union on July 12, 2023.

Candidates shall be entitled to an observer at the polling place, during the counting of the ballots and when the absentee ballots are picked up from the P.O. Box. (The candidate themselves may be the observer.)

Any member who believes a protest of the election is warranted must present their protest to the election judge prior to the certification of the election results. Further, protests of the election may be filed in writing with the International Vice



The purpose of the special order of business is for the nomination of Local Union #498 Officers, Delegate, and Alternate to the International Convention. Officers will be elected to three-year terms, commencing July 10, 2023 and concluding July 13, 2026.

A member must have two years of continuous good standings in the local immediately prior to being nominated and must be present to accept the nomination, or must submit, to Recording Secretary Ryan Lautner, not later than noon of May 8, 2023 their written willingness to be nominated. The written notice of nomination shall specify a single office that they are willing to be nominated to. No member may be a candidate for more than one office. No Apprentice shall be eligible to hold office in the Local Union as stated in Article III, Section 8 (e) of the Local

Union bylaws.

Nominations shall include President, Vice-President, Recording Secretary, Business Manager/Financial Secretary, Treasurer, Executive Board (six to be elected), Examining Board (five to be elected) and Alternate to the IBEW Convention. Candidates for Business Manager/Financial Secretary/Delegate to the IBEW Convention shall also be a participant in the Pension Benefit Fund.



Next chapter to be written for beautifully restored Book Tower

workers. They worked with the firm ODA for architecture and interior renovation and Kraemer Design Group for historic preservation.

Brinker/Christman Senior Project Manager Nate Hubert said the 484,000-square-foot building was in "various states of disrepair" at the start of the project, "and we stripped nearly everything from the inside" to get the building ready for its new configuration.

"When I talk to people about the project, I tell them what kind of shape it was in four years ago," Hubert said. "At the time I took my 6-year-old daughter (Beatta) in to work with me and she said 'dad, this place is kind of sketchy.' Well, we took a place that was hanging by a thread and made it beautiful. Now she asks when she can come back to see it again."

Brothers J. Burgess Jr., Herbert, and Frank Book, Detroitborn entrepreneurs and real estate developers, foresaw a demand for additional office space in booming downtown Detroit more than a century ago. They underwrote construction of the Book Tower, which was the tallest building in Detroit at the time of completion.

The Book was originally built for office space with streetlevel retail and/or dining establishments. It gradually lost tenants beginning in the 1960s, and closed for good when the last business, a bar, left in 1993.

Following its 2015 acquisition of the Louis Kamperdesigned, Italian Renaissance Revival-style building, Bedrock embarked on a comprehensive, historic restoration of Book Tower. The building was originally found in a state of disrepair, after sitting vacant for years, including destroyed century-old plaster ceiling tiles, shattered marble wainscoting, and exposed electrical and plumbing systems.

One of the largest adaptive reuse project ever undertaken in Michigan, the new building is expected to reopen June 1 with event, meeting, office, residential, and restaurant spaces. The new space will include 38 floors crafted into 229 residential units, 117 Roost Apartment Hotel rooms and 52,000 square feet of retail. There will also be three new dining options on site. An "activated alleyway" will bring some purpose to what was also some sketchy space outside on the west side of the building.

Tradespeople on the project

•Recreated and hand-painted more than 7,000 square feet of ornate ceiling tiles to match the original designs and color of the structure.

•Reinstalled 50,000 square feet of marble.

•Replaced all 2,483 windows with modern, historically accurate versions to increase energy

 Restored 29 caryatids on the exterior of the building.

•Adapted the former office spaces into 46 unique floor plans for apartments and hotel rooms.

•Refitted the rooftop event space with a 2,200-square foot skylight.

•Repaired the building's original travertine floors.

•Revealed the classic, limestone façade for the first time in

Hubert said the biggest challenge on the project was the "vertical transportation" of workers and materials up and down the tall tower. An extremely busy exterior elevator serving the building facing Washington Boulevard provided that transportation, as the individual floors moved from an interior demolition phase to completion. While some structural reinforcements were added, Hubert said, "it's a building that still has good bones."

At peak employment, about 300 tradespeople helped re-build the Book.

'Brinker/Christman Joint Venture is definitely proud of the work we've done here; the building is an icon in Detroit," Hubert said. "We couldn't have done it without our subcontractors and the tradepeople on the job, they felt the stress of the job and they worked through the up and down vertical constraints. It took teamwork, and the trades did some great work coming up with solutions when they were needed."

Biden touts his 'blue-collar blueprint for rebuilding the middle class'

Left unsaid was whether rankand-file building trades members agree with their leaders, especially in the key industrial states around the Great Lakes.

In 2020, Biden narrowly carried the nation's most-heavily industrial state, Wisconsin, against Republican Donald Trump. His margins were somewhat wider in swing states Minnesota, Michigan and Pennsylvania. He lost Ohio, which is slowly turning redder, 45-53 percent, and never had a chance in Indiana. Biden thumped Trump in Illinois (58-41 percent) and New York (61-38 percent).

In turn, Biden gave the workers generous credit for helping to elect him to the White House in 2020, in his prior Senate career, and in steering his program through a closely split Congress in 2021-22—and especially for the five-year \$1.2 trillion Infrastructure and Jobs Act, which the construction unions and their members lobbied long and hard for in those years.

'My economic plan is a bluecollar blueprint for rebuilding" the middle class, he declared.

And Biden got in some digs at the "MAGA Republicans," too. After all, he repeatedly told the audience, they want to repeal almost all the measures he, they and congressional Democrats enacted to pull the economy out of the coronavirus-caused Depression.

He even used the infrastructure law for a shot, by name, at his erstwhile foe, Donald Trump. Biden quoted a New York Times article: "President Biden appears to be presiding over the kind of manufacturing surge that Trump had promised."

Biden spent most of his speech touting the infrastructure achievements, and blasting the House Republicans for trying to repeal them in their budget blueprint. He conveniently omitted mentioning the other half of his coronavirus recovery plan, which conservative Democratic Sen. Joe Manchin, D-W. Va., the key swing vote on those social program boosts, forced Biden to drastically whittle, under threat of sinking it in what was then a 50-50 Senate.

"Under my predecessor, 'Infrastructure Week' became a punchline," Biden declared. "On my watch, infrastructure has become a decade headline. A decade." That's an admission of the slow rollout of actual work, which he later explicitly repeated, saying that while shovels have hit the ground for many infrastructure projects, "These things take

And Biden repeatedly reminded the crowd that almost all the accomplishments occurred "without one Republican vote." The infrastructure law was the exception. Even some House Republicans, and most Senate Republicans, voted for it, so Biden didn't use the zero-Republicansupport line then.

The coming job surge, in "green" factories and plants making semiconductor computer chips, will remake the economy and make the U.S. No. 1 in manufacturing again, he stated, without proof. Those plants will be union-built, Biden declared, with prevailing wage guarantees and using Project Labor Agreements. And all the materials "will be made in America." Those lines got more cheers.

When Biden wasn't touting his and their achievements, he got in digs against "the MAGA Republicans," especially House Speaker Kevin McCarthy (R-Calif.). The speaker is threatening to send the U.S. into default on its past debts unless Biden and the Democrats bow to McCarthy's planned 22 percent cut in domestic spending and his threats to Medicare and Social Security. McCarthy would also eliminate the project labor agreements and prevailing wage guarantees of the infrastructure law, said Biden.

A default, Biden forecast, would immediately cost 870,000 jobs. It also would blow the U.S.'s credit rating to hell. Even Trump recognized that.

"Little did I think I'd be quoting Donald Trump," Biden deadpanned. "But even Donald Trump said, 'I can't imagine (anyone) ever thinking of using the debt ceiling as a negotiating wedge." Raising the federal debt ceiling is the technical term for setting a new and higher debt limit. "These guys are saying unless I agree to cut all these programs by 22 percent...and cut taxes for the super wealthy and corporations," they won't raise the debt ceiling. "Folks, America is a not a deadbeat nation. We pay

As might be expected, the crowd was enthusiastic. One building trades union, the International Brotherhood of Electrical Workers, went beyond that and "jumped the gun," so to speak. No sooner had Biden announced his re-election bid in a video that morning than IBEW announced its endorsement.

"When the IBEW endorsed candidate Joe Biden in 2019, it was because of his commitment to creating good union jobs, protecting secure retirements, addressing climate change responsibly and investing in American manufacturing. President Joe Biden has delivered on all of these pledges: Promises made and promises kept," union President Kenneth Cooper's statement read in part.

"Throughout his first term, President Biden has been a steadfast ally of unions and American workers. I am confident that support will continue in his second term," Cooper continued. "The Biden-Harris administration consistently advanced policies that empower workers, created opportunities for everyday people, and promoted the well-being of working families.

"As a direct result" Biden and Vice President Kamala Harris have "overseen robust economic growth, increased worker wages and the lowest unemployment rate in 50 years."

Biden, too, touted the 3.5 percent jobless rate, and bragged about the 12.6 million new jobs businesses claimed to create on his watch. Federal data show even more than that are in the private sector. Its job numbers have soared beyond pre-coronavirus figures under Trump. State government jobs, however, mostly in schools, still lag behind the numbers they had before the

(Continued from Page 1) frequently portrayed as a mortal threat to unionism in the country," writes the paper's author, Kyungnok Chun, who has written extensively on labor relations issues. "This paper sheds new light on the old debate surrounding the effects of RTW legislation by evaluating their impacts in six U.S. states (including Michigan) that adopted such laws in the 21st Century." The author added: "Some of these findings are quite novel, and challenge conventional assumptions about

how RTW laws impact unions." The researcher found that in the private sector, statewide RTW laws:

•Importantly, decrease union "coverage" by more than 10 percent. The author suggests that unions struggling with signing existing workers to a bargaining unit are most at risk to seeing declines in unionization rates brought on

"With materials costs fluctuating so much month-to-month, contractors remain wary about committing to projects with unpredictable costs and lead times," said Ken Simonson, the AGC's chief economist. "While inflation in the broader economy is settling back to earth, construction costs keep hitting updrafts."

The wider-ranging Producer Price Index (PPI) report issued the same day by the BLS, offered better news for the economy as a whole with a more normal inflation rate. In the 12 months through March, the PPI increased 2.7 percent, a slower pace than February's reading of 4.9 percent. This represents the lowest rate of growth since January 2021. This drop was largely driven by falling goods prices, particularly lower energy prices, fresh and dry vegetables, and services.

"For builders and developers, the recent fall in the PPI for final demand is welcome news because it signals that inflationary pressures may be receding, " said Ralph Flores, an economist at Dodge Construction Network. "This suggests that the supply chain is stabilizing since the pandemic and may potentially lead to cost savings for construction projects currently in the pipeline. This could make it easier for construction firms to bid for projects and could lead to lower construction costs for developers.

"We are optimistic that this trend will hold, and we'll see further declines in the PPI for final demand in the coming months."

by RTW. "The question might then be asked, why were these unions afflicted by high levels of non-membership even before RTW legislation?" Chun asks, and the answer might be that they "did not deliver much for their workers and so failed to inspire loyalty."

•Also importantly, RTW laws increase union wage differentials and their premium over nonunion wages, which plausibly reflect changes in union bargaining behavior. "I also find evidence that RTW laws increased union wage differentials in the private sector by around three percentage points," Chun writes.

That differential refers to a three percent higher union wage advantage, and the study found that the lowest 70 percent of income earners are the beneficiaries of that advantage. The findings, Chun says, "suggest that unions respond to RTW laws by bargaining more aggressively to deliver for their constituents, in an attempt to cement their loyalty."

•In the public sector, RTW laws are associated with declines in union coverage but may be confounded by other state-level policies aimed at weakening public sector unions.

•RTW laws do not appear to adversely affect union formation through National Labor Relations Board- administered elections.

 Levels of strike activity appear to be unaffected by RTW

•RTW laws have little effect on union membership, plus or minus, considering the small presence of "free riders" who don't pay dues yet enjoy union benefits. That's a central complaint by labor unions, but Chun's paper suggested that "fewer than three out of a hundred covered workers forego union membership due to RTW laws. "Although positive as predicted by theory, these estimates are surprisingly small and insignificant," the researcher said.

"Such a weak response in free-riding may be explained in a number of ways," Chun writes. "First, most workers who join unions may value membership by more than the fees associated with it, so that the opportunity to save on the fees entices only a few uncommitted members to leave; second, unions may respond to RTW laws by heightened efforts to recruit members and instill loyalty; third, complementing the previous explanations, the force of social custom and solidarity may be a much bigger determinant of union membership than pecuniary (monetary) considerations."

150 years of fish hatcheries

Michigan has a rich history of rearing fish since the state began operating hatcheries 150 years ago. Hatcheries are facilities where fish eggs are hatched, and fish are raised to stocking age. The use of stocked fish has long been one of the cornerstones in managing Michigan's fisheries, but it has gone through many changes over time.

The need for fish hatcheries. In the early 1800s, Michigan's landscape was largely covered by old-growth forest. Northern Lower Peninsula streams teemed with Arctic grayling. In Upper Peninsula streams, the beautiful brook trout was king. Lake trout still served as the apex predator in the Great Lakes, but this idyllic scene was about to change.

With the opening of the St. Lawrence Seaway creating a connection between the Great Lakes and the Atlantic Ocean - specifically via the Welland Canal during the 1830s – invasive sea lamprey began arriving in the Great Lakes and would soon begin their assault on native lake trout.

Rapid economic growth in Michigan and beyond would soon require massive amounts of lumber – the primary building material of the day. Environmental protection was not even a concern at the time that the timber harvest industry began to deforest the state at a ferocious pace.

Trees were harvested right up to the edges of streams, resulting in huge amounts of sand being flushed into rivers, threatening fish spawning areas. Logs were floated down streams to get them to lumber mills, scouring valuable trout spawning habitat that had not already been covered by sediment.

All of this took a tremendous toll on the trout populations. Fortunately, the timber industry now employs much more environmentally friendly practices, but those measures did not come into play

had already been done to many of Michigan's trout streams.

By the 1870s, it was apparent that Michigan's fish populations were in trouble. In response to decreasing fish numbers and habitat quality, the Michigan Fish Commission was established and the state's first fish hatchery, Crystal Springs, was opened near Pokagon in Cass County in 1873.

Over the next several decades, many more hatcheries and satellite fish rearing stations were developed across the state. They were often located near railroads, as trains were the primary means of transporting fish to their stocking sites. Fish were moved by the Wolverine, a Pullman car that was around the countryside, including sleeping and dining quarters for those tending to the fish. A replica of the Wolverine can be seen at the Oden State Fish Hatchery Visitor Center near Petoskey.

In the early days of hatchery operations, fish were most often stocked at early life stages (fry and fingerlings) because the means of transporting them dictated that large biomasses of fish could not be efficiently moved across the state.

By the mid-1940s, largersized fish known as fall fingerlings and yearlings became the more common rearing target.

Lessons learned. From the 1920s through 1940s, the Department of Conservation, predeces-

of Natural Resources, commonly stocked species such as bluegill, bass and perch. We learned through time that these species were doing just fine on their own. Beginning in the 1950s, fishery managers pivoted away from stocking these prolific warmwater species and focused more on stocking trout and coolwater species like walleye.

While it is generally known that fish stocked at larger sizes tend to survive better, stocking catchable-sized trout resulted in "truck chasing" from some segment of the fishing community. Newly stocked fish are highly susceptible to fishing, so the practice of stocking catchable-sized fish was discontinued by the mid-1960s.

Fish are stocked for several reasons, including reintroduction of extirpated species, achieving ecosystem balance between predator and prey species, rehabilitation of depressed fish stocks and to provide diverse fishing opportunities.

Where possible, fishery managers strive to rely on natural reproduction to sustain fisheries. However, due to factors such as high fishing pressure, lack of spawning habitat, etc., stocking of hatchery-reared fish is likely to remain a common practice into the foreseeable future.

salmon. The late 1960s marked a new era of fisheries management in Michigan, as the Pacific salmon stocking program came into being. Coho and Chinook salmon eggs were imported from Pacific Northwest states, with the hope that the resultant salmon populations would staunch the uncontrolled growth of invasive alewives that had rendered many Great Lakes beaches unusable by tourists.

This program proved to be wildly successful, and it served as the impetus to move Michigan DNR hatcheries into the modern era.

The Platte River State Fish Hatchery, located west of Traverse City near the town of Honor, was the first of Michigan's hatcheries to be rebuilt. It was converted from a satellite trout-

primary Pacific salmon hatchery. Thus began the transition from many rearing facilities and hatcheries rearing fish at relatively low densities to only six modern facilities that were designed to rear fish at higher densities.

The switchover to modern facilities with higher targeted rearing densities has been very successful, but it came with its own learning curve and costs. High densities can cause stress for fish, and that can lead to health problems. Over the past 10 to 15 years, rearing densities have been ratcheted back somewhat to focus more on health and quality, rather than quite so much on quantity. The result is healthier, more robust fish that perform better after being stocked in lakes and streams.

The modern facilities largely rely on pumped well water that gets reused multiple times and must be re-aerated between uses. That means these facilities are reliant on complex mechanical systems, maintained by highly trained staff.

The Michigan DNR was fortunate to receive a \$30 million appropriation in fiscal year 2023 to be used to catch up on the backlogged maintenance needs at all six hatcheries and to make energy-efficiency improvements.

In all, the Michigan DNR currently operates six fish hatcheries, five permanent egg-take stations and up to 40 rearing ponds. In addition to the permanent egg-take stations, the DNR collects eggs and sperm from natural spawning runs of walleye, lake sturgeon and muskellunge.

The Marquette State Fish Introduction of Pacific Hatchery had a partial renovation completed in 1994. This included construction of a new incubation and early fish rearing building. Marquette serves as the brood and sole production facility for all the char species stocked by Michigan's fishery managers. The Arctic grayling brood fish are also held at Marquette. The rearing program includes brook trout, lake trout and the hybrid splake, which is a cross between female lake trout and male brook trout.

> Thompson State Fish Hatchery is a few miles west of the Upper Peninsula town of Manistique. The rearing program there has included Chinook salmon, steelhead, Atlantic salmon, brown trout and rainbow trout in the years since the facility's rebuild in 1976. Thompson also

and hatching station. In 2021, a new coolwater production facility was constructed at Thompson, adding muskellunge and spring fingerling walleye production to the rearing program. The coldwater species currently reared at Thompson include Chinook salmon and steelhead.

Oden State Fish Hatchery Oden State Fish Hatchery has been in operation since 1921. Over the years, Oden has reared brook trout, brown trout, rainbow trout, Arctic grayling and coho salmon. Having been fully rebuilt in 2002. Oden is the most recently modernized Michigan hatchery.

Oden's current rearing program includes both brood and production fish for the brown trout and rainbow trout stocking programs.

The Platte River State Fish Hatchery was fully rebuilt in 1975 and underwent a partial renovation that was completed in 2004. The current rearing program at Platte includes Chinook salmon, Atlantic salmon and 100 percent of the coho salmon produced by the DNR. Platte also incubates and hatches walleye eggs each spring.

The Harrietta State Fish Hatchery is located about 13 miles west of Cadillac. The longest continually operating hatchery in Michigan, Harrietta was originally put into service in 1901. Over the years, brook trout, brown trout and rainbow trout have been reared there. A full hatchery renovation was completed in 1978. The rearing program at Harrietta now includes brown trout, rainbow trout and Atlantic salmon.

The Wolf Lake State Fish Hatchery underwent a total renovation that was completed in 1982 and included construction of a new hatchery and early rearing building, as well as 12 new concrete outdoor raceways. A standalone visitor center was also built. Over the years, Wolf Lake has reared many different species, including Arctic grayling, lake sturgeon, brown trout, Atlantic salmon, Chinook salmon, walleye and muskellunge. The current rearing program at Wolf Lake includes muskellunge, walleye, steelhead and Chinook salmon.

In an average year, the Michigan DNR stocks 20-25 million fish at up to 1,000 stream, inland lake and Great Lakes sites to support fish populations throughout
