Union 'salting' gets more difficult

WASHINGTON, D.C. (PAI) – The top National Labor Relations Board's enforcement official and de facto chief of staff, Acting General Counsel William Cowen, is making the common construction union organizing strategy of "salting" even tougher.

The actions came in July 24 Cowen memos to the board's regional officials. Since right now the NLRB doesn't have a quorum and can't function as a result, Cowen is basically running the show. And even though he's a career NLRB attorney, he knows which way the political wind is blowing.

President Trump seems disinclined to seat a three-person quorum to the five-member NLRB - which handles most labor-management cases, elections and unfair labor practice complaints in the U.S. Only two members sit on the board; Trump fired Biden-appointed member Gwynne Wilcox in late January, destroying the

Cowen's memos are important. One will make it harder for a union-affiliated construction "salt" to prove they're a legitimate worker qualified and eligible for the nonunion employer's open job, salt or not. Construction unions often use out-of-work members as salts seeking jobs during organizing drives at nonunion companies.

The NLRB has always re quired the alleged salt to "prove a legitimate interest" in the posted job, although it's ostensibly illegal for them to discriminate based on a workers' union status. Now the salt can be turned away or fired from a job based on subjective "belligerent or offensive comments on his or her application, disruptive, insulting, or antagonistic behavior during the application process, or engaged in other conduct inconsistent with a genuine interest in employment," the memo said.

Full house for unions in Las Vegas Strip

The Venetian has been the lone holdout among Las Vegas Strip casinos in not recognizing the Culinary Workers union for its workforce.

That changed late last year, as new ownership at the casino/hotel wrought a union contract with the Culinary Workers Union, which now represents 60,000 workers, most of them in Las Vegas. The agreement brought an historic 32 percent bump in pay for workers over the life of the five-year contract. It also means that workers in every casino/hotel on the Strip have been organized by the Culi-

nary Workers. Then, two months ago, the Operating Engineers Local 501, which represents 10,000 maintenance engineers, slot technicians and other facilities workers in Nevada, Arizona and California, announced they reached an agreement to collectively bargain for 400 employees at the Venetian.

Michigan celebrates holiday for labor

The annual celebration of the American worker will take place in various communities statewide in Michigan, whether it's a walk over the Mackinac Bridge or a cookout in your union hall's parking lot, or a full-blown parade and picnic afterward.

Hopefully you will take time on Monday, Sept. 1 to take part in a Labor Day celebration near you. This year is an especially important one to exhibit some solidarity, with more than a million federal union workers seeing their collective bargaining agreements canceled by the Trump Administration in an historic, union-busting move.

Following are some Labor Day celebrations scheduled around Michigan:

Detroit – The city's Labor Day Parade will start at 9 a.m. on Monday, Sept. 1, at Michigan Avenue and Sixth Street, at the Lodge Freeway overpass. Beginning at 8 a.m., the building trades will line up on Sixth Street south of Michigan Avenue, then stage for a few blocks south to Porter Street and then on Porter west to Trumbull.

The order of lineup for the Detroit march: Pipe Trades, Michigan Regional Carpenters Council, Roofers, Sheet Metal Workers, Boilermakers, Bricklayers, Painters, Iron Workers, Laborers, Heat and Frost Insulators, Elevator Constructors, IBEW, Cement Masons, and Operating Engineers.

Trump's union-busting of 1M federal workers upheld by appeals court

President Trump's attack on federal labor unions was swift, all-encompassing, historic, and so far, legal.

On March 27, the president signed an executive order ending collective bargaining for federal workers employed over an array of federal agencies, citing their union contracts as a "national security" threat.

The order was held up in June, when federal Judge James Donato, issued a preliminary injunction against it, saying the order raised legitimate concerns about the president targeting specific unions in "retaliation for protected speech." But on Aug. 1, a federal appeals court lifted that preliminary injunction, which had been temporarily preventing 21 federal agencies from implementing Trump's order.

The American Federation of Government Employees, the lead plaintiff in the case and the largest federal union, argued that the Trump Administration had selectively enforced the executive order. Some agencies were allowed to recognize unions while others barred union agreements. Trump had framed his order stripping workers of labor protections as critical to protect national security. But the plaintiffs – a group of affected unions representing over a million federal workers – argued in a lawsuit that the order was a form of retaliation against those unions that have participated in a barrage of lawsuits opposing Trump's policies.

Indeed a White House fact sheet on the executive order called out "hostile federal unions" and "certain federal unions" who "have declared war on President Trump's agenda" and who are "fighting back" against Trump in the courts.

But the three-judge Court of Appeals panel, which overall has a liberal record, ruled in Trump's favor. "The government has shown that the president would have taken the same action even in the absence" of the union lawsuits," the judges wrote. Even if some of the White House's statements "reflect a degree of retaliatory animus," they wrote, those statements, taken as a whole, also demonstrate "the president's focus on national security.'

The 1978 Civil Service Reform Act allows federal employees to collectively bargain with agency-employers. Trump cited a portion of the law that allows a president to issue an order excluding an agency from coverage of the law if he "determines that the agency has a primary function of intelligence, counterintelligence, investigative or national security work, and the provisions of this chapter cannot be applied to that agency or subdivision in a manner consistent with national security requirements and considerations."

Specifically, the order will cancel collective bargaining agreements at the departments of Defense, Veterans Affairs, State, Treasury, Justice and Energy, as well as the National Science Foundation, Environmental Protection Agency, U.S. Agency for International Development (USAID), Nuclear Regulatory Commission, International Trade Commission, Federal Communications Commission and General Services Administration.

The order also impacts components of the departments of Interior, Agriculture, Commerce, Homeland Security, and Health and Human Services. Collective bargaining rights for teachers, nurses, and even cooks were eliminated under the order.

The appeals court also said it believed the government had "established a likelihood that it will suffer irreparable harm absent a stay" on the preliminary injunction. AFGE has maintained, (Continued on Page 5)

'Uncertainty' is the byword as construction edges ahead

The latest federal numbers show U.S. construction spending is down, but industry employment rose a bit, and a "Momentum Index" has wind in its sails.

"Employment growth in construction has slowed over the past year," said Ken Simonson, chief economist of the Associated General Contractors of America, on Aug. 1. "As more structures that broke ground in past years reach completion, it is likely that industry employment growth will taper off even more."

Well, that's one point of view. A rosier outlook came from Dodge Data and Analytics, which reported on Aug. 7 that its Momentum Index for the month rose 20.8 percent.

"Planning data skyrocketed in the month of July on the back of several large projects entering the planning queue for data centers, research and development labs, hospitals and service stations," said Sarah Martin, associate director of forecasting at Dodge Construction Network. "Combined with more organic momentum in planning for hotels, warehouses, and recreational projects, cumulative activity drove record highs in the DMI.

"After months of wait-andsee due to tariff uncertainty, owners and developers have begun to move forward with projects and assumed higher costs for them."

As we've pointed out, predicting the future course of the sprawling U.S. construction industry can be a bit thorny. The (Continued on Page 5)

Masons set course for new wall at Greenfield Village

DEARBORN - The wind, the rain, the ground's freeze-andthaw cycle, and some pretty gnarly tree roots have not been kind to the structural integrity of miles of brick wall and wrought-iron fence surrounding Greenfield Village.

Also unkind has been the regular passage of an historic train ferrying visitors around the village – the rumble of old locomotives along nearby track and the resulting vibrations have helped lead to failures in the masonry.

But the fix is in – and actually, repairs have been ongoing at

Workers' 'we-they' test

Yesterday I went into a local Starbucks and asked the barista behind the counter a simple question: "How is it to work here?"

He was understandably cautious in answering me. After all, I could have been a corporate stooge (Starbucks is doing whatever it can to bust unions, including firing workers who appear to be disgruntled and may be trying to organize a union). Then he said, reluctantly, "they treat us okay."

"They." That was the key word.

In honor of Labor Day, I want to give you a simple way to test for a good workplace. I came up with it years ago when as secretary of labor I visited workplaces all over America. I call it the "we-they" test. Ask a front-line worker a general question like "how is it work here?" or "how's your job?" or "how would you describe this workplace?"

Then listen for the pronoun. If workers describe the company as "they" or "them," it's a tipoff that workers regard the company and its executives as being on a different planet.

If workers describe the company as "we" or "us," the company instills a sense of pride and ownership in its workers.

Even a statement like "they aim for high quality here" suggests a workplace where employees regard the company and its

top executives as being on the other side of a great divide. Over the years, I've discovered that "we" companies achieve higher levels of quality, productivity and service than "they" companies. I could give you many examples, but let me offer the L-S Electro-Galvanizing Co. in Cleveland – at the heart of the Rust Belt. L-S passed the "we" test with ease. Every front-line worker I talked with told me how "we" were meeting the competition, how 'our" company was succeeding.

L-S Electro-Galvanizing won awards for quality. Its customers were loyal, and its profits were mounting. Why the success? The company's equipment for putting zinc coatings on cold-rolled steel was available to all competitors (including those abroad with cheaper labor). L-S Electro-Galvanizing's secret was its workers, who were constantly discovering better ways to use their equipment and serve their customers. The galvanized steel emerging from the factory was consistently high quality, tailored exactly to customer specifications and sold at a competitive price.

L-S's workplace was organized from the bottom up. When I visited, I couldn't tell managers from employees. All wore the same uniforms, parked in the same parking lots, ate in the same cafeteria. Worker committees did the hiring, decided on pay scales linked to levels of skill, and set production targets. They rotated jobs, so that every worker gained knowledge of the entire system. More than 10 percent of payroll was spent on training. And jobs were secure. Even during the recession, when its customers were scaling back, the company kept everyone on board.

All prospered together when the company did well. Workers received gain-sharing bonuses based on plant productivity and profit-sharing bonuses based on company performance. Almost no one ever quit. And L-S was unionized.

That's been my experience, too: As odd as it may seem, unionized workers are more likely to use the "we" pronoun than non-unionized. That's probably because unionized workers have a voice. They have more security. They're paid better. So they're not continuously at war with management. Workers and managers have to get along.

By contrast, Starbucks has consistently failed my "we" test. Its workers have no sense of ownership or control. Top executives regards them as replaceable parts. All decisions come from the top. The company's militant anti-unionism is a consequence of this culture.

Why aren't all workplaces "we" workplaces? Because top executives don't want to give up control. They don't want to entrust front-line workers with day-to-day decisions. Meanwhile, America's front-line workers feel bruised and beaten by years of promises unkept, real wages and benefits cut, and jobs eliminated. Many of them were dubbed "essential" during the pandemic – but

Masons set new wall at Greenfield Village

(Continued from Page 1) various times over the years and on various sections of the fence surrounding most of the 93-acre The Henry Ford/Greenfield Village complex. Grunwell Cashero and Bricklayers and Allied Craftworkers Local 2 masons have performed many of those repairs over the years - and a crew was back for eight weeks this summer repairing a failing 200-foot brick wall section along Village Road, some of which had started to lean.

"I'm proud to be on the team here that's preserving a bit of the history of Greenfield Village,' said Michael Hipes, a BAC Local 2 member and Grunwell Cashero project superintendent. "It's always nice to be here working at the village and it's a pleasure to be able to help preserve this for future generations."

The fence and walls around the village date to about 1932, the year before Henry Ford opened the site to the general public as a museum of American history and artifacts. Since selective repair work on the village's walls and fences started decades ago,

replacement matching brick has been manufactured by Brick Tec Architectural, Inc. Hipes said the mix for the matching mortar was similarly established years ago.

In the section the crew was replacing this summer, the brick had to be 100 percent removed and replaced. The existing wall was not pinned to the footings, which would have helped its longevity. But there were other factors in its demise.

"The existing foundation here is solid, it's 42 inches down and in great shape. It outlasted the wall," said BAC Local 2 member and Grunwell Cashero Foreman Oliver Cox. "What took out the wall was the roots, the weather – and the train."

Ahh, the train. One of five historic locomotives pulls visitors in coaches around the village every half-hour or so. And the wall section that Grunwell Cashero masons were replacing this summer sits only about 25 feet from a section of track. "Feel

the vibration?" Hipes said, urging a visitor to put his hand on part of the wall as the train passed.

The new wall will be reinforced with re-rod imbedded in the footings. And the design calls for the use of expansion and control joints, as well as the use of some caulk, to allow for the wall to have more flexibility.

Cox, a 28-year member of BAC Local 2, said his father, himself and now his son have worked on the walls at Greenfield Village. "We have a lot of experience among us out here, and I'm glad to be a part of the tradition," he said. "This is a job built to last - maybe another hundred years or





BUILDING MICHIGAN: Michigan's clay capitol HISTORY IN THE MAKING



THE GRAND LEDGE CLAY PRODUCTS CO. plant, in a postcard view, date unknown. The company was formed in 1906. The plant's clay products were not sewer lines to compete with their neighbor (at right), but primarily undergound conduit. "Clay Products manufactured conduits for underground telephone wires," says the Grand Ledge Historical Society. "Chicago was a prime market for that product, and many a street in Chicago still has Grand Ledge tile underneath it. These telephone conduits – hollow, pipe-like tiles – were also used as building materials." Mortar was often used to join the tile, which could make the sections inflexible and vulnerable to breakage.

When the glaciers receded from Michigan more than 11,000 years ago, they left behind a rich assortment of rocks, rock formations, and minerals. Sometimes local communities were named after those rocks and minerals – Copper Harbor, Alabaster, Petoskey, just to name a few in Michigan.

And sometimes, the lay of the land provided the place's name: here we take a dig into Grand Ledge, which was settled in the 1830s and became a village in 1864. Located about 12 miles west of Lansing, it was named for its sandstone and quartzite rock ledges that rise 60 feet above the Grand River.

But it was the quality and abundance of a less visible mineral – lowly clay – as well as a significant shale deposit, that helped create a prominent industry, and put Grand Ledge on the map for pottery manufactures and cities looking to install sewers and pipe covering.

all sewers and pipe covering. "Local investors decided to capitalize on Grand Ledge's rich clay deposits found in the area," wrote David Haueter for Remembering Grand Ledge. "For many decades, Grand Ledge was known around the country for its clay industry. Grand Ledge was the clay products capital of Michigan and some years produced more clay products than any city in the nation. The large industrial pottery factories began here in the 1880s."

Haueter wrote that in 1886, investors purchased 40 acres of land on the south side of West Jefferson Street and founded the Grand Ledge Sewer Pipe Co. Shale, a sedimentary rock that can be used in the manufacture of clay products like brick, tile, pipe and pottery, was quarried in a pit on the site behind the factory. The clay that was also quarried was fired in 12 large beehive kilns to produce a wide range of sewer and drainage tile.

This first clay pit became Grand Ledge Clay Products

exhausted and the plant was sold in 1898 to a competitor, the Ohio-based American Sewer Pipe Co. Shale itself is a sedimentary rock composed of clay-sized particles that can be crushed, mixed with water, and then processed and fired like clay, a fact that became apparent to other investors.

A number of Ohio workers came north and settled in the area. The company purchased 61 acres across Jefferson Street, along the Grand River, and a new shale quarry was excavated at the site of what today is the city's water treatment plant. Shale was put into small rail cars and pulled by mules along narrow tracks to the factory across the road.

Many of the same local investors again decided to band together and form a second clay factory. In 1906 these businessmen, among them were John Fitzgerald and R.E. Olds of Oldsmobile fame, formed the Grand Ledge Clay Products

The company was founded in 1886, and its clay pipe products would be used for decades to evacuate sewage in American cities. The company would later operate under the names "American Sewer Pipe Co." and then "American Vitrified Products." The process used to produce tiles did not change much over the years. Chunks of shale were ground and sifted into a fine granular powder that was mixed with water to form a soft clay. The clay was then forced down through an extruder into a die to form the products.

Co. They purchased a parcel of land at the corner of West Jefferson and Lawson Road which showed excellent prospects for rich deposits of shale. Over the years, the factory mined several clay pits, all of them along the river on Lawson Road. The new factory's land was also right next to the Sewer Pipe Company's parcel (today's Fitzgerald Park).

Meanwhile, American Sewer Pipe Co. "became American Vitrified Products in 1912," wrote Haueter. "It was the largest factory of its type in Michigan and one of the largest in the United States, employing about 100 men. Working with the hot kilns, fire was always a danger. The plant caught fire and burned in 1923 and was rebuilt larger in 1924."

Owing to the diversity of uses of clay and shale-based products at the time, American Vitrified Products and Grand Ledge Clay Products Co. and were neighbors using the same raw materials in their products — but they weren't competitors.

raw materials in their products
– but they weren't competitors.
"Vitrified," as it eventually became known to locals, produced clay pipe and drainage tiles used by sewer system

installers. Grand Ledge Clay

Products took advantage of a new trend in community development: using conduit to encapsulate buried telephone and electric lines.

"Grand Ledge Clay Products specialized in this new product and eventually shipped tons of clay conduits all over the nation," wrote Haueter. "Chicago was a major market. The clay conduit was a tube, about a foot long and three inches square. It was made in single tubes, or could be fused together into bundles of two, four or six. Ironically, in spite of local editorials calling for their use to bury our power lines, Grand Ledge was not one of the cities to use them."

Clay Products was one of the larger employers in Grand Ledge, with about 90 workers. They prospered making clay conduit until the 1930s. During the Great Depression production slowed along with the nationally economy. Then in 1937 a fire destroyed the factory and the dies used to extrude the conduit forms. The factory was rebuilt and the company used the opportunity to shift production to sewer tile, drainage tile and chimney flues.

The Great Depression forced the closure of the American Vitrified Products plant from 1930-1937. The plant later reopened and was in operation until 1966. Upon its closure, part of the land was added to Fitzgerald Park, some of it was redeveloped into a mobile home park. Most of the pit was filled in

Clay Products lasted two decades longer. By the late 1970s the work force shrank as competition from plastic pipes increased. In the 1980s the company tried to expand into floor tiles and other products. The efforts seemed to come too late however, and the plant was closed in 1986.

Grand Ledge's natural resources were utilized for years by Native Americans who made pottery out of the clay and ground shale with the use of ash kilns.

Bricks were also manufactured in town, a company that later became the Face Brick Co. was founded in 1914 along the Grand River. The plant started by producing glazed silo tile that were used by numerous farms in Michigan and Ohio, but the plant soon switched to brick production.

Let's be honest: Labor Day has lost its way. What started as a hard-fought tribute to America's union mem-



cians are doing everything they can to crush the labor movement Labor Day was meant to honor.

We're done with the hypocrisy. This year, the labor movement is taking Labor Day back.

Because let's not forget: this day belongs to us. It was a Machinist – Matthew Maguire of the International Association of Machinists and Aerospace Workers – who first proposed Labor Day back in 1882. From the start, it was about recognizing the contributions of working people and the power of organized labor. The IAM has never forgotten that legacy, continuing to lead the way with rallies, parades, and actions that speak louder than any politician's tweet.

Meanwhile, union-busting is running rampant across America:

• Donald Trump and his Project 2025 crowd are openly scheming to dismantle the NLRB and wipe out decades of worker protections. It's deregulation and privatization on steroids – and working people are the target.

•Tesla is firing workers for organizing, all while pushing unsafe conditions and silencing whistleblowers.

•Amazon is spending millions on union-busting consultants and retaliating against warehouse workers who dare speak up.

• Whole Foods (Amazon) is using the power of deep pockets and

a crippled NLRB to beat back a union victory in Philadelphia. • Starbucks has become the poster child for corporate hypocrisy - claiming to support its workers while refusing to bargain with over 400 unionized stores.

• Trader Joe's, REI, Google, Apple – they're all using different flavors of the same union-busting playbook, hoping their brand image will mask the exploitation happening behind the curtain.

But workers aren't backing down. They're organizing. They're striking. They're winning elections and demanding contracts. They're building the kind of solidarity that scares the hell out of CEOs.

Labor Day isn't just a break – it's a reminder. A reminder of the fights we've won. The power we still hold. And the work we've got left to do. And this year, we're taking it back.

co-president of Public Citizen. "Trump's union-busting efforts are an order of magnitude greater than (former President Ronald) Reagan's attack on the air traffic employee union; he is working to destroy the independence of the (National Labor Relations Board) and he has perpetrated possibly the largest ever transfer of wealth from working people to the super rich. This Labor Day, Americans are joining together to reject Trump's authoritarian anti-worker agenda and demanding the society we want and need."

The AFL-CIO, its building trades affiliates and other labor organizations are watching and speaking up, and have been using the weeks leading up to Labor Day as a time to spread the alarm about the full-scale public and private attack on the nation's labor unions.

"Big corporations and billionaires like Elon Musk and President Trump launched the biggest attacks on unions in history because they know that when we stand together, we have the power to speak out and fight back,' said AFL-CIO President Liz Shuler. "As I've been traveling the country this summer, I've been inspired by the energy and enthusiasm workers have to create a better future where we all earn fair wages, and have good health care, a secure retirement and the dignity we deserve on the job. It's better in a union – and we won't stop until all workers have a fair shot to join one."

As July turned into August, the AFL-CIO stepped up its public campaign against the Trump Administration's attack on workers, both in the courts and in the streets.

The courts part, is an ongoing effort by organized labor to use the judiciary to stop the Trump Administration's removal of collective bargaining rights for 81 percent of the federal workforce, on the thin and nonsensical argument that unionized workers are a security threat to the federal government.


The "streets" part, stretches from New York, Chicago, Boston and Los Angeles to Dallas, Decatur, Corpus Christi, the Twin Cities, St. Louis, Atlanta, Cleveland, Denver, Detroit, Seattle and Washington, D.C., with those sites and others hosting rallies, speeches, leafleting, picnics and worker leaders campaigning for lost workers' rights.

The "Workers Deserve Labor Day" week of action in the days prior to Labor Day will be a culmination of the AFL-CIO's "It's Better in a Union: Fighting for Freedom, Fairness and Security" bus tour, which will wrap up after two months of crisscrossing the country with two buses, to highlight workers' fights to organize, win fair contracts and counteract the impact that reckless policies are having on our lives.

"The CEOs and billionaires are scared of us. That's why they're attacking us. I've got a message for those who are assaulting our rights: You're right to be scared. Labor Day celebrations around Michigan this year are an opportunity for union members to put a public face on a union-positive trend in the nation. "The American people are rooting for workers," the AFL-CIO said. "With more than 70 percent of Americans and nearly nine out of 10 people younger than 30 supporting unions, the fight for freedom, fairness and security has never been more popular.

"The week of action will protest political attacks against unions, call out the un-American union-busting tactics of CEOs and demand an end to the Trump Administration's devastating cuts that are crippling communities, all while sharing our positive vision for a country that respects and celebrates all working people and our families.

however, that Trump's order on collective bargaining is both "overinclusive" and "under-inclusive," as it covers agencies with no connection to national security, while also exempting some law enforcement employees. Exempted from Trump's order were unions representing law enforcement and firefighters, the only unions to endorse the president ahead of last year's election.

AFGE National President Everett Kelley described the appeals court decision as "a setback for First Amendment rights in America." "While we assess this order's impact and our next steps in these preliminary injunction proceedings, we remain fully committed to fighting this case on the merits and are confident in our ability to ultimately prevail," Kelley said.

'Uncertainty' is the byword as construction edges ahead

AGC and the Labor Department said July's numbers showed only a mild uptick in construction jobs of 2,000, with U.S. industry spending on projects underway in June decreasing by 0.4 percent from May.

Overall U.S. construction employment totaled 8,310,000, seasonally adjusted, in July, which represented a 1.2 percent increase compared to July 2024. Year over year from July 2023 to July 2024, the gain was 3.1 percent.

The key word for the industry's future seems to be "uncertainty." "Uncertainty about tariffs and labor availability have caused owners to delay, stretch out, shrink, and cancel projects," The AGC's

Said Dodge's Martin: "As economic and fiscal uncertainty remains prevalent, volatility in planning activity will remain elevated."

Plumbing Law Changes: Starting March 20, 2025, anyone performing plumbing work in Michigan must either be registered and in good standing with the State as a plumbing apprentice or hold a current journeyman or master plumbing license. The new legislation also establishes a ratio of one journeyman for every two apprentices, with significant penalties, including steep fines and the suspension or revocation of a plumbing contractor's license for non-compliance.

This is excellent news for our industry and presents a great opportunity to expand our market share in West Michigan. Make sure that your license or apprentice registration is up to date with the State. If your license has expired or you need to register as an apprentice, you must contact the State Licensing Division at 517-241-9316.

Contract Ratification: At the special called meeting on July 1, the members voted to accept the bargaining committee's recommendation and ratify the new three-year collective bargaining agreement. The new agreement is as follows: 1st year \$4.20/2nd year \$3.30/3rd year \$10.80 over 3 years.

Language changes:

Section 13.2 - reduces the number from issuing orders from 4 to 2 to receive foremen pay.

Section 10.2 - Health care will be on hours paid not hours worked. *The contractors will now be administering the ESTA benefit.

ATTENDANCE: Please be reminded that Local 25 is at full employment with seven travelers working in town at the time that this is being written. During a quick "Hours Report" investigation it was determined that over a 12-week time period one of our mid-sized employers lost 52 mandays to absenteeism. Most of those days the call to report the absence did not come until the day of the absence and on a few occasions the call did not come in until after the start of the shift. Please be mindful of the effect that absenteeism has on our employers, our jobsites, our benefit funding and on each individual employee's own benefit package.

Example: When an employee does not maintain 140 hours in a month that employee must draw from his/her Health & Welfare banked hours to keep themselves funded. If you are an employee that is taking (or has been taking) an excessive number of days off, please be mindful of the effects of your actions. Please inform your foreman and superintendent of scheduled days off prior to the day of your absence. Refer to Article XII of our agreement between Master Insulators Association of Southeast Michigan and Local 25 International Association of Heat & Frost Insulators and Allied Workers. Section A outlines the agreed upon terms regarding absenteeism and tardiness.

Northern Valley continues work at the Holcim Cement Plant and Oscoda's Air Base, as well as many smaller projects and service calls. Pierce Powerline is wrapping up work in the Oscoda Schools and a commercial remodel in Mio.

AZCO has begun work on a larger Solar Project at Consumers Energy's Karn site in Essexville. Calls have begun to come in and will continue through the fall.

Multiple Prevailing Wage projects in Bay City have been bid or will be bid soon. Calls are starting for another Solar Project will begin late this summer or early fall in the Gladwin area. This Solar project has seen many delays but finally seems to be







<u>Outdoors</u> Long live our lake trout!

The oldest known lake trout in the Great Lakes, 62 years old at the time of capture, was recently documented by researchers at the Michigan Department of Natural Resources Marquette Fisheries Research Station.

This fish was collected from Klondike Reef in Lake Superior in the fall of 2023 by a team of intrepid researchers from the DNR, U.S. Fish and Wildlife Service, University of Wisconsin-Milwaukee and Purdue University.

Age is one of most important variables in tracking population health for fish, and this finding indicates that lake trout indeed live long and prosper in Lake Superior.

In March 2024, Dan Traynor, fisheries technician at the Marquette Fisheries Research Station, was working in the lab, processing samples collected in September 2023 at Klondike Reef, a remote offshore area near the Canadian border, 40 miles north of Grand Marais.

Traynor, one of the few experts on the age assessment of lake trout in North America, assigned the age of a humper lake trout collected during the survey. Humper lake trout are one subspecies of the fish found in offshore lake mounts in Lake Superior. They are slow-growing and don't get very large because they mostly feed on invertebrates.

The fish was female, weighed 2.1 kilograms (4.62 pounds) and was 627 millimeters (24.7 inches) in length. These stats aren't remarkable – the longest collected by the Marquette Fisheries Research Station was 53.1 inches and the heaviest collected was 35.5 pounds. The state record for Michigan is 61.5 pounds.

What was remarkable was the lake trout's age, estimated to be 62 years old – the oldest documented lake trout in the Great Lakes.

This fish, that DNR staff

has named "Mary Catherine," hatched in 1961 (Mary was one of the most common names for babies born that year). When Grandma Mary Catherine hatched, the U.S. president was John F. Kennedy and Yuri Gagarin was the first human to go into outer space.

If fish went to school (high school that is, not just schools of fish), she would have graduated from Klondike Reef High School in the same year as Meg Ryan, Princess Diana and Barack Obama reached that milestone.

This growth leaves rings each winter, similar to tree rings, which can then be counted to estimate the fish's age.

Lake trout are adapted to live in unproductive ecosystems with limited food resources, which makes them take the tortoise approach in life – high longevity over the long road, in contrast to salmon, which live and must do everything on their bucket list in only about four years.

Animals and plants that live in extremely unproductive environments with little food and extreme temperatures and weather (such as the Arctic, deep-sea trenches or deserts) take a long time to grow.

For example, some spruce trees that are only a few feet tall in the Arctic/boreal regions can live to be several hundreds of years old because they get limited sunlight and nutrients and grow very slowly.

The upper Great Lakes are considered oligotrophic (lowproductivity) ecosystems because of how deep, cold and far north they are. This is especially true for Lake Superior, the deepest of the Great Lakes, with an annual average surface temperature of only 40 degrees Fahrenheit and average depth of 483 feet.

Lake trout evolved and adapted to live in this type of ecosystem, and that is why lake trout can thrive at all depths in Lake Superior, even at Superior Maximus, the deepest location in the Great Lakes -1,332 feet) which was first explored in June 2006 by the Marquette Fisheries Research Station

Due to environmental conditions, competition for resources and fishing, the typical life span for a lake trout in Lake Superior is 25 to 30 years.

Prior to this discovery, the oldest known lake trout in Lake Superior, which was reported by the Wisconsin Department of Natural Resources in 1998, was

Age is one of the most vital statistics used to assess the health of fish populations. Scientists look at the age distribution in fish populations to measure mortality, growth and longevity.

Mary Catherine was captured during a special survey to inventory the ecomorphs (subspecies) of lake trout at Klondike Reef (part of the Caribou Island Reef complex), and also to study their reproductive biology.

This study will provide more details on the life history and biology of Klondike-strain lake trout to help fishery managers better understand where to stock these fish and what to expect in terms of their performance.

The survey was conducted by the DNR's Research Vessel Lake Char, which is crewed by specialists skilled in exploring the varied habitats and enduring the sometimes-harsh weather conditions encountered across Lake Superior.

The RV Lake Char crew, with home port in Marquette, is a blend of science and maritime professionals comprising two research technicians, two captains and a research biologist.

This team is highly experienced in working in deep water and has spent many hours together exploring the vast extents of Lake Superior, from Isle Royale to Superior Maximus.

The Klondike Reef expedition required the crew to plan logistics of operating in remote offshore areas far from land, conduct a reconnaissance of the area (much of that area is uncharted) and set nets to collect the various lake trout forms.

This study is important not only for Lake Superior, but also for lake trout recovery programs in the four lower Great Lakes. The Klondike strain of lake trout stocked in these lakes is based on fish collected from this

The U.S. Fish and Wildlife Service has Klondike-strain lake trout in their hatchery system to support the ongoing lake trout recovery programs in lakes Michigan, Huron, Erie and Ontario.

Lake trout recovery in Lake Superior.

In the early part of the 20th Century, Lake Superior lake trout supported high levels of commercial harvest. However, the invasion of the sea lamprey - a parasitic, eel-like fish that preys on other fish – combined with ongoing intense commercial fishing, resulted in the collapse of lake trout populations in Lake Superior by the 1950s.

The same thing happened earlier in all the other Great Lakes. In 1954, the United States and Canada adopted a treaty to form the Great Lakes Fishery Commission through the 1954 Convention on Great Lakes Fisheries, to combat the sea lamprey, help manage Great Lakes fisheries and rehabilitate lake trout in the Great Lakes.

In 2024, the Lake Superior Committee of the Great Lakes Fishery Commission, comprising state, federal, and tribal government agencies, declared that Lake Superior lake trout populations had been finally rehabilitated.

This is one of the greatest comeback stories in freshwater fisheries management.

The hard work of the natural resource agencies working together to control fishing, suppress sea lamprey and stock fish early on led to achieving the goal of having genetically diverse, selfsustaining, wild populations of Lake Superior lake trout, similar to levels found in the lake prior to the sea lamprey invasion.

SHORT WORK WEEK SUB PAY: If you miss work due to weather, and you are not laid off, the company must provide written documentation confirming the loss of hours was weather-related. If you work 16 hours or less in a week, you may be eligible to collect SUB, but only if the hours worked are at the beginning or end of a layoff. To apply:

Complete the SUB application at the hall.

Provide a pay stub for the week.


