Wrong direction for labor law reforms

WASHINGTON, D.C (PAI) - Call this a right-wing 'wish list" of changes, but Senate Labor Committee Chairman Bill Cassidy, (R-La.) unveiled a GOP package of labor law "reforms" that's a corporate lobbyist's dream - and the opposite of labor's Protect the Right to Organize (PRO) Act.

The batch of measures Cassidy stitched together in November omits the one bill with bipartisan backing, the Faster Labor Contracts Act, to mandate arbitration when workers and bosses can't reach first contracts within a set time.

What did make it into Cassidy's package of labor law 'reforms" pleased anti-worker ideologues:

•No card check recognition. And unions would win secret-ballot elections by majority votes only when at least two-thirds (not 50 percent) of the eligible voters cast ballots.

· Make it easier for dissident workers to decertify unions. Right now, after the union wins an election and bargaining – after management delays and appeals - actually starts, union foes have to wait a year before they can file "decert" petitions.

 Mandate the National Labor Relations Board follow court precedents - and only court precedents - in ruling on cases. That effectively neutralizes the board's power to set rules for relations between workers and bosses.

• Cassidy set no dates for work on his labor law package, but crowed that its passage would advance GOP President Donald Trump's "pro-worker agenda," a statement that would produce derisive laughter in union halls.

Trump still opposes minimum wage hike

WASHINGTON, D.C. -President Donald Trump on Nov. 17 advised a conference of McDonald's franchise owners and operators that "you're going to have to fight" increases in the federal minimum

The federal minimum wage has been stuck at \$7.25 hourly since 2009. Corporate opposition, especially from the fast food and restaurant industries, has stymied attempts to increase it.

The president made his comments as part of his ongoing political war with California Gov. Gavin Newsom, who he said is "laying siege" to the state's minimum wage by raising it to \$20 per hour. Trump told McDonald's franchisees that they would have to lobby lawmakers in other states to block additional minimum wage increases.

The \$7.25 per hour minimum wage seems ridiculously low in today's economy, and it is – but it is the wage rate in 16 states. The other 34 states, including Michigan (hourly minimum wage = \$12.48) have adopted statewide laws to pay beyond the federal minimum.

"The minimum wage thing, you'll have to be talking about, you're going to have to fight," Trump said, adding that it is a "very complex subject" and said McDonald's franchisees should "let your local congressman, your senators know about it."

Modern, user-friendly city hall rises in Lansing

LANSING – The structural iron was completed at the city's new, long-awaited city hall last month, and now the rest of the structure is taking shape.

Managing the project is Clark Construction, which is leading the team of subcontractors and building trades union workers at the site of the 65,000 square-foot building. Work began in April at Lenawee and Grand on the southeastern edge of the city's downtown.

ager Chris Martin said the project "is moving along very well," and will result in "a modern building with modern conveniences" compared to the existing, aging, leaky and inefficient city hall building that was constructed in 1958 and sits across the street from the state Capitol Building.

The city has been looking to modernize or move out of the existing city hall for three decades, but the funds have never been available. That changed in 2023 when the Boji Group LLC, the de-

Clark Senior Project Man-velopment manager for the new city hall project, successfully lobbied the state Legislature for the \$40 million for construction of the building.

> Lansing Mayor Andy Schor said the new city hall will be much more than a collection of city offices. "It's going to be an incredible one-stop shop for residents and others doing business with the city," he said. "In addition to having our city departments here, this new facility is a major part of our plans (Continued on Page 2)

Construction industry steady, but 'uncertainty' is hovering

The construction data that has been trickling in after the government shutdown ended shows an industry that's holding fairly steady.

"After several months of record-breaking levels, planning momentum slowed in October," said Sarah Martin, associate director of forecasting at Dodge Construction Network, on Nov. 7. "Activity remains solid across the board, especially for data centers and hospitals. However, recent growth should not solely be attributed to gains in real activity."

Martin made her comments in conjunction with the monthly release of the Dodge Momentum Index, which tracks anticipated building activity in the country. The overall DMI decreased 7.1 percent in (Continued on Page 2)

Nearly everyone, it seems, likes unions. Can labor capitalize?

At a time when Americans cannot agree on many things, unions have achieved popularity across nearly every age group regardless of partisan affiliation or education.

For several years, public support for labor unions has reached heights not seen since the 1960s, and even though Americans are polarized toward other American institutions, unions maintain strong public support across all age groups and across educational and partisan lines.

New Center for American Progress analysis of American National Election Studies (ANES) data on eligible voters in 2024 shows:

• Every generation expresses positive overall feelings toward unions, with younger generations supporting unions the most.

• On average, self-identified Republicans and Democrats of all but one generation express approval of unions, with only Republican Baby Boomers (born 1946-1964) expressing slightly less than neutral approval.

• Across generations, the working class has similarly strong support for unions, and unions have especially high support among the college-educated members of younger generations. Echoing the results of a similar CAP analysis using 2020 data, these findings suggest that the broad-based support unions won over the past several years has

U.S. labor union support is wide - and durable

• Every year since 2020, the annual Gallup survey has found American support for labor unions in the 67-71 percent range, a consistent level not seen since the late 1950s and early 1960s.

• The self-explanatory "Faster Labor Contracts Act," surprisingly, has early bipartisan support in a Congress that is completely controlled by Republicans. The legislation would prevent employers who are targets of union organizers from dragging their feet on approving union contracts.

 Young workers at companies like Starbucks, Apple and Amazon have for several years been making attempts at securing union contracts (with tremendous employer pushback).

• Now comes new survey results which show support for unions to be prevalent among young and old, white- and bluecollar, Democrat and Republican.

 Any goodwill toward unions is not shared by unionbuster-in-chief President Trump, who eliminated union coverage for 1 million federal workers

Can cracked concrete heal itself?

MSU researchers set new pavement slabs to test bendability, self-repair

EAST LANSING – Join the chorus, pothole-dodging Michigan motorists: "Let's hope this works!"

We refer to the next step conducted by Michigan State University researchers in their attempt to create a concrete mix that does what concrete has never been able to consistently do on America's roads: bend, but not break, and then heal its own cracks.

Maybe the right mix is in the

works, in Michigan or elsewhere. An Oct. 10 event took place on the MSU campus to mark the installation of four slabs of what researchers call a test for "selfheating and self-healing bendable concrete."

They placed four slabs, each using a different mixture, to determine which version of the proprietary concrete formula will perform the best. The event was timed to launch the pilot test prior to the entry of Old Man Winter.

"Every journey, no matter

how long, must begin with small steps, and it's no small thing to advance the state of the art in pavement materials engineering when it comes to Michigan's notoriously punishing climate especially with ever-escalating costs of repairs and materials, said MSU President Kevin M. Guskiewicz. "Today, we showcase our College of Engineering's research excellence and MSU's impact in our own backyard and

We have people. We need jobs...

We often hear that construction is facing a "skilled-labor shortage." Developers and end users say they simply can't find enough qualified workers to meet demand.

But here in the Mid-Atlantic we see a very different reality. There's no shortage of skilled ironworkers. There's a shortage of steady, high-quality jobs. At Iron Workers Local 5, which represents workers across Washington, D.C., Maryland and Virginia, we have a deep bench of highly trained professionals ready to go to work today. Our apprenticeship program processes applicants every month, and many end up on a waitlist because we already have a ready workforce capable of manning any large project.

Last year alone, roughly 290 individuals sought to join our trade. More than half were qualified and ready to start immediately. Yet most will wait an average of 11 months for an opportunity.

On the second Monday of each month, we process around 24 applicants – many with prior construction experience, certifications and a strong desire to build long-term careers as ironworkers. We also receive about 100 additional applications each year through word of mouth alone, without any formal marketing.

Nationwide, the Iron Workers unions operate more than 130 registered apprenticeship programs, training over 20,000 apprentices through paid, hands-on instruction. Each program typically has hundreds of applicants from diverse backgrounds seeking good wages, benefits and a stable future. On top of that, we maintain a reservoir of highly trained journey workers prepared to go to work at any time.

That level of interest isn't evidence of a shortage – it's proof of a willing, skilled workforce ready to build America's infrastructure. These are hardworking men and women prepared to answer the call, yet too often they're left waiting because the pipeline of jobs isn't steady enough. The labor is plentiful; the opportunities are not.

Workers are there to be found.

In more than three decades in this trade, I've seen the "labor shortage" narrative resurface whenever it becomes convenient to justify bringing in low-wage labor, cutting corners on safety or overlooking the skilled workers who already stand ready to perform this work.

In nearly three years, our organizers have not once had to delay a project for lack of qualified ironworkers. Whether commercial development, bridge rehabilitation or infrastructure expansion, we consistently provide trained, safety-focused professionals. And this is not unique to our region – it's true nationwide.

Unionized construction has built a sustainable, proven pipeline for developing talent. Our registered apprenticeship programs ensure workers receive rigorous training in safety, rigging, welding and structural assembly. Apprentices earn while they learn, avoid student debt and secure nationally recognized credentials that support lifelong careers.

Strong wages and benefits don't just attract new workers they retain experienced ones. When people know they can earn a family-supporting wage, access quality healthcare and retire with dignity, they stay. That stability is what keeps projects running efficiently and safely.

So instead of asking, "Where are the workers?" we should be asking how to better connect ready tradespeople with year-round projects. Public and private construction investment can put hundreds of skilled ironworkers to work tomorrow.

When developers and general contractors partner with union contractors, they access a reliable, fully trained workforce - ready to mobilize without delay. We don't need to reinvent the system or look elsewhere. The workforce is already here.

Over the past two full calendar years we have experienced record-setting hours worked by our membership. Heading into 2025, the future of available work was extremely optimistic. Projects in the energy, auto, chips and battery industries projected to carry us into another record year - even decade.

The \$1.2 trillion Infrastructure Investment and Jobs Act, signed into law under President Joe Biden's administration, laid the groundwork for an even more prosperous future ahead. Additionally, Biden's clean energy tax credits, primarily established through the Inflation Reduction Act (IRA), were projected to create a significant number of jobs in the clean energy sector – an estimated 1.5 million additional jobs over the next decade.

Biden's Executive Order 14063, titled Use of Project Labor Agreements for Federal Construction Projects, mandated project labor agreements (PLAs) on federal construction projects worth more than \$35 million. This would ensure jobs are completed on time and on budget, using union labor. All of the above was progress made under the Biden Administration represented a decade of long-term job opportunities, excellent contract settlements, stronger pension and health and welfare funds, and of course a stronger union.

Now as we near the end of 2025, the future does not look so promising. There is a strong feeling of uncertainty in the construction industry. The Trump Administration obviously isn't too concerned about the well-being of America's building trades members, based on his actions in the first six months of his term. Instead of long-term job growth, we are now facing a potential backslide.

The Department of Energy, for example, recently terminated 24 awards - more than \$3 billion worth of energy projects representing work for our members. Additionally, he signed legislation that ends the IRA's federal electric vehicle (EV) tax credits after Sept. 30, 2025. These tax credits spurred significant investment in EV and battery manufacturing plants across the U.S., which created enormous hours for our membership over the past few years.

The expansion has now come to a standstill, which means additional job losses. Numerous federally funded projects for high-speed rail, chip plants, and energy projects have been defunded since Trump took office, amounting to billions of dollars in investment and millions of man-hours lost.

Not only has the administration terminated building trades opportunities, but it has launched a full-on attack on our brothers and sisters working for the federal government. Despite its claims to put "American workers first," the Trump Administration has attempted to end collective bargaining for four out of five federal workers represented by unions at more than a dozen federal agencies.

According to a Center for American Progress analysis of federal employment data, more than 1 million American government workers have lost their right to collectively bargain due to a broad executive order issued in March. Fortunately the labor movement will not sit still regarding this union-busting tactic. Multiple lawsuits have been filed against the order to ensure that every worker has the fundamental right to be represented by their respective union.

The list of attacks on the American labor movement continues and will continue until we wake up and realize that attacks on unions are attacks on the middle class. "Making America great again" starts with a strong labor movement, which creates a strong middle class – not by catering to billionaires looking to pad their own pockets.

The current administration wants all of us to believe that they have your best interests at heart. If they did, why would they take away great job opportunities? Your ability to earn a living? Why would they end collective bargaining for millions of workers? Think about this the next time you vote. Your future and everything we have gained over the last hundred years will be at stake.

Oh, happy day! Thanksgiving, I mean - our annual pause for family gatherings to celebrate the rich and tasty diversity of America's harvests.

There is, however, something decidedly distasteful that has steadily been forcing its way onto our dinner tables: Raw monopoly



ates is decimating farm families, swindling food industry workers, and gouging consumers. Economists have a technical term for what food industry profiteers are doing to us: The term is

"stealing." Farmers know the evil of unrestrained monopolists all too well, for they are relentlessly squeezed by two sets of them. First, everything they must buy to produce food - from seed to tractors - is controlled by noncompetitive giants that charge rip-off prices. Second, when selling their products, farmers and ranchers are boxed-in by corporate cartels that only offer take-it-or-leave-it, go-broke

Then, this same anti-competitive system turns on us consumers, charging grossly-inflated grocery prices that give them monopoly profits and even more market power.

This Thanksgiving dinner is a good time to tally up the ever-widening monopoly spread separating you from farmers:

· A Butterball turkey costing you \$2.42 a pound, pays the farmer 6 cents per pound.

• Potatoes costing \$4 a bag returns only 55 cents to farmers.

• Wheat farmers only get 13 cents from a \$4.50 loaf of whole wheat bread.

•Top sirloin steak cost \$16.50 per pound, but ranchers get under • Even simple lettuce is \$2

city that we will keep pushing for good jobs, housing, and the amenities that people want and deserve in the capital city."

The site had been a city parking lot and prior to that, the location of the demolished BoarsHead Theater. The new three-story building will have a brick veneer and metal panel

Located at 425 S. Grand Ave., the first floor will have City Council chambers and offices, as well as offices for various other city departments. The public will be able to conduct business there at those offices and at public kiosks. The second and third stories will also contain space for city

Martin said about 35 trades workers were on site earlier this month, and that will increase to about 50 at peak employment. The project is expected to be completed by the end of 2026.

"According to reports, the existing city hall building is aging and not always very user-friendly

for the city's staff or the community," Martin said. "It needs a lot of maintenance. This new city hall is going to have modern workspaces tailored to each department and is just going to be a much more efficient building for the staff and the public."

In addition to Clark Construction, the Boji Group and city leadership, other parties who have been involved in the planning and construction include owner's representative Kramer Management Group and Krieger Klatt Architects. Other Clark site team members include Project Manager Eric Tironi, Project Supt. Paul Warfle and Project Engineer Conor Valade.

"The city has been a great client to work with – they're very involved in the planning and the execution of work," Martin said. "And we have a great team of tradespeople and subcontractors, many of whom are local to Lansing. We're very happy with the work we're seeing; it's a true partnership built for success."

poor condition. The news was a bit better for the state's bridges, wherein 33 percent were listed in good condition; 56 percent were fair and 7 percent in poor condition. Although, the report said 4 percent of Michigan bridges were in "severe" condition.

According to the report, the percentage of "good" roads in the state had been level at about 21 percent for three years prior to 2021, then began to climb yearby-year to 28 percent in 2024.

The increase was undoubtedly helped by additional spending by Gov. Gretchen Whitmer, who floated \$3.5 billion in bonds in 2020 – essentially, the state borrowed money – to fix the damn roads when the state Legislature continued its decades-long refusal to come up with a permanent road repair funding plan.

Last month, the Legislature finally approved an approximately \$2 billion annual plan to fund road improvements, which should move more state roads into the "good" category in the coming years.

(Continued from Page 1) October, although year-to-date it was up 35 percent compared to the average reading over the same period in 2024.

"Anticipated increases in labor and material costs are also driving up project expenses and are inflating the overall trend in the DMI," Martin said. "In the coming months, Dodge anticipates activity to continue to decelerate on average, especially as macroeconomic risks continue to mount." Those risks include the effect of tariffs, the government shutdown and the shrinking labor

Meanwhile, with the U.S. government still catching up with the release of its economic numbers, the Associated General Contractors cited the latest batch of federal statistics and reported on Nov. 17 that U.S. construction spending increased just 0.2 percent from July to August

The AGC said that the delayed data release "shows the impacts of economic uncertainty on demand for construction."

"Private and public sector construction owners are clearly being impacted by uncertainty about federal funding, material prices, and labor supply," said Macrina Wilkins, the AGC's senior research analyst. "The question is whether the reopening of the government will lead to a future bump in demand for construction."

Construction spending totaled \$2.169 trillion at a seasonally adjusted annual rate in August. That figure is 0.2 percent above the revised July rate and 1.6 percent below the August 2024 level.

By category, there were declines in the three largest nonresidential categories. Manufacturing slid 0.9 percent in August. Highway and street and power construction each fell by 0.2 percent for the month. Overall, ten of the 16 nonresidential categories the Census Bureau reports on posted declines in August.

Private residential spending increased 0.8 percent in August, but fell 2.0 percent compared to August 2024. Single-family homebuilding edged down 0.4 percent and 1.1 percent, respectively.



There's nothing left of the original Checker Cab Co. plant along Pitcher Road in Kalamazoo. Nor are any more Checker cabs picking up fares from America's streets. The places where Checker cabs become iconic, the streets of New York City, saw their last Checker taken out of service in 1999.

Today what's left of the Checker fleet, with the vehicles usually painted vellow for New York and green for Chicago – but almost always with checkered stripes along the sides – are either privately owned conversation pieces or are parked in a museum.

The Checker Cab Co. built more than 100,000 cabs from 1923 to 1982 in Kalamazoo, creating a uniquely American brand that became iconic while barely even trying. The unique vehicles were roomy, comfortable, mechanical beasts that could routinely run for 300,000 miles. A wide swath of Americans, rich and poor, famous and not-so-much, took rides in Checkers at one time or another. And movie-makers and television producers loved to use Checkers, making them famous as street backdrops, or for filming actors in their back seats.

"Kzoo is the city-endorsed nickname for Kalamazoo, Mich. - a place that Checker automobile enthusiasts know as the home of the beloved, boxy taxicabs that toiled in New York and other cities in their heyday from the 1950s until production ceased in 1982," said a 2014 article by the New York Times, on the occasion of a Checker Car Club of America Convention. The *Times* devoted numerous articles over the years to Checker cabs, especially when a Checker picked up its last fare in the Big Apple on July 27, 1999.

"New Yorkers still love Checkers - because it's bagels, it's pizza, it's New York," Michael Angelich, a Checker historian from New York, told the Times.

Checker Cab founder Morris Markin (1893-1970), a tailor, got into the auto assembly business then began running a fleet of taxicabs and an auto body shop business in Joliet, Illinois, near Chicago. Markin then acquired two car body businesses in 1921.

"Timing was on Markin's side in late 1922 when he elected to move the taxi business to Kalamazoo, Michigan," wrote George Laszlo in Kalamazoo Checker Plant History. "For it was in Kalamazoo that two factories were available for sale; Dort for the wood bodies and Handley-Knight for everything else. Both were vacant and ready for a speedy startup."

The Kalamazoo Public Library's Checker Motors: Taxicab Makers said that Markin purchased a pair of vacant plants on north and south Pitcher streets in Kalamazoo for his expansion. One reason offered for the placement of the Kzoo site was because the chief engineer Markin wanted for his motor company wouldn't move to Chicago. Another theory why Kalamazoo was chosen was not only the availability of the empty plants, but it allowed him to escape the violent "taxi wars" among rival cabbies in Chicago.

The predecessors for the site at 2016 North Pitcher St., upon which the Checker plant was built and expanded had a mixed history. While Lull Carriage Co. had a long history of making horsedrawn carriages and sleighs at the site, neither

Checker Cab. "One can only imagine his delight when cities initiated campaigns to stem wildcatting and violence by dictating that only purpose-built vehicles could operate as taxis.


Like other manufacturers that survived the Depression, the onset of World War II created a booming market for making war materiel. "Like the nation's other automakers, Checker shifted production during the war, making selfcontained trailers, truck cabs, and tank recovery vehicles for the U.S. Army," Brasie wrote.

With no new cabs being built during the war, Checker burnished its reputation for reliability with their longrunning cars.

"Checker's cabs developed a reputation for comfort and reliability. The company had an association with a number of cab operators who used Checker cabs exclusively. These operators, in fact, were Checker subsidiaries," said the Kalamazoo Public Library. "They included the Checker Cab Co., Yellow Cab, and the Parmalee Transportation Co. In effect, Checker was its own best customer, with around 1,500 cabs a year being devoted to these operators. Additionally, Checker's vehicles became a preferred mode of transportation for cabbies and passengers in cities around the nation. By 1965 over a quarter of the nation's cabs were Checker-built."

Checkers never made dramatic changes to their vehicle's design, inside or out. But it was the boxy 1956 Model A8 that became iconic in movies and television. "Why fix what's not broken had been their motto," said an account in the publication's Checker Motors - Taxi Cabs by Martha Hayden for "The Restless Viking." "Only a few minor changes had taken place over the next 27 years."

After winding down cabproduction in 1982, Checker Motors served as a subcontractor, supplying automotive parts and stampings to Detroit-area manufacturers. The company underwent reorganizations and acquisitions, before succumbing to bankruptcy in the Great Recession. The plant closed for good in June 2009, displacing about 125 workers. The plant was subsequently demolished. A container company has since been built on a portion of the site.



CHECKER MOTORS, led by owner Morris Markin, took over the Handley Motor Corp.'s plant in 1923. "The Morris Markin empire never equaled that of Henry Ford or Walter Chrysler. Checker never was able to compete with General Motors or Chrysler," wrote Jim Hinckley in his Rise of an Empire – The story of Checker Cab. "It did, however, create an American icon that lives on long after the company ceased operations."

Nearly everyone, it seems, likes unions. Can labor capitalize?

(Continued from Page 1) and in their ability to support their families. Although workers face an uphill battle in realizing their aspirations for better wages through unions - especially given the Trump Administra-

tion's union-busting campaign CAP's analysis clearly shows policymakers that workers are interested in stronger unions and organizing rights.

Support for unions crosses partisan and educational lines.

Across generations, respondents – particularly those in the youngest generations – positively rate unions. Not only does each generation have, on average, a strong positive attitude toward unions, favorability increases among the young, with Millennials (born 1981-1996) giving unions an average rating of 61 and Gen Zers (born 1997-2012) giving unions an average rating

These results are consistent with analysis by CAP of similar data from 2020, which suggests a stable base of support given the growth in the cohort of Gen Z adults: Gen Z made up 8.9 percent of the number of eligible voters in 2020 and grew to 15.2 percent in 2024, based on American National Election Studies

Other polls that ask about unions have similar findings. Gallup's 2025 poll on union approval, which showed that 68 percent of Americans approve of unions, also exhibited the highest popularity among the youngest respondents: 72 percent of Americans aged 18 to 34 and 71 percent of Americans aged 35 to 54 approve of labor unions, compared with 64 percent of Americans aged 55 or older.

Similarly, a 2025 Pew Research Center study found that 62 percent of Americans describe the decline in union membership as a bad thing for working people, increasing to 63 percent among respondents aged 35 to 49 and to 69 percent among adults younger than 35.

unions among younger generations is unsurprising given both the economic benefits of joining a union for young workers and the successes of a number of highprofile organizing campaigns led by young workers in recent years, such as the Starbucks organizing

Young workers today are especially likely to feel as though they have been left behind by high housing costs, low wage growth and lower job quality, and unions are an effective way for workers to come together to advocate for better wages and working conditions. One study from 2022 found that wages increase by 11.3 percent for union members younger than 35.

Both Democrats and Republicans across nearly every generation express positive attitudes toward unions. Respondents who describe themselves as Democrats tend to give unions higher ratings on average than those who describe themselves as Republicans, though among every generation except Baby Boomers, Republicans have a positive opinion of unions on average. Even Republican Baby Boomers are only just below the rating of 50, which corresponds to "neutral" or "no feeling at all" on the ANES' 100-point scale.

The working class expresses

similarly high levels of support for unions across generations, and support is even higher among the college educated in the youngest generations. Those without college degrees all approve of unions by roughly the same amount, or just below 60. By contrast, support increases in younger college-educated generations, with college-educated Millennials and college-educated Gen Zers giving unions an average rating of 65 and 75, respectively.

Workers want unions, and this analysis shows that support for unions crosses generational lines and encompasses members of both political parties and spans ranges of education. At a time when some policymakers are expanding the right to organize on a state level while the Trump administration ends collective bargaining rights for more than 1 million people, policymakers should champion policies that will empower workers.

(This article uses data from the 2024 American National Election Studies, a nationally representative survey of roughly 5,000 eligible American voters conducted from August 2024 to February 2025 includes demographic data on respondents and asks respondents about how they perceive labor unions. Results are similar when restricted only to full-time workers).

MSU tests: Can cracked concrete heal itself?

Engineering Research Complex off of Woodlot Drive on campus.

The concrete was developed by Qingxu "Bill" Jin, an assistant professor in the MSU College of Engineering, and his graduate student Xiaoqiang "Antonio" Ni. The concrete has self-heating properties that can store heat from the sun, which is released when the temperature drops near freezing. It's also bendable and can self-heal. Initial testing showed that cracks thinner than a human hair can repair themselves, and it can withstand the weight of about 2,000 pounds – or half of the weight of an average car – without cracking.

During the testing phase this winter, wires connected to the sidewalk concrete slabs will help Jin and his team monitor the durability of the concrete from foot traffic and the performance of its self-heating properties in melting ice and snow.

'This novel concrete project is a great example of MSU's economic relevance strategy, which fosters innovation and entrepreneurship, contributions to regional economic development and aligning research with state economic needs," said John Papapolymerou, interim dean of the MSU College of Engineering. "There are numerous applications on how this concrete will play a role in the infrastructure improvement strategy shared by our city and local government leaders and provides an opportunity to support national security.'

A number of other universities and research institutions worldwide are also testing and examining blends of bendable concrete. One leading area of interest being pursued by Texas A&M researchers probes a concrete mix with some unexpected ingredients: bacteria and fungi.

American Society of Manufacturing Engineers (AMSE) technology writer Kayt Sukel wrote a paper on their efforts in July, Leveraging Symbiosis for Self-Healing Concrete, which said "this synthetic system leverages cyanobacteria, a species of bacteria that relies on photosynthesis to provide its own food, coupled with filamentous fungi, which produce the material that can fill cracks through biomineralization. As a result, the system only needs air, light, and water to promote self-healing in concrete structures."

The Texas researchers are also studying their concrete mix in the

real world, using test slabs.

"Basically, the cyanobacteria convert the carbon dioxide in the air into organic nutrients for the fungi," Congrui Grace Jin, assistant professor in the Department of Engineering, Technology, and Industrial Distribution at Texas A&M told the AMSE. "The fungi then attract that matter into their body and generate calcium carbonate. The calcium carbonate can heal the crack in the concrete. This system can be autonomous because the cyanobacteria and fungi work together – and you don't need a human being to provide anything.'

So far, their system has been able to heal surface cracks, but not deep cracks within concrete, but the research continues.

Moore Mechanical plumbers seek contract

(Continued from Page 1) union members, supporters and

the now-striking Moore plumbers have walked picket lines outside Moore's Grand Rapids office, as well as holding informational pickets at a large job site where Moore plumbers have been working.

"We're here for these plumbers; they want a contract, and we're here to help them get one," said Ortiz. "These are good guys, good plumbers. One of them asked me, 'when does it stop?' I told him it stops when you get a contract."

The "when does it stop" question by the striking plumber referred to actions taken by Moore's management, who Ortiz said have changed the company's handbook twice in a year to include more company-friendly language. One of the most grievous actions imposed by Moore is to stop paying the plumbers for the drive between the company's shop to the jobsite.

"They reached out to me and asked if Moore can do that," Ortiz said. "I told them, yeah, unfortunately, they can do that, because you don't have a contract." The plumbers have also complained about poor maintenance of company vehicles and the high cost

of co-pays of employer-provided

health insurance. One of the striking Moore

Mechanical plumbers is Brendan Nelson, who started his career with the company and has been with them for two years. He said two of his major grievances with the company are the aforementioned changes in the company's employee handbook, and Moore's refusal to treat him and his fellow workers "as skilled professionals."

He said he doesn't necessarily have a problem with the company's pay or benefits, but "I'm single so the benefits don't matter so much to me. But I could see how it would matter more to a worker with a family."

Nelson said another factor in deciding to strike Moore was the "not impressive" Michigan Works training program he had gone through, vs. what he saw was available at the Local 174 Training Center. "I saw their training center and I just said, this is insane, this is where the top dogs go to improve themselves," he said.

With a majority (seven of 12) of the Moore-Grand Rapids plumbers signing union authorization

cards, Ortiz and Local 174 Business Manager Ryan Bennett went to the local Moore office on Sept. 29 and declared that they wanted the company's volunteer recognition of a collective bargaining process after the "card check" vote to bring in a union. The company's response: "He said we aren't negotiating and they kicked us out of the office," Ortiz said.

Nelson said last week that he goes back and forth on a daily basis over whether the strike is worth it. "I know the management, I didn't want it to go this way. I want the company to do well," Nelson said. "And I look at the guys who are still there, and hope that will realize we're trying to do this for the betterment of all of us."

The plumbers simply want their grievances addressed, Ortiz said. "They still want to work at Moore, but they feel they aren't being heard," Ortiz said. "I know where they're coming from, I worked six years nonunion. They want what I wanted when I went over to the union. I wanted good wages and benefits, but another big thing is, I wanted that voice on the job, to have a say in my future."



Clements Electric's work on the Midland Center for the Arts and Dow Gardens Welcome Center continues, as does work at Mersen USA and Bay Co. Health Department. Contracts for Oddfellows Hall in Midland, a housing development in Downtown Bay City, Bay City Animal Control and Bay Co. Road Commission have all been signed with work to start soon. Another housing complex in Auburn is also underway. Work also continues at Mersen for Clements along with being awarded a nice project out to Michigan Sugar in Bay City

Conti Electric has projects that are ramping up inside the I-Park (Dow) and ongoing work at the Karn Generation Facility.

Escon Group is ramping up work within the I-Park and Consumers Energy service centers.

Master Electric continues work at Clare Co. Road Commission. **Ted's Electric** has work in Mt. Pleasant and Clare Schools. Bay Valley Electric is continuing work at Bay Valley Resort. John's Electric has work through the winter at Clear Lake and Hoeft State Parks. Swan Electric has secured a decent project at TCE Charlton in Johannesburg. Northern Valley continues work at the Holcim Cement Plant and Oscoda's Air Base, as well as many smaller projects and service calls. J. Raymond Electric has a project at Warbler's Cove Campground near Rose City.



MEMBERS OF IRON WORKERS Local 25 and Operating Engineers Local 324 on Oct. 3 set the final structural steel section for the 65,000 square-foot Lansing City Hall, making way for the rest of the trades to build the remainder of the new home for the city's government. "We fabricated it and erected it," said Casadei Steel Project Manager Dalton Thorner. "Everything went together very well; no issues." Thorner said the project employed 15-20 iron workers at peak. 

Consider hunting in state parks

As Michigan's fall deer season continues, hunters are encouraged to consider state parks and recreation areas when preparing to hit the woods and fields

"Over 90 percent of state park and recreation area land is open to hunting," said Ray Fahlsing, stewardship manager for the DNR Parks and Recreation Division.

Along with enjoying the beauty of our state's 103 state parks, hunters who venture into these areas also can play a pivotal role in helping preserve and protect these natural public spaces by hunting deer. These animals, often making meals out of park plants and wildflowers, can be highly damaging to flora and fauna.

"Unfortunately, overabundant deer are a significant threat to the biological diversity of most of our state parks and recreation areas. The only thing more worrisome is direct habitat loss," Fahlsing said.

"Trillium and many other wildflowers are like ice cream to deer," he added. "These highly palatable plant species disappear first when deer numbers get too high. Some 'tasty' trees have difficulty regenerating even with relatively low numbers of deer. If deer numbers stay high, less appetizing plants become overbrowsed. Eventually, even plants not normally eaten by deer are damaged."

The impact of too many deer in state parks and recreation areas can snowball into additional issues, Fahlsing said. "The impact cascades – pollinator insects decline as the numbers of their host plants are eaten, and birds and animals have fewer seeds and insects to dine on," he said. "Ecosystems with too many deer have fewer native plants and are less resilient."

A part of our natural heritage is diminished when this kind of damage occurs, he added. "This should matter to you whether you are a birder, nature-watcher or hunter."

> Where to hunt, how to help. Harvesting antlerless deer

helps reduce their impact on state parks. Hunters can also consider harvesting an additional doe for donation to the Hunters Feeding Michigan program. www.michigan.gov/huntersfeedingmichigan. "Not only will you help feed hungry people, but you will help conserve wildlife, wildflowers and the state's natural heritage," Fahlsing said.

Since not all parks and recreation areas are open to hunting, and those that are have specific areas designated for this activity, it's best to contact parks directly for details before you go.

Ludington State Park in Mason County allows hunting in a designated area, said park manager Jim Gallie.

'We have a fair number of hunters use the park during deer season – there are regular bow and firearm hunters," he said. "We often see them biking along the lighthouse trail, north to the hunting zone, with their rifles over their backs or while hauling a trailer to assist with getting the deer back to the campgrounds and parking areas."

Park does come with some physi-

cal challenges, he said.

"Getting deer out of rolling sand dunes, thick jack pine bar-

"We've heard multiple tales of it taking hours to get the bagged deer to a boat on Hamlin Lake or rens and around interdunal ponds to the lighthouse road before bikcan be quite a workout," he said. ing and boating it to civilization."

Break out the sleds, maybe

With state-designated snowmobile trails set to open Dec. 1 – trail grooming occurs when there is enough snow on the ground – now is a good time to prep for the season, starting with purchasing your snowmobile trail permit.

Michigan is home to 6,100-plus miles of DNR-designated



snowmobile trails, public roads and public lands (only where riding is authorized).

Did you know that nearly 1,900 private landowners allow use of their

land to create the trails network? Their generosity allows the DNR to offer trails that connect communities and bring snowmobilers to places of interest that otherwise wouldn't be available to them.

"We're incredibly grateful to these property owners and their partnerships with their local snowmobile clubs," said Ron Yesney, U.P. trails coordinator for the DNR Parks and Recreation Division. "It's important for all of us to give thanks to these landowners and to remember to be respectful of the land, wherever we ride."

Your \$52 snowmobile trail permit is valid for one year, which Hunting at Ludington State begins Oct. 1 and ends Sept. 30 of the following year. Buy permits online through *eLicense* (Google: "Michigan snowmobile e-license").

Firewood for sale

If you're feeling a budget pinch this fall, consider "shopping" for firewood from dead or downed trees in a state forest near you.

Fuelwood permits cost \$20 and allow collection of fuelwood for personal use from select state-managed land in the Upper Peninsula and northern Lower Peninsula. Permit holders may collect up to five standard cords of wood, a stack measuring 4 feet by 4 feet by 8 feet.

In the 12-county area affected by the severe ice storm in March, the limit is raised to 10 cords. Collected wood must be from already dead and downed trees within 200 feet of the road.

There are three ways to get fuelwood permits, which are good through Dec. 31:

•Buy a permit online at mdnr-elicense.com.

•Purchase a permit in person at DNR customer service centers in the northern Lower Peninsula or Upper Peninsula. A few forestry field offices also will sell permits in person; call to confirm business hours and availability.

•Mail an application to the DNR office that manages the state forest land where you wish to collect fuelwood.

A few rules are in place to ensure wood is collected safely and

•Do not drive vehicles off the road, though you may use a wheelbarrow or handcart to carry wood to your vehicle.

•Gather wood only from already dead and downed trees; do not remove wood from trees that are dead and still standing.

•Have your permit with you and fill out the collection log before transporting your wood. Failure to do so could result in a citation.

•Do not sell or trade firewood. It is for personal use only. Avoid spreading invasive pests and diseases; collect firewood

near where it will be used.

You can leave the leaves

If raking and bagging fall leaves is an outdoor chore you dread, listen up! There are some good reasons to scratch this from your to-do list.

Where do little critters go during the winter? Many spend it in/ under the leaves. Bees, salamanders, turtles and many other species rely on fallen leaves for different stages of their lives.

Luna moths and swallowtail butterflies cleverly disguise their cocoons as dried leaves. With their shabby, brown color and ragged texture, you'd never know there was a colorful, winged creature waiting inside. Woolly bear caterpillars, creeping beetles and fluttering moths and butterflies all rely on leaves, whether they hide among the foliage or simply eat leaves.

There are benefits to leaving your lawn "as is" (or close to it) during the colder months. As you prep your outdoor spaces for winter, try not to be too orderly – leaving a bit of natural chaos is just how many species like it.


