#### **Good momentum** for U.S. building

The Dodge Momentum Index for U.S. construction grew a scant 0.9 percent in April, but the DMI was up 22 percent when compared to year-ago

"Despite an uptick in April, the bulk of the DMI's growth was driven by a surge in data center planning, while momentum in other nonresidential sectors lagged behind," said Sarah Martin, associate director of forecasting at Dodge Construction Network. "Owners and developers are navigating heightened economic and policy uncertainty, which likely bogged down much of this month's planning activity."

The DMI is a monthly measure of the value of nonresidential building projects going into planning, shown to lead construction spending for nonresidential buildings by a full year.

#### Solid jobs hike for **U.S.** construction

U.S. construction sector employment increased by 11,000 positions in April as rising wages enabled the industry to add workers more rapidly than other sectors, according to an analysis of new government data released May 2 by the Associated General Contractors of

America. "The construction industry continued to add workers at a faster clip than other sectors in April as the industry boosted pay more than other private employers," said Ken Simonson, the AGC's chief economist. "But uncertainty over tariffs and other policy reversals may cause a halt to many projects and employment gains.

U.S. construction employment in April totaled 8,316,000, seasonally adjusted, an increase of 11,000 from March. Better yet, headcount rose by 218,000 building industry jobs, or 2.7 percent, during the past 12 months. That's better than the 1.4 percent growth rate in total U.S. nonfarm payroll employ-

Moreover, average hourly earnings for production and nonsupervisory employees in construction - covering most onsite craft workers as well as many office workers - climbed by 4.5 percent over the year to \$36.96 per hour. That gain exceeded the 4 percent rise in pay for such workers in the overall private sector.

#### Federal judge slaps Ann Arbor Starbucks

A federal appeals court on April 17 upheld an National Labor Relations Board (NLRB) decision against Starbucks, finding the coffee giant committed unfair labor practices by disciplining workers for union activity - including wearing union-themed T-shirts – and improperly enforcing its dress code.


The ruling from the D.C. Circuit Court followed a longrunning dispute involving Starbucks workers at a store in Ann Arbor. Workers there alleged they were fired or disciplined for union organizing efforts, and the NLRB found Starbucks violated several federal labor

The case comes as Starbucks faces growing scrutiny nationwide over its handling of unionization efforts. To date, Starbucks Workers United reports they have organized 570 stores and 11,000 workers.

## **Judge blocks Trump's** try at union-busting federal workforce

WASHINGTON, D.C. -A federal judge on April 25 blocked President Trump from ending collective bargaining with unions representing federal workers, temporarily halting a component of the president's sweeping effort to strip more than 1 million civil servants of union job protections.

Judge Paul L. Friedman of the District Court of Washington, D.C., ruled in favor of the National Treasury Employees Union, which represents tens of thousands of federal workers across the government. Trump's executive order, issued in late March, would strip collective bargaining rights from about twothirds of the federal workforce, effectively banning them from joining unions.

"We commend the court for recognizing the Trump Administration's executive order stripping collective bargaining rights for what it was: illegal, retaliatory union-busting," said AFL-CIO President Liz Shuler. "This was the most significant attack on workers' rights in history, and if Trump was allowed to do it to federal workers, he would be able to do it to every worker in America, in every workplace and every industry. So this ruling to restore federal workers' collective bargaining rights and reinstate their existing contracts - even if temporarily while the case continues in court – is an important first (Continued on Page 12)

#### AFL-CIO's Shuler:

## Time to fight back-'Democracy does not defend itself'

- Declaring "the labor movement does not fall in line for autocrats," AFL-CIO President Liz Shuler laced into President Donald Trump at a conference, with like-minded organizations, on Trump's first 100 days in the Oval Office.

Shuler keynoted the April 29 session by discussing how workers in general and organized labor in particular are fighting back against the attempted destruction of unions, workers and programs people depend upon, through protests in the streets and lawsuits in the courts.

"Democracy means rule by the people," Shuler began her address. "Organized labor believes

in that idea at our very core. Fifteen million working people," the members of the AFL-CIO's 63 unions, "know 'my voice matters.' It is because of that belief in democracy that we stand up every day against the concentration of wealth and power that exists in our country right now.'

Many of the union-brought court cases fighting Trump's executive orders have been successful, at least in obtaining judicial (Continued on Page 12)

parade, first-in-line holiday. But in much of the rest of the world – where the first Monday in September is not a national holiday – May 1 is International Workers' Day - or May Day. In many nations, May 1 is a national workers holiday, celebrating and supporting many of the same labor issues that are important in the U.S. (Although, that May 1 date has also been linked with government-backed celebrations in present and former Communist countries).

Labor supporters and other social activists in Detroit and numerous other cities made an effort on May 1 to rekindle the International Workers' Day holiday, with a march and rally at Roosevelt Park in front of Michigan Central Station. About 500 people were in attendance, and by reading their signs, protesting the anti-worker (Continued on Page 4)

## **Consumers Energy's shift to clean** power a boon to Michigan trades

LANSING - Consumers Energy is going to be powering a significant amount of employ-

ment for building trades union workers in Michigan over the next few years. The work will be driven by new natural gas, pipeline, solar and wind projects – as well

as projects associated with demolition of existing coal-burning units. The good news was delivered by Consumers Energy Senior Construction Manager Doug Wunder, who addressed delegates to the Michigan Building and Construction Trades Council's 63rd Legislative Conference on April 22.

"The original plan for the next five years" for Consumers Energy, Wunder said, "was to spend roughly \$5 billion in capital work in new generation, and in maintaining our existing fleet." Now, with increasing demand from commercial and industrial customers, he told the delegates, "those numbers are going to double. Next year you'll see another plan rolled out CONSUMERS Energy's Doug Wunder: "We

#### **Death on the** job: Michigan is average; but what the hell Wyoming?

Michigan's on-the-job fatality rate for workers is nothing to brag about – our state is close to average compared to the other 49.

Then, there's Wyoming. Every year since at least 2018, Wyoming has led the country with double-digit death rates per 100,000 workers.

The national death rate was 3.5 deaths per 100,000 workers in 2023, a figure that's held relatively steady for at least six years. Nationally, 5,283 workers died on the job in 2023, 203 fewer than the year before.

Those are some of the numbers that came via the release last month of the AFL-CIO's depressingly titled, Death on the Job, an annual report that for decades has tracked on-the-job fatalities among the states. It takes so long to compile the numbers that the

information is two years old by the time it's released.

"Every worker has the fundamental right to come home safe at the end of their workday. But for too many workers, that basic right is under attack," said AFL-CIO President Liz Shuler, an IBEW member, in introducing the report.

The report said an average of 14 American workers die on (Continued on Page 3)

"When someone is injured on the job, we have no problem jumping into action," said Dr. Michelle Keys, a University of Michigan clinical psychologist, therapist, educator and researcher

specializing in studying suicide. "But whenever something in mental health might come up, we tend to walk the other way. And that's not just you, that's everybody. Most people walk the other way."

Keys was invited to talk to delegates on April 22 at the 63rd Legislative Conference of the Michigan Building and Construction Trades Council. The (Continued on Page 3)

#### **Cheaters shouldn't prosper**

Imagine, for a moment, that you're starting a business in the construction industry. After years of honing your craft and learning from your employers, you know what it takes to succeed.

You register your new business with the state of Michigan and obtain an Employer Identification Number to begin withholding employment taxes. You purchase general liability insurance and pricey workers' compensation coverage. You establish relationships with local supply houses to secure preferred contractor pricing on materials. You retain an attorney to help draft contracts that will define your business relationships, scope of work, pricing and payment terms.

Maybe you sign with your local skilled trades union to access world-class training, a dependable labor pool and to take care of your employees with healthcare and retirement plans. Maybe you don't because you decide to provide training and benefits directly, and you've already hired a dedicated crew of men and women you used to work with. Based on your experience, you know what it takes to deliver a job. Whether union or nonunion, you are confident that your team can execute at a high level with safety, efficiency and quality - you are ready.

So you begin bidding on jobs. And you lose bid after bid after bid, often by 20 percent or more. You wonder how it could be possible to lose by that much or how anyone could break even when bidding so low. It turns out, the only mistake you made was being an honest contractor in an industry plagued by dishonesty and trapped in a race to the bottom,

Materials generally cost a set amount. So, when the competition undercuts bids by double digits, it isn't because they are that much smarter or more efficient. It's simply because cheating contractors are willing to exploit those who work for them by engaging in payroll and insurance fraud. After all, why pay employment taxes, unemployment and workers' compensation when it's so easy to misclassify employees as independent contractors? When that isn't enough, why not shortchange workers' pay by shifting between hourly and by-the-foot rates? And when that isn't enough, why not employ labor brokers willing to traffic undocumented workers who are more vulnerable to these kinds of exploitation?

With these practices as a playbook, the worst players in our industry exploit weaknesses in the law to evade accountability, pushing their liability onto shell companies or the very workers they exploit. By shedding costs that responsible employers must pay, cheaters steal work from the rest who play by the rules. But those costs don't just go away. Instead, they're merely shifted onto the rest of us: the employers who pay higher workers' compensation premiums and who lose work; to the taxpayers who subsidize safety net programs relied on by exploited workers to make ends meet; to communities that miss out on tax revenue; to the workers who pay more in self-employment taxes or who outright lose eligibility for Social Security, and who are at risk of suffering a physically and financially devastating injury; and to all of us who pay higher healthcare costs to cover uncompensated care.

All told, construction industry tax fraud costs billions every year while harming workers, honest contractors, and the rest of us. As long as that's the case, we will remain vigilant in calling out the bad actors and fight against the race-to-the-bottom by upholding area standard wages negotiated by workers. Also, we will champion new laws to crack down on payroll fraud, insurance fraud, labor trafficking and wage theft.

We must restore a level playing field where honest contractors can succeed based on their merits instead of failing to those willing to compromise themselves and exploit their workers.

"UMCI will bring together the best of the University of Michigan to catalyze economic development in the city of Detroit," said U-M Provost Laurie McCauley. "It will house a robust portfolio of academic programs, including new interdisciplinary graduate degrees and certificate programs aligned to the skills of the future needed to attract startups as well as major employers to the region.

"UMCI will also host a

multitude of community engagement activities for the residents of Detroit, ranging from K-12 programs like the Michigan Engineering Zone to the Detroit Neighborhood Entrepreneurs Project and many more."

The first two floors of the project, according to the University of Michigan, will house public programs, a cafe and shared office space for the U-M Detroit Center, admissions office, School of Environment and Sustainability Clinic and others, while levels three through six

are planned for multidisciplinary graduate research.


The center will add diversification – and warm bodies – to the downtown real estate market, which, like most city centers, has been hit hard by the work-athome trend which began during the Covid pandemic.

The center will be funded by a \$100 million gift from donor Stephen M. Ross, \$100 million from the State of Michigan, a land donation from Olympia Development of Michigan, and an additional \$50 million to be

raised from donors. The development represents U-M's largest investment in downtown Detroit.

Construction is proceeding via a memorandum of understanding between Walbridge, U-M and the building trades to make it an all-union project.

Local 25 iron workers and Local 324 operating engineers started the steel erection process, which, Ideal said, "represents exciting progress toward the completion of what will be a dynamic addition to both the city and the University of Michigan's growing presence in Detroit. Ideal Contracting is proud to be partnering with Walbridge and the University of Michigan to erect the structural and miscellaneous steel for this transformative building in the heart of the city."

#### Consumer watchdogs unclear on their mission

Top officials of the Consumer Financial Protection Bureau erupted in cheers this month.

How odd. The cheers were for a federal court that had just ruled in favor of letting big



bitant feeds when we're late making a credit card payment. Bizarrely, agency officials joined

jubilant bank executives in declaring, "This is a win for consumers.

Huh? The court's blatantly plutocratic ruling lets financial giants slap us credit card customers with punitive fees of \$32 or more for every late payment.

The court is legalizing their Project 2025. That extremist consumer robbery, allowing credit card lenders to pluck an extra \$10 billion a year in excess fees from our pockets. Adding to their shame, the profiteering bankers will mainly squeeze this windfall from low-paid working families who're living paycheck to paycheck, having to rely on credit to make ends meet.

So why in hell are the government's consumer protectors cheering this? Because these officials are no longer "ours," but corporate operatives been installed by Trump's brigade of billionaires. The supreme goal of their autocratic government is to further empower the rich over the rest of us.

Indeed, displacing consumer protectors with agents who'll protect corporations from conmanifesto was co-authored by Russell Vought, a fanatical rightwing politico from the Christian Nationalist cult. What's he doing now? Trump has put Vought in charge of the Consumer Financial Protection Bureau.

Today, asbestos has a welldeserved reputation as a silent killer, responsible for the deaths of 90,000 people per year around the globe, according to the World Health Organization. Over the past century, the substance has also ruined the quality of life for countless others who have been exposed to it – inhaling asbestos fibers causes lung-related diseases like asbestosis and mesothelioma that can lead to cancer, shortness of breath, and often,

Often, symptoms don't appear until decades after exposure. Here in Michigan, with all its industry, thousands of building trades workers across the spectrum of crafts have been exposed to asbestos, and not just the stuff in 1950s and 60s-era floor tiles that are considered safe unless it's removed.

In the 1970s, knee-deep in asbestos that was knocked off of old boilers that were being demolished in a project he was working on, a retired Heat and Frost Insulators Local 25 retiree once told us, "It was everywhere. We didn't wear masks. We used to make snowballs out of asbestos and throw it at each other." Today, the jurisdiction for performing tasks like duct and pipe insulation on Michigan job sites falls mainly to Heat and Frost **Insulators Local 25 and Local** 47 members, both of which were known decades ago as "asbestos workers."

The danger of asbestos lies in its microscopic fibers, which can become airborne when disturbed and pose severe health risks when inhaled or ingested. Asbestos comes from a family of six different fibrous silicate materials.


From Mesothelioma.net: "Though asbestos has been used since ancient times, its use as a component of insulation began in the United States in the late 1800s, when the company that would eventually become Johns Manville first started selling the product. Asbestos insulation offered significant improvements over previous options, which included everything from horsehair and hav to wool and textiles. While these products formed a barrier, asbestos' physical properties and the structure of its fibers slow the transfer of heat and cold, helping buildings to maintain indoor temperatures.

"At the same time, its resistance to fire helped protect the structures and equipment that it was insulating, and the material's strength and durability meant that it could last for decades without deteriorating. It represented a cost-effective, long-term solution."

Modern insulation materials are essentially just as effective as asbestos, and of course they come without all the potentially horrible side effects.

"Through much of the 20th Century, asbestos was an integral component of insulation that was used for residential, commercial, and industrial applications," wrote Drs. Luis Agote-Green and Paul Sugarbaker, in medically reviewed comments for mesothelioma. net. "Though it was extremely effective and provided remarkable resistance to fire and heat, it was also responsible for countless illnesses and deaths."

It's difficult to come up with a substance with a history similar to asbestos, which has morphed from being a darling of commerce and industry and even homeowners, to a pariah that has spawned an industry and skilled workforce (we're looking at you, Taylor-based **Abatement Workers Regional** Local 207) devoted to its safe removal and disposal.



"The original use for asbestos in 1890 was for fireproof roofing material," wrote Kathleen Hess-Kosa, in Environmental Site Assessment Phase I: A Basic Guide. "Later in the 1890s, this expanded to engine gaskets and boiler insulation. In the 1900s, uses expanded to acoustical and thermal insulation, hot and cold, and by 1935 it was being used in everything from baby blankets to cement. More than 3,600 commercial products have been manufactured with asbestos since its creation."

an understatement, as usual, the AFL-CIO said, because it "does not include workers who die from occupational diseases, estimated to be 135,304 each year."

"We can't bring back the thousands of workers lost each year, but we can fight to prevent more devastation to working families...and demand the Trump administration reverse course."

Some other numbers from the report:

 Michigan's 2023 on-the-job fatality rate for workers was 3.6 deaths per 100,000 workers. The 166 workers who died in Michigan that year was the highest since the deaths of 175 workers in 2001. The average number of worker fatalities per year in Michigan since 2000 has been 143.

•What's going on in Wyoming: there were 16 deaths per 100,000 in workers there in 2023 - nearly double the rate of the next-worst state. The report did not delve into why Wyoming's record has been so bad for so long, but several factors stand out.

"Wyoming not only eclipsed its own grim precedent, but also doubled the national workplace mortality rate," says Farmonaut, an agricultural technology company. "The state's unique economy (heavy in hazardous mineral extraction work), geographic expanse, and lack of enforcement capacity created an environment where workplace fatalities and chronic occupational illnesses are almost inevitable." With only six safety and health inspectors, it would take them 307 years to get to each Wyoming workplace.

Other states with high worker fatality rates include secondplace West Virginia (8.3/100,000 workers), followed by (7.5) and Alaska (7.4).

• The two states with the lowest mortality rates on the job were Rhode Island (1.2 per 100,000 deaths) and Connecticut (2.0).

stark, elevated numbers related to suicide among building trades workers is prompting a serious effort among labor unions and their contractors to address, using education, an issue that has been swept under the rug for far too long.

"In the construction trades, we not only have construction hazards, because that is the environment in which we've chosen, but we have hazards in the mental health environment," Steve Claywell, an electrician and president of the MBCTC, told delegates. "And the mental health environment is one in which I will admit I don't know a lot about." Inviting Keys to speak to delegates, he said, is part of an ongoing effort to help educate and "provide the proper mental health tools to benefit all of our members."

Keys agreed that mental health awareness is lacking in the trades – in fact, it's a subject that's generally avoided entirely. She said it's very common to talk about physical health - people are often keen to talk about how far they walk, or how much weight they can lift, or what happened at a doctor visit. "The analogy I use is, when do you teach someone to swim?" Keys said. "You don't teach them to swim when they're in the middle of the ocean and you're throwing them a life vest. You teach them beforehand, and the same thing should happen with mental health."

Keys said her talk was especially aimed at leaders in the construction industry – foremen, supervisors – who are in a position to make a difference with workers who are at risk of suicide. The journeyman-apprentice relationship counts, too. And it doesn't take much of an effort. "Historically the culture of your industry - and I say this with kindness in my heart - there is a culture and an expectation of tough it out, suck it up, man up - where vulnerability can equal weakness," she said. "To say I have a mental health condition, to say I am struggling, is to admit that weakness."

With that in mind, she said leaders on construction projects only need to take some small steps to make an effort that could literally save a life. That involves noticing a change in a worker, and speaking up, not in a group setting, but one on one.

"Most often there's a behavior change," Keys said. "The person is different than they were before. If you remember nothing else today, that's the one thing I want you to remember. The best way to tell if somebody is struggling with mental health, is that something is different." A worker who has anxiety or is depressed - two frequent precursors of suicide – might be habitually late to work, hungover, or exhibit consistent signs of irritability and distraction. Other red flags, she said are people who might talk about what a burden they are to others, or ending it all.

"If you see those kinds of comments, please act. But what do you do?" Keys said. "First thing I'd say is, don't say something in a group. Don't do that to a person. Respectfully pull someone aside and say, 'hey I wonder if I can talk to you for a couple of minutes."

She continued: "We did a study a few years back about people who were thinking about making a suicide attempt. The No. 1 thing that kept them from making that attempt was somebody saying, 'you good man? Something seems off.' It is incredibly powerful to somebody who is struggling to be seen, and to be given that space to be seen." Then, Keys suggests that those workers should be "guided, without pushing," to mental health resources available with a phone call.

Changing the culture of construction jobsites is part of the potential for change. Posters can be placed with mental health hotlines. Leaflets can describe related benefits in workers' health care plan. Toolbox and safety talks can include acknowledgements about mental health. In the military, which also suffers from high rates of suicide, Keys said the culture is changing wherein leadership is openly discussing their own mental health issues with other soldiers

"One of the terms we like to use is changing the mental health culture. How do people act about mental health? Can we get people a little more comfortable with being uncomfortable and shifting the culture just a little bit?" Keys said. "We have tools for the job. Let's work on these mental health tools as well."

#### Deported tinknocker Garcia tops May Day union agenda

policies of the Trump Administration was their primary goal.

'We're not going away, we're not going to be silent," said Abayomi Azikiwe, who helped organize the effort. "International rights for working people, for oppressed people. We oppose the Trump/ Musk program of laying off federal agency employees, attempting to privatize the Post Office, and attacks on migrants."

Frank Hammer, a UAW retiree and an organizer of the effort who works with Southeast Michigan Jobs with Justice, said the May Day effort "is an historic day in Detroit and the rest of the country, as we reclaim the holiday that was stolen from us by red baiters," or communists. We're here to fight for the working class."

One small battle that has had big implications is the imprisonment of Kilmar Abrego Garcia, who was illegally deported to El Salvador. The Trump Administration has acknowledged that Garcia was wrongly deported, but Trump – who has accused Garcia of being a gang member – has so far refused to have him returned to the U.S. Garcia is an apprentice member of Sheet Metal Workers Local 100

A group of union sheet metal workers appeared at the May Day rally in Detroit to support the return of Garcia.

He had not been convicted of any crime," said the group's spokesman, Local 80's Jason Grunenwald. "In a March 31 court filing the Trump Administration admitted that he had mistakenly been deported. When deported he had been living with his wife and three children, all U.S. citizens. Since the deportation a federal judge has ruled that the deportation was illegal and the administration was ordered to facilitate his return. The U.S. Supreme Court unanimously backed the lower court's order, however it has yet to be honored.

"This is a family man. Most alarming if it can happen to one of us it can happen to any of us. With that I say bring our brother home."

**Plumbing Law Changes:** Since March 20, 2025, anyone performing plumbing work in Michigan must either be registered and in good standing with the State as a plumbing apprentice or hold a current journeyman or master plumbing license. The new legislation also establishes a ratio of one journeyman for every two apprentices, with significant penalties, including steep fines and the suspension or revocation of a plumbing contractor's license for non-compliance.

This is excellent news for our industry and presents a great opportunity to expand our market share in West Michigan. Make sure that your license or apprentice registration is up to date with the State. If your license has expired or you need to register as an apprentice, you must contact the State Licensing Division at 517-241-9316.

Earned Sick Time Act (ESTA): Beginning on March 1, 2025 contractors will contribute 1/30 of your base wage for every hour worked into a Sick Fund on your behalf. Solxsys will set up and administer a fund for each individual member. Starting June 1, 2025 members will be able to fill out a form and request reimbursement for time missed. If you have any questions, please contact the Union office.

Wage Allocation: The 2024 wage allocation was voted on at the June 4, 2024 membership meeting. Results were \$1.27 increase on the check, \$0.05 increase to the Retiree Bonus Program, \$0.60 increase to the Pension fund, and \$0.30 increase to the Training Fund.



Motor City Electric has been awarded the new line at Bay City's GM Powertrain site. They will continue to hire for this project.

J. Ranck Electric is continuing work at SK Siltron semiconductor chip manufacturing facility, thanks in part to \$560M which was allocated by the Biden administration as part of the Chips & Science Act. J. Ranck has also secured both phases 4 and 5 on this project and calls are coming in. Ranck is continuing work on their Mission Street Solar project. This is a 250-mw site which will require a substantial number of JIWs from our hall to complete.

Master Electric has begun their work on phase 2 at Bangor Schools.

Countyline Power has ongoing work at the Mt. Pleasant Water Treatment facility and Harrisville Pumpstations. Countyline Power has also been recently awarded a high voltage termination project at Michigan Sugar in Bay City.

Clements Electric has work at Mersen USA. They have also recently been awarded a maintenance contract at Mersen. Work on the Midland Center for the Arts, Bay City lift stations and HL Mechatronics in Midland continues. Clements Electric is also working on an apartment complex in Auburn.

Conti Electric has projects that are ramping up inside the I-Park (Dow) and also has work at the Karn Generation Facility.

JOBSITE SAFETY - is and should always be #1 on all IBEW jobs. Recently, issues have occurred on the Local's Mega Project in Hemlock. Local contractors Conti and J. Ranck have led the charge to preserve safety for 557 members and travelers. Ongoing OSHA investigations into the recent events are underway and will be taken very seriously by the Local, Contractors and the members involved. This thorough investigation being led by the State of Michigan will get to the bottom of the matter and be done to the letter of the law. No deadline or profit should be placed ahead of the simple fact that members need to go to work and return home in the same safe state in which they were prior to their day of work.

EARNED SICK TIME ACT- Michigan's new law requiring employers to pay their employees Earned Sick Time (ESTA), is now in effect. By now, every member working for an IBEW contractor currently, should have seen a written notice of some sort regarding this matter. Local 557's CBA does not contain any language related to ESTA, therefore, this law will apply to our membership. If your employer is NOT complying with this law you are strongly encouraged to file a complaint with the State of Michigan. ## Consumers Energy's shift to clean power a boon to Michigan trades

to where you're going to see \$10 billion spent, by Consumers Energy alone, in the utility market. Which is fantastic for everybody in this room," (not to mention tradespeople reading this article).

Consumers Energy is the state's largest utility, serving 6.8 million Michigan residents in the Lower Peninsula. The company is aggressively moving toward a new clean energy standard, with plans to halt all coal-powered production this year. The company aims to generate 90 percent of their power from renewable sources (like solar and wind, natural gas with carbon capture and storage, and nuclear) by 2040.

Getting there will take planning, talent and hard work – and building trades union workers have been hired exclusively by Consumers Energy for their projects using various forms of project labor agreements.

project labor agreements.

As Consumers Energy navigates a new clean energy path,
Wunder – who continues to hold his membership in Boilermakers
Local 169 – made a few observations to building trades delegates.
He addressed what many in

Michigan are thinking: how will

they replace the power generated by huge coal baseload plants that are being retired?

•"Probably the most important bullet point in this whole presentation," Wunder said, "is new natural gas generation. Not only is it not off the table, we are actively looking at what we're going to do there. Load growth in Michigan is raising exponentially. All these data centers and all the industry that the governor and other folks are trying to bring to Michigan. We know we need good baseload generation.

"The current projection for us as a company is anywhere between 2 and 3 gigawatts of natural gas generation. Some of that may require carbon sequestration... in a spot that's geologically right for them."

• Consumers Energy's state-wide renewable projects alone are creating work for about 1,000 tradespeople. Some major projects include solar work at Sunfish II in Calhoun County (450 craftworkers); Spring Creek in Calhoun and Berry counties (125 workers); Blackman Solar in Calhoun County (40 workers), and River Hydro, miscellaneous projects (50 workers).

The largest ongoing project is the Muskegon Solar Energy Center, which will be a 250-megawatt facility – enough to power approximately 40,000 homes. He said about 130 Hardhats are currently working on the project.

Long-term, Consumers intends to bring 8,000 megawatts of solar online by 2040.

• Other trades employment ongoing at Consumers sites involves "major maintenance projects that we have ongoing at all of our generating sites, at our gas facilities, and gas upgrades," Wunder said.

• Battery storage projects "have taken a bit of a turn," Wunder said, with installations that were set to start this summer put on pause. "The cost associated with the technology on these is at risk," Wunder said, but the

utility still plans to move ahead with battery projects in the future, one of them at the J.H. Campbell plant

• Wind energy is a key part of the utility's portfolio, and "we are looking at expanding some of our existing wind farms," Wunder said. But "we are not looking at building out any new ones just yet."

• Demolition is continuing at the utility's Karn 1-2 units near Bay City. "We are taking them right down to the ground," Wunder said, with completion in about two years. Karn 3 and 4, which are fueled by oil and natural gas, are going to remain operating until 2031, at which point they will be shut down.

•The utility's days of using coal as fuel are coming to an end. The coal-burning J.H. Campbell plant, located between Holland and Grand Haven, opened in 1962, and like other baseload plants, provided hundreds of thousands of work-hours for the trades.

"It will shut down no later than May 31 of this year," Wunder told delegates." I know it's a dagger to the heart of a lot of people in here who have made a lot of money over the years maintaining it and building it out. There are rumors flying around that it's going to get a lifeline. I can say those rumors are not true. We are staying the course. As of midnight on May 31, all three units at Campbell will come down." He said they would clean the plant and get it ready for actual demolition, with the major portion starting Jan. 1.

•The 1,176-megawatt Covert Generating Plant, located south of South Haven, has been purchased by Consumers Energy. "It's not in the best shape, it has changed ownership three or four times," said Wunder of the gasburning plant. "Even the initial build was bare-bones, it's a little beat-up. Our capital spend at Covert is projected at \$25 million per year. We're looking at a lot of investments there."

## Shuler: 'Democracy does not defend itself'

temporary injunctions. But Trump has been ignoring lower court edicts and is turning a blind eye to the mass marches, including those on May Day, two days after the 100th day of his reign.

Trump's aggressions toward working people are wide-ranging, from mass firings at the National Institute for Occupational Safety and Health (NIOSH), to allowing an ineffectual National Labor Relations Board by not appointing a quorum of members, to using executive orders to strip the collective bargaining rights of more than 1 million federal workers under the guise that they are somehow a threat to national security.

"Authoritarians always start with organized labor," Shuler said. "They came immediately for our federal workforce: Cutting funding Congress appropriated, firing workers with no process, lying about their performance. Trying to get other workers to quit. When our unions fought back, with grievances and lawsuits, what we saw in response was the single biggest act of union-busting in American history.

"One million federal workers illegally stripped of their collective bargaining rights. Moving to cancel their union contracts with the stroke of a pen. Saying to those who haven't filed grievances yet: We'll give you your rights and contracts back if you keep your mouths shut and fall in line."

Shuler explained that to counter Trump, and Elon Musk's so-called Department of Government Efficiency (DOGE) – labor set up its own tongue-in-cheek-named "Department of People Who Work for a Living." It's designed as a vehicle for workers "to raise their voices about what's going on in their lives." That department is touring the country, holding hearings on the impact of Trump's and Musk's cuts in people, policies and programs, she explained. It's hosted town halls in deep red cities and states, in direct contrast to Republican lawmakers, who now deliberately shun town halls and direct questions from constituents after the first several were jeered and booed off the stage

The AFL-CIO set up its town halls "with a very simple idea: 'If you have a story, if you've been affected by what's gone on, come out tonight. We want to hear from you," Shuler said. "Over two weeks, thousands of Americans showed up. They have heard from "working people who had been fired from the only job they'd worked in 20 years, over e-mail," she said of the almost 175,000 federal workers whom Musk and Trump chainsawed out of jobs. "Veterans who served in active duty who suddenly couldn't get the care they needed," when the duo axed 80,000 workers from VA hospitals.

"Their stated reason for stripping 1 million workers of their collective bargaining rights was: 'We didn't like it that your unions were fighting back.' They've attacked our most vulnerable – our immigrant brothers and sisters, like Kilmer Abrego Garcia. They've attacked the coalitions most equipped to fight back," starting with unions, who lead the resistance.

Shuler said after all the federal worker firings: "Asking every American a very simple question: 'Are you better off now than you were 100 days ago?' Do you feel safer knowing the people who inspect our food, and keep our water clean, and make sure our planes are flying in the sky have been fired from their jobs? Is life for you and your family easier now that the people who run our child care centers, and work at our Social Security offices, are not there anymore?

"Democracy does not defend itself. Nor can we expect politicians to save us from autocrats' clutches. The decision to capitulate or to resist rests with each of us."

# Judge blocks Trump's try at union-busting federal workforce (Continued from Page 1) preliminary injunction granted

step. But this fight isn't over, and it isn't limited to the courts."

Trump's executive order canceled union rights at more than two dozen federal agencies and offices. He cited national security concerns as justification for terminating workers' collective bargaining rights, although in tens of thousands of jobs, their connection to national security is dubious.

Some of the affected workers are tasked with trade policy, national energy, and pandemic response. The executive order affects workers at the departments of Defense, Justice, Veterans Affairs, Treasury, National Institutes of Health, Federal Emergency Management Agency, the Environmental Protection Agency, the Federal Communications Commission, the National Science Foundation, and Department of Agriculture, among other agencies.

Notably, federal police and otehr law enforcement agencies – who supported Trump's candidacy – were not included in the executive order. This was not lost on Judge Friedman, who said in a subsequent ruling on a related case: "Now that he's telling us there's unions he likes and does not like, there's no presumption of regularity."

Most federal workers have been eligible to bargain collectively since 1962, although they are forbidden from going on strike and they cannot directly negotiate their pay and benefits. And while union dues are not compulsory for members, the unions do provide significant security for workers and protect them from arbitrary discipline and firings, which puts them at the center of Trump's historic assault on the bureaucracy.

"Today's court order is a victory for federal employees, their union rights, and the American people they serve," said National Treasury Employees Union President Doreen Greenwald. "The

at NTEU's request means the collective bargaining rights of federal employees will remain intact and the administration's illegal agenda to sideline the voices of federal employees and dismantle unions is blocked."

Also hailing the ruling was

the American Federation of Government Employees, the nation's largest federal union. "President Trump's latest executive order is a disgraceful and retaliatory attack on the rights of hundreds of thousands of patriotic American civil servants – nearly one-third of whom are veterans – simply because they are members of a union that stands up to his harmful policies," wrote AFGE National President Everett Kelley.

Presidents could push back at federal union demands by "beyond the nuclear option of denying representation," writes Nicholas Handler, an associate professor of law at the Texas A&M School of Law.

"The current executive order dispenses with many of the incremental tactics Trump relied on in his first term to push back against unions," Handler said. "Rather than rescinding specific CBA (collective bargaining agreement) provisions or litigating before the FLRA (Federal Labor Relations Authority) to limit the scope of union representation, the administration has gone straight for the jugular – seeking to strip much of the federal workforce of union representation entirely."



### <u>Outdoors</u> After the ice





(From the Michigan DNR) Following severe ice storms in Northern Michigan in late March, Gov. Gretchen Whitmer declared a 12-county disaster area encompassing Alcona, Alpena, Antrim, Charlevoix, Cheboygan, Crawford, Emmet, Mackinac, Montmorency, Oscoda, Otsego and Presque Isle counties.

The storms profoundly impacted approximately 919,550 acres of DNR-managed lands, including 3,260 miles of state forest roads, 12 state parks, 32 state forest campgrounds, 122 boating access sites, and 4,000 miles of trails (including 1,700 miles of state-designated ORV trails and routes).

DNR staff are currently assessing damage and conducting cleanup at these sites, prioritizing public and staff safety.

After the storm, the DNR recommends prioritizing forest health in tree management.

The ice storm has left an overwhelming tangle of downed and damaged trees across northern Michigan and the eastern Upper Peninsula. For those working with damaged trees in this region or across the state, the Michigan Department of Natural Resources is providing guidance in prioritizing work to reduce the impacts of tree pests and diseases now and in the future.

**Prioritize pine.** Pine species are widespread in storm-affected areas. Downed pine trees develop a fungal stain quickly, losing their value as timber. Stressed or damaged pines and fresh pine debris in early spring can attract native pine bark beetles. If left for several weeks, pine logs and downed branches can become breeding grounds for bark beetles, leading to population explosions. Beetles can emerge to attack stressed trees and even overwhelm the defenses of healthy trees.

Take these steps to reduce the impact of pine bark beetles:

• Salvage and clean up as much affected pine as possible before June to reduce beetle re-

•Avoid piling logs and branches. Piles reduce drying

time and invite increased beetle production.

• Prioritize removal of debranched and tipped trees, followed by those that are severely bent, and then those with the fewest intact branches.

Conifers, especially red pines, are also susceptible to Heterobasidion root disease, or HRD, spread by fungal spores that enter from cut stumps and travel through root connections to other, nearby pines, creating pockets of dead trees. In the ice-stormdamaged area, HRD is known to be present in several locations in Emmet County and one location in Montmorency County.

If working within a 5-mile radius of known HRD infection, pine stumps within plantations should be treated with approved chemicals to prevent new infections.

Delay oak pruning and management. Due to the threat of oak wilt, a fatal fungal disease introduced through oak tree wounds, oak salvage and cleanup should be postponed wherever possible until after the high-risk period of April 15 to July 15.

There is less urgency to harvest damaged oak because deterioration of storm-damaged oak and other hardwoods will occur more slowly than pine, providing up to two years to complete

April 15 through July 15 is the high-risk period for oak wilt spread because that is when oak wilt fungal spores are most

Oak wilt is fatal to trees in the red oak family, which includes black oak, northern red oak and northern pin oak – all identifiable oaks, those with rounded lobes

or leaf tips, are susceptible to oak wilt but may survive for several years or succumb more slowly before dying. Once infected, oaks can spread the disease to other oaks through underground root connections or grafts, creating an expanding circle of dead trees. Important considerations

for protecting oak trees:

• Trees that were wounded or damaged in the late March storm are at less risk of infection than trees sustaining fresh wounds later this spring.

• If you must work around oaks during the high-risk period, take precautions to avoid hitting or damaging them.

• If oaks are pruned or damaged during the high-risk period, immediately coat wounds with latex paint. · Oak wounds are only vul-

nerable to oak wilt infection for three to four days. It is not necessary to coat wounds or stumps of previously damaged trees.

Future forest health concerns. Many trees have been damaged or weakened by the storm. In some areas, drought or infestations like spongy moth may have already stressed trees, making recovery more difficult. Stressed and damaged trees are more susceptible to a host of native and invasive insects and diseases that may strike in the

 Armillaria root disease, a mushroom-producing fungus that slowly kills trees, may become by their pointed leaf tips. White evident in one to three years in impacted trees and stands.

 Native two-lined chestnut borer may attack damaged or stressed oak trees. Heavy infestations can stop the flow of sap, killing branches and entire trees.

• Native white spotted pine sawyer beetles will also attack dead and dying pines and may be confused with the invasive Asian longhorned beetle. Michigan State University's Spot the Difference guide can help distinguish between the two beetles.

Newly opened forest canopy and cleared landscape areas invite invasive trees and shrubs. Look for and remove common invaders like autumn olive, buckthorns, invasive honey-suckles, Norway maples and Scotch pines. Early action can improve native forest regeneration and rebuild wildlife habitat. More information on invasive trees and shrubs is available at Michigan.gov/Invasives/ id-report/plants.

Proper debris disposal. To help with cleanup efforts, 17 public debris disposal sites have been opened to serve the 12-county disaster area. A map of these locations is included in the 2025 Northern Michigan Ice Storm dashboard at Michigan.gov/MSP. Check the location listing for hours of operation and permissible items. Some locations are accepting tree debris only, and others will accept all vegetative debris.

Note that it is unlawful to dump or dispose of debris on public lands or property. Be aware that moving vegetative debris can spread invasive insects, plants and

Don't move firewood. Tree insects and diseases don't move far on their own, but when people move firewood, these species can move hundreds of miles. Though the storm has created a lot of potential firewood, it is important to use it on-site or locally to prevent the spread of invasive pests and tree diseases to new locations.

Help for forested lands. The U.S. Department of Agriculture's Farm Service Agency can provide payments to eligible owners of nonindustrial private forest land for emergency measures to restore land damaged by natural disasters through its Emergency Forest Restoration Program. The program is available in areas affected by the ice storm. Landowners are encouraged to contact their local FSA office to determine eligibility.


