UIA offers one-onone phone support

LANSING - The state Unemployment Insurance Agency (UIA) is now offering telephone appointments for customers with specific claim issues, in an effort that began Oct. 21.

"We're excited to offer this additional option for customer service," said UIA Director Steve Gray. "This new scheduling system is another tool to help us ensure continued service to Michigan's residents who are facing unemployment during the COVID-19 pandemic."

The new service began Oct. 21. Customers can schedule an appointment online up to one week in advance at Michigan.gov/uia for the following issues:

• I filed under the wrong Social Security Number

• My claim is inactive

• I am unable to certify for all weeks needed

• I need to file a claim, but one is already filed in my name • I do not have the link in MiWAM to file a claim

The agency said a customer service agent will call the customers on the designated day and time they choose from the agency's customer service line-866-500-0017. Claimants should be prepared to verify their identity with their Social Security number and driver's license/state identification number.

Jobless numbers naggingly high

WASHINGTON (PAI)-Some 25.2 million U.S. workers – 17.2 percent of the nation's work force – sought or received state or federal jobless benefits in the week ending Sept. 26, the Bureau of Labor Statistics reported Oct. 17.

The Economic Policy Institute reported on Oct. 22 that the 1.1 million who applied for Unemployment Insurance was a decline of 47,000 from the prior week's revised figures. But, "last week was the 31st straight week total initial claims were far greater than the worst week of the Great Recession," the EPI said

State extends jobless benefits but only through end of 2020

LANSING - One of a series of COVID-19-related bills signed by Gov. Gretchen Whitmer on Oct. 14 will extend

jobless benefits for workers, providing an additional 13 weeks of federal payments once state benefits are exhausted, while extending the maximum length of Lansing state payments to

26 weeks, from 20 weeks, to the end of the year.

Gretchen Whitmer, who last spring issued an executive order extending the maximum length of jobless benefits to 26 weeks from 20 weeks.

'My legislation," said bill sponsor state Sen. Ken Horn (R-Frankenmuth), "would ensure those who are relying on the state's Unemployment Insurance Agency as they get back on their feet see no interruption in the benefits rightfully owed to them. The bills would also protect retirees who temporarily returned to work to assist with the state's response to the coronavirus."

Teamsters back Biden

2020 is a year for the record books. A global pandemic has wreaked havoc not only with the health of Americans, but also on their wallets. Tens of millions of Americans have lost their jobs during the coronavirus pandemic, and millions are still out of work.

But if we are honest with ourselves, these tumultuous times did not start back in March. Working families all over the country have been struggling for years with a federal government that's prioritized the corporate class over the working class. That's why we've seen a curtailing of union rights and a lack of attention to pension security issues.

(Continued from Page 1) to 2.2 million workers, or roughly 96 percent of potentially eligible, certifying claimants. There are currently around 80,000 claimants needing ID verification and around 13,000 in the adjudication process, which requires a oneon-one review of their claim.

"No Michigander should have to worry about how to put food on the table or pay their bills, especially during a global pandemic," said Gov. Gretchen Whitmer. "These bipartisan bills are an important step in providing immediate relief for working families, but given the recent rise in COVID-19 cases and hospitalizations in Michigan, I urge the legislature to take further action to make this permanent."

Whitmer said while the bills she signed codify the majority of her prior executive orders on unemployment compensation, the Legislature failed to extend the governor's efforts to speed up claim processing by allowing the Unemployment Insurance Agency to review only a claimant's most recent employer separation. UIA must now evaluate every job a worker has left in the past 18 months - "a waste of resources," she said, because employers are not being directly charged for benefits paid at this time.

Forty states, including all of Michigan's neighbors, automatically provide at least 26 weeks of unemployment relief. Michiganders deserve better than a shortterm extension that expires at the end of the year. "It's time to work together on a long-term solution for working families," Whitmer said.

(Continued from Page 1) Peters told a virtual town hall with the Great Lakes State Teamsters on Oct. 5. "This is a tough time. But I know how hard you fight to get the benefits you deserve."

Peters has been a champion of the PRO Act, a union-backed bill that would greatly aid the ability of unions to organize new workers.

He supports a higher minimum wage and has championed worker-friendly trade deals.

He told the Teamsters that beefing up organizing rights is essential because it builds the middle class, which in turn strengthens the economy. More union jobs, he said, brings higher pay that in turn increases spending and keeps people on the job.

Mike Randick, business manager of Iron Workers Local 25, was asked to speak at the topping out ceremony, which included a bevy of Memorial Healthcare personnel. "You take good care of people in the building trades when we need your help, you have the best health care people in the industry," Randick said. "And just like you, we have the best iron workers in the industry, and have since 1901. We appreciate the opportunity to come out to work for Memorial Health Care."

(Continued from Page 1) employees that covers, at a mini-

mum, workplace infection-control practices, the proper use of personal protection equipment (PPE), steps workers must take to notify the business or operation of any symptoms of COVID-19 or a suspected or confirmed diagnosis of COVID-19, and how to report unsafe working conditions.

MIOSHA's Emergency Rules implement workplace safeguards for all Michigan businesses and specific requirements for industries, including manufacturing, construction, retail, health care, exercise facilities, restaurants and bars.

The rules establish workplace safety requirements and employers should coordinate these requirements with the Emergency Order issued by the Michigan Department of Health and Human Services restricting gathering sizes, requiring face coverings in public spaces and childcare facilities, placing capacity limitations on stores, bars and other public venues and providing safer workplaces. "As we re-engage our economy, the governor's actions reiterate the importance to keep

workplaces safe for employees and protect customers from COVID-19 transmission," said COVID-19 Workplace Safety Director Sean Egan. "These rules will formalize the workplace safety guidelines previously in place, and are necessary to save lives. We will continue to educate workers and employers on requirements for businesses to get open and stay open."

Since March 2020, employers have reported 30 worker deaths from COVID-19 in Michigan and 127 in-patient hospitalizations potentially linked to workplace exposure. MIOSHA has received more than 3,800 complaints from employees alleging uncontrolled COVID-19 hazards in the workplace and 263 referrals from local government, including local health departments, indicating that businesses were not taking all the necessary measures to protect their employees from infection.

Brian Calley, president of the Small Business Association of Michigan, said small businesses owners "are dedicated to providing safe workplaces. Consistent, practical, and clear rules are important to achieving that goal. We welcome the initiation of the departmental rulemaking process to establish predicable and well defined expectations."

Cashing in on COVID

The holy mantra of health professionals was coined about 2,500 years ago by the Greek physician, Hippocrates: "Do no harm."

Of course, that was before corporate health care took charge and asserted a new guiding ethic: "Jack up profits." Putting this in practice, America's largest and richest hospital chains rushed to the



front of the COVID-19 bailout line this spring to pull \$15 billion from the government's emergency fund. They pocketed the taxpayers' money despite sitting on tens of billions of dollars of their own cash reserves.

But hold your nose, for it gets much stinkier. The bailout was intended to keep hospital workers on the job, yet the wealthiest chains have hit nurses, janitors, and other crucial, frontline staffers with layoffs, pay cuts, and deadly shortages

of protective gear. For example, HCA, the \$36-billion a-year behemoth that's wallowing in profits, snatched a billion-dollar taxpayer bailout for itself, then demanded hospital staffers accept wage freezes, elimination of company pension payments, and other cuts... or have thousands of jobs eliminated.

However, in a public show of compassion, HCA's chief exec Samuel Hazen donated two months of his \$1.4 million salary to an employee support fund. How magnanimous! Uh, no – his generosity is a deception, not a sacrifice. The trick is that a CEO's "salary" is a minuscule part of total pay. Hazen's annual bonus, stock payouts, and other compensation will raise his actual pay to \$26 million this year! So his donation is less than 1 percent of his pay, and he almost certainly will write that off his income taxes – so we taxpayers (including the nurses and others he's knocking down) not only underwrite his fat take-home, but we also subsidize his face-saving philanthropic gimmick.

What we have here is a raging virus of executive suite greed doing deeper damage to our society than COVID-19 ever could. (via www.otherwords.org)

BUILDING MICHIGAN: The Ford Rouge Plant HISTORY IN THE MAKING By Marty Mulcah



THE FORD MOTOR CO.'S Rouge Plant in Dearborn was still going strong when this photo was taken in 1947 with its concept of "vertical integration." That was Henry Ford's concept of self-sufficiency importing raw materials like iron ore, controlling manufacturing and the assembly of every single aspect of a vehicle on site – allowing him to capture profits on all aspects of the supply chain.

In 1915, Henry Ford was producing more vehicles at his Highland Park plant than all of his competitors combined.

He had money to burn, and a vision for growing his manufacturing capacity the likes the world had never seen. That year, he purchased a marshy, 2,000acre plot of land in southeast **Dearborn on the Rouge River** next to Detroit, and at first he wasn't sure what to do with it maintaining it as a bird sanctuary was a possibility.

That changed near the end World War I, when Undersecretary of the Navy Franklin D. Roosevelt engaged Ford to build Eagle boats, which would hunt German submarines. The boats were built in 1917 at the hastily constructed "Building B" at the Rouge site, but the war ended before the boats ever saw action.

But the federal government's backing in building the Eagle boats had also changed the fundamental potential use of Rouge site. The widening and dredging of the river to accommodate the Eagle boats also provided room for the movement of mighty Great Lakes bulk-carriers that could deliver more iron ore, coal and limestone into a potial complex at the site. Bingo. Ford got his favorite architect, Albert Kahn, on speed dial, and told him to he wanted to build his Model T at what would be the world's largest industrial plant in the world at the Rouge site. Work began on April 1, 1917. "The new plant had several advantages over Highland Park, which was fast becoming inadequate during the late 1910s," says a history provided by the Ford Motor Co. "The undeveloped site along the Rouge River was vast, which would allow for continuing expansion. The river would afford Ford the option of shipping materials to the plant by water as well as by rail. "The potential of the site inspired Henry Ford and his engineers to think big, so they planned a new facility that would allow the company to start with raw materials and make nearly everything needed to assemble new cars. The Rouge plant would receive iron ore, coal, and limestone to smelt iron and then make steel. It would receive raw rubber and make tires. "Building a new plant at the Rouge site also allowed the company to construct factory buildings designed by Albert Kahn to accommodate flows of materials and parts through the processes of fabrication according to the engineers' experiences in finetuning the processes at Highland Park.'

Car and Driver magazine, commemorating the 100th anniversary of the plant in 2018, said the plant's first coke oven battery was first to come online in **October 1919.**

This was the largest facility of its type in the world at the time," said Car and Driver. "The electricity plant came online in 1920, and blast furnaces were added in 1920 and 1922. Glass production came online in 1923, and steelmaking furnaces and rolling mills were added in 1926, at which point the Rouge was producing virtually every component needed to assemble a Model T. Despite this, final assembly for the Model T remained at Ford's Highland Park plant."

The first mass-produced vehicle manufactured entirely at the Rouge complex was actually the Fordson tractor, where production began in 1921. The 1928 Model A was the first automobile completely built at the Rouge.

"The Rouge was the largest single manufacturing complex in the United States, with peak employment of about 120,000 during World War II," says a history provided by the State of Michigan. "Here Henry Ford achieved self-sufficiency and vertical integration in automobile production, a continuous work flow from iron ore and other raw materials to finished automobiles. The complex included dock facilities, blast furnaces, open-hearth steel mills, foundries, a rolling mill, metal stamping facilities, an engine plant, a glass manufacturing building, a tire plant, and its own power house supplying steam and electricity." According to The Henry Ford, the new powerhouse furnished all the Rouge's electricity and one-third of the Highland Park Plant's needs as well. At times, surplus Rouge power was even sold to the Detroit Edison Co. An innovative glass plant began operation in 1923, that itself was erected with heavily glassed upper walls and the ceiling, allowing for a tremendous amount of natural illumination. "It was called 'the single factory that carries industrial architecture forward more than any other,' said The Henry Ford. And utilizing a continuous process that Ford had helped develop, it produced higher quality glass at lower cost. The 1928 Model A became the first lowpriced car to use laminated safety glass.

original Rouge complex was a mile and a half wide and more than a mile long.

"For many years, it was the epicenter of the manufacturing world," wrote Austin Weber in 2003 for Assembly Magazine. "It was big. It was bold. It was breathtaking. For most of the 20th Century, the world-famous River Rouge plant was a monumental complex that was the embodiment of manufacturing on an epic scale."

What Ford and Kahn built was staggering.

"There were huge ore docks, steel furnaces, coke ovens, rolling mills, glass furnaces and plate-glass rollers," Assembly Magazine said. "In addition to several chassis assembly lines, the self-sufficient complex included a tire-making plant, a stamping plant, an engine casting plant, a transmission plant, a radiator plant, and a tool and die plant. At one time, the unique facility even included a paper mill and a soybean conversion plant that turned soybeans into plastic auto parts.

The original works included:

Trump's NLRB to block workers from suing their employers as a group or in a class action. They got it.

•Corporations asked the Trump NLRB to make it harder to hold all responsible companies accountable when workers' rights are violated on the job. The Trump administration is delivering.

·Corporations asked the Trump NLRB to make it harder for workers who want a union to have an election. The Trump Administration is working on it. And the list goes on:

•They want to make it harder to form a union by changing which workers are in the bargaining unit.

•They want to be able to make unilateral decisions about workplace policies that they used to have to bargain over.

•They want to be able to discipline union-protected workers, during bargaining, without notifying the union.

•They want to be able to prevent workers from using their work email to communicate with each other, about workplace and union issues.

•They want to be able to discipline, or even fire workers, for using profanity in a labor dispute, even if that interferes with activity previously protected under the National Labor Relations Act.

•They want to be able to gag employees from talking to each other about employer investigations like sexual harassment. And, they want to be able to kick you off company property if you're discussing workplace grievances.

The NLRB is supposed to protect workers rights. Trump has turned it into an agency that delivers for corporate interests, like the Chamber of Commerce, which, according to the Center for Responsive Politics, spent nearly \$100 million in lobbying in 2018 alone.

Working people deserve an NLRB and labor policy that makes it easier for them to form a union. And insist on fair wages, benefits and safe workplaces. Not the agenda from a wish list of corporate lobbyists.

An Oct. 21 editorial in the Wall Street Journal predicted that if Democrats win a majority in the Senate, "and eliminate the filibuster as they say they will, the Pro Act is likely to pass. Union power over workers, and leverage over employers, will expand more than it has in 85 years."

Chill in the air for U.S. construction; COVID-19 still an economic anchor

The weather is starting to get chilly. So is the U.S. construc-Year-to-date through the end of September, total U.S. construction starts were down 14 percent from the same period in 2019, according to a report issued Oct. 15 by Dodge Data and Analytics. Nonresidential starts were lower by 26 percent and nonbuilding was down 18 percent, while residential starts gained 1 percent. For the 12 months ending September 2020, Dodge said total construction starts were down 8 percent from the 12 months ending September 2019 "That construction starts took a significant step back in September is disappointing, but also not surprising," said Richard Branch, chief economist for Dodge Data and Analytics. "The economic recovery has lost momentum and is showing strain since support provided to consumers and businesses from expanded unemployment insurance benefits and the Paycheck Protection Program have expired. "The worsening budget crisis for state and local areas has also slowed growth in public project starts, particularly in the face of a somewhat uncertain outlook for federal infrastructure spending programs. The road to recovery will continue to be uneven and fraught with potholes until a vac-

At its peak in the 1940s, more than 100,000 people worked at the facility. To accommodate them, the Rouge complex included a multi-station fire department, a scheduled bus service, a police force, a fully staffed hospital and a maintenance crew, 5,000 strong. Every month, 3,500 mop heads had to be replaced to keep the complex clean.

In recent years, steelmaking operations at the site, now owned by Cleveland Cliffs, have been shrinking. And the manufacture of glass, casting, stamping and all the other sub-categories of auto manufacturing have gradually been removed from the Rouge complex over the last several decades.

Today, the Rouge complex is

primarily used for the assembly of Ford's F-150 pickup at the Dearborn **Truck Plant.**

Bill Ford, Jr., executive chairman of Ford Motor Co., told the Detroit Free Press on the occasion the Rouge of complex's 100th anniversary in 2018: "I describe it as the heartbeat of the company. We make the F-150 there. It's our flagship, built by the best workers in the country. Whatever we do in the future, we'll do it at the Rouge."

Michigan continued to be in the middle of the pack among the states when it comes to construction employment (losses). Our state lost 7,600 construction jobs from pre-pandemic February 2020 through September, a 4.2 percent loss that ranked Michigan No. 26 among the states.

The Associated General Contractors of America, which compiled the numbers using Bureau of Labor Statistics data, said only eight states and the District of Columbia have recouped the severe pandemic-induced losses of construction jobs that occurred last spring. The AGC warned that job losses would become even more widespread unless lawmakers promptly renew and expand the loan program that enabled firms to temporarily retain and rehire many workers.

"New spikes in coronavirus cases, along with ongoing pandemic-related costs and revenue losses, are causing ever more private owners, developers, and public agencies to delay and cancel projects," said Ken Simonson, the association's nonresidential construction activity has stalled, leaving large numbers of workers at risk of losing their jobs as current projects finish up with nothing on the horizon.

Seasonally adjusted construction employment in September was lower than in February – the last month before the pandemic forced many contractors to suspend work - in 42 states, Simonson added. California lost the most construction jobs over that span (-54,900 jobs, -6.1 percent), followed by Texas (51,800 jobs, -6.5 percent). Vermont had the largest percentage loss (-24.5 percent, -3,600 jobs), followed by Iowa (-14.6 percent, -11,400 jobs).

Dodge said a summertime surge in U.S. construction starts was essentially erased with an 18 percent dip in activity in September. Dodge's Index for U.S. Construction was down 23 percent in September compared to 12 months prior.

The federal loans to companies that were part of the federal stimulus last spring "saved tens of thousands of construction workers from unemployment, but those funds are rapidly running out," said Stephen E. Sandherr, the AGC's chief executive officer. "Renewal of the loan program should be a top priority for any policy maker who cares about keeping the economy from backsliding.'

A) Attend a Project Specific Orientation facilitated by the Contractor at mutually agreed upon times and locations;



Prior to the start of work on the project the employee must provide confirmation of negative results to a MUST Substance Abuse Test or equivalent test within the last 30 days.

MEMBER ASSISTANCE: Local 292 is now partnering with Ulliance, an employee assistance program designed to assist active members and their eligible family members who may be struggling with emotional, domestic or substance abuse issues, as well as legal and financial referrals. update your beneficiary choice on all of your Local 80 and international benefits. The law requires that in the event of an untimely death your benefits go to your spouse first and if there is no spouse to your children UNLESS you designate otherwise in writing with each specific benefit. Depending on your classification you could have benefits due to your heirs from Local 80 pension, insurance, annuity and from international and SASMI. Each individual benefit needs to have a designated beneficiary unless you want it to go to your spouse or children. As always seek the advice of an attorney.

ACCIDENTAL DEATH and DISMEMBERMENT INSURANCE FROM OUR INTERNATIONAL ASSOCIATION: Members who have their dues paid in advance (prior to the month of the accident) are eligible for accidental death and dismemberment benefits up to \$7,500. This benefit comes as a dues paving member of SMART International.

WEEKEND WORK ASSIGNMENTS: Saturday and Sunday work assignments. Please remember that when performing work on a Saturday or Sunday the steward must report it to the hall, give each members' name and obtain a form for signatures. Each member must sign the form along with the number of hours they worked. The completed form must be sent back to by hall by the end of the day on the following Monday. Weekend work assignments must be called or emailed into the hall prior to 3:00 pm on Friday.

WORK ASSIGNMENTS: Everyone must obtain a work assignment prior to starting work. If you fail to do so you could be written up on charges.

LAY-OFFS: All members must report to the Union Hall immediately upon lay-off, even if you only work one day. These are the By-Law rules for the Out-of-Work List. Your name will be removed from the list 14 days after receiving an assignment. It is very important to report to the union hall immediately after your layoff. Members get confused because the S.U.B. Fund allows you a period of up to seven days to apply for S.U.B. benefits after lay-off.

LAY-OFF SLIPS/TERMINATION NOTICES: Lay off slips must accompany all applications for sub pay. Without lay off slips you cannot collect sub pay. It is the member's responsibility to make sure they get one from the contractor when laid off. Your application cannot be submitted without one. It is the contractor's responsibility to issue one in accordance with our contract.

S.U.B. BENEFITS: Report to the hall promptly upon layoff. You must complete a S.U.B. Application within seven days from your layoff date or you will forfeit S.U.B. benefits. Lay-off slips must accompany the application to be eligible. Proof of UIA benefit payments must be submitted within 21 days of when you were paid in order to receive SUB benefits. Do not submit your sub applications directly to the fund office. Your application must be signed by the hall or you will not collect benefits.

OUT-OF-WORK LIST: You must be on the out-of-work list to collect S.U.B. benefits or SASMI. Members must re-register bi-annually: March 1-20 and Sept 1-20. If you fail to re-register you will be removed from the list.

SHORT WORK WEEK SUB PAY: If you work 16 hours or less in a week or have a short work week due to weather you may collect sub for that week but only if it is at the **beginning or the end of a** layoff. You may NOT collect if you are not laid off. You must complete a sub application at the hall, provide a pay stub for that week and the hall will submit it to the fund office. If you are not laid off and it is due to weather the company MUST provide written documentation that it was weather related.





VOTE: Mail ballots are going out in mid-September and the campaigning is ramping up. Remember in Michigan you can now vote absentee for no reason. You can apply for an absentee ballot and register to vote at www.mvic.sos.state.mi.us/ avapplication.

401K Withdrawal: The recently enacted CARES Act allows the 401k Plan to adopt a special in-service distribution for participants who are diagnosed with COVID-19, whose spouse or child is diagnosed with COVID -19, or who are experiencing economic hardship as a result of the pandemic. This distribution can be up to \$100k, is not subject to the ordinary 10% excise tax, and the income tax from the distribution can be spread out over a 3year period. Individuals receiving such a distribution may also repay the distribution over 3-year period, in which case they will not be subject to income tax on what they repay.

Unlike other hardships, this distribution only requires that the member self-certify the need. The Fund is not required to independently corroborate the participant's certification with medical documentation or other types of documentation. The distribution is a one-time event only and must be taken in 2020. Make sure you specify that you are taking a COVID withdrawal.

Sub-Pay: The board of trustees voted to temporarily raise the maximum sub pay credit from \$130 to \$260 from March 23rd until the end of April. To file for sub-pay, fill out a sub-pay form. You can find a form on the members only section of the website under the "forms" tab on the left hand side, or you can call the Union office and we'll mail or email you some. Mail or fax the completed form along with verification that you received an unfrom a one-day ride-along with a Business Agent or Organizer all the way up to full blown salting.

Dues: Please keep your monthly window dues current. You can find your dues balance on the website or by calling the Union office. 





Whether it's a picturesque Great Lakes shoreline where people flock for a day at the beach, a state forest that's vital to the timber industry and filled with recreation opportunities for everyone from hikers to snowmobilers, or a game area, park or trail that offers a chance to get close to nature not far from home – chances are, your part of the state has public lands that benefit residents and businesses.

And chances are, the Michigan Department of Natural Resources has a hand in taking care of those public lands, either directly or in collaboration with other agencies.

Caring for public lands.

"These are lands where any of us can go and enjoy a number of activities. And the DNR is a big part of that because we partner with locals, we partner with the federal government, and we strategically manage 4.6 million acres of it with a lot of valuable input," said Scott Whitcomb, DNR senior advisor for wildlife and public lands.

The DNR is responsible for more than 4 million acres of public lands owned by Michigan residents. This includes 3.85 million acres of state forests, 363,000 acres of state parks and 364,000 acres of state game and wildlife areas. It includes places from the tip of the Keweenaw Peninsula to Detroit and everywhere in between.

"These are some of the areas that people often think about – Tahquamenon Falls or Porcupine Mountains Wilderness State Park or Pigeon River Country State Forest – and also areas in southern Michigan like Belle Isle or some of our game areas," Whitcomb said. "So that's a big footprint."

Managing such a large and varied collection of public lands takes a lot of consideration, planning and input.

Public Act 240 of 2012 required the creation of a strategic plan for public land management. The resulting strategy, created in 2013, provides a framework for DNR-managed public lands to ensure their best use for the benefit of Michigan residents and visitors and the state's natural resources.

As detailed in the 2013 pubic land strategy, nearly every

is at an all-time high, with ORV use up more than 20 percent.

"Public lands are getting used more than ever," Whitcomb said. "They offer a chance to get away, social distance, get some fresh air and exercise, and enjoy the health benefits that come with that – getting out in nature helps calm nerves, clear the head and lower blood pressure."

In addition to enhancing quality of life, DNR-managed public lands play a significant role in supporting many aspects of Michigan's economy, drawing millions of visitors and helping drive Michigan's \$20 billion-plus tourism industry, offering abundant locations for activities like hunting, fishing and wildlife viewing that contribute billions to the state's economy and supplying timber for the \$21 billionplus forest products industry.

Public lands the DNR manages also strengthen the state's environmental health, serving functions like air pollution removal, water quality protection and storm water management.

Among the benefits of DNRmanaged public land ownership for local communities are payments in lieu of taxes (PILT). The state makes these payments to local units of government in lieu of property taxes for every acre of land owned by the state and administered by the DNR. While these public lands do not require the same level of local government services as private ownership, local communities still see the advantages of the payments. resources.

•Providing spaces for quality outdoor recreation opportunities.

•Promoting natural resources management.

As the 2013 strategy explains, "The North American Model of Wildlife Conservation and the Public Trust Doctrine, the foundations that drive the acquisition and management of public lands, both rests on the principle that wildlife and, more broadly, natural resources belong to everyone."

Because all Michigan residents own the state's public

broad participation in the update process is key to ensuring a strong, comprehensive strategy.

"We have 83 counties, 10 million people, and public lands look different depending on where you are – in Iron County versus Wayne County, for example," Eichinger said. "We're aiming to manage these lands in a way that benefits all residents and ensures healthy natural resources in all areas of the state, not just rural, not just urban. We want to make sure we're considering everyone and looking at this plan through the lens of diversity, equity and inclusion."

Note: classes & certifications contractors have been asking for are, OSHA 30, Asbestos & Lead Awareness, Hoisting & Rigging, Pipeline Safety, Class A Cdl License, Asbestos Removal Supervisors Licence, Confined Space Permit Required, Grade Checking Blueprint Reading & Measuring Tools, Gps Location, all are available at the training center. It could mean the difference of being sent to work or not!

FYI: By taking the OSHA 30 your 18 MUST Safety modules are updated as well. If you are not able to go to the Training Center for MUST Safety Modules contact the Local, we will help make arrangements for you to complete them.

Referral List: Every member who is looking for work must call, or come to the Local Union Office on Mondays between 1:00 pm and 4:00 pm and put their name on the out-of-work list. You must have an out-of-work skills sheet filled out and on file in order to be referred out for work by this Local Union. (Be sure to Check & Update your Skills.)

Also please be advised: Per the out of work list rules, all members on the list must re-register your availability for work every quarter and do so within the first five days of the following months March, **June**, **September and December (Roll Call).** Your failure to do so will result in your name being removed from the referral list. *Example: If your name is on the list in April and or May and you don't re-register by June 5th your name will be removed from the list.

Members are urged to report new project starts to the Local Union. Members working for a contractor who may be looking to hire additional laborers are urged to call the Union Hall and help a brother or sister get referred out to work. The next time, it may be your name on the list when that call comes in for work.

Now in the process of updating this strategy, the DNR is seeking input from people around the state.

"While the reasons people use and value them vary, one thing remains constant – when public lands are well taken care of, they contribute significantly to the health of Michigan's residents, environment and economy, in many ways driving our quality of life," said DNR Director Dan Eichinger.

Benefits of public lands.

Careful, thoughtful management of these lands ensures plentiful outdoor recreation opportunities across the state, offering residents and visitors places to go off-road, put a boat in the water, hunt, camp, hike, watch wildlife and learn about history – to name just a few options.

The condition and availability of these outdoor spaces close to home are now more critical than ever, with more people out enjoying Michigan's natural resources during the COVID-19 pandemic.

"Hiking a wooded trail, fishing a trout stream, paddling a lazy river – the comfort provided by these outdoor activities underscores the value of Michigan's public lands and the need to manage them carefully," Eichinger said.

People are flocking to public lands in unprecedented numbers, with activities like turkey hunting and visiting state parks seeing significant increases.

Spring/summer 2020 data shows that – compared to the same time frame in 2019 – the number of spring turkey hunters increased 27 percent, the number of anglers climbed 11 percent, state park visitation was up nearly 50 percent, camping and lodging increased 25 percent, and trail use strategy.

The public land strategy seeks to strike a balance among the many ways these lands benefit Michigan and its residents.

An updated strategy, which must be submitted by July 1, 2021, to the Michigan Legislature for consideration and approval, will explain why a public land base is so important and provide goals, strategies and measurable objectives to guide the DNR in:
