State sees slightly better jobless rate

LANSING - The state's seasonally adjusted unemployment rate inched down by a tenth of a percentage point to 5.1 percent in March, the third straight month of decline, according to data released April 14 by the Michigan Department of Technology, Management & Budget.

Total employment in the state rose by 12,000, while unemployment edged down by 4,000, resulting in a minor workforce gain of 8,000 over the month.

Nationwide, the U.S. jobless rate fell by two-tenths of a percentage point between February and March to 6.0 percent. Michigan's unemployment rate in March was 0.9 percentage points below the national rate. Since March 2020, the U.S jobless rate advanced by 1.6 percentage points, a slightly larger gain than the 1.4 percentage point increase exhibited by the state.

Our state's adjusted payroll edged up by 15,000 jobs over the month. Michigan's total non-farm job count in March was 4.13 million.

"Michigan's labor market was stable in March," said Wayne Rourke, associate director of the Bureau of Labor Market Information and Strategic Initiatives. "The state jobless rate and number of payroll jobs were little changed over the

roads, airports, subways, water pipes, sewers, bus terminals and so on. All big projects and all built in past decades by mostly male workers, many of them unionists.

President Joe Biden isn't thinking like that. His \$2 trillion American Jobs Plan isn't just a "guys' jobs bill," unlike past such legislation. It gives a big boost to women workers and families, too. It's "the single biggest investment in jobs since World War II...and invests not just in roads and bridges for today, but in the infrastructure for tomorrow,' Biden said on April 7.

Occupations that build the "big projects" in the bill are still male-dominated, and Biden's plan specifically calls for higher wages for workers in federally funded construction, using prevailing wage amd through union-friendly project labor agreements. But in job sectors dominated by women workers - in teaching, child care and other social service-oriented occupations – the infrastructure measure also helps them via the investment of billions of dollars.

Biden is proposing raises in pay and benefits for home health care workers, and open doors for them to unionize. His plan points out that caregivers - who are disproportionately women of color - have been underpaid and undervalued for far too long, with wages approximately \$12 per He's calling on Congress to spend \$25 billion to help upgrade child care facilities and increase the supply of child care in areas that need it most. He's also seeking \$100 billion to upgrade the nation's public school infrastructure, specifically pointing out the

need for improved indoor air quality and ventilation.

And for everyone, there's paid family and medical leave and backing unions, by passing the Protect The Right To Organize Act, which would ease unionization for all workers.

There's a gender imbalance in construction, just as there's one in education and social services. Labor Department data shows 12.7 percent of all 7 million U.S. construction workers are women.

PRO Act passage will help level playing field with Amazon

I organized a congressional delegation to Bessemer, Alabama, last month to show solidarity with the Amazon warehouse workers organizing a union and view their working conditions firsthand. Amazon's abusive employment practices have been widely reported, but it wasn't until I talked to the people who clock in for 10

nonth. Payroll jobs and total employment have dropped sharply in Michigan over the past year due to the impact of the pandemic.'

Michigan's quarterly jobless rate for the first quarter of 2021 was 5.3 percent, 2.9 percentage points below the 8.2 percent rate recorded during the fourth quarter of 2020.

Biden seeks 14% \$ hike at Labor Dept.

After four years of constant attacks, the Department of Labor (DOL) is hoping to be in a good position for the next fiscal year after President Biden proposed spending \$14.2 billion on the Department, a 14 percent increase from the agency's current budget.

In the proposal, the Biden Administration proposes using the increased funding on workplace enforcement agencies. They also want to use some of the money to provide support for states in processing unemployment claims.

His plan would spend \$285 million to expand registered apprenticeship programs, \$100 million more than the current level.

Department of Labor agencies that focus on worker protection would get a 17 percent increase (\$304 million). Agencies like the Wage and Hour Division and OSHA have lost about 14 percent of their staff in recent years, which means that both agencies were able to conduct fewer investigations, resulting in more employers getting away with taking advantage of their workers by not paying them overtime or minimum wages. According to the White House, they hope to use the increase in funding to boost efforts around investigating claims of misclassification of workers as independent contractors.

Higher material costs 'wreaking hardships' across construction

Contractors would probably appreciate it if the trades would handle that plywood, copper and plastic pipe and ductwork a little more carefully these days. That's because many construction materials are costing a small fortune.

Input costs for general contractors have soared overall 12.8 percent from April 2020 to February 2021, the Associated General Contractors reported this month. of the week of March 11, the price cool

Lumber, steel prices up, astronomically – it's a tough time to be an estimator

of lumber (all types) rose 188 percent since March 2020. PVC prices are up 240 percent since the onset of the pandemic. Diesel fuel is up 114 percent. Drywall prices are up 20 percent. Flat glass manufacturing was up 4.2 percent in January from the previous year. Hot-rolled steel prices heated up 168 percent from their recent low But that's an overall number. The National Association of Home Builders calculates that current lumber prices are adding at least \$24,000 to the price tag of a typical new single-family home. Ouch.

Maybe, a tipping point?

Editor's note: the workers' vote to organize the Bessemer, Ala. Amazon warehouse lost earlier this month by a 2-1 margin.

The most dramatic change in American capitalism over the last half-century has been the emergence of corporate behemoths like Amazon and the shrinkage of labor unions. The resulting imbalance has spawned near-record inequalities of income and wealth, corruption of democracy by big money and the abandonment of the working class.

Amazon faced a union vote at its warehouse in Bessemer, Ala. If successful, it would have been Amazon's first U.S.-based union in its nearly 27-year history. Conditions in Amazon warehouses would please Kim Jong-un - strict production quotas. 10hour workdays with only two half-hour breaks, unsafe procedures, arbitrary firings "and they track our every move," Jennifer Bates, a worker at Bessemer, told the Senate budget committee last month.

To thwart the union drive, Amazon required Bessemer workers to attend anti-union meetings, warned workers they'd have to pay union dues (wrong - Alabama is a "right-to-work" state that bars mandatory dues), and intimidated and harassed organizers.

Why is Amazon abusing its workers? The company isn't exactly hard-up. It's the most profitable firm in America. Its executive chairman and largest shareholder, Jeff Bezos, is the richest man in the world, holding more wealth than the bottom 39 percent of Americans put together. Amazon is abusing workers because it can.

Fifty years ago, General Motors was the largest employer in America. The typical GM worker earned \$35 an hour in today's dollars and had a major say over working conditions. Today's largest employers are Amazon and Walmart, each paying about \$15 an hour and treating workers like cattle.

The typical GM worker wasn't "worth" more than twice today's Amazon or Walmart worker and didn't have more valuable insights about how work should be organized. The difference is GM workers a half-century ago had a strong union, summoning the collective bargaining power of more than a third of the entire American workforce.

By contrast, today's Amazon and Walmart workers are on their own. And because only 6.4 percent of America's privatesector workers are unionized, there's little collective pressure on Amazon or Walmart to treat their workers any better. Fifty years ago, "Big Labor" had enough political clout to ensure labor laws were enforced and that the government pushed giant firms like GM to sustain the middle class.

Today, organized labor's political clout is minuscule by comparison. The biggest political players are giant corporations like Amazon. And what have they done with their muscle? Encouraged "right-to-work" laws, diluted federal labor protections and kept the National Labor Relations Board understaffed and overburdened.

They've also impelled government to lower their taxes (Amazon paid zero federal taxes in 2018); extorted states to provide them tax breaks as condition for locating facilities there (Amazon is a champion at this game); bullied cities where they're headquartered (Amazon forced Seattle to back down on a plan to tax big corporations to pay for homeless shelters); and wangled trade treaties allowing them to outsource so many jobs that blue-collar workers in America have little choice but to take low-paying, highstress warehouse and delivery gigs.

Oh, and they've neutered antitrust laws, which in an earlier era would have had companies like Amazon in their crosshairs.

This decades-long power shift - the emergence of corporate leviathans and the demise of labor unions - has resulted in a massive upward redistribution of income and wealth. The richest 0.1 percent of Americans now has almost as much wealth as the bottom 90 percent together.

Corporate profits account for a growing share of the total economy and wages a declining share, with multi-billionaire executives and investors like Bezos taking home the lion's share. The power shift can be reversed – but only with stronger labor laws, tougher trade deals and a renewed commitment to antitrust. Bidenomics beats Reaganomics, and I should know – I saw Clintonomics fail (Reich was President Clinton's labor secretary). The Biden Administration and congressional Democrats appear willing. The House has just passed the toughest labor reforms in more than a generation. Biden's new trade representative, Katherine Tai, promises trade deals will protect American workers rather than exporters. And Biden is putting trustbusters in critical positions at the Federal Trade Commission and in the White House. I'd like to think America is at a tipping point similar to where it was some 120 years ago, when the ravages and excesses of the Gilded Age precipitated what became known as the Progressive Era. Then, reformers reversed the course of American capitalism for the next 70 years, making it work for the many rather than the few.

He said the tiles arrived at the lobby site in crates, with Styrofoam in between the layers. The entire set arrived in 24 panelstrips, and were placed on the wall in four rows of tile. The two masons dry-fit the tile on site on the floor of the lobby, then put up the sections in rows from the floor up. Occasionally a piece of mosaic would fall out, but extra tiles were provided.

According to the Detroit Historical Society, the early layout of Detroit as depicted by the mosaic was mapped by Augustus Woodward, who was appointed territorial judge in the Michigan Territory. He arrived in Detroit just days after the devastating 1805

fire in the city. Woodward laid out a new plat for the city, a "hub and mosaic." This is timeless, it spoke" plan modeled after Washington, D.C.'s street layout. The main north-south thoroughfare in his plan bears his name.

"I love it," Morris said of the shows Detroit's street history and it's never going to get outdated. It's really nice to be able to take part in something like

"I love the fact that it's done," Beliger said, referring back to how costly it would be to fix a mistake. "And it really does look nice."

(Continued from Page 1) projects," said an analysis released April 9 by the Associated General Contractors of America, based on government data.

"Today's producer price index report documents just some of challenges contractors are experiencing with fast-rising materials costs, lengthening or uncertain delivery times, and rationing of key inputs," said Ken Simonson, the AGC's chief economist. "These problems threaten to drive up the cost and completion time for many vital projects and potentially set back the recovery in construction employment.'

Both the monthly and yearto-year increases in materials were the highest recorded in the past 35 years, the AGC said. "If a contractor or subcontractor submitted a fixed-price bid in April 2020 based on materials costs at that time but did not buy the materials until February 2021, its cost for the materials would have risen an average of nearly 13 percent," said the AGC "Given that materials often represent half or more of the cost of a contract, such an increase could easily

Home Builders that in November, they broke ground on a 270-unit Class A residential project in November. "Our budget was sent and submitted to our lender in September 2020," the developer said. "We are now dealing with a \$2.5 million lumber bust. We are prepared to handle this challenge, but we will be building the project at zero profit or a loss."

The reason for the spike in construction material pricing is rooted in the pandemic, but it's not the only factor, and there is a lot of diversity in secondary causes:

• "It's no secret that lumber prices in 2021 are at record-breaking levels, largely due to pent-up demand and tightened supply, says an April 1 report by National Business Capital and Services.

"Construction and manufacturing were two of many industries that slowed down during the pandemic. Lumber mills closed in early 2020 throughout initial lockdowns, causing production to take a hit. Softwood lumber supply was cut short, while at the same time, the housing market underwent a boom and home builders were busier than ever. People moved away from cities and into suburban single-family homes. Low interests rates fueled the demand for mortgages and pushed commodity markets to record high levels.' •The extreme winter weather in February in Texas that knocked out power to millions also brought down key PVC manufacturing facilities. Then, a resulting deep-freeze and surge in broken water lines created even more demand for piping fixtures. •Paul Jannke, principal at Forest Economic Advisors, told CNBC that lumber mills were caught off guard when the economy loosened up a few months after the pandemic started. They scrambled to get back to production while having to limit workers in order to comply with social distancing guidelines. Most believed the boom would be short-lived. "Lumber dealers didn't exactly believe demand would stay as strong as it was after last summer," Jannke said, "so they let their inventory drop to record low levels in the fall.' •Raw material prices for steel have increased about 60 percent from the pre-pandemic low. In February the Coalition of American Metal Manufacturers and Users called on the Biden Administration to rescind the U.S. tar-

the National Association of iffs on foreign steel (25 percent) and aluminum (10 percent) imposed by former President Trump, who also imposed tariffs on Canadian timber. "By taking action to terminate the Trump tariffs, your Administration can prevent U.S. manufacturers from shutting down production lines, laying off workers, and potentially even closing their doors,' CAMMU said in a letter to Biden.

"By contrast, the ripple effects of allowing these Section 232 tariffs to remain are substantial. Our member companies report not only record steel prices, but also delivery times stretching 12-16 weeks, causing significant disruptions.'

Analysts say costs in the steel industry are expected to cool over the summer.

• Contractors are incurring other, downhill costs, the AGC says. Delayed deliveries, higher expenditures for personal protective equipment and other sanitation measures, and shortages of employees or subcontractors' workers on jobsites due to coronavirus impacts are all driving up contractors' costs.

Small uptick for Dodge construction momentum

The Dodge Momentum Index for U.S. construction moved 1.7 percent higher in March to 151.4 (2000=100) from the revised February reading of 148.8.

The Momentum Index, issued by Dodge Data & Analytics, is a monthly measure of the first (or initial) report for building nonresidential projects in planning, which have been shown to lead construction spending for nonresidential buildings by a full year.

According to the March data reviewed on April 7, the Index hit its highest level since the summer of 2018 as a result of an increase in institutional projects that entered the planning stage, and which came on the heels of a similar gain for the sector in February.

Overall, the Momentum Index for March 2021 was up 11 percent in total versus March 2020. While health care and lab projects continue to dominate institutional planning, Dodge said March saw a more broad-based selection of project types includ-

TODAY IT'S A GHOST TOWN, an unincorporated village located on a spit of land that juts into Lake Superior's Keweenaw Peninsula. A century ago, however, Henry Ford turned the sleepy little sawmill community of Pequaming into a beehive of activity, building works that produced wooden components for his vehicles. When it comes to economic booms and busts among the states, Michigan is nigh unbeatable.

Our state has had some crazy ups and downs - over the decades we have had them in a diversified range of industries: from the extraction of raw materials like copper, iron ore, and salt, to the production/manufacture of stoves, cigars, war materiel, furniture, water craft, and motor vehicles, among many others.

But perhaps the granddaddy of all the economic boom and bust cycles involved the state's first widespread, viable economic resource recognized since the arrival of Europeans: the lumber industry. OK, maybe beaver pelt harvesting is the better answer, but we're going to skip right past that fashion trend.

No, in the latter part of the 19th Century, timber was king in Michigan, and the deforestation of our state made an economic fortune for many a "lumber baron." Much of the lumber had been taken by the turn of the last century, but there were still some first- and second-growth forests that were untapped in Michigan a century ago – the lumber industry was diminished, but not out.

Which brings us to Pequaming. Pequaming?

"One of the largest ghost towns in the Upper Peninsula with buildings still standing is Pequaming," says Michigan Ghost Towns of the Upper Peninsula. "Located about eight miles north of L'Anse, the huge smokestacks and water towers are visible from the L'Anse wafirst large-scale lumbering and milling operation in the Lake Superior region – boasting over a 20-year period an annual production average of 30 million feet of lumber. Charles Hebard, an immigrant Englishman and a successful timber speculator in the East, founded the sawmill and community in 1878. He located it on the Pequaming Peninsula. He acquired the site specifically for its deep, protected harbor and its access to timber."

Hebard created a classic "company town," growing Pequaming from a population of 174 in 1880 to a peak of 800 in 1897. Michigan History said that an "1883 observer reported that Hebard had developed a magnificent business. By good taste and proper regard for comfort and pleasure, they have built up a tasty little town.""

Hebard provided an attractive town with many services. He laid out his village along the contours of the land, featuring amenities such as parks, bathhouses, a post office, churches, schools, a hotel, a community hall and a clubhouse.

'Over a short time," writes John Robinson in *Historic* Michigan: The Ghost Town of Pequaming, "Pequaming soon had not only the lumber mill, but a band and orchestra, bath houses, boarding houses, churches, general store, hotel, 100+ houses, ice rink, livery stable, lumber offices, parks, post office, saloon, and schools."

His efforts attracted a stable workforce. Hebard owned the tidy homes that were constructed, but he charged reasonable rents.

World War I Eagle Boat. Michigan History said Ford's purchase included the site's doubleband sawmill, "the lath and shingle mills, 40,000 acres of land, 30 million feet of manufactured lumber sitting on Pequaming's docks, three million feet of logs ready to be cut into lumber, the town of Pequaming, its railroad, and towing and water equipment. With the purchase, Ford's lands in L'Anse Twp. totaled 175,000 acres, which by 1933 saw Ford Motor Co. paying about 75 percent of the township's property taxes."

Most of the mill's lumber was loaded on Ford boats for shipment to plants in Dearborn; Edgewater, New Jersey, and Chester, Penn. Much of the wood was used for crating lumber, some went overseas. The better grades of lumber went south by train to Iron Mountain for later use in the automotive manufacturing plants. A significant portion of Ford's Model T - framework, wheels and flooboard - was made of wood.

But the boom times never last. When the Great Depression started to affect car sales in 1930, Ford was reportedly distressed that Pequaming had been idled. Apparently it was his favorite plant and community in the U.P., and he instead shut down his works in Iron Mountain and L'Anse. But by 1933, Pequaming's works were shut down for a while, too.

Ford, who kept a home in the community, tried to help idled Pequaming residents by building a cooperative farm. He

hours on their feet get only two 30-minute breaks a day. Schedules are changed overnight while employees sleep, leading to late arrivals and "time off task," which can lead to firing. "You get treated like a number. You don't get treated like a person. They work you like a robot," warehouse worker and union supporter Darryl Richardson told The Guardian.

Amazon has a long history of prioritizing production demands over safety and forcing workers to endure grueling conditions or risk losing their jobs. The company, which had 14,000 serious injuries in 2019 alone, has repeatedly tried to downplay injury rates at its warehouses - and sometimes even failed to report them at all. During the COVID-19 pandemic, Amazon required employees to work without proper PPE, did not give them time to wash hands and sanitize equipment, and sent warehouse workers with fevers home without pay. Amazon has repeatedly and unjustly fired employees who called out the company's coronavirus response. Delivery drivers have even reported urinating in bottles, speeding and running stop lights, and skipping lunch breaks to meet strict demands and avoid termination.

Amazon workers have filed numerous cases against the company for racial and disability discrimination and sexual harassment in violation of state and federal laws. Some have faced discrimination based on religious beliefs and wrongful termination over medical issues and injuries suffered on the job.

Is this the American workplace we want? Is this the future of work we want for our kids? Of course not.

In taking on one of the world's most powerful corporations, 5,800 mostly Black and female employees, along with organizers from the Retail, Wholesale and Department Store Union, have already inspired a new optimism and determination among hourly-wage workers across the country, and may have changed the course of this nation's economic history. Despite coming up short, they showed that workers can indeed fight back – not just for higher wages and safe working conditions, but for justice and dignity, as well.

Of course, the deck was stacked against them from the beginning. Amazon employs over a million people worldwide, and it has a long history of union-busting tactics. The company has gone to great lengths over the past 25 years to prevent workers from achieving safer working conditions, receiving better pay, and having a voice in the company. Amazon has fired warehouse workers who advocated for sick pay for part-time workers and safer working conditions during COVID, as well as workers who attempted to unionize, signaling to other employees that they will be retaliated against if they also support unions.

In Bessemer, I learned that Amazon deployed its anti-union tactics with the same brutal precision they use to control their workplaces. They coordinated a campaign so invasive that workers in Bessemer told me posters were even hung in bathroom stalls, urging them to vote against the union. They said Amazon pulled them into mandatory anti-union harangues and photographed the IDs of workers who pushed back. Employees received multiple text messages from Amazon every day, saying they should not abandon a "winning team."

According to workers I spoke with, Amazon's messaging was rife with misinformation, including claims that paying union dues would make workers unable to afford necessities like school supplies for their children. Amazon even colluded with local officials to change the timing of traffic signals near the warehouse to prevent organizers from speaking to workers at red lights. And they hired modern-day Pinkertons - in the form of off-duty, but still uniformed, Bessemen police officers - to harass organizers in the name of "security."

We can best honor these workers' fight for economic justice and personal dignity in a 21st century economy by updating labor laws that were written for the economy of the 1930s. The Protecting the Right to Organize (PRO) Act, which I co-sponsored, has passed the House and is now before the Senate. It will help level a playing field that is currently tilted steeply in favor of rich, anti-union employers like Amazon.

Reduced traffic hasn't lowered crash zone fatals

Women, families would benefit from infrastructure opportunities

928,000 U.S. child care workers are women. Women are 90.3 percent of 571,000 home health care aides, 81.5 percent of 1.28 million personal care aides and 77.5 percent of 4.87 million pre-K through 12th grade teachers. Teachers unions say three-fourths of the teachers are women. DOL doesn't publish separate data for union density for teachers.

The administration says Part II of its infrastructure plan, yet to be rolled out, will be the "family" part that really addresses the concerns of women. Many progressives call for a massive program to provide children from the age of six months up to the age of 18 with a variety of services and programs that allow both mothers and fathers to work full time

Biden helps all genders, a point his new Labor Secretary, Marty Walsh, made in his first White House press briefing on April 2. Walsh, a member of Laborers Local 223 in Boston and the city's mayor before taking over DOL, is taking that message on the road. He's one of five Cabinet members Biden told to get out in public and talk about both the jobs plan and the prior \$1.9 trillion American Rescue law.

"Barriers to the labor force participation for women continue to be a problem that has been exposed and exasperated during this pandemic. We must continue to address the fact that working people and communities already suffering the most from inequality were hit the hardest during the COVID illness and job loss,' Walsh said. "That's why the American Jobs Plan...is so vital to our future. It tackles each of these issues head on and with bold action. The plan offers a necessary path forward towards sustainable economic growth that is robust, competitive, and inclusive."

That path is at least \$621 billion for the traditional infrastructure, with the PLAs. It's also \$100 billion to retrofit schools and \$400 billion to rebuild and reopen child care facilities.

"As a former mayor, I know a11 about infrastructure

terfront where the remains of the once prosperous industrial town lies at the tip of a tree-covered peninsula jutting out into the Keweenaw Bay."

Not too much has changed since that book was published in 1973. Today, Pequaming is an unincorporated community in Baraga County, populated by a handful of residents.

A century ago, however, the place was buzzing – with buzz saws. Henry Ford's ravenous need for wood to use in his car parts put Pequaming and other U.P. communities on the map with some major league construction and development. But even long before Henry came to town, the town was thriving.

"In 1919," says *The Henry* Ford, "Henry Ford began buying vast amounts of forestland in Michigan's Upper Peninsula. These prime hardwood forests supplied the lumber used to create vehicle bodies and parts. Other products such as railroad ties, shipping containers and chemical byproducts were also made - all to support Ford's automobile operations and his goal of manufacturing self-sufficiency."

Much of Ford's Upper Peninsula wood gathering and processing operations were in the timber-rich and more populated Iron Mountain/Kingsford area, down on the Wisconsin border. But 90 miles north, Ford's agents also had their eye on other tracts of forest, which had ongoing lumbering operations.

"Pequaming," says Michigan History magazine, "was the

The sawmill operations were still viable and successful by 1923, when Hebard's sons negotiated the sale of the property to the Ford Motor Co. "In 1923, Henry Ford bought the mill and the town itself with everything intact: railroad, all the mills, land, buildings, cut lumber and more," Robinson wrote. "His operation was obviously to benefit his automobile manufacturing, and it did. The price: \$2.85 million.

Ironically, Pequaming's resident workforce began to live under the thumb of a second paternalistic employer. Ford raised workers' wages to \$5 a day as he did in Dearborn, and he had the town painted, re-roofed, and generally upgraded. He closed the sawmill works for a while to overhaul and modernize that, too.

But Ford social engineering tendencies also came into play – he ordered residents' fences to come down, and had their farm animals relocated for hygienic reasons. He told them they could now afford to buy their own milk, eggs and meat. Every worker received new medical examinations for which they were charged \$5, shift work and time clocks were introduced and children were no longer allowed to work in the lumberyard. No smoking was permitted on the clock, nor was sitting down allowed, and workers were assessed a laundry fee.

Ford built a new powerhouse on the mill's west side, with power provided by a 1,000 horsepower engine retrieved from a

opened a vocational school, as well as four one-room elementary and intermediate schools. He built a high school in Pequaming in 1937, so the kids didn't have to travel to L'Anse's high school. But only one class of freshmen made it through the school, and declining demand led to the Ford Motor Co. discontinuing of operations at Pequaming on Oct. 9, 1942.

Remnants – Ghost Towns of the U.P. said about 400 residents lived in Pequming when the mills closed. By 1950 only about three families remained, with most of the buildings dismantled or boarded up.

"The Ford Co. sold Pequaming in 1952 to a group of investors who planned to make a recreation and resort area," Ghost Towns of the U.P. said. "However, the plans fell through, as did many other ideas for redevelopment through the years. Some of the original 1890s homes that were falling apart were torn down. In 1989 The **Bungalow (Ford's Pequaming** home) was purchased and restored and in 1993 it was listed on the National Register of Historic Places.

"For a while it operated as a bed and breakfast and later, and to this day, for rent. The powerhouse and Ford water tank remain. There are still some family homes and rentals in the community as well as commercial fishing operations. Pequaming is still frequented as a ghost town and by former inhabitants for reunions."

says LIUNA General Secretary-Treasurer and LHSFNA Labor Co-Chairman Armand E. Sabitoni. "As much as possible, we have to take steps to separate workers from passing motorists with barriers and other positive protection."

(The Michigan Department of Transportation (MDOT) in January reported 1,032 people died on Michigan's roadways in 2020, up 47 from 2019. The increase in crashes and fatalities comes at a time when the department was reporting a 20-percent decrease in overall statewide traffic volumes due to the ongoing COVID-19 pandemic).

According to Becky Allmeroth, chief safety and operations officer for the Missouri DOT, the number of vehicles crashing into truck-mounted attenuators doubled from 21 to 41 year over year. Attenuators are attached to the back of trucks or other construction vehicles in highway work zones as a way to provide a barrier between workers and motorists. Despite this, workers are still sometimes injured or killed if they are in the vehicle at the time of impact or if the intruding vehicle is heavy enough (e.g., a tractor trailer) to move the attenuated vehicle.

A DOT spokesperson from Ohio shared similar information, citing that fatal crashes in work zones were up in 2020 from 2019, despite fewer drivers on the road. Virginia and other states across the country reported the same problem.

Speeding and distracted driving are to blame for increased crashes. Part of the reason for the increase in work zone incidents could be that many state DOTs have used lighter traffic during peak hours to step up maintenance, repair and construction efforts. However, in almost every case, driver speed is being cited as the primary cause behind the increase in crashes, injuries and deaths.

Freeways and interstates that used to be slowed down by rushhour traffic are now wide open. In Chicago, the average speed on Interstate 290 went from 24 mph to 62 mph. Because there are fewer cars on the road, the drivers who are left can go faster – in many cases, much faster. "With less cars on the road, we would expect that crashes and citations would be down. And what we're seeing is an increase in dangerous speeding and dangerous driving," said Jeff Marootian, director of the D.C. Department of Transportation.

Speed is a major factor in the outcome when workers and pedestrians are struck by vehicles. When vehicles are moving faster, the chances of escaping a work zone intrusion alive go down dramatically. At 23 miles per hour, 90 percent of pedestrians survive the impact with a vehicle. At 42 mph, it's only 50 percent. At 58 mph, only 10 percent of people survive.

Walsh, as might be expected, said he was "thrilled" by the jobs plan, emphasizing its use of workers, their skills and their opportunities while strengthening the right to organize.

The jobs plan's "investments will create and open up access to good manufacturing and construction jobs. There's also a major investment in our caring professionals, in an industry where one in six workers – who are disproportionately women of color - live in poverty. We've seen how much our families depend on childcare and seniors care over the last year. Those skilled, compassionate workers need and deserve a better deal," he declared.



Christman-Brinker provided construction management services on the project, and Harley Ellis Devereaux was the building's designer. The sole tenant of the building's third floor, Warner's space features a lounge overlooking Woodward Avenue, downtown skyline views, a 40-seat cafe and a media center. Oliver/Hatcher acted as general contractor for Warner's office build-out. There is space for future tenants available in the

building.

Labor prods the PRO Act: 'No better path to the middle class than a union job with the security it provides'

dent Lonnie R. Stephenson said the PRO Act is the most extensive expansion of workplace democracy since the 1935 passage of the Wagner Act, which created the National Labor Relations Board and granted private sector workers the right to form and join unions

'Where unions are strong, wages are higher for typical workers- union and nonunion alike," Stephenson said in a letter sent to all members of the House before the vote. "Family-sustaining middle-class jobs are the route to economic security and there is no better path to the middle class than a union job with the security it provides.'

A similar bill died last year when the Republican Senate was controlled by then-Majority Leader Mitch McConnell and the Trump White House vehemently opposed it.

Despite the Democrats slim 51-50 lead in the Senate (with Vice President Kamala Harris breaking any tie) the bill faces an uncertain future. The bill will need to find 60 votes to break a filibuster, or the Democrats will have to break the filibuster itself.

As if signaling the importance of the bill to working people, opposition is fierce. The National Retail Federation called it the "worst bill in Congress." The Chamber of Commerce called the PRO Act "dangerous" and said it would "destabilize" the economy.

ventions, lawyers and bankers have invented companies for the purpose of skinning working people."

Fast food restaurants have particularly taken advantage of a legal fiction that a franchise is somehow separate, as if say, McDonalds didn't set all the rules, making it impossible for McDonalds workers to organize for better wages and benefits. "A hundred years ago, factory work and mining jobs were no different from modern day low wage work. They became middle class jobs when they became union jobs, and the PRO Act ends the lie that some jobs, and some people, don't deserve dignity,' Keyser said.

The PRO Act also revises the definitions of employee, supervisor, and employer to reflect the ways companies have purposefully blurred lines to block them from joining unions.

One of the last and most powerful forms of leverage a worker has is withholding their labor, but that right has been increasingly constrained over the last 80 years. The PRO Act would deregulate workers' use of strikes, secondary strikes and boycotts. Unions will be able to make direct appeals to a company's customers, support other unions in their strikes and target a company's suppliers and vendors. And a company would be forbidden from permanently replacing striking workers or preemptively locking workers out.

Holding employers accountable for violating workers' rights. Second, the bill holds employers accountable for violating the rights of working people.

yet been "promoted" to independent contractor or been made a "frontline leader."

First, companies have to make all payments for union busting companies and lawyers public and the dreaded captive audience meetings would be banned outright. But it goes much further

"The decision to join a union is a constitutional right and really none of the company's concern at all. They should have no more involvement in a representation vote than they should be allowed to tell their workers how to vote for president," Stephenson said.

If the bill passes, companies have to provide organizers contact lists for the proposed bargaining unit and allow workers to use company email for union and other organizing activities.

Businesses would have no say anymore in who is included in a bargaining unit, what the unit will be and where and how the election is conducted. Votes could be held by certified mail, virtually, at a neutral site or even by email.

And unlike today, where corporations can delay and delay a vote, election hearings would be held no more than eight days after filing authorization cards with the NLRB and the election 20 days later, at most.

Under current law, if an organizing drive fails because of employer misconduct, the only remedy is to re-run the election, imposing no cost on the em-

'Only a bunch of CEOs could look around this country and see stability," said IBEW Political and Legislative department Director Austin Keyser. "The only reliable thing about this economy is that wages for working people are going to be the same next year as they are this vear.

There are decades of data drawing a clear line between union busting and going bust. Between 1979 to 2019, as relentless attacks on workers' rights cut union membership by more than half, average incomes for the bottom 90 percent of households increased just 1.1 percent.

Over the same period, average incomes for the wealthiest 1 percent increased more than 184 percent.

During the first seven months of the pandemic alone while workers suffered recordhigh unemployment and thousands who could work were left unsafe, infected and sadly, killed – America's 614 billionaires grew their wealth by a combined \$931 billion. "The PRO Act is a game changer" Stephenson said. "If you really want to make America work for working people you have to get the up off their knees; passing the PRO Act is absolutely essential to doing that."

Making the right to organize a reality again.

The bill has three broad areas of reform.

First, it gives workers back the tools they need to exercise their right to organize and strips away many of the tools businesses use to deny workers' rights.

First to go is the pervasive misclassification of workers, where an employer uses lawyer words like "onboarding" and "independent contractor" in place of simpler ones like "hire" and "employee" and magically gets out of paying minimum wages, workers' compensation and Social Security.

Since private sector unions were legalized in 1935, whole business models have popped up with the sole purpose of getting around labor laws" Stephenson said. "Instead of entrepreneurs starting companies to sell their in-

There are currently no penalties for employers who illegally fire or retaliate against workers attempting to form a union. The most any working man or woman can get is back pay, minus whatever they earned in whatever job they landed before judgment in their favor. The PRO Act establishes compensatory damages for workers and punitive damages and fines up to \$50,000 for employers who violate the NLRA and \$100,000 if they have previous violations in the last five years.

Companies would also be liable for front pay and consequential damages, none of which will be reduced if a worker gets a job in the meantime or refuses to find other work.

The process of holding a company to account is also accelerated, giving the NLRB a power most other regulatory agencies in the federal government already have: the right to enforce its own rulings and issue injunctions to stop bad behavior in its tracks.

Finally, if the NLRB's General Counsel fails to prosecute a case – as happened often during the previous administration when management-side attorney Peter Robb filled that role – that worker is out of luck. If the PRO Act is signed into law, every worker would have the opportunity to get their day in court no matter what the NLRB says. If successful, workers could not only receive back pay and punitive damages, they could also recover attorney fees.

Bringing democracy back to the American worker.

Lastly, some of the most dramatic changes in the bill would reset the rules for representation elections.

The National Labor Relations Act says the policy of the United States is to encourage unionization, but the rules for elections have made it nearly impossible, even for the small section of the workforce that hasn't

ployer.

The PRO Act also allows the NLRB to set aside the result and create the bargaining unit if the organizing committee can show they have a majority of signed authorization cards.

As many a newly formed union has learned, a successful election is no guarantee of a contract. Ask the Comcast technicians in Middleboro, Mass., Local 2322 who had to fight for seven years for their first contract

That would all end with the passage of the PRO Act.

First contract negotiations would have to start within 10 days of a successful vote. If no deal is reached within 90 days, either side can request federal mediation.

Within 30 days of a declaration of impasse or a union request for mediation, a panel of federal arbitrators (one chosen by the union, one by management and one by mutual agreement) would be able to impose the terms of an agreement on both parties.

Under current law, it's the employer who gets to impose their last offer.

"This bill doesn't force a single person to join a union if they don't want to. It doesn't put a single worker in control of a company's business decisions. The line between workers and management is not moved a single inch," Stephenson said.

"The U.S. with this bill as law would simply be returning to the deal that built the most successful economy in human history," Stephenson said. "We encourage the U.S. Senate to do whatever it takes to pass the PRO Act and return balance to our nation's labor laws. Workers across this country are watching very closely to see who their champions are in Congress."

Prior to the start of work on the project the employee must provide confirmation of negative results to a MUST Substance Abuse Test or equivalent test within the last 30 days.

IRS regulations require that every use of the Benny Card be substantiated or validated as an eligible covered expense under the Plan. This validation is required by the IRS, the Fund cannot make exceptions. It is the member's responsibility to ensure all requested documentation be returned to the Fund office in a timely manner.



Deep in the forest, streams are rushing and tips of green are emerging from gaps between fallen leaves. Blooming time for northern Michigan's three-petaled wild orchid, the trillium, is just around the corner. Colorful songbirds are making the long trip back to their summer homes with a season of abundance before them.

With this natural beauty in store, now is the time to start planning a getaway to the forest. Make lifetime memories while hunting for mushrooms, casting a line into a trout stream or catching sight of a free-roaming elk.

Want to get out there? Check out our online state forest tour (www.michigan.gov/dnr) and click on "About Us" and the "Maps and Data" to inspire your trip. State forests can be found in the Upper Peninsula and northern Lower Peninsula, although there are plenty of forested areas to see in parks and recreation areas across the state as well.

The wild character of forests comes with seclusion, so get a hard copy map or download your route before you arrive as cell service can be spotty. Once there, it's time to unplug - the only reason you'll need to take out your phone is to use the camera to capture memories.

State forest pathways, part of the state's trails system, and state forest roads open to ORVs and snowmobiles are two ways to navigate state forests. Some forest roads are maintained seasonally, so do your research in advance before heading out during the winter. Road maps are updated April 1 each year.

Only a small fraction of state forest land is harvested annually, but if you come across an active timber job or planting operation, there are a few things you should know for safety.

First, stay on the trail. Logging companies must keep trails passable and post signage about upcoming activities. Let on-theground staff know you're passing through if you'll be close to the action, and don't approach logging or cultivation equipment.

'A machinery operator may not be able to see or hear you

Department of Natural Resources ies of water and state pathways camp, hike, fish and ride on horse-Forest Resources Division Acting Assistant Chief Dave Lemmien. "Splinters and wood debris from cutting can sometimes fly through the air and could accidentally hit a passerby if they get too close."

Timber harvesters can accommodate equestrian groups if notified in advance. Ride organizers should work with the Michigan Trail Riders Association and the local forest resources unit office in the area you plan to ride.

Ready to call it a day? A state forest campground is where a day hike turns into an overnight adventure, complete with starry skies, a crackling campfire and a true wilderness experience.

"Rustic" is the best way to describe these unique campgrounds. Many of these secluded sites are hike-in or paddle-in only and are available on a first-come, first-served basis. Facilities available include basic vault toilets, fire rings and picnic tables. Drinking water comes from a hand pump, a novelty that often delights young adventurers and many adults, too.

Here are a few state forest destinations to visit, suggested by DNR staff:

Pigeon River Country State Forest. A must-see is the famed Pigeon River Country State Forest - "the Big Wild," which at 109,000 acres is the largest block of undeveloped land in the northern Lower Peninsula. This forest land is home to Michigan's elk herd and offers opportunities to back. Flowing trout streams, cool sinkhole lakes and a network of trails offer scenic views.

For a challenging adventure in this storied landscape, plan a hike on the High Country Pathway, a rugged, weeklong backpacking trail. Shorter trails are perfect for day hikes and picnics. An interpretive center is a great place to learn about the area's history and stage your hike.

to visit two scenic overlooks perched over the Jordan River Valley in Antrim County. Landslide Hill Scenic Overlook and Dead Man's Hill Overlook provide spectacular views of the forest and river floodplain below, especially when autumn colors begin to turn.

'The Jordan River Pathway is a great area to visit with many points of interest along the trail," said DNR forest management specialist Jason Stephens. "Maybe it's my local bias, but this area is really special."

The Dead Man's Hill Overlook, whose name recalls a tragic lumbering accident a century ago, is the trailhead for three- and 18mile hiking loops on the Jordan River Pathway. The 18-mile loop, part of the 4,600-mile North Country National Scenic Trail, is popular among backpackers who camp at the Pinney Bridge State Forest Campground.

In addition to excellent hiking in the valley, the Jordan River is a popular water trail for intermediate paddlers. If you don't own a kayak or canoe, local outfitters can help plan a trip.

Mouth of the Two-Hearted **River.** The mighty Two-Hearted River meets Lake Superior's icy waters along the coastline in Luce County. In this setting, perfect for exploration, a walking bridge leads visitors to a rocky beach strewn with a rainbow of stones. Jordan River Valley. It's Rockhounds can attempt to get worth a drive off the beaten path lucky and find an agate as they

catch a lakeside sunset before retiring next to the fire at a 39-campsite state forest campground. A nearby boat launch is an access point on the Lake Superior East Water Trail, and a short trip inland takes visitors to the spectacular Upper and Lower Tahquamenon Falls.

Sands Lake Quiet Area. In contrast to the nearby bustle of Traverse City, the Sand Lakes Quiet Area in Grand Traverse County is a serene forest designated in 1973 exclusively for nonmotorized uses including hiking, mountain biking, horseback riding, fishing and birdwatching.

Five small, distinctive "marl lakes" can be found along hiking trails that ramble over 2,800 acres of rolling hills. These glacial lakes have an ethereal teal hue due to calcium carbonate content in the water. A few of the lakes are stocked with trout. Trails and lakes can be accessed starting at the Guernsey Lake State Forest Campground.

Big Eric's Bridge State Forest Campground. In the Upper Peninsula, Big Eric's Bridge State Forest Campground, along the banks of the Huron River in Baraga County, is a secluded destination. Visitors will enjoy hiking, camping, fishing, ORV riding and viewing nearby waterfalls, including Big Eric's Falls, flowing over the rocky riverbed.

"It's just a really peaceful, beautiful place," said DNR training coordinator Jan Hebekeuser.

With a campground, road, bridge and falls named after him, who was Big Eric? Eric Erickson, a well-known local figure of an imposing stature, was Henry Ford's lumber camp foreman more than a century ago.

Before you head out, pack the following information with you.

In the outdoors, Leave No Trace principles are the gold standard for responsible recreation, encouraging people to leave the places they love wild and in better shape than they found them.

That means packing out trash of all kinds and leaving wildflowers alone. Occasionally, you may run into something worse than a few candy wrappers - a dump site. In addition to being unsightly, piles of trash in the woods are a danger to people and wildlife. If you encounter one, report it to the Report All Poaching hotline at 1-800-292-7800.
