### Little benefit to halt of jobless money

Extended federal unemployment benefits have been blamed for making it difficult for employers to hire workers.

But *Politico* reported on Aug. 20 that only eight of the 26 states that ended federal jobless benefits early saw a statistically significant drop in unemployment in July, according to Bureau of Labor Statistics data.

## The holiday's origin: killing of 30 strikers launches the day in 1894

Scheduled every year on the first Monday in September, the Labor Day holiday in the United States wasn't always a fixture on the calendar like Christmas Day or New Year's Day.

It became a three-day weekend because an American president wanted to appease American workers, who were upset that strikers were killed... for striking.

"In 1894 President Grover Cleveland created Labor Day by signing federal legislation declaring the first Monday in September a national holiday," wrote Mike Smith for *Michigan History* magazine. "Yet the origins of Labor Day predate his action by many years. As the number of trade unions grew in America during the mid- to late-19th century, their members began to hold periodic parades, rallies, picnics and other events to demonstrate the talents and accomplishments of American workers.

"For more than 100 years, Michiganders have participated in Labor Day parades and other celebrations. One of the first Michigan labor parades took place on July 4, 1865, when more than 4,000 union members – on their way to a picnic – marched down Detroit's Woodward Avenue, carrying banners, tools and other symbols of their trades. By the turn of the 20th Century, similar demonstrations were held in urban centers across the state."

New York and Chicago have been among the epicenters of

## To rebuild our nation, make unions great again

Imagine a world where workers have real power. In this world, workers are paid a living wage,

are protected by a strong union, and wield enough political clout to ensure Congress passes pro-worker laws.

Corporations can't treat them like robots and abandon communities to find cheaper labor elsewhere. It is a world of low

inequality, where workers have a bigger share of the fruits of their labor.

This world is America in the 1950s.

This world was far from perfect. Black people and women were still second-class citizens. Windows of opportunity were still small or shuttered. That's why it's not enough to just go back in time. We must build upon it and expand it.

For the past 40 years, this world has been dismantled. The

voice of workers has been steadily drowned out in both the workplace and on the national political stage by the voice of big corporations.

This massive power shift wasn't the result of "free market forces" but of political choices. Now, it's time to make the political choice to strengthen the voice of all workers.

Start with one of the biggest sources of worker power: unions. Every worker in America has a legal right to join a union free from

interference from their employer – a hard-fought victory that workers shed blood to secure. But corporate America has been busting unions to prevent workers from organizing.

In Bessemer, Alabama, for instance, Amazon used every trick in the anti-union playbook to prevent its predominantly Black workforce from forming the first Amazon union.

Most union-busting tactics are illegal, but the punishment is

## New Branch Co. Jail yields one happy sheriff

COLDWATER – Branch County's current jail facilities have been operating out of a converted nursing home since the 1990s. According to Sheriff John Pollack, that should tell you just about everything you need to know about why a new detention facility is needed.

And a new one is on the way: Clark Construction, its subcontractors, and building trades workers are close to wrapping up construction of a new 56,000 square-foot jail/office facility – a \$22 million structure that was actually designed and constructed as a modern jail with related office, meeting, medical, and recreational space that's expected to be a vast improvement over the existing facilities located about 500 feet away.

"Security is our biggest concern in our current set up," said Pollack. "There are no locks on some doors, there are no bathrooms in the cells, there are so many inefficiencies in technology, manpower and infrastructure.

deserve. We must seize this opportunity. It is time to get the job done so Laborers members, who are ready, willing, and able, can get to work now building America and securing our future," he added.

Bricklayers President Tim Driscoll agreed, then quickly reminded lawmakers to pass the second and much larger reconciliation bill, too.

**How the state fares with new federal funds: 'a win for Michigan'**

LANSING – Michigan's share of the \$1 trillion infrastructure package that was adopted by the U.S. Senate, awaiting approval by the U.S. House, will be a dandy smorgasbord of jobs for the building trades.

The bill includes \$110 billion for roads and bridges across the nation, as well as \$66 billion in new spending on the U.S. rail network. For Michigan, the state Department of Transportation estimates that the bill would fetch a total of \$7.26 billion from those funds – that's \$1.7 billion more coming to Michigan over the next five years than over the past five.

Estimates over the past few years have called for additional spending in Michigan of an additional \$2 billion a year in order to do an adequate job of fixing the damn roads. This money wouldn't be a permanent funding fix – but it would a great help over the next half-decade.

The package also includes new programs that would bring to Michigan for the first time an estimated \$171 million to fund the reduction of carbon via transportation emissions, and another new \$194 million to

**Many anchors weighing down U.S. construction**

Total U.S. construction starts fell 3 percent in July to a seasonally adjusted annual rate of \$854.8 billion, according to an Aug. 18 report by Dodge Data & Analytics. There were few bright spots during the month, with all three sectors (residential, non-residential building and nonbuildings) moving lower.

"Construction material prices continue their march higher and are weighing heavily on construction starts," said Richard Branch, chief economist for Dodge Data & Analytics. "Lumber and copper prices have fallen in recent weeks; however, steel, plastic and other construction-related products are continuing their ascent. These increases will continue to impact construction starts over the coming months, somewhat muting the impact of stronger economic activity."

"A further risk to the sector is the rising number of COVID-19 cases due to the Delta variant. On the upside, projects entering the planning stage remain at levels not seen in several years and forward progress on an infrastructure program and the federal budget provides hope that brighter days are ahead."

For the 12 months ending July 2021, nonresidential building starts were 8 percent lower than the 12 months ending July 2020. During the same period, Dodge said total residential starts were 23 percent higher.

### When unions died a little

Reagan's firing of striking air traffic controllers was the first huge offensive in corporate America's war on everyone else.

Forty years ago, on Aug. 5, 1981, President Ronald Reagan fired 11,345 striking air traffic controllers and barred them from ever working again for the federal government. By October of that year, the Professional Air Traffic Controllers Organization, or PATCO, the union that had called the strike, had been decertified and lay in ruins. The careers of most of the individual strikers were similarly dead; While Bill Clinton lifted Reagan's ban on strikers in 1993, fewer than 10 percent were ever rehired by the Federal Aviation Administration.

PATCO was dominated by Vietnam War-era veterans who'd learned air traffic control in the military and were one of a vanishingly small number of unions to endorse Reagan in 1980, thereby scoring one of the greatest own goals in political history. It's easy to imagine strikers expressing the same sentiments as a Trump voter who famously lamented, "I thought he was going to do good things. He's not hurting the people he needs to be hurting."

The PATCO saga began in February 1981, when negotiations began between the union and the FAA on a new contract. PATCO proposed changes including a 32-hour workweek and a big increase in pay. The FAA came back with counterproposals the union deemed insufficient, and on Aug. 3, with bargaining at an impasse, most of the air traffic controllers walked out.

It was unquestionably illegal for PATCO, as a union of government workers, to strike. However, which laws are enforced is always and everywhere a political decision: Wall Street firms broke countless laws in the run-up to the 2008 financial crisis, yet almost no executives suffered any consequences. Reagan & Co. wanted to send a message that mere workers could expect no such forbearance. Just two days after the strike began, the air traffic controllers were gone.

The significance of Reagan's actions is rarely discussed today in the mainstream, and for understandable reasons: It was the first huge offensive in a war that corporate America has been waging on this country's middle class ever since. As Warren Buffett – current estimated net worth \$101 billion – has said, "There's class warfare, all right, but it's my class, the rich class, that's making war, and we're winning."

The stunning victory of the wealthy over everyone else can be measured in several straightforward ways. During a speech last May at a community college in Cleveland, Joe Biden explained one of them: "From 1948 after the war to 1979, productivity in America grew by 100 percent. We made more things with productivity. You know what the workers' pay grew? By 100 percent. Since 1979, all of that changed. Productivity has grown four times faster than pay has grown. The basic bargain in this country has been broken."

Productivity is a simple but extremely important economic concept. Over time, as technology advances and society learns how to use it, each worker can produce more. One person with a bulldozer can move a lot more dirt than one person with a shovel. One person with the latest version of Microsoft Excel can do a lot more math than one person with Napier's bones.

The meaning of Biden's statistics is that for decades after World War II, America got much richer overall, and average worker pay went up at the same rate. Then the link between productivity and pay was severed: The U.S. overall continued to get much richer, but most of the increased wealth went to the top, not to normal people. Corporate CEOs, partners at corporate law firms, orthopedic surgeons – they make three, five, 10 times what they did in 1981. Nurses, firefighters, janitors, almost anyone without a college degree – their pay has barely budged.

The situation is especially egregious at the bottom of the pay scale. Until 1968, Congress increased the federal minimum wage in line with productivity. That year, it reached its highest level: Adjusted for inflation, it was the equivalent of \$12 per hour today. It has since fallen to \$7.25. Yet the whole story is far worse. Even as low-wage workers have battled fruitlessly to get the federal minimum wage raised to \$15, no one realizes that if it had continued increasing along with productivity since 1968, it would now be over \$24 per hour. At that level, a couple working full-time minimum wage jobs would take home \$96,000 a year. This seems incredible, yet there are no economic reasons it couldn't happen; we have simply made a political decision that it should not.

Another way to understand this is to look at the other end of American society. In 1995, Bill Gates had a net worth of \$10 billion, worth about \$18 billion in today's dollars. That was enough to make him the richest person in America. If that were all Gates had today, there would be 25 or so billionaires ahead of him in line. Jeff Bezos, currently in first place, possesses 10 times Gates's 1995 net worth.

Then there's the number of significant strikes in the U.S. each year. A confident, powerful labor movement will generate large numbers of strikes; one terrorized and cowed into submission will not. According to the Labor Department, there were generally 200-400 large-scale strikes each year from 1947 to 1979. There were 187 in 1980. Then after the PATCO firing, the numbers fell off a cliff. In 1988, the last full year of Reagan's second term, there were just 40 strikes. By 2017, there were seven.

The direct causal relationship between the firing of the air traffic controllers and the crushing of labor is widely noted and celebrated on the right. In a 2003 speech at the Reagan Library in California, then-Chair of the Federal Reserve Alan Greenspan spoke glowingly of the "flexibility" of U.S. labor markets, by which he meant "the freedom to fire." Greenspan said that "perhaps the most important" contribution to these flexible markets "was the firing of the air traffic controllers in August 1981.... (Reagan's) action gave weight to the legal right of private employers, previously not fully exercised, to use their own discretion to both hire and discharge workers."

Donald Devine, the head of Reagan's Office of Personnel Management at the time, later wrote, "American business leaders were given a lesson in managerial leadership (by Reagan) that they could not and did not ignore. Many private sector executives have told me that they were able to cut the fat from their organizations and adopt more competitive work practices because of what the government did in those days."

The question today is whether the U.S. will ever go back to being the middle-class society it once was. Many Americans have long believed and hoped that that was the norm, and we will naturally return to it without much effort on our part. But as the past 40 years have gone by, it appears more and more that Gilded Age brutality is the U.S. norm, and the years of an American middle class were a brief exception. That means recreating it will require the same titanic struggle needed to create it in the first place.

# Sheriff happy with new Branch Co. Jail

"Block walls, that are not reinforced by re-rod or grout, are being kicked in by inmates. I can't tell you how excited we are to be able to move into this new facility."


Clark Construction is managing the project, which was down to about 25 tradespeople last month after seeing peak employment of 85. Completion of the project is expected at the end of September, with occupancy taking place by the end of the year. "I know they've been trying to get this jail approved for the last seven years, and it's been a long process," said Clark Project Supt. Jeff Melvin.

"They're going to be very happy when this is complete. The sheriff is over here so often looking things over; the tradespeople all know him by his first name," Melvin joked.

The new Branch County Jail will have 210 beds and 56 cells, as well as five larger holding cells. The 10x16-foot cells were prefabricated in Georgia and trucked in to Michigan. Forklifts set the cells in place.

Construction started on the jail in the fall of 2019, and it soon became apparent that the wet earth under the green space at the site wasn't ideal for construction. Melvin said soil amendments and a redesigned foundation – with 865 22-foot-deep, rammed-stone cast auger piles – kept the development on track.

"In my 35 years, this is the smoothest job I have ever been on," Melvin said. "Our biggest issue was the redesigned foun-

dation, and getting past Covid. But the trades have been fine, it's been great working with them and seeing them work together. Everything went smooth."

In addition to the jail cells, the site will contain administrative offices for the Sheriff's Department, a nurses station, a laundry area, locker areas, interview rooms and a kitchen. The building, of course, has numerous electronic systems for security and saving energy. The "sally port" at the back is large enough to fit a bus, to aid the smooth handling of prisoners. Toilets can be shut off remotely in case an inmate gets the urge to ruin the plumbing.

According to project architect/engineer Byce and Associates, "the new jail will be a single-level operational concept, distinctly divided into four areas: Inmate Housing; Support and Intake; Booking and Release; Public; and the Sheriff's Office. The tiered cell block features one Control Room to permanently supervise the 16 dayrooms of double-tiered cells and dormitories. The Support Areas will accommodate the Intake Processing Areas, Kitchen, Mechanical, Laundry, and Medical spaces. The Administrative Areas include office spaces, records, training rooms and support areas.

Sheriff Pollack said the existing facility is rife with inefficiencies, and the design of the new set up is the result of learning lessons from visiting recently built jails elsewhere. He lauded the work of Clark Construction and the tradespeople on the project.

"Clark, their subcontractors,

the trades – they have just done a terrific job," Pollack said. "We kind of thought we would have to be watching the project all the time, but that wasn't the case. Clark has been great – they have taken care of whatever concerns we have had had. They have been great. It's almost scary how well this job has gone."

The largest earthen dam in North America (east of the Mississippi) has been holding back a 4,000-acre reservoir on the Muskegon River since 1931.

That's the year the Hardy Dam was completed. Construction of the dam in Newaygo County and the installation of a hydroelectric system was part of a key link in the chain of power plants that electrified western Michigan in the 1930s.

Now owned by Consumers Energy, the Hardy Dam isn't just for generating electricity – although it is the largest hydro plant in Michigan. The reservoir, with more than 50 miles of shoreline, serves as a popular recreation destination for thousands of visitors each year. The tremendous engineering and the nice architecture that went into construction of the service buildings helped put the Hardy Hydroelectric Plant on the National Register of Historic Places in 1997.

The historical marker reads:


"Constructed from 1929 to 1931, on a site once known as the Oxbow, the Hardy Hydroelectric Plant was built by Consumers Power Company. The plant was named for George Hardy, a partner in the firm that financed Consumers' projects from 1911 through 1928. The complex includes a Spanish Colonial Revival-style powerhouse and intake tower, an oil house, and a dormitory. It originally included four operator's houses on the eastern bank of the pond, which were Sears-Roebuck kit homes. Due to advancements in fossil fuel steam generating plants, this was the last conventional hydroelectric plant built by Consumers."

According to the National Historic Site (NHS) database, by the 1920s, Consumers Power had established a string of hydroelectric and coal-burning steam plants tied together with high-voltage, long-distance transmission lines that distributed power throughout Michigan's Lower Peninsula. Hardy was the final link in that chain and the largest hydroelectric plant built by Consumers Power, and "was intended to be a showpiece of the system."

The NHS said the Hardy plant "also has statewide significance in the area of engineering." Consumers Power's inter-

connected electrical system enabled some plants to serve as baseload power suppliers while others stood ready to provide peak and emergency service. "A variety of technical considerations made hydroelectric plants with large storage ponds well-suited to serve as peak-supply plants. Hardy's high embankment and sizable pond indicated the plant's intended function in the system," the NHS said.

The National Historic Site said "most Michigan hydro plants were utilitarian structures, but prominent facilities were sometimes given architec-


tural embellishment to reflect a company's stature or pride in its latest achievement. Hardy, a Spanish Colonial Revival plant, was built as a monument to (Consumers Power's) interconnected system of electric power supply."

A 2009 retrofit of a new Unit 3 water turbine at the plant boosted the facility's production by 600 kilowatts – increasing the entire plant's generation capacity to 33,000 kilowatts. That's enough to meet the annual power needs of about 12,200 residential customers.

According to ArchinForm, construction on the plant began

in the fall of 1929. It was designed by William G. Fargo and construction was carried out by his company, Fargo Engineering. Large amounts of concrete were placed into the foundation as solid bedrock was not present, particularly in the streambed.

Allied Engineers began constructing the power plant in the autumn of 1929. In August 1930 the Muskegon River was diverted through the power plant's penstocks and away from the dam construction site. The embankment of the dam was filled by March 1931 using the semi-hydraulic method of construc-

height, round-arched windows on its downstream (south) facade. Inside the powerhouse, three vertical direct-connected General Electric generator units driven by I.P. Morris hydraulic turbines are capable of producing 10,000 KW of three-phase, 60-cycle alternating current at 7,500 volts."

Any talk of a dam these days would have to include an allusion to the awful failure of the Edenville Dam in mid-Michigan after an historic rain caused the failure of the dam's embankment in May 2020. The dam's failure destroyed homes and caused about \$250 million in damages.

For comparison, the Hardy Dam impounds a reservoir with a surface area of 4,000 acres.

The dam's embankment is 114-feet tall, more than twice the size of the embankment in Edenville. Consumers Energy maintains that the Hardy Dam site is safe,

The utility said daily visual inspections are made at both the Hardy and nearby Croton dam, of the dam, and the company has set up underground monitoring instruments to provide real-time data.

ensure our infrastructure is protected against floods, lake levels rising, and changing weather conditions.

"The historic federal infrastructure package" adopted by the Senate, said Michigan Gov. ## Labor Day's origin: killing of 30 strikers launches the day

union strength in the U.S., now and during the birth of Labor Day and the demonstrations that preceded it. New York workers had been the first to hold what's recognized as the nation's first Labor Day parade.

"In the late 1800s," says an account by the *New York Times*, "many Americans toiled 12 hours a day, seven days a week, often in physically demanding, low-paying jobs. Children worked too, on farms and in factories and mines. Conditions were often harsh and unsafe. It was in this context that American workers held the first Labor Day parade, marching from New York's City Hall to a giant picnic at an uptown park on Sept. 5, 1882."

"Because it wasn't yet an official holiday, many of the attendees risked their jobs by participating in the one-day strike. On their signs, they called for 'Less Work and More Pay,' an eight-hour workday and a prohibition on the use of convict labor. They were met with cheers."

That action led to a number of worker parades and shows of solidarity in other cities in subsequent years, and several states adopted legislation making the Labor Day a holiday – even before Congress took action. But President Cleveland didn't sign the federal legislation creating Labor Day out of the goodness of his heart – he did it to soothe outraged workers.

The *Times* account added: "It took several more years for the federal government to make it a national holiday – when it served a greater political purpose. In the summer of 1894, the Pullman strike severely disrupted rail traffic in the Midwest, and the federal government used an injunction and federal troops to break the strike."

An account by *Indiana Public Media* spotlighted the contribution of Eugene Debs, who led the American Railway Union in the 1890s. "Pullman was this odd little city completely surrounded by the City of Chicago at the time," said Indiana University history professor Carl Weinberg, to *IPM*. "And it was run as a company town by George Pullman, the owner of (the Pullman Palace Car) Co. that made these luxury 'Pullman palace cars' at that time, which was the ultimate way to travel in the 1890s. And in the early 1890s, there was an economic depression and it was putting great pressure on companies to lower their costs."

"Eventually, (Pullman) did cut workers' wages pretty substantially and yet, still charged them the same for rent as they had been paying. And so these workers felt awfully squeezed and eventually went out on strike," in May 1894.

"Debs was initially reluctant about calling workers out in support of Pullman strikers. To organize a sympathy strike or secondary strike was considered somewhat radical because he was asking people who were not themselves suffering directly from the effects of George Pullman's actions to sacrifice in support of a greater cause. But he was convinced to go along with it, and it became this massive labor action through much of the country in support of the Pullman strikers."

"President Grover Cleveland eventually sent federal troops to Chicago to quash the strike and stop it from affecting U.S. mail and things got pretty intense, especially in Chicago, where troops came in and workers were fired on. (Thirty workers were killed). They retaliated in kind, especially destroying railroad property."

"Cleveland was aware that he was hated by many workers around the country for having sent in federal troops to Chicago and having issued a federal injunction to arrest Eugene Debs and other leaders of the American Railway Union. And so he was clearly looking to boost his popularity a bit by trying to demonstrate that he, in fact, was the friend of workers."

"The momentum built up over time and eventually, in June 1894, Grover Cleveland did sign this law, making it a national holiday – at that point applying only to federal employees."

But for a few decades, that three-day weekend proved elusive for many workers. "As late as the 1930s," says the *History of Labor Day*, "unions were encouraging workers to strike to make sure they got the day off." Eventually, all 50 U.S. states have celebrated the day as a national holiday.

## Largest infrastructure bill ever Ok'd by Senate

His union “has long supported comprehensive investment in our nation’s infrastructure, broadly defined,” Driscoll said. The “hard” infrastructure bill “represents a good start, (but) we must continue to work to make sure that other vital infrastructure needs are not neglected.”

House Speaker Nancy Pelosi, D-Calif., won’t bring the \$1 trillion “hard” bill to the floor until senators approve the accompanying \$3.5 trillion “reconciliation” bill, which technically is supposed to cover just taxes and sets overall spending limits. Reconciliation now will order Congress to fund everything from combating global warming to expanding child care and paying those workers a living wage to permanent paid family and medical leave to rolling back the 2017 GOP tax cut.

“We will fight to make it easier, not harder, for workers to join unions in America,” declares Senate Budget Committee Chairman Bernie Sanders (Ind.-Vt.), who is trying to shepherd reconciliation through.

### MANY UNION MEMBERS

have Taft-Hartley Trust Funds to thank for their health care benefits, and often times their pensions too. Taft-Hartley Benefit Trust Funds, which are a type of multiemployer fund, are common in building trades industries where unions are present.

### In a nutshell

In conjunction with the collective bargaining process, Taft-Hartley Benefit Trust Funds allow multiple employers to pool contributions that are used to provide benefits for their union represented workers.

Participating in a Taft-Hartley Fund is especially cost effective for small employers, who otherwise might not be able to shoulder all the administrative costs or have the needed expertise to choose the best plans and wade through myriad regulations. In the case of health care, the multiemployer group can leverage their bigger size to get more favorable pricing from insurers and providers.

Workers don't lose their benefits if they leave a participating trust fund employer to work for another employer in the same fund. This portability is highly valued not only in the building trades, but anywhere workers are apt to move from project to project, such as arts and entertainment, trucking, and mining.

### It starts with collective bargaining

Taft-Hartley Benefit Trust Funds are bargained by each employer and the union. The union contract sets employer contribution rates going into the trust fund. Once established and funded, the fund becomes a separate entity governed by a board of trustees with equal union and employer representation.

The trustees have a legal fiduciary responsibility to use fund assets solely for the provision

## Taft-Hartley Benefit Trust Funds: how good union benefit plans were born despite an effort to weaken unions

*While the overall intent of the Taft-Hartley Act was to weaken labor unions, the provisions that created benefit trust funds actually strengthened unions in some respects, and became a vehicle to deliver critical benefits for their members.*

- Outlaw secondary strikes and boycotts which leverages united labor action against powerful employers;

- Captive audience meetings whereby employers can force workers to attend anti-union meetings, typically during a union organizing drive. Though it's illegal for an employer to threaten closing their facility if a union is voted in, it's not an uncommon practice, especially when the employer has captive audience access to workers;

### OK on regulated Trust Funds

While the Taft-Hartley Act by and large aimed its sights on unions, it also made it a federal crime for employers to give anything of value to labor unions – with one significant exception. Employers may contribute to benefit trust funds in the course of collective bargaining.

The multiemployer plans that evolved from the Taft-Hartley Act are tightly regulated and must also comply with applicable ERISA, COBRA, and other rules.

In spite of the intent of the Taft-Hartley Act to weaken labor unions, the provisions that created benefit trust funds strengthened unions in some respects, and became a vehicle to deliver critical benefits for their members.

Labor unions have proven time and again that forging a better path for working people is their purpose. Let's remember that as we face tomorrow's challenges. United we all do better.

**Organizers Report.** 692's Organizing team continues to reach out to unrepresented workers in our jurisdiction about the benefits of joining the IBEW. Zone 2 continues to be a priority as we anticipate larger-scale projects coming to the area over the next few years. The ability to provide adequate manpower to these projects will only strengthen our contractors' chances of securing this work.

The jobs our signatory contractors are performing in our jurisdiction are as follows: Work on the two Bay City bridges will begin this fall with a large-scale remodel of the Liberty bridge followed by the construction of a new Independence Bridge in the spring. Master Electric has secured the new Meijer in West Branch as well as the new Isabella County Jail in Mt. Pleasant. The Meijer project is underway but has seen delays as other crafts have had problems securing material. The new jail is also seeing some delays, we will keep you posted.

Ted's Electric has been awarded some of the work at Midland Public Schools with Barton Malow serving as GC. Ted's was also awarded the Bay County lift station project. Alpena Schools have been awarded to Zone II contractor John's Electric. Clements Electric is wrapping up work on the Monitor Township Fire Department and also the Bay-Arenac ISD bus garage.

Work continues for them at multiple marijuana dispensaries and the new Drift in Bay City. Countyline Power has secured Midland/Gladwin County dam work, the Mackinaw City lift station and the Roscommon Airport. Countyline is also low on a very nice project at the Cheboygan Wastewater Plant. Consumers Energy work for the summer includes Karn 1&2 utility separation, and also work on the gen-


**Retirees Lunch.** The monthly retiree lunches have resumed. We will continue to post information as the dates become available to us.


