### Rail unions incensed over forced contract

WASHINGTON (PAI) -Giving in to pressure from President Joe Biden and corporate rail bosses, Congress overwhelmingly imposed a five-year contract on 115,000 unionized freight railroad workers – without the seven paid sick days they sought.

A nationwide rail strike was seen as imminent, and would have been catastrophic to the U.S. economy. Federal law allows Congress to step in an impose contract conditions on rail workers, which they did.

Biden tried to make up ground by saying the whole issue of paid sick leave will be considered later, and for everyone, not just the rail workers. But that response, and the failure to insert the sick days into the contract, left workers and union leaders irate.

"Rail companies could do the right thing today and grant workers paid sick leave," AFL-CIO President Liz Shuler said just before the Senate's rejection of paid sick leave, on Dec. 1. "But they've refused, putting profits over people. That's how we got here. Regardless of what happens...the fight for paid sick leave won't end. Calling workers 'essential' one minute and treating them as dispensable the next is abhorrent. "We join rail workers and all America's workers - in securing paid sick leave, fair scheduling, and the dignity and respect they deserve.' That respect and dignity includes respect and dignity for collective bargaining agreements - something both Congress and Biden disregarded in wrangling over this rail pact. Railroad Workers United, a rank-and-file organization representing all rail crafts, called them on it. Since "a majority of rankand-file union members have declared" the pact "completely unsatisfactory, President Biden and Congress would be overriding the democratically expressed will of railroad workers," RWU said. "While the tentative agreement provides significant wage increases, workers stated clearly and repeatedly their fight is not just about money. Railroad workers are fighting for the right to live – and have a life - outside of work."

# **Construction's future** cloudy with a chance for sunny breaks in '23

Sooo, how about 2023, eh? Got any ideas on what the construction economy is going to look like next year?

At this stage, your opinion may be as valid as any, as the varied factors affecting the national and worldwide economies are driving the forecast conversation more than anything else. Most forecasters are generally expecting a mixed year, maybe a bit down from the past two years, with growth for some areas – and possibly significant growing pains for other construction sectors. And residential work looks like it will be a bit challenging.

"Looking at the big picture - or skimming through any news site – it's clear there is a lot going on in the world," said Construction Pros last month. Indeed, the war in the Ukraine, inflation including higher energy and material costs, fears of a recession, ongoing supply chain woes and worker shortages are all combining to leave a mark on the world's economy. But not everywhere: many sectors of construction and the rest of the economy are actually doing quite well, and expect to be doing the same in 2023. Dodge Data & Analytics

### Industry forecasting challenged by the vast sea of variables

delivered its 2023 "Construction Industry Outlook" on Nov. 17, and Chief Economist Richard Branch said "the key issue facing the economy now is inflation, (which is) determining its path as we move forward."

The Federal Reserve has aggressively raised interest rates in order to slow inflation, and there are signs that that is happening. Steadier interest rates in the first quarter of 2023 "should allow the economy to stabilize and start to recover in the back half of 2023," Branch said. However, he added that in many construction sectors, "it is going to feel recessionary."

According to Dodge, through the first 10 months of 2022, total construction starts rose 8 percent to a seasonally adjusted annual rate of \$1.12 trillion. That's roughly what most forecasters predicted for the end of this year, and 8 percent would match the level of construction growth in 2021.

However, Dodge predicted that U.S. construction starts will drop 3 percent next year when adjusted for inflation to clock in at \$1.08 trillion, according to their 2023 Outlook. But who will get ahead or fall behind depends on the industry sector. Deloitte, which issued its 2023 "Engineering and Construction Industry Outlook" last month, suggested that the residential sector will be the industry's primary source of pain in 2023. Given that nonresidential work should be boosted with the passage and ongoing spending of President Biden's \$1.2 trillion Infrastructure Investment and Jobs Act and \$280 billion CHIPs and Science Act to boost domestic high-tech manufacturing.



### U.S. jobless rate steady at 3.7%

WASHINGTON (PAI) -The U.S. unemployment rate stayed at 3.7 percent in November, for the third straight month, the Bureau of Labor Statistics reported Dec. 2. The number, for now, reflects a strong workplace economy. Businesses claimed to create a net of 221,000 new jobs, while governments claimed to add 42,000.

The number of jobless dropped by 48,000 in November, to 6.06 million, but the number of employed people also declined, for the third straight month. November's drop was 138,000, to 158.47 million.

# Pfizer set to inject \$750M into K'zoo plant

announced on Dec. 5 that it will the uninterrupted supply of Pfizer be investing \$750 million in its facility here, in an effort that will expand production and create 300 jobs.

This investment builds on an initial investment of \$465 million at the facility announced in 2018, and a \$120 million expansion announced earlier this year.

The company said the plant is one of the most technologically advanced in the world, and the in-

KALAMAZOO - Pfizer Inc. vestment will continue to ensure medicines and vaccines.

> "Since 2017, Pfizer has invested \$5 billion to support the ongoing growth of our manufacturing leadership in the U.S.," said Albert Bouria, Pfizer's chairman and CEO. "This expansion is part of our blueprint to grow our U.S. manufacturing base, create more manufacturing jobs, and help ensure patients everywhere can get the medicines they need."

One of Pfizer's largest plants, the Kalamazoo facility is a global supplier of sterile injectable, liquid, and semi-solid medicines, as well as active pharmaceutical ingredients, producing more than 144 products. Currently, the multistory, 400,000-square-foot MAP production facility employs 3,000 colleagues and contractors.

Pfizer's operations in Kalamazoo County generate an estimated annual economic impact in west Michigan of \$3 billion. The plant has been in operation since 1948 and has had a presence in the community through the legacy Upjohn Co. since 1886.

'Today, Pfizer is making another bold bet on Michigan's manufacturing strengths and hardworking people," said Gov. Gretchen Whitmer. "This \$750 million investment will expand capacity at their Kalamazoo facility, creating good-paying jobs and fostering long-term economic opportunity for Michiganders."

'On the one hand," the report said, "the nonresidential segment is likely to be buoyed by funds entering the market from the Infrastructure Investment and Jobs Act and the CHIPS and Science Act of 2022. On the other hand, residential construction companies are relatively more pessimistic about the industry outlook for the next year compared to other segments. So, while some segments may be more bullish than others, there are headwinds - from inflation to (Continued on Page 5)

### A win for labor unions

This year's U.S. midterm elections delivered unexpected victories for hundreds of Democratic candidates at the federal and state level during a time when the incumbent party typically struggles.

These results will have a huge political impact over the next two years, most notably in the form of Democrats retaining control of the U.S. Senate. But beyond the impact on national party politics or any individual race, these midterm elections were also an undeniable sign of what U.S. voters actually want.

Voters turned out in droves - especially young voters - and overwhelmingly they voted for candidates that represent the interests of workers and workers' rights. Voters in Illinois enshrined collective bargaining into the state's constitution, saying no to socalled "right to work" laws that undercut unions. And voters said an emphatic no to candidates who continue to peddle false election claims that threaten our very democracy.

Is it a coincidence that these results come at a time when Americans' approval of labor unions stands at 71 percent, the highest mark we've seen since 1965? This positive public perception is due in part to the tireless work of the Laborers' International Union of North America (LIUNA) and its District Councils, local unions, affiliates, members and signatory contractors. LIUNA and the entire labor movement also benefit from the unwavering support of President Biden, who always speaks loudly and proudly about the importance of unions and working people.

It's easy to see why more and more people approve of unions, especially in these uncertain economic times. A recent Economic Policy Institute (EPI) report lays out the broad range of benefits that unions create for workers, communities and the economy. The average union worker earns 10 percent more than a non-union worker in their industry with the same experience. Unions drive equity by helping to eliminate discriminatory pay gaps across gender and racial lines.

And as we often discuss at the Laborers' Health & Safety Fund of North America (LHSFNA), union workers are much more likely to have high-quality health insurance and long-term financial security in the form of retirement plans and savings.

Unions aren't just good for workers - they're good for communities and democracy too. The EPI report went on to note that when unions are weakened, such as through restrictive "right to work" laws, the result is lower voter turnout overall and fewer working-class candidates on the ballot. This leads to policies and candidates that don't serve the needs of workers, their families or the communities where they live. By contrast, a strong union presence raises the bar for wages, health benefits and safer working conditions. A strong labor movement promotes income equality and economic growth that we can build on.

This year, U.S. voters said yes to preserving their right to organize, said yes to protecting their health and said yes to building a future that gives everyone a voice. Unions have been bringing these values and policies to their members for decades. Now it's time to continue that fight beyond these midterms elections so we can offer a hand up and a path forward to even more workers and their families in the years to come.



The peak of the 50-foot-tall steeple is about 150 high, topped by a copper cross fabricated by a another contractor. Built in an octagonal shape, each side of the eight sides of the steeple is 100 inches wide at the base, tapering to 4 inches wide at the top. Approximately 1,500 square feet of copper was placed. Olson said they used a lift to access the steeple and make the repairs and add the new copper cover. A lightning protection system was also installed.







The early years of development of the U.S. auto industry was never a sure era for any carmaker. Thousands of companies that would design and assemble cars – or supply their parts, engines and running boards – sprang up and then went out of business, or were merged into or out of existence.

By 1917, it was becoming clear that General Motors Corp. was emerging from its pack of competitors to suggest that it had a great chance at a successful future.

That year, two years before it began construction on the General Motors headquarters building in Detroit, the automaker was the 34th largest American company (by rev-

enue), and earlier that decade had linked with Chevrolet and acquired Cadillac, Oldsmobile, Oakland (later Pontiac) and several dozen other companies, as well as supplier firms and an electric company.

"Based in a number of rented offices, first in New York and then Detroit, it wasn't until early 1918 that GM's board of directors pressured (GM founder William) Durant to build a permanent headquarters in Detroit," writes A. Wayne Ferens in *A History of the General Motors Building*.

"A 3.7- acre tract of land was purchased between Cass and Second on West Grand Boulevard just west of Wood-

> ward Avenue. Albert Kahn, known as the 'architect of Detroit' and the foremost industrial architect of his day, was hired by GM, along with main contractor Thompson-Starrett Co., to complete the task."

Not unlike Henry Ford's decision to go big or go home with the conr struction of the massive Rouge Plant in Dearborn during that era, the self-

assuredness – or let's say the cajones – shown by Durant and the GM corporate board to build the massive new headquarters was remarkable, and resulted in the construction of one of Detroit's landmark buildings.

"What is most impressive about the GM Building is the sheer scale of the enterprise," says *The American Institute of Architects Guide to Detroit Architecture.* "Upon completion, the 15-story structure was the second largest office building in the world after the Equitable Building in New York."

Ferens wrote that Kahn submitted plans in the spring of 1919 for a large neoclassical style building 15 stories high covering 1.2-million square feet of floor space. With some changes to the original proposal and another nearly 200,000 square feet of floor space added to the plans, the GM board approved the final modifications and scheduled groundbreaking for the building on June 2, 1919. The first phase of the project was clearing the land and demolishing nearly 50 structures.

"The building was originally named after Durant but following a power struggle at General Motors in 1921, it was renamed the General Motors Building," says the Detroit Historical Society. "A 'D' above the entrance and elsewhere on the building is evidence of the earlier name. When it opened in 1923, it was the second largest office building in the world, in capacity."

The New Center area, about three miles north of Detroit's downtown, was envisioned in the 1920s as a second business hub convenient to both downtown and outlying factories. GM's property dominated the landscape from every direction.

Writes Dan Austin for Historic Detroit: "The scale of the building, even now, is impressive: 15,000 tons of steel, four miles of corridors, 3,500 offices, 5,148 windows containing more than seven acres of glass and 30 acres of floor space. If you laid its 8.8 million bricks end to end, they would stretch for 1,110 miles. It had two swimming pools, tennis and handball courts, 19 bowling alleys, nine auto showrooms and a fourstory laboratory. As the tallest show in the neighborhood, it was said that on a clear day the 220-foot building could be seen from 20 miles away. In addition to being GM's world headquarters, it hosted conventions in a 41,000-square-foot expo hall."

The façade of the building was constructed in limestone. The base of the building is two stories tall with four parallel 15-story wings designed to allow sunlight to reach each of the hundreds of individual offices in the building.

"This monumental structure is perhaps Albert Kahn's

personal masterpiece in commercial architecture," said the American Institute of Architects Guide to Detroit Architecture. "Here neoclassical refinement is applied to the tall building with considerable maturity and skill. Kahn followed Sullivan's (the 'father of skyscrapers' architect Louis Sullivan) threepart skyscraper formula to be sure, with an Italian Renaissance arcade that engages the street, a finely proportioned shaft and a Corinthian colonnaded crown."

The building was added

Historic Detroit to the National Register of Historic Places in 1978. The application said the only exterior change was that wooden windows had been replaced with metal, and that the company had successfully created "a general office to coordinate, appraise, and set goals and policies for numerous operating divisions. Quoting management historian Alfred Chandler, Jr. in the application, the document said of the company's innovations and management that went on in the building: "General Motors pioneered beyond the automobile industry because its decentralized form of administrative organization... became a model... for much of the rest of American industry."

For the past two decades – since GM moved its headquarters to the Renaissance Center – the State of Michigan has been using the renamed "Cadillac Place" building for offices. But the structure's massive presence in Detroit's New Center Area remains an historic reminder of GM's corporate might.

Today, GM has slipped to being ranked No. 25 on the Fortune 500 list.

### **Construction's** future cloudy; chance for sun (Continued from Page 1)

supply chain woes - which may continue to affect the industry overall in the coming year."

FMI's North American Engineering and Construction Outlook Fourth Quarter predicts that single-family residential construction will drop 12 percent next year, while multi-family residential will gain 6 percent. The National Association of Home Builders said earlier this month that the ongoing 11-month decline in Housing Market Index means the residential industry is in recession.

FMI also sees spending declines in various nonresidential segments, including lodging, office, educational, religious, public safety and transportation, with more "softening" economic conditions in the second half of 2023.

The industry prognosticators at Deloitte, without putting numbers on their forecast, suggested that "a closer look at current market dynamics suggests that 2023 will likely experience differentiated growth rates across different industry segments."

The group suggested construction owners and contractors should be prepared for inflation and supply chain issues that will bring "increased lead times and volatile energy costs." They suggested that a nagging tight labor market may force companies to continue to "raise wages and expand benefits to attract and retain employees in 2023."

Even with the potential headwinds, many construction sectors keep chugging along. Dodge Data and Analytics reported on Dec. 6 that their Momentum Index rose 3.8 in November from October.

'The Momentum Index continued to rise in November, conveying hopefulness from owners and developers that the construction sector will endure the possible economic slowdown next year," said Sarah Martin, senior economist for Dodge Construction Network. "The rate of increase in the DMI, however, has steadied over the month. Labor and supply shortages, high material costs and high interest rates could temper planning activity over the next 12 months to a more modest pace."

WASHINGTON (PAI)— Flanked by Teamsters whose pensions will be preserved, not destroyed, President Joe Biden touted the law - The Butch Lewis Act - that will keep pensions flowing to retirees and their families through 2051.

The Lewis Act, part of Biden's American Rescue Act, gives long-term aid to some 200 financially troubled multiemployer pension plans, all clobbered by the financier-caused 2008 crash. It robbed those plans of income and asset values they used to pay beneficiaries and left them on the brink of going broke.

Some two to three million workers were at risk, including 357,056 retirees and beneficiaries in the largest impacted plan, the Teamsters Central and Southern States Plan. Multi-employer plans cover a total of 11.2 million workers and retirees.

The Lewis Act resulted in Central States receiving \$36 billion, "which ensures" beneficiaries "will enjoy their full pension benefits for the rest of their lives," the union said. Benefits are guaranteed through 2051.

Without aid, it would have become insolvent by the end of 2025, leaving its beneficiaries to turn to the federal Pension Benefits Guaranty Corp., whose multi-employer plan fund too would have run out of money by 2026. PBGC's fund will stay solvent for almost as long.

"T-Mobile created an illegal workplace organization," CWA said. The board "ordered T-Mobile to disband the organization and post a notice informing employees of their right to join a union. The company-controlled organization, called T-Voice, was established in 2015, in the midst of worker efforts to form a union at the wireless company." That campaign continues.

"T-Mobile's illegal attempt to undermine worker organizing at the company is just one in a string of labor law violations at the company, which merged with Sprint in 2020," CWA continued.

"Throughout the merger process, CWA raised concerns about the impact of the merger on workers and consumers, particularly the effect of store closures on jobs and wages. T-Mobile's anti-union actions made it impossible for workers to win the protections offered by collective bargaining agreements."

And T-Mobile's company union, T-Voice, also stood in the way, the board panel's majoritysaid.

Message from the Business Manager. You have my sincere wishes Brothers and Sisters for a very Merry Christmas and a Happy New Year from my family to yours! It is my hope the New Year brings you and your family all unfound prosperity.

Recently it was proposed and overwhelmingly approved by the membership to raise the death benefit from \$5.00 to \$10.00 per death of a member. Last week, I received notification from International Vice President Paul Noble that the International Office has also approved this By-Laws change.

There are some software updates that will be needed in order to make this change possible. There will also need to be some record keeping updated in order to facilitate this change. For these reasons, effective January 1<sup>st</sup>, 2023 the death benefit increase from \$5.00 to \$10.00 will take place.

Work Report. The first and most important thing I am going to say about the work outlook is supply issues continue to slow or stall projects. This is our work outlook to the best of my knowledge.

Ongoing projects in our iurisdiction that may require additional manpower include:

Nelson Electric – GM Powertrain work started on October 3<sup>rd</sup> and will run through the first quarter of 2023. Swan Electric -Multiple DTE natural gas pumping stations throughout Zones 1 and 2. This project just as many others have seen delays due to supply issues. J.Ranck Electric - continuing work on phase 1 of the SK Siltron semi-conductor

MICHIGAN branches of the state legislature. This is a big deal.

Rest assured that union officials will demand action on legislation that matters most to organized labor, the building trades, and working families. Right-to-Work will be repealed. An unequivocal reinstatement of Prevailing Wage on all state funded projects over \$50k is expected, as is a repeal of the pension tax (all union-killing measures enacted by past Republican legislatures and administrations).

Holding our political leaders accountable on these legislative priorities will allow our contractors to secure more work and put money in our members' pockets. That is the sole reason we are so involved in the political arena, to secure the financial security of working men and women and strengthen our communities.

We also expect our elected officials to deal with issues such as combatting inflation, increasing unemployment compensation, continued investments with infrastructure improvements, supporting our public schools, and population retention by providing jobs that pay a livable wage. We must ensure our that political leaders deliver for Michigan workers. If you voted in the midterms or volunteered for candidates, thank you.

If you'd like to register on any other IBEW Local out-ofwork lists, please reach out to the hall for details on which locals accept fax or email registration. There are currently nearly 250 open calls throughout the Sixth District (Michigan, Minnesota, Indiana, Illinois, Wisconsin) and an additional 1,300 unfilled calls for manpower elsewhere nationwide.

692 Organizers continue to visit jobsites within our jurisdiction to speak with unrepresented electricians, building relationships and discussing the opportunities that exist by joining our Brotherhood. We should never lose sight of the organizing mission that guided the birth and growth of the IBEW. Our founders built a strong union by organizing all qualified workers, which allows us to build a higher union density and ultimately increases our bargaining power during negotiations.





### State's minumum wage to rise, a bit

Michigan's minimum wage will increase from \$9.87 to \$10.10 per hour beginning Jan. 1, in accordance with the state's Improved Workforce Opportunity Wage Act of 2018, which established the annual schedule of increases.

The Michigan Department of Labor and Economic Growth reminded employers on Dec. 5 that the "85 percent rate" for minors aged 16-17 will set their pay increase to \$8.59 per hour, and the tipped employee hourly rate increases to \$3.84 per hour on Jan. 1.

The state's minimum wage has been a bit of a political hot potato since 2018, when a citizens petition drive organized by One Fair Wage sought to allow voters to decide on raising Michigan's minimum wage to \$12 an hour by 2022. The initiative would also have raised the minimum wage incrementally for tipped workers, ultimately by 2024 matching the minimum wage earned by all Michigan workers.

The Republican-led state Legislature – in a so-called "review and screw" maneuver – basically sidestepped and superseded the successful petition effort by raising the minimum wage before it took effect, and replaced it with a lower wage. Instead of the \$12 an hour wage by 2022, the GOP forced through a law that increased the minimum wage rates more slowly, ultimately to \$12.05 per hour by 2030. They also set the tipped minimum wage at 38 percent of the standard minimum wage.

The Legislature's amendment has been challenged in court as unconstitutional. "Workers have been fighting this subminimum wage, which has been a source of sexual harassment and racial inequity, for decades," said Saru Jayaraman, president of One Fair Wage, which supported a Michigan coalition that collected more than 400,000 voter signatures for the initiative.

On July 19, 2022, the Michigan Court of Claims issued a decision that agreed with that challenge and voided the amended versions of the Republican-backed Michigan Improved Workforce Opportunity Wage Act and Paid Medical Leave Act in favor of their original, unamended versions as set by the petition language.

On July 29, 2022, the Court of Claims entered an order staying the effect of this decision until Feb. 19, 2023, to give employers and the relevant state agencies time to accommodate the changes required by the ruling. That ruling is under appeal.





designate or update your beneficiary choice on all of your Local 80 and international benefits. The law requires that in the event of an untimely death your benefits go to your spouse first and if there is no spouse to your children UNLESS you designate otherwise in writing with each specific benefit.

Depending on your classification you could have benefits due to your heirs from Local 80 pension, insurance, annuity and from international and SASMI. Each individual benefit needs to have a designated beneficiary unless you want it to go to your spouse or children. As always seek the advice of an attorney.

ADDRESS CHANGES: If you have a new address please make sure to let the hall know. We will take care of your account with the union hall which includes the Tradesman paper. You will need to call Benesys at 800-400-7710 and update your address with them as well. That is not done through the hall.

ACCIDENTAL DEATH and DISMEMBERMENT INSURANCE FROM OUR INTERNATIONAL ASSO-CIATION: Members who have their dues paid in advance (prior to the month of the accident) are eligible for accidental death and dismemberment benefits up to \$7,500.00. This benefit comes as a dues paying member of SMART International.

WORK ASSIGNMENTS: Everyone must obtain a work assignment prior to starting work. If you fail to do so you could be written up on charges.

LAYOFF SLIPS/TERMINA-TION NOTICES: Layoff slips must accompany all applications for sub pay. Without lay off slips you cannot collect sub pay. It is the member's responsibility to make sure they get one from the contractor when laid off. Your application cannot be submitted without one. It is the contractor's responsibility to issue one in accordance with our contract.

**S.U.B. BENEFITS:** Report to the hall promptly upon layoff. You must complete a S.U.B. Application within seven (7) days from your layoff date or you will forfeit S.U.B. benefits. Lay-off slips must accompany the application to be eligible. Proof of UIA benefit payments must be submitted within 21 days of when you were paid in order to receive SUB benefits. Do not submit your sub applications directly to the fund office. Your application must be signed by the hall or you will not collect benefits.

OUT-OF-WORK LIST: You must be on the out-of-work list to collect S.U.B. benefits or SASMI. Members must reregister bi-annually: March 1 through March 20 and September 1 through September 20. If you fail to re-register you will be removed from the list.

SHORT WORK WEEK SUB PAY: If you work 16 hours or less in a week or have a short work week due to weather you may collect sub for that week but only if it is at the **beginning** or the end of a layoff. You may NOT collect if you are not laid off. You must complete a sub application at the hall, provide a pay stub for that week and the hall will submit it to the fund office. If you are not laid off and it is due to weather the company MUST provide written documentation that it was weather related.

MEMBERS ASSISTANCE **PROGRAM:** If you are experiencing problems in your family, marriage or relationships, stress or emotional difficulties, grief or loss issues or problems with alcohol and drug use please contact our assistance program. Ulliance is there to help you with your needs. They can also help you with legal issues, financial concerns, elder care referrals and child care resources. 



The above training and certifications are all available at the training center. It could mean the difference of being sent to work or not! FYI: By taking the OSHA 30 your 18 MUST Safety modules are updated as well. If you are not able to go to the Training Center for MUST Safety Modules contact the Local Union to assist you with making arrangements to complete them.

**Referral List:** Every member who is looking for work must call, or come to the Local Union Office on Mondays between 1:00 pm and 4:00 pm and put their name on the out-of-work list. You must have an out-of-work skills sheet filled out and on file in order to be referred out for work by the Local Union. Also be sure to Check & Update your Skills regularly.

### **NLBR targets Apple for labor law violations**

The National Labor Relations Board has gone after Starbucks and Amazon this year. Now it's taking on Apple for labor law violations, *Labor 411* reports.

"In April, an Apple Store in Atlanta became the first of the company's American retail locations to file for a union election," *Tech Crunch* said. "Yet about a month later, the Communications Workers of America (CWA) withdrew its request for an election. The labor union alleged that Apple was using illegal



Think of this and act." – Hannah More union-busting tactics to influence voting, like interrogating workers and requiring them to attend daily, mandatory anti-union meetings. Now, the National Labor Relations Board (NLRB) has found merit to the CWA's complaint that these anti-union activities were illegal.

"Apple executives think the rules don't apply to them. Holding an illegal forced captive audience meeting is not only union-busting, but an example of psychological warfare,' said Tom Smith, CWA Organizing Director, in a statement. 'We commend the NLRB for recognizing captive audience meetings for exactly what they are: a direct violation of labor rights."

In April, NLRB General Counsel Jennifer Abruzzo issued a memo saying that captive audience meetings are inherently inconsistent with the rights employees have under the National Labor Relations Act. In the past, NLRB representatives had ruled that these meetings were permissible.

### Today's "Real Men" Take Their Mental Health Seriously

THERE WAS A POPULAR phrase in the 1980s that you still occasionally hear - "real men don't eat quiche." It was based on a book of the same name, which was a tongue-in-cheek review of stereotypes about masculinity. The ideal male, according to the images conjured by the book, was heavy on testosterone and light on acknowledging their own feelings, listening to others, or asking for help. It was meant to be funny, and who doesn't chuckle when we hear about men arriving somewhere late because they couldn't bear to ask for directions?

Does this image still hold true today?

While there are plenty "tough guy" examples – football players, ripped actors who perform lots of daring feats, and yes, even building trades workers – many of the men in these fields today are expressing feelings and emotions without diminishing their status. Many of them point out they've become better fathers, husbands, sons, and brothers because they've stopped locking away their feelings.

### Even "The Rock" Cries

Men who've done the difficult work of tending to their mental health find they've also become better fathers, husbands, sons, and brothers because they've stopped locking away their feelings.

low when injuries sidelined his dream of playing professional football.

"Struggle and pain is real," Johnson said in an interview, and it "took me a long time to realize it but the key is to not be afraid to open up. . . Especially us dudes have a tendency to keep it in. You're not alone."

Other athletes, including Dallas Cowboys quarterback Dak Prescott; Philadelphia Eagles player Lane Johnson; Cleveland Cavaliers forward Kevin Love; and American sprinter Noah Lyles have publicly revealed their mental health challenges and encouraged others to get help rather than suffer in silence.

### A Widespread Problem

Mental health problems affect a large segment of the population, with 1 in 5 adults experiencing symptoms which can include anxiety; depression; over use of alcohol or drugs; and aggressive or passive behaviors. the general population. Family and personal problems, economic stressors, and work itself are often the sources of distress.

### Let's Help Each Other

"Having conversations about mental health in the workplace can be difficult," said DeShon Leek of the Michigan Building Trades at a Construction Suicide Prevention event in September. Attendees from state health and safety organizations, employers and union representatives came together to shine a light on mental health and promote resources for help. "We all have a role to play in supporting the people who help make our communities great," Leek emphasized.

While women are more likely than men to get mental health help, less than half of people with mental illness - men and women - receive treatment. Clearly, both men and women need encouragement and support when it comes to mental health.

Construction industry workers fare even more severely in the statistics, with suicide rates that are four times higher than
